- 2 AN ACT TO CHANGE THE TIME OF THE ELECTION AND THE TERM OF 3 OFFICE FOR MEMBERS OF THE CABARRUS COUNTY BOARD OF
- 4 EDUCATION.

5 The General Assembly of North Carolina enacts:

6 Section 1. Beginning in the year 1990, the Cabarrus County Board of 7 Education (" the Board" ) shall be elected at the time of the general election (the first 8 Tuesday after the first Monday in November) in each even-numbered year. The Board 9 shall continue to consist of seven members (identified as Seats 1-7), elected on a 10 nonpartisan basis.

11 Sec. 2. Unless otherwise identified in the implementation schedule 12 hereinafter set forth, the term of office of each member of the Board hereafter elected 13 shall be four years, beginning on the December 1 next following the election of such 14 member. The terms shall be staggered so that three members are elected at one election 15 and four members are elected at the next election, implemented as follows:

(a) The two persons elected to fill the seats for the terms expiring December 1,
17 1990, (Seat numbers 1 and 2) shall be elected for six-year terms expiring December 1,
18 1996;

(b) The two persons elected to fill the seats for the terms expiring December 1,
1992, (Seat numbers 3 and 4) shall be elected for four-year terms expiring December 1,
1996;

(c) The three persons elected to fill the seats for the terms expiring December 1,
1994, and each four years thereafter (Seat numbers 5, 6 and 7) shall be elected for fouryear terms expiring December 1, 1998, and each four years thereafter, respectively;
