AN ACT TO DEFINE THE LIMITS OF LOCAL GOVERNMENT EMPLOYEES'
POLITICAL ACTIVITIES WHILE ON DUTY.

The General Assembly of North Carolina enacts:

18 19 Section 1. Chapter 153A of the General Statutes is amending by adding a new section to read:

"§ 153A-99. County employee political activity.

- (a) Purpose. The purpose of this section is to ensure that county employees are not subjected to political or partisan coercion or interference while performing their job duties, and to ensure that public funds are not used for political or partisan activities.
- It is not the purpose of this section to allow infringement upon the rights of employees to engage in free speech and free association. Every county employee has a civic responsibility to support good government by every available means and in every appropriate manner. Employees are not restricted from affiliating with civic organizations of a partisan or political nature, nor are employees restricted from attending political meetings, or advocating and supporting the principles or policies of civic or political organizations in accordance with the Constitution and laws of the State and the Constitution and laws of the United States of America.
 - (b) Definitions. For the purposes of this section:

'County employee' or 'employee' means any person employed by a 1 (1) 2 county or any department or program thereof that is supported, in 3 whole or in part, by county funds; 'On duty' means that time period when an employee is engaged in the 4 <u>(2)</u> 5 duties of his or her employment: and 6 (3) 'Workplace' means any place where an employee engages in his or her 7 iob duties. 8 No employee while on duty or in the workplace may: (c) 9 (1) Engage in partisan political activity: 10 (2) Use his or her official authority or influence for the purpose of interfering with or affecting the result of an election or nomination for 11 12 political office; or 13 (3) Coerce or compel contributions for political or partisan purposes by 14 another employee. 15 No employee may be required as a duty or condition of employment, (d) promotion, or tenure of office to contribute funds for political or partisan purposes. 16 17 No employee may use county funds, supplies, or equipment for political or 18 partisan purposes."
