2	AN ACT TO ENSURE THAT SUFFICIENT FUNDS ARE AVAILABLE TO		
3	PROVIDE TEXTBOOKS TO PUBLIC SCHOOL STUDENTS.		
4	The General Assembly of North Carolina enacts:		
5	Section 1. G.S. 115C-96 reads as rewritten:		
6	"§ 115C-96. Powers and duties of the State Board of Education in regard to		
7	textbooks.		
8	The children of the public elementary and secondary schools of the State shall be		
9	provided with free basic textbooks within the appropriation of the General Assembly for		
10	that purpose. The To implement this directive, the State Board of Education is directed to		
11	shall evaluate annually the amount of money necessary to provide textbooks based on		
12	the actual cost and availability of textbooks and shall request sufficient appropriations		
13	from the General Assembly to implement this directive. Assembly.		
14	The State Board of Education shall administer a fund and establish rules and		
15	regulations necessary to:		
16	(1) Acquire by contract such basic textbooks as are or may be on the		
17	adopted list of the State of North Carolina which the Board finds		
18	necessary to meet the needs of the State public school system and to		
19	carry out the provisions of this Part.		
20	(2) Provide a system of distribution of these textbooks and distribute the		
21	books that are provided without using any depository or warehouse		
22	facilities other than those operated by the State Board of Education.

- (3) Provide for the free use, with proper care and return, of elementary and secondary basic textbooks. The title of said books shall be vested in the State."
- Sec. 2. G.S. 143-11 reads as rewritten:

# 5 "§ 143-11. Survey of departments.

6 On or before the fifteenth day of December, biennially in the even-numbered years, 7 the Director shall make a complete, careful survey of the operation and management of 8 all the departments, bureaus, divisions, officers, boards, commissions, institutions, and 9 agencies and undertakings of the State and all persons or corporations who use or 10 expend State funds, in the interest of economy and efficiency, and of obtaining a working knowledge upon which to base recommendations to the General Assembly as 11 12 to appropriations for maintenance and special funds and capital expenditures for the 13 succeeding biennium. If the Director and the Commission shall agree in their 14 recommendations for the budget for the next biennial period, he shall prepare their 15 report in the form of a proposed budget, together with such comment and 16 recommendations as they may deem proper to make. If the Director and Commission 17 shall not agree in substantial particulars, the Director shall prepare the proposed budget 18 based on his own conclusions and judgment, and the Commission or any of its members retain the right to submit separately to the General Assembly such statement of 19 20 disagreement and the particulars thereof as representing their views. The budget report 21 shall contain a complete and itemized plan of all proposed expenditures for each State department, bureau, board, division, institution, commission, State agency or 22 23 undertaking, person or corporation who receives or may receive for use and expenditure 24 any State funds, in accordance with the classification adopted by the State Controller, and of the estimated revenues and borrowings for each year in the ensuing biennial 25 period beginning with the first day of July thereafter. Opposite each item of the 26 27 proposed expenditures, the budget shall show in separate parallel columns the amount expended for the last preceding appropriation year, for the current appropriation year, 28 29 and the increase or decrease. The budget shall clearly differentiate between general 30 fund expenditures for operating and maintenance, special fund expenditures for any purpose, and proposed capital outlays. 31

9		and the total receipts from the fee during the prior fiscal year.	
0	<u>(4)</u>	A statement showing the State Board of Education's request, in	
1		accordance with G.S. 115C-96, for sufficient funds to provide	
2		textbooks to public school students.	
3	It shall be a compliance with this section by each incoming Governor, at the first		
4	session of the General Assembly in his term, to submit the budget report with the		
5	message of the outgoing Governor, if he shall deem it proper to prepare such message,		
6	together with any comments or recommendations thereon that he may see fit to make,		
7	either at the time of the submission of the said report to the General Assembly, or at		
8	such other time, or times, as he may elect and fix.		
9	The function of the Advisory Budget Commission under this section applies only if		
0	the Director of the Budget consults with the Commission in preparation of the budget."		
1		B. This act is effective upon ratification and applies to all budget	
2	requests beginning	ng with the budget request for the 1993-95 fiscal biennium.
