1 A BILL TO BE ENTITLED

2 AN ACT TO EXTEND THE CORPORATE LIMITS OF THE TOWN OF DAVIDSON.

4 The General Assembly of North Carolina enacts:

Section 1. The corporate limits of the Town of Davidson are extended to include the following described property:

- 7 PARCEL ONE: Right of Way of Portion of Davidson-Concord Road
- 8 Being the 60-foot right of way of a portion of Davidson-Concord Road, the centerline of
- 9 which begins along the eastern town limits of the Town of Davidson and runs in a
- southeasterly direction approximately 9,077 feet to the intersection of the southerly
- 11 margin of the right of way of Parting Oaks Lane, as shown on a plat recorded in Map
- 12 Book 23 at Page 277 in the Mecklenburg County Public Registry.
- 13 PARCEL TWO: 914.3 Acre River Run Community
- 14 Lying and being in Deweese Township, Mecklenburg County, North Carolina and being
- more particularly described as follows:

Sec. 1.1. If the Town of Davidson exercises extraterritorial jurisdiction in an area not to exceed one mile from the corporate limits established in this act and where it is not already exercising such jurisdiction, as provided by G.S. 160A-360, after satisfying the requirements of that statute, the regulations applicable in such extraterritorial jurisdiction, in recognition of the rural character and existing uses in the area, for a period of five years after the effective date of the annexation shall not prohibit farming operations, horticultural enterprises or horse raising or training businesses or related uses, including accessory buildings used in connection with these uses.

Sec. 2. This act becomes effective June 30, 1991.
