## A BILL TO BE ENTITLED

- 2 AN ACT TO AUTHORIZE QUALIFIED DENTISTS TO ADMINISTER GENERAL3 ANESTHESIA.
- 4 The General Assembly of North Carolina enacts:
  - Section 1. G.S. 90-29(b) reads as rewritten:

6 "(b) A person shall be deemed to be practicing dentistry in this State who does, 7 undertakes or attempts to do, or claims the ability to do any one or more of the 8 following acts or things which, for the purposes of this Article, constitute the practice of 9 dentistry:

23 subsection shall not apply to a lawfully qualified nurse or anesthetist
