BILL SUMMARY: Authorizes a two-year pilot project in the Charlotte-Mecklenburg school system to allow funds for up to 75 State-funded teacher assistant positions to be used to hire teachers and reduce class size in grades K-3.

The Plan is subject to the following limitations:

A. Vote by certificated staff and parents of kindergarten children if the local board develops a plan for that grade level.

B. Vote by certificated staff and parents of grades 1-2 children if the local board develops a plan for those grade levels.

C. Teacher Assistant positions cannot be abolished if filled on June 1, 1992.

D. No more than 75 teacher assistant positions can be abolished.

E. Plan can only be implemented in 18 schools.

F. Pilot project is effective for only 2 years.

ASSUMPTIONS AND METHODOLOGY:

1. Charlotte-Mecklenburg school system would not receive additional State funds for teacher assistants beyond those the system is already entitled in FY 1992-93.
2. Hiring teachers with teacher assistant funds would not convert these dollars to a position allotment and a State guaranteed salary.
