By will or intestacy. 15 (4) (5) By a conveyance between a husband and wife or a parent and child. 16 By a distribution of marital property as a result of a divorce. 17 (6) To a volunteer fire department or volunteer rescue squad when the **(7)** 18 motor vehicle is one of the following: 19 A fire truck, a pump truck, a tanker truck, or a ladder truck used 20 a. 21 to suppress fire.
