A BILL TO BE ENTITLED 1 2 AN ACT TO AUTHORIZE THE DEPARTMENT OF ENVIRONMENT, HEALTH, 3 AND NATURAL RESOURCES TO ESTABLISH AND IMPLEMENT A PILOT 4 PROGRAM IN SELECTED COUNTIES TO ASSIST LOW-INCOME INDIVIDUALS TO OBTAIN PRESCRIPTION DRUGS AT REDUCED COST. 5 6 The General Assembly of North Carolina enacts: 7 Section 1. (a) Short title. This act shall be known as the Prescription Drug 8 Assistance Pilot Program. 9 (b) Purpose. The General Assembly recognizes that many of North Carolina's medically needy citizens are unable to afford the cost of prescription drugs for treatment 10 of certain illnesses. The General Assembly further recognizes that cooperative efforts 11 between State and local government agencies and the private sector are often successful 12 in providing important services to local communities, which services would not 13 otherwise be available because of limited government resources. The purpose of this 14 15 act is to authorize the Department of Environment, Health, and Natural Resources to facilitate local public and private sector cooperative efforts to identify and assist 16 medically needy individuals in obtaining certain prescription drugs at reduced cost. 17 This effort will be initially implemented as a pilot program consisting of two project 18 19 sites each of which will serve five selected counties that apply for assistance from the 20 Program.

3	Prescription Drug Assistance Pilot Program. The purpose of the pilot program is to

Further pursuant to its responsibilities under 1 2 this act, the Department may enter into informal agreements or written contracts with public or private entities for the purposes of obtaining or providing prescription drugs 3 4 available under the Program for eligible individuals; provided, however, that any agreement or contract that contains a financial commitment or otherwise imposes a 5 6 financial obligation on the State shall be in writing and shall not be binding upon the 7 State unless the agreement or contract has the written approval of the Secretary of 8 Environment, Health, and Natural Resources. 9 (e) Assistance in obtaining prescription drugs at reduced cost under the 10 Prescription Drug Assistance Pilot Program shall be granted to any person who lives within a project area and who: 11 12 Has insufficient income to pay for prescribed medication of the kind (1)13 available under the Prescription Drug Assistance Pilot Program, 14 provided that no person whose income exceeds one hundred fifty 15 percent (150%) of the poverty level shall be eligible for assistance 16 under the Program; and 17 (2)Is not receiving assistance that pays the cost of prescribed medication of the kind covered by the Prescription Drug Assistance Pilot Program, 18 19 under the program of medical assistance established under G.S. 108A-20 54. 21 (f) Assistance received by an individual under the Prescription Drug

21 (f) Assistance received by an individual under the Prescription Drug 22 Assistance Pilot Program shall not be considered in determining the amount of 23 assistance to be paid to the individual under Chapters 108A and 111 of the General 24 Statutes, except where such assistance is required to be considered by federal law or 25 regulations.

(g) An application processing fee not to exceed five dollars (\$5.00) per initial application and each renewal thereafter may be collected from each individual applying for assistance under the Prescription Drug Assistance Pilot Program. Individuals deemed eligible for assistance shall be issued a card identifying the individual as eligible for assistance. Identification cards shall be valid for a period not exceeding two years and may be renewed upon application by the individual and determination that the individual is eligible for assistance.

33 Sec. 3. The Commission for Health Services shall adopt rules necessary to 34 implement this act.

Sec. 4. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources the sum of fifty thousand dollars (\$50,000) for the 1993-94 fiscal year and the sum of fifty thousand dollars (\$50,000) for the 1994-95 fiscal year to be used for administrative costs to implement the Prescription Drug Assistance Pilot Program.

40 Sec. 5. Sections 1 and 3 of this act are effective upon ratification. Section 4 41 of this act becomes effective July 1, 1993. Section 2 of this act becomes effective 42 October 1, 1993.
