G.S. 7A-344 reads as rewritten: 8 Special duties of Director concerning representation of indigent "§ 7A-344. 9 persons. 10 In addition to the duties prescribed in G.S. 7A-343, the Director shall also: Supervise and coordinate the operation of the laws and regulations 11 **(1)** concerning the assignment of legal counsel for indigent persons under 12 Subchapter IX of this Chapter to the end that all indigent persons are 13 adequately represented; 14 Advise and cooperate with the offices of the public defenders as 15 (2) needed to achieve maximum effectiveness in the discharge of the 16 defender's responsibilities; 17 Collect data on the operation of the assigned counsel and the public 18 (3) defender systems, and make such recommendations to the General 19 Assembly for improvement in the operation of these systems as appear 20 to him to be appropriate; and 21

Accept and utilize federal or private funds, as available, to improve defense services for the indigent, including indigent juveniles alleged

to be delinquent or undisciplined. To facilitate processing of juvenile

1	cases and civil cases in which a party is entitled to counsel, the
2	administrative officer is further authorized, in any district or set of
3	districts as defined in G.S. 7A-41.1(a), with the approval of the chief
4	district court judge for cases in the district court division and the
5	approval of the senior resident superior court judge for cases in the
6	superior court division, to engage the services of a particular attorney

Sec. 2. There is appropriated from the General Fund to the Judicial Department, Indigent Persons Attorney Fee Fund, the sum of three million six hundred forty thousand dollars (\$3,640,000) for the 1994-95 fiscal year to implement the provisions of this act.

Sec. 3. This act becomes effective July 1, 1994.
