A BILL TO BE ENTITLED

2 AN ACT TO MODIFY THE REPORTING REQUIREMENT REGARDING 3 INDIVIDUAL SCHOOLS CLOSED DUE TO EMERGENCIES OR OTHER

- 4 UNSAFE CONDITIONS.
- 5 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 115C-84(c) reads as rewritten:

There shall be operated in every school in the State a uniform school term of 7 "(c) 180 days for instructing pupils. The school calendar for each local school 8 administrative unit shall include days that can be used to make up any of the 180 days 9 of the school term on which school is closed due to hazardous weather conditions, 10 natural disaster, or other emergency; the required number of such days for a local school 11 administrative unit shall be the greater of (i) five days or (ii) the average number of days 12 missed in five of the last six school years in which the least number of days were missed. 13 14 If-missed.

15 If a local school administrative unit has made up at least the required number of such days and if the local school board finds that it is impracticable to make up additional 16 days, the local school board may excuse students from attendance at all schools within 17 the unit for three such days; additional days. Regardless of whether the local school 18 administrative unit has made up the required number of days, the local school board 19 may excuse students from attendance at an individual school closed due to emergencies 20 or unsafe conditions for as many days as the local school board deems appropriate. on 21 22 On the days excused for students, the local board may require teachers to report for a workday or it may excuse teachers from attendance on such days. The days excused for 23 teachers under this paragraph do not have to be made up by teachers and do not affect 24

1 teachers' pay. Local boards of education shall report all days excused for students, 2 whether the days were excused for teachers, and the reason they were excused to the 3 State Board of Education. This report shall include as justification for the local board's the total days missed at all schools and any additional days 4 action in the matter (i) 5 missed in individual schools due to emergencies or unsafe conditions, (ii) the date the 6 days were missed, (iii) the reason the days were missed, and the reason therefor, by date, and (iv) the total number of days made up, as justification for the local board's action in the 7 8 matter.-up. After the required number of days have been made up within the school calendar and 9 10 after the local board has exercised its authority to suspend days as set forth in the preceding paragraph, the State Board of Education, at the request of the local board of 11 12 education, may suspend school additional days in any local school administrative unit 13 where it finds that conditions justify such suspension of school. The days excused 14 under this paragraph do not have to be made up by teachers or students and the first 15 15 such days do not affect teachers' pay. 16 During any period of emergency, in any section of the State where the said 17 emergency conditions make it necessary, the State Board of Education may order

18 general, and if necessary, extended recesses or adjournment of the public schools."

Sec. 2. This act is effective upon ratification.
