		ion 1. G.S. 58-78-5(a) reads as rewritten:			
"(a)		Commission shall have the following powers and duties:			
	(1)	To formally adopt a State Fire Education and Training Plan, a State			
		Master Plan for Fire Prevention and Control, a Rescue Training Plan,			
	(2)	and a State Master Plan for Rescue Services;			
	(2)	To assist and participate with State and local fire prevention and			
		control agencies in the improvement of fire prevention and control in			
		North Carolina and to work with State and local rescue agencies to			
	(2)	improve rescue services in the State;			
	(3)	To increase the professional skills of fire protection and fire-fighting personnel and rescue personnel;			
	(4)	To encourage public support for fire prevention and control and rescue			
	(4)	services;			
	(5)	To accept gifts, bequests, devises, grants, matching funds, and other			
	(3)	considerations from private or governmental sources for use in			
		promoting its work;			
	(6)	To make grants for use in pursuing its objectives, under such			

conditions as are deemed to be necessary and such other powers as

2		grants to the State by the United States Fire Administration and the
3		National Fire Academy; and all support programs brought into the
4		State by these two entities shall be coordinated and controlled by the

8		studies and recommendations for the coordination and implementation

10		effective fire prevention and control and rescue services education;
11	(8)	To set objectives and priorities for the improvement of fire prevention
12		and control and rescue services throughout the State;
13	(9)	To advise State and local interests of opportunities for securing federal
14		assistance for fire prevention and control and rescue services and for
15		improving fire prevention and control and rescue services
16		administration and planning within the State of North Carolina;
17	(10)	To assist State agencies and institutions of local government and
18		combinations thereof in the preparation and processing of applications
19		for financial aid and to support fire prevention and control, rescue
20		services, and planning and administration;
21	(11)	To encourage and assist coordination at the federal, State and local
22		government levels in the preparation and implementation of fire
23		prevention and control and rescue services administrative
24		improvements and crime reduction plans;
25	(12)	To apply for, receive, disburse and audit the use of funds received
26		from any public and private agencies and instrumentalities for fire
27		prevention and control and rescue services, their administration and

29	(13)	To enter into monitoring and evaluating the results of contracts and

- (14c) To prepare an annual report to the Governor on its fire prevention and 1 2 control activities and plans, rescue activities and plans, and to 3 recommend legislation concerning fire prevention and control and rescue services: and 4 5 (14d) To reimburse the members of the Commission's certification board, in 6 accordance with G.S. 138-5, for travel and subsistence expenses 7 incurred by them in their duties as certification board officers; and 8 To take such other actions as may be deemed necessary or appropriate (15)9 to carry out its assigned duties and responsibilities." 10
 - Sec. 2. The North Carolina Fire and Rescue Commission is authorized four staff positions to administer fire and rescue certification programs. Of the four positions, three shall be field positions and one shall be clerical. The positions shall be funded by the Department of Insurance Fund and shall become part of the Commission's continuation budget.
 - Sec. 3. This act is effective upon ratification except for Section 2 of this act which becomes effective July 1, 1993.
