A BILL TO BE ENTITLED

1 AN ACT TO RECONFORM THE MILEAGE REIMBURSEMENT FOR OUT-OF-
2 STATE WITNESSES TO THAT RECEIVED BY IN-STATE WITNESSES AND
3 STATE EMPLOYEES.

5 The General Assembly of North Carolina enacts:

6 Section 1. G.S. 7A-314(c) reads as rewritten:

7 "(c) A witness who resides in a state other than North Carolina and who appears for
8 the purpose of testifying in a criminal action and proves his attendance may be
9 compensated at the rate of ~~ten cents (10¢) a mile~~ currently authorized for State employees
10 for one round-trip from his place of residence to the place of appearance, and five dollars
11 (\$5.00) for each day that he is required to travel and attend as a witness, upon order of the
12 court based upon a finding that the person was a necessary witness. If such a witness is
13 required to appear more than one day, he is also entitled to reimbursement for actual
14 expenses incurred for lodging and meals, not to exceed the maximum currently
15 authorized for State employees."

16 Sec. 2. G.S. 15A-813 reads as rewritten:

17 "**§ 15A-813. Witness from another state summoned to testify in this State.**

18 If a person in any state which by its laws has made provision for commanding persons
19 within its borders to attend and testify in criminal prosecutions, or grand jury
20 investigations commenced or about to commence in this State, is a material witness in a

1 prosecution pending in a court of record in this State, or in a grand jury investigation
2 which has commenced or is about to commence, a judge of such court may issue a
3 certificate under the seal of the court, stating these facts and specifying the number of
4 days the witness will be required. Said certificate may include a recommendation that the
5 witness be taken into immediate custody and delivered to an officer of this State to assure
6 his attendance in this State. This certificate shall be presented to a judge of a court of
7 record in the county in which the witness is found.

8 If the witness is summoned to attend and testify in this State he shall be ~~tendered the~~
9 ~~sum of ten cents (10¢) a mile~~ compensated at the rate currently authorized for State
10 employees for each mile by the ordinary traveled route to and from the court where the
11 prosecution is pending, and five dollars (\$5.00) for each day that he is required to travel
12 and attend as a witness. A witness who has appeared in accordance with the provisions
13 of the summons shall not be required to remain within this State a longer period of time
14 than the period mentioned in the certificate unless otherwise ordered by the court. If such
15 a witness is required to appear more than one day, he is also entitled to reimbursement for
16 actual expenses incurred for lodging and meals, not to exceed the maximum currently
17 authorized for State employees when traveling in the State. If such witness, after coming
18 into this State, fails without good cause to attend and testify as directed in the summons,
19 he shall be punished in the manner provided for the punishment of any witness who
20 disobeys a summons issued from a court of record in this State."

21 Sec. 3. This act is effective upon ratification, and applies to all out-of-state
22 witness travel expenses incurred on or after that date.
