3	The General Assembly of North Carolina enacts:
4	Section 1. Chapter 143 of the General Statutes is amended by adding a new
5	Article to read:

7	"NORTH CAROLINA STATE BOXING COMMISSION.
8	"§ 143-650. Legislative findings and declarations.
9	The General Assembly finds and declares to be the public policy of this State that it is
10	in the best interest of the public and of boxing that boxing should be subject to an
11	effective and efficient system of strict control and regulation in order to:
12	(1) Protect the safety and well-being of participants in boxing; and
13	(2) Promote the public confidence and trust in the regulatory process and
14	the conduct of boxing.

2	(a) Creat	ion. – The North Carolina State Boxing Commission is created within the
3	Department of	the Secretary of State to regulate live boxing matches, whether
4	-	amateur, in North Carolina. The Commission shall consist of five voting
5	<u> </u>	two advisory members. All the members shall be residents of North
6		nembers shall be appointed as follows:
7	(1)	One voting member shall be appointed by the Governor for an initial
8	/	term of two years.
9	<u>(2)</u>	One voting member shall be appointed by the General Assembly upon
10		the recommendation of the President Pro Tempore of the Senate for an
11		initial term of one year, in accordance with G.S. 120-121.
12	<u>(3)</u>	One voting member shall be appointed by the General Assembly upon
13		the recommendation of the Speaker of the House of Representatives for
14		an initial term of one year.

4	(c) Meetings. – Meetings of the Commission shall be called by the chair or by any
5	two members of the Commission, and meetings shall be held at least quarterly. Any
6	three members of the Commission shall constitute a quorum at any meeting. Action may
7	be taken and motions and resolutions adopted by the Commission at any meeting by the
8	affirmative vote of a majority of the members of the Commission present at a meeting at
9	which a quorum exists. Any or all members may participate in a regular or special
10	meeting by, or conduct the meeting through the use of, any means of communication by
11	which all members participating may simultaneously hear each other during the meeting.
12	A member participating in the meeting by this means is deemed to be present in person at
13	the meeting.
14	(d) Rule-Making Authority of the Commission. – The Commission shall have the
15	exclusive authority to issue rules for the regulation of the conduct, promotion, and
16	performances of live boxing matches and exhibitions in this State. The rules shall be
17	issued pursuant to the provisions of Chapter 150B of the General Statutes and may
18	include, without limitation, the following subjects:
19	(1) <u>Requirements for issuance of licenses and permits required by this</u>
20	Article.
21	(2) <u>Regulation of ticket sales.</u>
22	(3) <u>Physical requirements for contestants, including classification by weight</u>
23	and skill.
24	(4) <u>Supervision of matches and exhibitions by licensed physicians and</u>
25	referees.
26	(5) Insurance and bonding requirements.
27	(6) <u>Compensation of participants and licensees.</u>
28	(7) <u>Contracts and financial arrangements.</u>
29 20	(8) <u>Prohibition of dishonest, unethical, and injurious practices.</u>

31 32	(e) <u>Compensation. – None of the members of the Commission shall receive</u> compensation for serving on the Commission. However, members of the Commission
32 33	may be reimbursed for their expenses in accordance with the provisions of Chapter 138
34	of the General Statutes.
35	(f) Executive Director and Other Staff. – The Secretary of State shall appoint an
36	executive director for the State Boxing Commission chosen from a list of nominees
37	submitted to the Secretary by the Commission. The executive director shall be
38	responsible to and serve at the pleasure of the Secretary of State. The executive director
39	shall perform any duties described in the administrative rules adopted by the
40	Commission. The Secretary of State shall provide such staff assistance as the
41	Commission may require. Commission expenses, including salaries for the executive
42	director, other staff members, and administrative expenses, shall be funded from monies
43	collected pursuant to the provisions of this Article.

1	" <u>§ 143-653. Ultimate warrior matches prohibited.</u>
2	Ultimate warrior matches, whether the participants are professionals or amateurs, are
3	prohibited. No person shall promote, conduct, or engage in ultimate warrior matches.
4	This section shall not preclude boxing and kickboxing as regulated in this Article or
5	professional wrestling.
6	"§ 143-654. Licensing and permitting.
7	(a) License and Permit Required. – It is unlawful for any person to act in this
8	State as an announcer, contestant, judge, manager, matchmaker, promoter, referee,
9	timekeeper, or second unless the person is licensed to do so under this Article. It is
10	unlawful for a promoter to present a match in this State unless the promoter has a permit
11	issued under this Article to do so. The Commission has the exclusive authority to issue,
12	deny, suspend, or revoke any license or permit provided for in this Article.
13	(b) License. – A license issued under this Article must be renewed annually on or
14	before January 1. A license for an announcer, contestant, judge, matchmaker, referee,
15	timekeeper, or second shall be issued only to a natural person. A natural person shall not
16	transfer or assign a license or change it into another name. A license for a manager or
17	promoter may be issued to a corporation or partnership; provided, however, that all
18	officers or partners shall submit an application for individual licensure, and only those
19	officers or partners who are licensed shall be entitled to negotiate or sign contracts. The
20	addition of a new officer or partner during the license period shall necessitate the filing of
21	an application for individual licensure by the new officer or partner.
22	An applicant for a license shall file with the Commission the appropriate
23	nonrefundable fee and any forms, documents, medical examinations, or exhibits the
24	Commission may require in order to properly administer this Article. The information
25	requested shall include the date of birth and social security number of each applicant as
26	well as any other personal data necessary to positively identify the applicant and may
27	include the requirement of verification of any documents the Commission deems
28	appropriate. A person may not participate under a fictitious or assumed name in any
29	match unless the person has first registered the name with the Commission.
30	(c) Surety Bond. – An applicant for a promoter's license must submit, in addition
31	to any other forms, documents, or exhibits, a surety bond in an amount to be no less than
32	five thousand dollars (\$5,000). The amount of the surety bond shall be negotiable upon
33	the sole discretion of the Commission or executive director. All surety bonds shall be
34	upon forms approved by the Secretary of State and supplied by the Commission.
35	(d) <u>Permit. – A permit issued to a promoter under this Article is valid for a single</u>
36	match. An applicant for a permit shall file with the Commission the appropriate
37	nonrefundable fee and any forms or documents the Commission may require.
38	" <u>§ 143-655. Fees; State Boxing Commission Revenue Account.</u>
39	(a) <u>License Fees. – The Commission shall collect the following license fees:</u>

6	The annual license renewal fees shall not exceed the initial license fees.
7	(b) <u>Permit Fees. – The Commission may establish a fee schedule for permits</u>
8	issued under this Article. The fees may vary depending on the seating capacity of the
9	facility to be used to present a match. The fee may not exceed the following amounts:
10	Seating Capacity Fee Amount
11	Less than 2,000 \$100.00
12	<u>2,000 - 5,000</u> <u>\$200.00</u>
13	<u>Over 5,000</u> <u>\$300.00.</u>
14	(c) State Boxing Commission Revenue Account There is created the State
15	Boxing Commission Revenue Account within the Department of the Secretary of State.
16	Monies collected pursuant to the provisions of this Article shall be credited to the
17	Account and applied to the administration of the Article.
18	" <u>§ 143-656. Contracts and financial arrangements.</u>
19	Any contract between a boxer and any other licensee and any contract involving a
20	boxing match or exhibition held or to be held in this State must meet the requirements of
21	administrative rules as set forth by the Commission. Any contract which does not satisfy
22	the requirements of the administrative rules shall be void and unenforceable. All
23	contracts shall be in writing.
24	" <u>§ 143-657. Kickboxing.</u>
25	In addition to the other applicable provisions of this Article, a kickboxing match shall
26	be conducted pursuant to the rules and regulations in effect for the Professional Karate
27	Association, the International Sport Karate Association, or for any other professional
28	organizations approved by the Commission.
29	" <u>§ 143-658. Violations.</u>
30	(a) <u>Civil Penalties. – The Commission may issue an order against a licensee or</u>
31	other person who willfully violates any provision of this Article, imposing a civil penalty
32	of up to five thousand dollars (\$5,000) for a single violation or of up to twenty-five
33	thousand dollars (\$25,000) for multiple violations in a single proceeding or a series of
34	related proceedings. No order under this subsection may be entered without prior notice
35	and an opportunity for a contested case hearing conducted pursuant to Article 3 of
36	Chapter 150B of the General Statutes.
37	(b) Criminal Penalties. – A willful violation of any provision of this Article shall
38	constitute a Class 2 misdemeanor. The Secretary of State may refer any available
39	evidence concerning violations of this Article to the proper district attorney, who may,
40	with or without such a reference, institute the appropriate criminal proceedings.
41	The attorneys employed by the Secretary of State shall be available to prosecute or
42	assist in the prosecution of criminal cases when requested to do so by a district attorney
43	and the Secretary of State approves.

1	(c) Injunction. – Whenever it appears to the Commission that a person has
2	engaged or is about to engage in an act or practice constituting a violation of any
3	provision of this Article or any rule or order hereunder, the Commission may in its
4	discretion bring an action in any court of competent jurisdiction to enjoin those acts or
5	practices and to enforce compliance with this Article or any rule or order issued pursuant
6	to this Article.
7	(d) Enforcement. – For purposes of enforcing this Article, the Department of the
8	Secretary of State's law enforcement agents have statewide jurisdiction. These law
9	enforcement agents may assist local law enforcement agencies in their investigations and
10	may initiate and carry out, in coordination with local law enforcement agencies,
11	investigations of violations of this Article. These law enforcement agents have all the
12	powers and authority of law enforcement officers when executing arrest warrants."
