A BILL TO BE ENTITLED
AN ACT TO PROVIDE FOR THE REGISTRATION OF ESTHETICIANS AND
ESTHETICIAN APPRENTICES BY THE STATE BOARD OF COSMETIC ART
EXAMINERS.

The General Assembly of North Carolina enacts:

Section 1. Chapter 88 of the General Statutes is amended by adding a new section to read:

"§ 88-6.1. Esthetician.

(a) 'Esthetician' is any person other than a registered cosmetologist, registered apprentice, or esthetician apprentice, who practices esthetics.

(b) 'Esthetics' means providing services, for compensation, to enhance the appearance of the face, neck, arms, legs, or shoulders of an individual through skin care, makeup artistry, facials, or body waxing.

(c) 'Esthetician apprentice' is any person who is registered by the State Board of Cosmetic Art Examiners to learn the practice of esthetics under the direction and supervision of a registered cosmetologist or a registered esthetician as provided in G.S. 88-12.2. An applicant for this registration shall pay the fees required under G.S. 88-21."

Sec. 2. Chapter 88 of the General Statutes is amended by adding the following new sections to read:

1 **"§ 88-12.2. Supervision of a registered esthetician apprentice.**

2 (a) A registered esthetician apprentice shall be directly supervised and trained by a
3 registered cosmetologist or a registered esthetician with two years of experience.

4 (b) The registered cosmetologist or the registered esthetician who supervises an
5 esthetician apprentice pursuant to subsection (a) of this section shall:

6 (1) Ensure that the esthetician apprentice receives the theory and practical
7 training prescribed by the Board.

8 (2) File a monthly report, on a form prescribed by the Board, stating the
9 progress of each esthetician apprentice under his or her supervision and
10 identifying the registered cosmetologist or the registered esthetician
11 who provides direct supervision of each esthetician apprentice.

12 (3) Advise the Board immediately upon an esthetician apprentice
13 discontinuing his or her apprenticeship.

14 (4) Ensure that the esthetician apprentice performs esthetic services only
15 under the supervision of a registered cosmetologist or a registered
16 esthetician.

17 **"§ 88-12.3. Qualifications for registered esthetician.**

18 (a) A certificate of registration as a registered esthetician shall be issued by the
19 State Board of Cosmetic Art Examiners to any person who satisfies all of the following
20 qualifications:

21 (1) Successful completion of at least 550 hours in courses in an appropriate
22 program taught in a cosmetic art school or college, which courses and
23 schools are approved by the Board.

24 (2) Successful completion of at least 30 hours per week for at least 12
25 months of an apprenticeship as a registered esthetician apprentice
26 pursuant to G.S. 88-12.2.

27 (3) Successful completion of an examination conducted by the Board to
28 determine the applicant's fitness and skill to practice esthetics, as
29 defined in G.S. 88-6.1.

30 (4) Payment of fees required by G.S. 88-21.

31 (b) The Board shall adopt rules that establish an appropriate program of study for
32 estheticians, including a curriculum that addresses sanitation management and equipment
33 requirements.

34 (c) A person who has five years of experience as of January 1, 1996, in the
35 practice of esthetics may, upon submitting evidence of this experience to the Board and
36 upon the Board accepting this experience as sufficient, obtain a certificate of registration
37 without satisfying subdivisions (1) through (3) of subsection (a) of this section. An
38 application for licensure under this subsection must be submitted to the Board by January
39 1, 1997.

40 (d) Any person who is certified, registered, or licensed as an esthetician in another
41 state that has a reciprocity agreement with the State Board of Cosmetic Art Examiners
42 may be issued a certificate of registration by the Board without satisfying subdivisions

1 (1) through (3) of subsection (a) of this section if that person meets all of the following
2 requirements:

- 3 (1) Has at least two years of experience in the practice of esthetics.
4 (2) Submits a certification, registration, or license from the other state that
5 is in effect within six months of making application for a registration
6 under this Chapter.

7 (e) A certificate of registration as a registered esthetician must be renewed
8 annually."

9 Sec. 3. G.S. 88-21 reads as rewritten:

10 "**§ 88-21. Fees required.**

11 (a) The following fees shall be paid to the Board:

- 12 (1) The fee to be paid by an applicant for a certificate of registration to
13 practice cosmetic art as an apprentice and to practice esthetics as an
14 esthetician apprentice shall be five dollars (\$5.00).
15 (2) The fee to be paid by an applicant for an examination to determine his
16 or her fitness to receive a certificate of registration as a registered
17 cosmetologist who does not intend to practice esthetics shall be ten
18 dollars (\$10.00).
19 (2a) The fee to be paid by an applicant for an examination to determine his
20 or her fitness to receive a certificate of registration as a registered
21 cosmetologist who intends to practice esthetics or as an esthetician shall
22 be twenty dollars (\$20.00).
23 (3) The fee to be paid by an applicant for an examination to determine his
24 or her fitness to receive a certificate of registration as a registered
25 manicurist shall be five dollars (\$5.00).
26 (4) The license fee for a registered cosmetologist shall be thirty-three
27 dollars (~~\$33.00~~ (\$33.00) for three years, payable in advance.
28 (5) The fee for renewal of the license of a registered cosmetologist shall be
29 thirty-three dollars (\$33.00) for three years, payable in advance, if the
30 license is renewed before it becomes delinquent. The licenses of all
31 registered cosmetologists shall be due for renewal in October 1986, and
32 every three years thereafter.
33 (6) A delinquency penalty of ten dollars (\$10.00) shall be paid, in addition
34 to the renewal fee, for the renewal of a registered cosmetologist's license
35 that has become delinquent.
36 (7) The annual fee for a registered ~~apprentice~~ apprentice, registered
37 esthetician apprentice, or certified manicurist, which shall be due on or
38 before October 1, shall be five dollars (\$5.00).
39 (8) All cosmetic art shops shall pay an annual fee of three dollars (\$3.00)
40 for each active booth, on or before February 1 of each year.
41 (9) A delinquency penalty of ten dollars (\$10.00) shall be paid by each
42 cosmetic art shop that does not pay the required fees by the February 1
43 deadline.

- 1 (10) The fee for reissuance of an expired permit of a cosmetic art shop shall
2 be twenty-five dollars (\$25.00).
- 3 (11) All cosmetic art schools shall pay a fee of fifty dollars (\$50.00)
4 annually.
- 5 (12) Applicants for licensing under G.S. 88-19 shall pay an application fee of
6 fifteen dollars (\$15.00).
- 7 (13) Registered cosmetologists licensed under G.S. 88-19 shall pay an
8 annual license fee of eleven dollars (\$11.00) until the year in which all
9 other registered cosmetologist licenses are due for renewal and then
10 shall pay the fees required in subdivision (5) above.
- 11 (14) A delinquency penalty of three dollars (\$3.00) shall be paid by all
12 registered cosmetologists licensed under G.S. 88-19, paying on an
13 annual basis if they do not renew their license before October 1 of that
14 year.
- 15 (15) Apprentice cosmetologists, licensed under G.S. 88-19, shall pay an
16 annual license fee of five dollars (\$5.00) for the first year, or part of the
17 year, in addition to the application fee required by subdivision (12)
18 above.
- 19 (16) All cosmetic art teachers shall be licensed by the Board and shall pay a
20 fee of ten dollars (\$10.00) for that license which shall be renewed every
21 two years.
- 22 (17) The fee to be paid for the issuance of a certificate of registration to
23 practice esthetics as an esthetician shall be thirty dollars (\$30.00).
- 24 (18) The annual fee for a registered esthetician shall be thirty dollars
25 (\$30.00).
- 26 (b) The Board shall not increase the fees set in subsection (a) of this section, but
27 the Board may regulate the payment of the fees and may prorate the fees as appropriate."
- 28 Sec. 4. All persons practicing esthetics and all esthetician apprentices in this
29 State must be registered pursuant to the provisions of G.S. 88-12.3 and G.S. 88-12.2
30 respectively within one year of the effective date of this section.
- 31 Sec. 5. This act is effective upon ratification.
