April 12, 1995 A BILL TO BE ENTITLED AN ACT TO REPEAL THE BASIC EDUCATION PROGRAM AND THE OUTCOME-BASED EDUCATION PROGRAM AND REPLACE THEM WITH THE REAL EDUCATION PROGRAM. The General Assembly of North Carolina enacts: —-REPEAL OF BASIC EDUCATION PROGRAM Section 1. G.S. 115C-81 and G.S. 115C-81.1 are repealed. —-REPEAL OF OUTCOME-BASED EDUCATION PROGRAM Sec. 2. Part 5 of Article 16 of Chapter 115C of the General Statutes is repealed. —-ESTABLISHMENT OF REAL EDUCATION PROGRAM Sec. 3. Chapter 115C of the General Statutes is amended by adding a new section to read: "§ 115C-81.2. Real education program – findings; establishment of program. The General Assembly finds that: Teachers should engage children in the process of teaching and learning (1) rather than just telling children what to do: Parents should have the opportunity of participating in character-(2) centered learning environments and community experiences with their

1		children. Public school environments should be characterized by
2		attention to positive growth and emotional, intellectual, social, and
3		physical development of students. Through partnership with families,
4		an atmosphere should be fostered wherein the young child is eager to
5		learn. Faculty and staff shall prepare students who are confident and
6		ready to assume civic roles and responsibilities in a multifaceted
7		changing society and world community;
8	<u>(3)</u>	All subjects should be taught in the light of American values. Parents
9		are the primary educators of their children; therefore, teachers must
10		work closely with them in both the school context; and
11	<u>(4)</u>	Students reach their individual potential by thinking clearly, forming
12		strong convictions, and acting in ways consonant with their beliefs for
13		the betterment of their own lives and society as a whole;
14	therefore, the Re	eal Education Program is established. The Real Education Program sets
15	out, within curri	culum areas, the goals with concrete and specific skills developments and
16	the measurable	accomplishments that are appropriate for students at each grade level.
17	The Real Educ	eation Program also provides specific guidelines for teachers within
18	curriculum areas	s to construct teaching/learning activities for students."
