2	AN ACT TO REQUIRE PARENTAL CONSENT FOR SERVICES PROVIDED AT
3	SCHOOL-BASED HEALTH CLINICS AND TO LIMIT THE SCOPE OF THE
4	SERVICES PROVIDED.
5	The General Assembly of North Carolina enacts:
6	Section 1. G.S. 115C-47 is amended by adding a new subdivision to read:
7	"(38) To Adopt Rules Concerning the Operation of School-Based Health
8	Clinics As used in this subdivision, 'school-based health clinic'
9	means any arrangement made for the provision of medical or health
10	services in or by a school for students enrolled in that school,
11	regardless of the source of funds for the services, except for services
12	provided in accordance with G.S. 115C-307(c).
13	Local boards of education shall adopt rules concerning the operation
14	of school-based health clinics. These rules shall apply to all school-
15	based health clinics after August 15, 1995. These rules shall provide
16	that school personnel shall not provide any health or medical care to
17	students under the age of 18, except as provided in G.S. 115C-307(c),
18	without the written consent of the students' parents or guardians. The
19	parents or guardians shall be provided a complete written explanation of

1	the scope of services offered by the school-based health clinic and the
2	parental consent options prior to their completion of the consent form.
3	The signatures of parents or guardians on the consent form shall be
4	verified by the school. The consent form shall offer the parent or
5	guardian of a student the following options:
6	a. <u>The clinic may provide services, refer the student to another</u>
7	organization or agency for services, or transport the student to
8	another organization or agency for services, as deemed
9	necessary, without further parental consent or notification;
10	b. Notwithstanding any other provision of law, the clinic shall
11	notify the parent or guardian within five days of the clinic (i)
12	providing services to the student of the services and of any
13	physical or psychological problems identified and of any
14	treatment prescribed, (ii) referring the student to another
15	organization or agency for services, or (iii) transporting the
16	student to another organization or agency for services; or
17	c. Notwithstanding any other provision of law, the clinic shall
18	notify and obtain the consent of the parent or guardian each time
19	services are requested or deemed necessary, prior to providing
20	any services to the student and prior to referring or transporting
21	the student to another organization or agency for services.
22	Notwithstanding any other provision of law, the clinic shall also
23	notify the parent or guardian of any physical or psychological
24	problems identified and any treatment prescribed for the student.
25	The consent form shall be maintained in each student's record at the
26	clinic, and the clinic staff shall review the form prior to offering any
27	service to the student. The consent form shall remain in effect as long
28	as the student is enrolled at the school unless it is revoked or modified
29	in writing by the parent or guardian.
30	The rules shall also require the school-based clinic to notify the
31	parents or guardians of students 30 days prior to expanding the scope of
32	services offered by the clinic and to give the parents or guardians an
33	opportunity to modify the consent forms for their children.
34	The rules shall also provide that school-based health clinics shall not
35	provide any services related to contraception, prenatal care, abortion,
36	abortion counseling, or any other reproductive services, and that the
37	clinics shall not refer a student or transport a student to any other
38	organization or agency providing these services without the written
39	consent of the parent or guardian of the student as provided in this
40	subdivision."
41	Sec. 2. G.S. 90-21.5(a) reads as rewritten:
42	"(a) Any minor may give effective consent to a physician licensed to practice

treatment of (i) venereal disease and other diseases reportable under G.S. 130A-135, (ii) 1 2 pregnancy, (iii) abuse of controlled substances or alcohol, and (iv) emotional disturbance. 3 This section does not authorize the inducing of an abortion, performance of a sterilization 4 operation, or admission to a 24-hour facility licensed under Article 2 of Chapter 122C of 5 the General Statutes except as provided in G.S. 122C-222. This section does not prohibit 6 the admission of a minor to a treatment facility upon his own written application in an emergency situation as authorized by G.S. 122C-222. This section does not apply to 7 8 services provided at a school-based health clinic in a public school or to services for 9 which a minor is referred by a school-based health clinic in a public school, if the parent or guardian of the minor has requested the right to give prior consent for those services." 10 Sec. 3. This act becomes effective July 1, 1995. 11
