4	FILING DATE FOR MEMBERS OF THE ROCKINGHAM COUNTY
5	CONSOLIDATED BOARD OF EDUCATION.
6	The General Assembly of North Carolina enacts:
7	Section 1. G.S. 153A-158.1 reads as rewritten:
8	"§ 153A-158.1. Acquisition and improvement of school property in certain counties.
9	(a) Acquisition by County. – A county may acquire, by any lawful method, any
10	interest in real or personal property for use by a school administrative unit within the
11	county. In exercising the power of eminent domain a county shall use the procedures of
12	Chapter 40A. The county shall use its authority under this subsection to acquire property
13	for use by a school administrative unit within the county only upon the request of the
14	board of education of that school administrative unit and after a public hearing.
15	(b) Construction or Improvement by County. – A county may construct, equip,
16	expand, improve, renovate, or otherwise make available property for use by a school
17	administrative unit within the county. The local board of education shall be involved in
18	the design, construction, equipping, expansion, improvement, or renovation of the

19 property to the same extent as if the local board owned the property.

1 (c) Lease or Sale by Board of Education. – Notwithstanding the provisions of G.S. 2 115C-518 and G.S. 160A-274, a local board of education may, in connection with 3 additions, improvements, renovations, or repairs to all or part of any of its property, lease 4 or sell the property to the board of commissioners of the county in which the property is 5 located for any price negotiated between the two boards.

6 (d) Board of Education May Contract for Construction. – Notwithstanding the 7 provisions of G.S. 115C-40 and G.S. 115C-521, a local board of education may enter into 8 contracts for the erection or repair of school buildings upon sites owned in fee simple by 9 one or more counties in which the local school administrative unit is located.

(e) Scope. – This section applies to Alleghany, Ashe, Avery, Bladen, Brunswick,
Cabarrus, Carteret, Chowan, Columbus, Currituck, Duplin, Edgecombe, Forsyth,
Franklin, Greene, Halifax, Harnett, Haywood, Iredell, Jackson, Johnston, Lee, Macon,
Madison, Moore, Nash, Orange, Pasquotank, Pender, Randolph, Richmond, <u>Rockingham</u>,
Rowan, Sampson, Scotland, Stanly, Union, Wake, and Watauga Counties."

15 Sec. 2. The filing date for candidates for the Rockingham County 16 Consolidated Board of Education is the same as for municipal nonpartisan elections as 17 referenced in G.S. 163-294.2(c).

18 Sec. 3. This act is effective upon ratification.
