A BILL TO BE ENTITLED

AN ACT TO DIVIDE NORTH CAROLINA INTO TWELVE CONGRESSIONAL DISTRICTS.

The General Assembly of North Carolina enacts:

Section 1. That part of Section 1 of Chapter 6 of the Session Laws of the 1991 Extra Session which rewrote G.S. 163-201(a) is repealed.

Section 2. G.S. 163-201(a) reads as rewritten:

"(a) For the purpose of nominating and electing members of the House of Representatives of the Congress of the United States in ~~1982-1998~~ and every two years thereafter, the State of North Carolina shall be divided into ~~11~~ 12 districts as follows:
