6	The General Assembly of North Carolina enacts:
7	Section 1. G.S. 20-81.12 is amended by adding a new subsection to read:
8	"(b5) Scenic Rivers Plates. – The Division shall receive 300 or more applications for
9	a scenic rivers plate with the words 'Scenic Rivers' and a picture representing the unique
10	beauty of the scenic rivers of North Carolina before the plate may be developed. The
11	Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
12	Account derived from the sale of scenic rivers plates to the Clean Water Management
13	Trust Fund established by Article 13A of Chapter 113 of the General Statutes."
14	Section 2. G.S. 20-79.4(a) reads as rewritten:
15	"(a) Fees. – Upon request, the Division shall provide and issue free of charge one
16	registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
17	veteran, and an ex-prisoner of war. All other special registration plates are subject to the
18	regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee

Distribution of Fees. - The Special Registration Plate Account and the 12 "(b) Collegiate and Cultural Attraction Plate Account are established within the Highway 13 Fund. The Division must credit the additional fee imposed for the special registration 14 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the 15 Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage 16 Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows: 17
