A BILL TO BE ENTITLED

AN ACT TO REQUIRE A ONE-YEAR SUSPENSION FOR ANY STUDENT WHO BRINGS OR POSSESSES A FIREARM OR EXPLOSIVE ON EDUCATIONAL PROPERTY OR AT A SCHOOL-SPONSORED CURRICULAR OR EXTRACURRICULAR ACTIVITY OFF EDUCATIONAL PROPERTY AND TO MAKE OTHER CONFORMING CHANGES.

The General Assembly of North Carolina enacts:

- Section 1. If House Bill 517, 1999 Regular Session, becomes law, then effective September 1, 1999, G.S. 115C-391(d1) reads as rewritten:
- "(d1) A local board of education or superintendent shall suspend for 365 calendar days any student who brings-who:
  - (1) Brings onto educational property or to a school-sponsored curricular or extracurricular activity off educational property, or
  - (2) Possesses on educational property or at a school-sponsored curricular or extracurricular activity off educational property,
- a weapon, as defined in G.S. 14-269.2(b), 14-269.2(b1), and 14-269.2(g), onto educational property.—14-269.2(g). The local board of education upon recommendation by the superintendent may modify this suspension requirement on a case-by-case basis that

includes, but is not limited to, the procedures established for the discipline of students with disabilities and may also provide, or contract for the provision of, educational services to any student suspended pursuant to this subsection in an alternative school setting or in another setting that provides educational and other services."

Section 2. Effective December 1, 1999, G.S. 115C-391(d1), as rewritten by Section 1 of this act, reads as rewritten:

"(d3) A local board of education shall suspend for 365 calendar days any student who, by any means of communication to any person or group of persons, makes a report, knowing or having reason to know the report is false, that there is located on educational property or at a school-sponsored curricular or extracurricular activity off educational property any device designed to destroy or damage property by explosion, blasting, or burning, or who, with intent to perpetrate a hoax, conceals, places, or displays any device, machine, instrument, or artifact on educational property or at a school-related-schoolsponsored curricular or extracurricular activity on or off educational property, so as to cause any person reasonably to believe the same to be a bomb or other device capable of causing injury to persons or property. The local board upon recommendation by the superintendent may modify either suspension requirement on a case-by-case basis that includes, but is not limited to, the procedures established for the discipline of students with disabilities and may also provide, or contract for the provision of, educational services to any student suspended under this subsection in an alternative school setting or in another setting that provides educational and other services. For purposes of this subsection and subsection (d1) of this section, the term 'educational property' has the same definition as in G.S. 14-269.2(a)(1)."
