A BILL TO BE ENTITLED

1 AN ACT TO INCREASE THE NUMBER OF PAID MEMBERS A FIRE  
2 DEPARTMENT MAY HAVE AND REMAIN ELIGIBLE TO RECEIVE GRANTS  
3 FROM THE VOLUNTEER FIRE DEPARTMENT FUND AND TO INCREASE  
4 THE NUMBER OF PAID MEMBERS A RESCUE OR RESCUE/EMS UNIT MAY  
5 HAVE AND REMAIN ELIGIBLE TO RECEIVE GRANTS FROM THE  
6 VOLUNTEER RESCUE/EMS FUND.

8 The General Assembly of North Carolina enacts:

9 Section 1. G.S. 58-87-1(b) reads as rewritten:

10 "(b) A fire department is eligible for a grant under this section if it meets all of the  
11 following conditions:

12 (1) It serves a response area of 6,000 or less in population.

13 (2) ~~It has no more than two paid members and otherwise consists of volunteer~~  
14 ~~members.~~ It consists entirely of volunteer members, with the exception  
15 that the unit may have paid members to fill the equivalent of three full-  
16 time paid positions.

17 (3) It has been certified by the Department of Insurance.

1 In making the population determination under subdivision (1), the Department shall use  
2 the most recent annual population estimates certified by the State Planning Officer."

3 Section 2. G.S. 58-87-5(b) reads as rewritten:

4 "(b) A rescue or rescue/EMS unit is eligible for a grant under this section if it meets  
5 all of the following conditions:

6 (1) Repealed by Session Laws 1989 (Regular Session, 1990), c. 1066, s.  
7 33(a).

8 (2) ~~It has no more than two paid members and otherwise consists of volunteer~~  
9 ~~members. It consists entirely of volunteer members, with the exception~~  
10 ~~that the unit may have paid members to fill the equivalent of three full-~~  
11 ~~time paid positions.~~

12 (3) It has been recognized by the Department as an organization that  
13 provides rescue or rescue and emergency medical services.

14 (4) It satisfies the eligibility criteria established by the Department under  
15 subsection (a) of this section."

16 Section 3. This act becomes effective October 1, 1999.
