3	ISSUE BEER AND WINE SHIPPERS PERMITS TO ALLOW THE DIRECT
4	SHIPMENT OF MALT BEVERAGES AND WINES TO RESIDENTS OF NORTH
5	CAROLINA.
6	The General Assembly of North Carolina enacts:
7	SECTION 1. G.S. 18B-902(d) reads as rewritten:
8	"(d) Fees. – An application for an ABC permit shall be accompanied by payment
9	of the following application fee:

1	SECTION 3. Chapter 18B of the General Statutes is amended by adding a
2	new section to read:
2 3	" <u>§ 18B-1114.3. Authorization of malt beverage shipper permit.</u>
3 4	
	(a) Holders of malt beverage shipper permits may sell and ship not more than
5	two cases of malt beverage per month to any person in North Carolina to whom
6 7	alcoholic beverages may be lawfully sold. All sales and shipments shall be for personal
	consumption only and not for resale. A case of malt beverages shall mean any
8 9	combination of packages containing not more than 288 ounces of malt beverage. Any brewery located within or outside the State may apply to the Commission for issuance
9 10	of a malt beverage shipper permit that shall authorize the shipment of brands of malt
11	beverages identified in the application. Any person located within or without the State
12	who is authorized to sell malt beverages at retail in their state of domicile and who is
13	not a brewery may nevertheless apply for a malt beverage shipper permit. Any brewery
14	that applies for a malt beverage shipper permit or authorizes any other person, other
15	than a retail off-premises permittee, to apply for a permit to ship the brewery's brands of
16	malt beverage shall notify any wholesale permittees that have been authorized to
17	distribute those brands within this State that an application has been filed for a malt
18	beverage shipper permit. The notice shall be given in writing and in a form prescribed
19	by the Commission. The Commission may adopt rules necessary to implement the
20	provisions of this section, including rules to allow the malt beverage shipper permittee
21	to amend the brands of malt beverages identified in the permit application.
22	(b) Any applicant for a malt beverage shipper permit that does not own or have
23	the right to control the distribution of the brands of malt beverage identified in the
24	permit application may be issued the permit if the applicant obtains the written consent
25	of the brewery whose brands of malt beverage are contained in the application. Any
26	retail off-premises malt beverage permittee who purchases malt beverages from anyone
27	authorized to sell malt beverages in North Carolina shall be presumed to have the
28	authorization of the winery or supplier to ship its brands. Any brewery that has supplied
29	written authorization to a malt beverage shipper permittee to sell and ship its brands of
30	malt beverage shall not be restricted by any provision of this section from withdrawing
31	the authorization at any time. If the authorization is withdrawn, the brewery shall
32	promptly notify the Commission of its decision to withdraw from the malt beverage
33	shipper permittee the authority to sell and ship any of its brands, and the permittee shall
34	promptly file with the Commission an amendment to its permit application eliminating
35	the withdrawn brand or brands.
36	(c) The direct shipment of malt beverages by malt beverage shipper permittees
37	made pursuant to this section shall be by approved common carrier only. The
38	Commission shall adopt rules under which common carriers may apply for approval to
39	provide common carriage of malt beverages shipped by holders of permits issued
40	pursuant to this section. These rules shall include provisions that require:
41	(1) The recipient to demonstrate, upon delivery, that he is at least 21 years
42	<u>of age.</u>
43	(2) The recipient to sign an electronic or paper form or other
44	acknowledgment of receipt as approved by the Commission.

1	(3) The Commission-approved common carrier to submit any information
2	that the Commission may require.
3	The Commission-approved common carrier shall refuse delivery when the proposed
4	recipient appears to be under the age of 21 years and refuses to present valid
5	identification. All malt beverage shipper permittees shipping malt beverages pursuant to
6	this section shall affix a notice in 16-point type or larger to the outside of each package
7	of malt beverage shipped within or to the State in a conspicuous location stating:
8	<u>'CONTAINS ALCOHOLIC BEVERAGES; SIGNATURE OF PERSON AGED 21</u>
9	YEARS OR OLDER REQUIRED FOR DELIVERY'. Any delivery of malt beverages
10	to a minor by a common carrier shall constitute a violation by the common carrier. The
11	common carrier and the malt beverage shipper permittee shall be liable only for their
12	independent acts.
13	(d) For purposes of Chapter 105 of the General Statutes, each shipment of malt
14	beverages by a malt beverage shipper permittee shall constitute a sale in North Carolina.
15	The permittee shall collect the taxes due to the State and remit any excise taxes or any
16	sales taxes to the Department of Revenue."
17	SECTION 4. Chapter 18B of the General Statutes is amended by adding a
18	new section to read:
19	" <u>§ 18B-1114.4. Authorization of wine shipper permit.</u>
20	(a) Holders of wine shipper permits may sell and ship not more than two cases of
21	wine per month to any person in North Carolina to whom alcoholic beverages may be
22	lawfully sold. All sales and shipments shall be for personal consumption only and not
23	for resale. A case of wine shall mean any combination of packages containing not more
24	than nine liters of wine. Any winery located within or outside the State may apply to the
25	Commission for issuance of a wine shipper permit that shall authorize the shipment of
26	brands of wines identified in the application. Any person located within or without the
27	State who is authorized to sell wines at retail in their state of domicile and who is not a
28	winery may nevertheless apply for a wine shipper permit. Any winery that applies for a
29	wine shipper permit or authorizes any other person, other than a retail off-premises
30	permittee, to apply for a permit to ship the winery's brands of wine shall notify any
31	wholesale permittees that have been authorized to distribute those brands within this
32	State that an application has been filed for a wine shipper permit. The notice shall be
33	given in writing and in a form prescribed by the Commission. The Commission may
34	adopt rules necessary to implement the provisions of this section, including rules to
35	allow the wine shipper permittee to amend the brands of wines identified in the permit
36	application.
37	(b) The direct shipment of wine by wine shipper permittees made pursuant to this
38	section shall be by approved common carrier only. The Commission shall adopt rules
39	under which common carriers may apply for approval to provide common carriage of
40	wines shipped by holders of permits issued pursuant to this section. These rules shall
41	include provisions that require:
42	(1) The recipient to demonstrate, upon delivery, that he is at least 21 years
43	<u>of age.</u>

26 27	shipped to him from outside this State unless he has the appropriate ABC permit.permit
27	or unless the shipper holds a malt beverage shipper permit or a wine shipper permit."
28	SECTION 7. This act is effective when it becomes law.
