A BILL TO BE ENTITLED

1 AN ACT TO INCREASE THE FEE FOR A BREAST CANCER AWARENESS
2 SPECIAL PLATE TO SUPPORT SERVICES TO DETECT BREAST CANCER
3 EARLIER; TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE
4 THE FOLLOWING NEW SPECIAL REGISTRATION PLATES: CAROLINA'S
5 AVIATION MUSEUM, EMT, FOX HUNTING, GOLD STAR, GREYHOUND
6 FRIENDS OF NC, KAPPA ALPHA PSI FRATERNITY, LEUKEMIA &
7 LYMPHOMA SOCIETY, LUNG CANCER RESEARCH, NC CHILDREN'S
8 PROMISE, NC STATE PARKS, PRINCE HALL MASON, SUPPORT OUR
9 TROOPS, AND US EQUINE RESCUE LEAGUE; TO ELIMINATE THE
10 REGISTRATION PLATE FEE REQUIREMENT FOR INDIVIDUALS WHO
11 QUALIFY FOR THE LEGION OF VALOR SPECIAL REGISTRATION PLATE;
12 TO ADD THE DUCKS UNLIMITED SPECIAL PLATE TO THE LIST OF
13 PLATES NOT REQUIRED TO HAVE A "FIRST IN FLIGHT" BACKGROUND;
14 AND TO REPEAL THE SUNSET ON THE HARLEY OWNERS' GROUP AND
15 ROCKY MOUNTAIN ELK FOUNDATION SPECIAL LICENSE PLATES.

17 The General Assembly of North Carolina enacts:

18 **SECTION 1.** G.S. 20-63(b) reads as rewritten:

19 "(b) Every license plate shall have displayed upon it the registration number
20 assigned to the vehicle for which it is issued, the name of the State of North Carolina,
21 which may be abbreviated, and the year number for which it is issued or the date of
22 expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and
23 weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is
24 a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a
25 trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for
26 7,000 pounds through 26,000 pounds must bear the word "weighted".

27 Except as otherwise provided in this subsection, a registration plate issued by the
28 Division for a private passenger vehicle or for a private hauler vehicle licensed for

1 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have
 2 the words "First in Flight" printed at the top of the plate above all other letters and
 3 numerals. The background of the plate shall depict the Wright Brothers biplane flying
 4 over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The
 5 following special registration plates do not have to be a "First in Flight" plate. The
 6 design of the plates that are not "First in Flight" plates must be approved by the Division
 7 and the State Highway Patrol for clarity and ease of identification.

27 **SECTION 2.** G.S. 20-79.4(b) reads as rewritten:

28 "(b) Types. – The Division shall issue the following types of special registration
 29 plates:

- 31 (3h) Breast Cancer Awareness. – Issuable to the registered owner of a
 32 motor ~~vehicle.~~ vehicle in accordance with G.S. 20-81.12. The plate
 33 shall bear the phrase "Early Detection Saves Lives" and a
 34 representation of a pink ribbon. ~~The Division must receive 300 or~~
 35 ~~more applications for the plate before it may be developed.~~
- 36 ...
- 37 (3n) Carolina's Aviation Museum. – This plate is issuable to the registered
 38 owner of a motor vehicle in accordance with G.S. 20-81.12. The plate
 39 shall bear the phrase "Carolina's Aviation Museum" and a logo
 40 provided by the museum.
- 41 ...
- 42 (14e) Emergency Medical Technician. – Issuable to an emergency medical
 43 technician, as defined in G.S. 131E-155. The plate shall bear the Star
 44 of Life logo and the letters "EMT". The Division may not issue the

- 1 plate authorized by this subdivision unless it receives at least 300
2 applications for the plate.
3 ...
- 4 (15c) Fox Hunting. – Issuable to the registered owner of a motor vehicle.
5 The plate shall bear the phrase "Fox Hunting" and a picture of a
6 foxhound on the left side and a picture of a fox on the right side. The
7 Division may not issue the plate authorized by this subdivision unless
8 it receives at least 300 applications for the plate.
9 ...
- 10 (16b) Greyhound Friends of North Carolina. – Issuable to the registered
11 owner of a motor vehicle in accordance with G.S. 20-81.12. The plate
12 shall bear the phrase 'Greyhound Friends of North Carolina' and a
13 picture of a greyhound.
14 ...
- 15 (16f) Gold Star Lapel Button. – Issuable to the recipient of the Gold Star
16 lapel button. The plate shall bear the emblem of the Gold Star lapel
17 button and the words "Gold Star". The Division may not issue the plate
18 authorized by this subdivision unless it receives at least 300
19 applications for the plate.
20 ...
- 21 (20f) Kappa Alpha Psi Fraternity. – Issuable to the registered owner of a
22 motor vehicle. The plate shall bear the fraternity's symbol and name.
23 The Division may not issue the plate authorized by this subdivision
24 unless it receives at least 300 applications for the plate.
25 ...
- 26 (22c) Leukemia & Lymphoma Society. – Issuable to the registered owner of
27 a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear
28 the phrase and logo provided by The Leukemia & Lymphoma Society
29 that reflects "TEAM IN TRAINING".
30 ...
- 31 (22k) Lung Cancer Research. – Issuable to the registered owner of a motor
32 vehicle in accordance with G.S. 20-81.12. The plate shall bear the
33 phrase "Lung Cancer Research" and a representation of the American
34 Lung Association's Red Cross.
35 ...
- 36 (28k) NC Children's Promise. – Issuable to the registered owner of a motor
37 vehicle in accordance with G.S. 20-81.12. The plate shall bear the
38 phrase "N.C. Children's Promise" and a logo representing the North
39 Carolina Children's Promise organization.
40 ...
- 41 (32g) Prince Hall Mason. – This plate is issuable to the registered owner of a
42 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear
43 the phrase "Prince Hall Mason" and a picture of the Masonic symbol.
44 ...

(45a) Support Our Troops. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear a picture of a soldier and a child and shall bear the words: "Support Our Troops".

...

(46c) US Equine Rescue League. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "United States Equine Rescue League", and a depiction of two horses in a circle."

SECTION 3. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of ~~the Congressional Medal of Honor, a Legion of Valor award,~~ a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional ~~Congressional Medal of Honor, Legion of Valor,~~ 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

2 **SECTION 4.** G.S. 20-79.7(b) reads as rewritten:

3 "(b) Distribution of Fees. – The Special Registration Plate Account and the
4 Collegiate and Cultural Attraction Plate Account are established within the Highway
5 Fund. The Division must credit the additional fee imposed for the special registration
6 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
7 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
8 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
9 Trust Fund, which is established under G.S. 113-44.15, as follows:

42 **SECTION 5.** G.S. 20-81.12(b2) is amended by adding a new subdivision to
43 read:

1 "(b2) State Attraction Plates. – The Division must receive 300 or more applications
2 for a State attraction plate before the plate may be developed. The Division must
3 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
4 derived from the sale of State attraction plates to the organizations named below in
5 proportion to the number of State attraction plates sold representing that organization:

6 ...

7 (1i) North Carolina State Parks. – One-half of the revenue derived from the
8 special plate shall be transferred quarterly to Natural Heritage Trust
9 Fund established under G.S. 113-77.7, and the remaining revenue shall
10 be transferred quarterly to the Parks and Recreation Trust Fund
11 established under G.S. 113-44.15."

12 **SECTION 6.** G.S. 20-81.12 is amended by adding the following new
13 subsections to read:

14 "(b53) Breast Cancer Awareness. – The Division must receive 300 or more
15 applications for a Breast Cancer Awareness plate before the plate may be developed.
16 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction
17 Plate Account derived from the sale of Breast Cancer Awareness plates to Friends for an
18 Earlier Breast Cancer Test, Inc., to support services to detect breast cancer earlier.

19 (b54) Carolina's Aviation Museum. – The Division must receive 300 or more
20 applications for a Carolina's Aviation Museum plate before the plate may be developed.
21 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction
22 Plate Account derived from the sale of Carolina's Aviation Museum plates to the
23 Carolina's Historic Aviation Commission, a domestic nonprofit corporation, to be used
24 to help continue operation of the Museum.

25 (b55) Greyhound Friends of North Carolina. – The Division must receive 300 or
26 more applications for a Greyhound Friends of North Carolina plate before the plate may
27 be developed. The Division must transfer quarterly the money in the Collegiate and
28 Cultural Attraction Plate Account derived from the sale of the Greyhound Friends of
29 North Carolina plates to the Greyhound Friends of North Carolina, Inc., to be used for
30 the care and upkeep of retired greyhound racers that are awaiting adoption.

31 (b56) Leukemia & Lymphoma Society. – The Division must receive 300 or more
32 applications for a Leukemia & Lymphoma Society plate before the plate may be
33 developed. The Division must transfer quarterly the money in the Collegiate and
34 Cultural Attraction Plate Account derived from the sale of Leukemia & Lymphoma
35 Society plates to the Eastern Chapter of the North Carolina Leukemia & Lymphoma
36 Society, a State-chartered chapter of the national nonprofit organization known as The
37 Leukemia & Lymphoma Society, Inc., a duly registered New York nonprofit
38 corporation. These funds may be divided between the Eastern and Western chapters of
39 the North Carolina Leukemia & Lymphoma Society which shall each use the funds for
40 blood cancer research, awareness, and education.

41 (b57) Lung Cancer Research. – The Division must receive 300 or more applications
42 for the Lung Cancer Research plate before the plate may be developed. The Division
43 must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
44 Account derived from the sale of Lung Cancer Research plates to the American Lung

1 Association of North Carolina, Inc., to be used for eliminating lung disease and
2 fostering healthy breathing for all people through prevention, outreach, education,
3 research, and advocacy.

4 (b58) NC Children's Promise. – The Division must receive 300 or more applications
5 for a N.C. Children's Promise plate before the plate may be developed. The Division
6 must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
7 Account derived from the sale of NC Children's Promise plates to The Medical
8 Foundation of North Carolina, Incorporated, to be used to support the North Carolina
9 Children's Promise.

10 (b59) Prince Hall Mason. – The Division must receive 300 or more applications for
11 a Prince Hall Mason plate before the plate may be developed. The Division must
12 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
13 derived from the sale of Prince Hall Mason plates to The Most Worshipful Prince Hall
14 Grand Lodge of Free and Accepted Masons of North Carolina and Jurisdiction, Inc., to
15 be used for scholarships, family assistance, and other charitable causes.

16 (b60) Support Our Troops. – The Division must receive 300 or more applications
17 for a Support Our Troops plate before the plate may be developed. The Division shall
18 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account
19 derived from the sale of Support Our Troops plates to NC Support Our Troops, Inc., to
20 be used to provide support and assistance to the troops and their families.

21 (b61) US Equine Rescue League. – The Division must receive 300 or more
22 applications for the US Equine Rescue League plate before the plate may be developed.
23 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction
24 Plate Account derived from the sale of US Equine Rescue League plates to the United
25 States Equine Rescue League, Inc., to be used for the care and upkeep of rescued
26 equines."

27 **SECTION 7.** Section 8 of S.L. 2001-498 reads as rewritten:

28 "**SECTION 8.** Section 7 of this act becomes effective at the earliest practical date,
29 but no later than January 1, 2003. The remainder of this act is effective when it becomes
30 law. Sections 1(b), 3(b), 4(b), and 6(b) expire on June 30, 2006."

31 **SECTION 8.** As applied to G.S. 20-79.4, the authority in G.S. 164-10 for
32 the Division of Legislative Drafting and Codification to reletter or renumber section
33 subdivisions includes the authority to renumber all the subdivisions in G.S. 20-79.4(b)
34 in sequential and alphabetical order and to eliminate mixed number-letter subdivision
35 designations. This section expires July 1, 2011.

36 **SECTION 9.** The increase in the additional fee for the Breast Cancer
37 Awareness special plate, as amended in Section 3 of this act, becomes effective January
38 1, 2007, and applies to plates issued or renewed on or after that date. The remainder of
39 this act is effective when it becomes law.
