AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
GUILFORD BATTLEGROUND COMPANY SPECIAL REGISTRATION
PLATE.

5 The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b) reads as rewritten:

7 Every license plate shall have displayed upon it the registration number "(b) 8 assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of 9 10 expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and 11 weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a 12 13 trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 14 7,000 pounds through 26,000 pounds must bear the word "weighted".

Except as otherwise provided in this subsection, a registration plate issued by the 15 16 Division for a private passenger vehicle or for a private hauler vehicle licensed for 17 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and 18 numerals. The background of the plate shall depict the Wright Brothers biplane flying 19 20 over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The 21 design of the plates that are not "First in Flight" plates must be approved by the Division 22 23 and the State Highway Patrol for clarity and ease of identification.
