March 23, 2005 A BILL TO BE ENTITLED 1 2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A 3 BUDDY PELLETIER SURFING FOUNDATION SPECIAL REGISTRATION 4 PLATE. 5 The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 20-79.4(b) reads as rewritten: 6 7 "(b) Types. – The Division shall issue the following types of special registration 8 plates: 9 10 (3m) Buddy Pelletier Surfing Foundation. – Issuable to the registered owner 11 of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the words "Buddy Pelletier Surfing Foundation" and bear the logo 12 of the Foundation. The Division must receive 300 or more applications 13 14 for the plate before it may be developed. (3m)(3n) Buffalo Soldiers. - Issuable to the registered owner of a motor 15 16 vehicle in accordance with G.S. 20-81.12. The plate shall bear the 17 words "The Buffalo Soldiers" and the logo of the 9th & 10th (Horse) 18 Cavalry Association of the Buffalo Soldiers Greater North Carolina Chapter (BSGNCC)." 19 20 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten: Fees. - Upon request, the Division shall provide and issue free of charge one 21 "(a) registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled 22 23 veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of 24 25 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount: 26 Special Plate 27 Additional Fee Amount **Crystal Coast** \$30.00 28
