A BILL TO BE ENTITLED

1 AN ACT TO PROVIDE THAT ONE OF THE FIFTEEN MEMBERS OF THE
2 YADKIN/PEE DEE RIVER BASIN ADVISORY COMMISSION MAY BE FROM
3 A WATER OR SEWER MUNICIPAL UTILITY RATHER THAN AN
4 AUTHORITY AND TO PROVIDE THAT MEMBERS OF THE GENERAL
5 ASSEMBLY WHOSE DISTRICTS INCLUDE ANY PART OF THE NORTH
6 CAROLINA PORTION OF THE ROANOKE RIVER BASIN MAY SERVE AS
7 LEGISLATIVE MEMBERS OF THE ROANOKE RIVER BASIN BI-STATE
8 COMMISSION.

10 The General Assembly of North Carolina enacts:

11 **SECTION 1.** G.S. 77-113(b) reads as rewritten:

12 "(b) The Yadkin/Pee Dee River Basin Advisory Commission shall be composed
13 of 15 members as follows:

14 ...

15 (7) One person from a water or sewer municipal ~~authority~~, utility,
16 appointed by the Governor of North Carolina.

18 **SECTION 2.** G.S. 77-92(a) reads as rewritten:

19 "(a) The Roanoke River Basin Bi-State Commission shall consist of 18 members
20 with each state appointing nine members. The North Carolina delegation to the
21 Commission shall consist of the six members of the General Assembly of North
22 Carolina appointed to the North Carolina Roanoke River Basin Advisory Committee
23 and three nonlegislative members of the North Carolina Roanoke River Basin Advisory
24 Committee, established pursuant to G.S. 77-103, who represent different geographical
25 areas of the North Carolina portion of the ~~Basin~~, Basin and who reside within the
26 Basin's watershed, to be appointed by the Governor of North Carolina. The Virginia
27 delegation to the Commission shall be appointed as determined by the Commonwealth
28 of Virginia."

29 **SECTION 3.** G.S. 77-92(b) reads as rewritten:

1 "~~(b) All members appointed to the Commission from the State of North Carolina~~
2 ~~and the Commonwealth of Virginia shall reside within the Basin's watershed. Members~~
3 of the North Carolina House of Representatives, the North Carolina Senate, the Virginia
4 House of Delegates, the Virginia Senate, and federal legislators, who have not been
5 appointed to the Commission and whose districts include any portion of the Basin, may
6 serve as nonvoting ex officio members of the Commission."

7 **SECTION 4.** This act is effective when it becomes law.
