SENATE JOINT RESOLUTION DRSJR55279-LB-226 (8/10)

Sponsors: Senator Rand.

Referred to:

1 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE
2 2005 GENERAL ASSEMBLY TO MEET IN 2006 AND LIMITING THE
3 SUBJECTS THAT MAY BE CONSIDERED IN THAT SESSION.

4 Be it resolved by the Senate, the House of Representatives concurring:

5 **SECTION 1.** When the Senate and House of Representatives adjourn on
6 Wednesday, August 24, 2005, they stand adjourned to reconvene on Tuesday, May 9,
7 2006, at 12:00 noon.

8 **SECTION 2.** During the regular session that reconvenes on Tuesday, May 9,
9 2006, only the following matters may be considered:

- 10 (1) Bills directly and primarily affecting the State budget, including the
11 budget of an occupational licensing board, for fiscal year 2006-2007,
12 provided that the bill must be submitted to the Bill Drafting Division
13 of the Legislative Services Office no later than 4:00 P.M. Thursday,
14 May 18, 2006, and must be introduced in the House of Representatives
15 or filed for introduction in the Senate no later than 4:00 P.M.
16 Thursday, May 25, 2006.
- 17 (2) Bills and resolutions introduced in 2005 and having passed third
18 reading in 2005 in the house in which introduced, received in the other
19 house in accordance with Senate Rule 41 or House Rule 31.1(d) as
20 appropriate, and not disposed of in the other house by tabling,
21 unfavorable committee report, indefinite postponement, or failure to
22 pass any reading, and which do not violate the rules of the receiving
23 house.
- 24 (3) Bills and resolutions implementing the recommendations of:
- 25 a. Study commissions, authorities, and statutory commissions
26 authorized or directed to report to the 2006 Session;
- 27 b. The General Statutes Commission, the Courts Commission, or
28 any commission created under Chapter 120 of the General

1 Statutes that is authorized or directed to report to the General
2 Assembly;

3 c. The House Ethics Committee;

4 d. Select committees; or

5 e. The Joint Legislative Ethics Committee or its Advisory
6 Subcommittee.

7 A bill authorized by this subdivision must be submitted to the Bill
8 Drafting Division of the Legislative Services Office no later than 4:00
9 P.M. Wednesday, May 10, 2006, and must be filed for introduction in
10 the Senate or introduced in the House of Representatives no later than
11 4:00 P.M. Wednesday, May 17, 2006.

12 (4) Any local bill that has been submitted to the Bill Drafting Division of
13 the Legislative Services Office by 4:00 P.M. Wednesday, May 17,
14 2006, is introduced in the House of Representatives or filed for
15 introduction in the Senate by 4:00 P.M. Wednesday, May 24, 2006,
16 and is accompanied by a certificate signed by the principal sponsor
17 stating that no public hearing will be required or asked for by a
18 member on the bill, the bill is noncontroversial, and that the bill is
19 approved for introduction by each member of the House of
20 Representatives and Senate whose district includes the area to which
21 the bill applies.

22 (5) Selection, appointment, or confirmation of members of State boards
23 and commissions as required by law, including the filling of vacancies
24 of positions for which the appointees were elected by the General
25 Assembly upon recommendation of the Speaker of the House of
26 Representatives, President of the Senate, or President Pro Tempore of
27 the Senate.

28 (6) Any matter authorized by joint resolution passed during the 2006
29 Regular Session by a two-thirds majority of the members of the House
30 of Representatives present and voting and by a two-thirds majority of
31 the members of the Senate present and voting. A bill or resolution filed
32 in either house under the provisions of this subdivision shall have a
33 copy of the ratified enabling resolution attached to the jacket before
34 filing for introduction in the Senate or introduction in the House of
35 Representatives.

36 (7) A joint resolution authorizing the introduction of a bill pursuant to
37 subdivision (6) of this section.

38 (8) Any bills primarily affecting any State or local pension or retirement
39 system, provided that the bill has been submitted to the Bill Drafting
40 Division of the Legislative Services Office no later than 4:00 P.M.
41 Wednesday, May 17, 2006, and is introduced in the House of
42 Representatives or filed for introduction in the Senate no later than
43 4:00 P.M. Wednesday, May 24, 2006.

1 (9) Joint resolutions, House resolutions, and Senate resolutions pertaining
2 to Section 5(10) of Article III of the Constitution of North Carolina or
3 authorized for introduction under Senate Rule 40(b) or House Rule
4 31(g).

5 (10) A joint resolution adjourning the 2005 Regular Session, sine die.

6 (11) Bills to disapprove rules under G.S. 150B-21.3.

7 (12) Constitutional amendments.

8 **SECTION 3.** A bill containing no substantive provisions may not be
9 introduced in the House of Representatives during the 2006 Regular Session.

10 **SECTION 4.** The Speaker of the House of Representatives or the President
11 Pro Tempore of the Senate may authorize appropriate committees or subcommittees of
12 their respective houses to meet during the interims between sessions to:

13 (1) Review matters related to the State budget for the 2005-2007
14 biennium,

15 (2) Prepare reports, including revised budgets, or

16 (3) Consider any other matters as the Speaker of the House of
17 Representatives or the President Pro Tempore of the Senate deems
18 appropriate,

19 except that no committee or subcommittee of a house may consider, after the date of
20 adjournment provided in Section 1 of this resolution and before the date of reconvening
21 provided in Section 2 of this resolution, any bill, or proposed committee substitute for
22 such bill, which originated in the other house. A conference committee may meet in the
23 interim upon approval by the Speaker of the House of Representatives or the President
24 Pro Tempore of the Senate.

25 **SECTION 5.** This resolution is effective upon ratification.
