1 A BILL TO BE ENTITLED 2 AN ACT TO APPLY STATEWIDE BOARDS OF COUNTY COMMISSIONERS 3 AUTHORITY OVER COMMISSIONS, BOARDS, AND AGENCIES. 4 The General Assembly of North Carolina enacts: 5 SECTION 1. G.S. 153A-77 reads as rewritten: 6 Authority of boards of commissioners in certain counties over "§ 153A-77. 7 commissions, boards, agencies, etc. 8 In the exercise of its jurisdiction over commissions, boards and agencies, the (a) board of county commissioners may assume direct control of any activities theretofore 9 conducted by or through any commission, board or agency by the adoption of a 10 resolution assuming and conferring upon the board of county commissioners all powers, 11 responsibilities and duties of any such commission, board or agency. This subsection 12 shall apply to the board of health, the social services board, area mental health, 13 14 developmental disabilities, and substance abuse area board and any other commission, board or agency appointed by the board of county commissioners or acting under and 15 pursuant to authority of the board of county commissioners of said county. A board of 16 17 county commissioners exercising the power and authority under this subsection may, notwithstanding G.S. 130A-25, enforce public health rules adopted by the board through 18 the imposition of civil penalties. If a public health rule adopted by a board of county 19 20 commissioners imposes a civil penalty, the provisions of G.S. 130A-25 making its 21 violation a misdemeanor shall not be applicable to that public health rule unless the rule states that a violation of the rule is a misdemeanor. The board of county commissioners 22 23 may exercise the power and authority herein conferred only after a public hearing held 24 by said board pursuant to 30 days' notice of said public hearing given in a newspaper 25 having general circulation in said county. The board of county commissioners may also appoint advisory boards, committees, 26

27 councils and agencies composed of qualified and interested county residents to study,

1	interpret and develop community support and cooperation in activities conducted by or				
2	under the authority of the board of county commissioners of said county.				
3	(b) In the exercise of its jurisdiction over commissions, boards, and agencies, the				
4	board of county commissioners of a county having a county manager pursuant to				
5	G.S. 153A-81 may:				
6	(1) Consolidate the provision of human services in the county under the				
7	direct control of a human services director appointed and supervised				
8	by the county manager in accordance with subsection (e) of this				
9	section;				
10	(2) Create a consolidated human services board having the powers				
11	conferred by subsection (c) of this section;				
12	(3) Create a consolidated county human services agency having the				
13	authority to carry out the functions of the local health department, the				
14	county department of social services, and the area mental health,				
15	developmental disabilities, and substance abuse services authority; and				
16	(4) Assign other county human services functions to be performed by the				
17	consolidated human services agency under the direction of the human				
18	services director, with policy-making authority granted to the				
19	consolidated human services board as determined by the board of				
20	county commissioners.				
21	(c) A consolidated human services board appointed by the board of county				
22	commissioners shall serve as the policy-making, rule-making, and administrative board				
23	of the consolidated human services agency. The consolidated human services board				
24	shall be composed of no more than 25 members. The composition of the board shall				
25	reasonably reflect the population makeup of the county and shall include:				
26	(1) Eight persons who are consumers of human services, public advocates,				
27	or family members of clients of the consolidated human services				
28	agency, including: one person with mental illness, one person with a				
29	developmental disability, one person in recovery from substance				
30	abuse, one family member of a person with mental illness, one family				
31	member of a person with a developmental disability, one family				
32	member of a person with a substance abuse problem, and two				
33	consumers of other human services.				
34	(2) Eight persons who are professionals, each with qualifications in one of				
35	these categories: one psychologist, one pharmacist, one engineer, one				
36	dentist, one optometrist, one veterinarian, one social worker, and one				
37	registered nurse.				
38	(3) Two physicians licensed to practice medicine in this State, one of				
39	whom shall be a psychiatrist.				
40	(4) One member of the board of county commissioners.				
41	(5) Other persons, including members of the general public representing				
42	various occupations.				
43	The board of county commissioners may elect to appoint a member of the				
44	consolidated human services board to fill concurrently more than one category of				

1 membership if the member has the qualifications or attributes of more than one category2 of membership.

All members of the consolidated human services board shall be residents of the county. The members of the board shall serve four-year terms. No member may serve more than two consecutive four-year terms. The county commissioner member shall serve only as long as the member is a county commissioner.

7 The initial board shall be appointed by the board of county commissioners upon the 8 recommendation of a nominating committee comprised of members of the 9 preconsolidation board of health, social services board, and area mental health, 10 developmental disabilities, and substance abuse services board. In order to establish a 11 uniform staggered term structure for the board, a member may be appointed for less 12 than a four-year term. After the subsequent establishment of the board, its board shall be 13 appointed by the board of county commissioners from nominees presented by the 14 human services board. Vacancies shall be filled for any unexpired portion of a term.

15 A chairperson shall be elected annually by the members of the consolidated human 16 services board. A majority of the members shall constitute a quorum. A member may be 17 removed from office by the county board of commissioners for (i) commission of a 18 felony or other crime involving moral turpitude; (ii) violation of a State law governing 19 conflict of interest; (iii) violation of a written policy adopted by the county board of 20 commissioners; (iv) habitual failure to attend meetings; (v) conduct that tends to bring 21 the office into disrepute; or (vi) failure to maintain qualifications for appointment 22 required under this subsection. A board member may be removed only after the member 23 has been given written notice of the basis for removal and has had the opportunity to 24 respond.

A member may receive a per diem in an amount established by the county board of commissioners. Reimbursement for subsistence and travel shall be in accordance with a policy set by the county board of commissioners. The board shall meet at least quarterly. The chairperson or three of the members may call a special meeting.

29 (d) The consolidated human services board shall have authority to:

- 30 Set fees for departmental services based upon recommendations of the (1)31 human services director. Fees set under this subdivision are subject to 32 the same restrictions on amount and scope that would apply if the fees 33 were set by a county board of health, a county board of social services, 34 or a mental health, developmental disabilities, and substance abuse 35 area authority. 36 Assure compliance with laws related to State and federal programs.
