1 A BILL TO BE ENTITLED  
2 AN ACT TO MAKE VARIOUS CLARIFYING CHANGES TO THE GENERAL STATUTES  
3 AND THE SESSION LAWS.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 1-398 reads as rewritten:

6 "§ 1-398. Filing time enlarged.

7 The time for filing the complaint, petition, or any pleading may be enlarged by the court for  
8 good cause ~~shown by affidavit, shown,~~ but may not be enlarged by more than 10 additional  
9 ~~days, days or 30 additional days for partitions,~~ nor more than once, unless the default was  
10 occasioned by accident over which the party applying had no control, or by the fraud of the  
11 opposing party."

12 SECTION 2. G.S. 20-179(p) reads as rewritten:

13 "(p) Limit on Amelioration of Punishment. – For active terms of imprisonment imposed  
14 under this section:

- 15 (1) The judge may not give credit to the defendant for the first 24 hours of time  
16 spent in incarceration pending trial.  
17 (2) The defendant shall serve the mandatory minimum period of imprisonment  
18 and good or gain time credit may not be used to reduce that mandatory  
19 minimum period.  
20 (3) The defendant may not be released on parole unless he is otherwise eligible,  
21 has served the mandatory minimum period of imprisonment, and has  
22 obtained a substance abuse assessment and completed any recommended  
23 treatment or training ~~program-program~~ or is paroled into a residential  
24 treatment program.

25 With respect to the minimum or specific term of imprisonment imposed as a condition of  
26 special probation under this section, the judge may not give credit to the defendant for the first  
27 24 hours of time spent in incarceration pending trial."

28 SECTION 3. G.S. 20-183.4C reads as rewritten:

29 "§ 20-183.4C. When a vehicle must be inspected; ~~three-day~~10-day trip permit.

30 (a) Inspection. – A vehicle that is subject to a safety inspection, an emissions  
31 inspection, or both must be inspected as follows:

- 32 (1) A new vehicle must be inspected before it is sold at retail in this State. Upon  
33 purchase, a receipt approved by the Division must be provided to the new  
34 owner certifying compliance.  
35 (1a) A new motor vehicle dealer who is also licensed pursuant to this Article  
36 may, notwithstanding subdivision (1) of this section, examine the safety and

1 emissions control devices on a new motor vehicle and perform such services  
2 necessary to ensure the motor vehicle conforms to the required specifications  
3 established by the manufacturer and contained in its predelivery check list.  
4 The completion of the predelivery inspection procedure required or  
5 recommended by the manufacturer on a new motor vehicle shall constitute  
6 the inspection required by subdivision (1) of this section. For the purposes of  
7 this subdivision, the date of inspection shall be deemed to be the date of the  
8 sale of the motor vehicle to a purchaser.

9 (2) A used vehicle must be inspected before it is offered for sale at retail in this  
10 State by a dealer. Upon purchase, a receipt approved by the Division must be  
11 provided to the new owner certifying compliance.

12 (3) Repealed by Session Law 2007-503, s. 5, effective October 1, 2008.

13 (4) Except as authorized by the Commissioner for a single period of time not to  
14 exceed 12 months from the initial date of registration, a new or used vehicle  
15 acquired by a resident of this State from outside the State must be inspected  
16 before the vehicle is registered with the Division.

17 (5) Except as authorized by the Commissioner for a single period of time not to  
18 exceed 12 months from the initial date of registration, a vehicle owned by a  
19 new resident of this State who transfers the registration of the vehicle from  
20 the resident's former home state to this State must be inspected before the  
21 vehicle is registered with the Division.

22 (5a) Repealed by Session Law 2007-503, s. 5, effective October 1, 2008.

23 (6) A vehicle that has been inspected in accordance with this Part must be  
24 inspected by the last day of the month in which the registration on the  
25 vehicle expires.

26 (7) A vehicle that is required to be inspected in accordance with this Part may be  
27 inspected 90 days prior to midnight of the last day of the month as  
28 designated by the vehicle registration sticker.

29 (8) A new or used vehicle acquired from a retailer or a private sale in this State  
30 and registered with the Division with a new registration or a transferred  
31 registration must be inspected in accordance with this Part when the current  
32 registration ~~expires~~ expires unless it has received a passing inspection within  
33 the previous 12 months.

34 (9) ~~A used vehicle acquired from a private sale in this State must be inspected in~~  
35 ~~accordance with this Part before the vehicle is registered with the Division~~  
36 ~~unless it has received a passing inspection within the previous 12 months.~~

37 (10) An unregistered vehicle ~~must be inspected before the vehicle is~~ may be  
38 registered with the Division ~~unless it has received a passing inspection~~  
39 ~~within the previous 12 months.~~ in accordance with G.S. 20-50(b) for a period  
40 not to exceed 10 days prior to the vehicle receiving a passing inspection in  
41 accordance with this Part.

42 (11) A person who owns a vehicle located outside of this State when its  
43 emissions inspection becomes due may obtain an emissions inspection in the  
44 jurisdiction where the vehicle is located, in lieu of a North Carolina  
45 emissions inspection, as long as the inspection meets the requirements of 40  
46 C.F.R. § 51.

47 (b) Permit. – The Division may issue a ~~three-day~~ 10-day trip permit to a person that  
48 authorizes the person to drive a vehicle whose inspection authorization or registration has  
49 expired. The permit may only be issued when the person has furnished proof of financial  
50 responsibility. The permit must describe the vehicle whose inspection authorization or  
51 registration has expired. The permit authorizes the person to drive the described vehicle for a

1 period not to exceed 10 days from the date of issuance, only from the place the vehicle is  
2 parked to an inspection station, repair shop, or Division or contract agent registration office.

3 ~~The Division may issue a 10 day temporary permit to a person that authorizes the person to~~  
4 ~~drive a vehicle that failed to pass the emissions inspection. The permit must describe the~~  
5 ~~vehicle that failed to pass inspection and the date that it failed to pass inspection.~~

6 (c) Exemption. – The Division may issue a temporary exemption from the inspection  
7 requirements of this Article for any vehicle that has been determined by the Division to be  
8 principally garaged, as defined under G.S. 58-37-1(11), in this State and is primarily operated  
9 outside a county subject to emissions inspection requirements or outside of this State."

10 **SECTION 4.** G.S. 20-382(c) reads as rewritten:

11 "(c) Trip Permit. – A motor carrier that is not registered as required by this section may  
12 obtain an emergency trip ~~permit by filing an application for it with the Division, permit.~~ An  
13 emergency trip permit allows the motor carrier to operate a for-hire motor vehicle in this State  
14 for a period not to exceed 10 days."

15 **SECTION 5.(a)** G.S. 36C-4-401.2 reads as rewritten:

16 "~~§ 36C-4-401.2. Trust pursuant to 46 U.S.C § 1396p(d)(4). Creation of trust by a court.~~

17 ~~Any interested party may petition the court, in accordance with the provisions of this~~  
18 ~~Chapter, to establish a trust pursuant to section 1396p(d)(4) of Title 42 of the United States~~  
19 ~~Code. This section is not the exclusive method of establishing a trust pursuant to section~~  
20 ~~1396p(d)(4) of Title 42 of the United States Code; and the court shall maintain its authority to~~  
21 ~~create or establish any trust, including a trust pursuant to section 1396p(d)(4) of Title 42 of the~~  
22 ~~United States Code, by means of judgment, order, or decree in any matter properly before the~~  
23 ~~court. A court may create or establish a trust by judgment or decree, including a trust pursuant~~  
24 ~~to section 1396p(d)(4) of Title 42 of the United States Code, upon petition of an interested~~  
25 ~~party in accordance with the provisions of this Chapter or in any other matter properly before~~  
26 ~~the court."~~

27 **SECTION 5.(b)** G.S. 36C-8-816.1(c)(7) reads as rewritten:

28 "(7) ~~If the power to distribute principal or income in the original trust is subject~~  
29 ~~to an ascertainable standard, If a trustee of an original trust exercises a power~~  
30 ~~to distribute principal or income that is subject to an ascertainable standard~~  
31 ~~by appointing property to a second trust, then the power to distribute income~~  
32 ~~or principal in the second trust must be subject to the same ascertainable~~  
33 ~~standard as in the original trust and must be exercisable in favor of the same~~  
34 ~~current beneficiaries as to whom such distribution could be made in the~~  
35 ~~original trust."~~

36 **SECTION 6.(a)** G.S. 42-42(7) reads as rewritten:

37 "(7) Provide a minimum of one operable carbon monoxide detector per rental  
38 unit per level, either battery-operated or electrical, that is listed by a  
39 nationally recognized testing laboratory that is OSHA-approved to test and  
40 certify to American National Standards Institute/Underwriters Laboratories  
41 Standards ANSI/UL2034 or ANSI/UL2075, and install the carbon monoxide  
42 detectors in accordance with either the standards of the National Fire  
43 Protection Association or the minimum protection designated in the  
44 manufacturer's instructions, which the landlord shall retain or provide as  
45 proof of compliance. A landlord that installs one carbon monoxide detector  
46 per rental unit per level shall be deemed to be in compliance with standards  
47 under this subdivision covering the location and number of detectors. The  
48 landlord shall replace or repair the carbon monoxide detectors within 15  
49 days of receipt of notification if the landlord is notified of needed  
50 replacement or repairs in writing by the tenant. The landlord shall ensure  
51 that a carbon monoxide detector is operable and in good repair at the

1 beginning of each tenancy. Unless the landlord and the tenant have a written  
2 agreement to the contrary, the landlord shall place new batteries in a  
3 battery-operated carbon monoxide detector at the beginning of a tenancy,  
4 and the tenant shall replace the batteries as needed during the tenancy.  
5 Failure of the tenant to replace the batteries as needed shall not be  
6 considered as negligence on the part of the tenant or the landlord. A carbon  
7 monoxide detector may be combined with smoke detectors if the combined  
8 detector does both of the following: (i) complies with ANSI/UL2034 or  
9 ANSI/UL2075 for carbon monoxide alarms and ANSI/UL217 for smoke  
10 detectors; and (ii) emits an alarm in a manner that clearly differentiates  
11 between detecting the presence of carbon monoxide and the presence of  
12 smoke. This subdivision applies only to dwelling units having ~~a fossil-fuel  
13 burning heater or appliance, fireplace, or an attached garage. a heater,  
14 appliance, or fireplace fueled by fossil fuel, wood, wood products, biomass,  
15 or any other combustible product, and in any dwelling unit having an  
16 attached garage.~~ Any operable carbon monoxide detector installed before  
17 January 1, 2010, shall be deemed to be in compliance with this subdivision."

18 **SECTION 6.(b)** G.S. 143-138(b2) reads as rewritten:

19 "(b2) The Code may contain provisions requiring the installation of either  
20 battery-operated or electrical carbon monoxide detectors in every dwelling unit having a  
21 ~~fossil-fuel burning heater or appliance, fireplace, or an attached garage. a heater, appliance, or  
22 fireplace fueled by fossil fuel, wood, wood products, biomass, or any other combustible  
23 product, and in any dwelling unit having an attached garage.~~ Carbon monoxide detectors shall  
24 be those listed by a nationally recognized testing laboratory that is OSHA-approved to test and  
25 certify to American National Standards Institute/Underwriters Laboratories Standards  
26 ANSI/UL2034 or ANSI/UL2075 and shall be installed in accordance with either the standard  
27 of the National Fire Protection Association or the minimum protection designated in the  
28 manufacturer's instructions, which the property owner shall retain or provide as proof of  
29 compliance. A carbon monoxide detector may be combined with smoke detectors if the  
30 combined detector does both of the following: (i) complies with ANSI/UL2034 or  
31 ANSI/UL2075 for carbon monoxide alarms and ANSI/UL217 for smoke detectors; and (ii)  
32 emits an alarm in a manner that clearly differentiates between detecting the presence of carbon  
33 monoxide and the presence of smoke."

34 **SECTION 7.** G.S. 58-3-285(a) reads as rewritten:

35 "(a) Every health benefit plan, including the State Health Plan for Teachers and State  
36 Employees, shall provide coverage for one hearing aid per hearing-impaired ear up to two  
37 thousand five hundred dollars (\$2,500) per hearing aid every 36 months for covered individuals  
38 under the age of 22 years subject to subsection (b) of this section. The coverage shall include  
39 all medically necessary hearing aids and services that are ordered by a physician or an  
40 audiologist licensed in this State. Only those persons authorized by law to fit hearing aids,  
41 including individuals licensed under Chapter 93D of the General Statutes, are eligible to fit a  
42 hearing aid under this section. Coverage shall be as follows:

- 43 (1) Initial hearing aids and replacement hearing aids not more frequently than  
44 every 36 months.
- 45 (2) A new hearing aid when alterations to the existing hearing aid cannot  
46 adequately meet the needs of the covered individual.
- 47 (3) Services, including the initial hearing aid evaluation, fitting, and  
48 adjustments, and supplies, including ear molds."

49 **SECTION 8.** G.S. 93B-9 reads as rewritten:

50 **"§ 93B-9. Age requirements.**

1 ~~Any other provision notwithstanding, no~~ No occupational licensing board may require that  
 2 an individual be more than 18 years of age as a requirement for receiving a ~~license~~ license with  
 3 the following exceptions: the North Carolina Criminal Justice Education and Training  
 4 Standards Commission and the North Carolina Sheriffs' Education and Training Standards  
 5 Commission may establish a higher age as a requirement for holding certification through  
 6 either Commission."

7 **SECTION 9.** G.S. 95-25.5(n) reads as rewritten:

8 "(n) Nothing in this section prohibits qualified youths under 18 years of age from  
 9 participating in training through their fire department, the Office of State Fire Marshal, or the  
 10 North Carolina Community College System. As used in this subsection, the term "qualified  
 11 youth under 18 years of age" means an uncompensated fire department or rescue squad member  
 12 who is ~~over~~ at least the age of 15 and under the age of 18 and who is a member of a bona fide  
 13 fire department, as that term is defined in G.S. 58-86-25, or of a rescue squad described in  
 14 G.S. 58-86-30."

15 **SECTION 10.** G.S. 116B-62(f) reads as rewritten:

16 "(f) Notwithstanding the provisions of Chapter 132 of the General Statutes, ~~the~~ any  
 17 supporting data and data, including aging reports, or lists of apparent owners of unclaimed  
 18 property held by a clerk of superior court or any other office of State or local government may  
 19 be confidential but shall be disclosed to the Treasurer in accordance with the reporting of  
 20 escheated and abandoned property. The supporting data and lists of apparent owners of  
 21 escheated and abandoned property held by the Treasurer may be confidential until six ~~12~~  
 22 months after the list to the clerks of superior court required by subsection (b) of this section has  
 23 been distributed. This subsection shall not apply to owners of reported property making  
 24 inquiries about their property to the Escheat Fund."

25 **SECTION 11.** Article 36A of Chapter 143 of the General Statutes reads as  
 26 rewritten:

27 "Article 36A.

28 "State Employee ~~Incentive Bonus~~ Suggestion Program (NC-Thinks).

29 **"§ 143-345.20. Definitions.**

30 The following definitions apply in this Article:

- 31 (1) Baseline reversion. – The two-year historical average of reversions by a  
 32 State department, agency, or institution.
- 33 (2) Repealed by Session Laws 2001-424, s. 7.2(b).
- 34 (2a) Participating agency. – Any State department, agency, or institution, or any  
 35 local school administrative unit that employs State employees eligible to  
 36 participate in ~~the State Employee Incentive Bonus Program~~ NC-Thinks. The  
 37 term includes the North Carolina Community Colleges System, The  
 38 University of North Carolina and its constituent institutions, and charter  
 39 schools. The term does not include federal or local government agencies.
- 40 (2b) ~~SEIBP~~ NC-Thinks. – ~~Aeronym for the~~ The State Employee ~~Incentive~~  
 41 ~~Bonus~~ Suggestion Program.
- 42 (3) State employee. – Any of the following:
- 43 a. A person who is a contributing member of the Teachers' and State  
 44 Employees' Retirement System of North Carolina, the Consolidated  
 45 Judicial Retirement System of North Carolina, or the Optional  
 46 Program.
- 47 b. A person who receives wages from the State as a part-time or  
 48 temporary worker, but is not otherwise a contributing member of one  
 49 of the retirement programs listed in sub-subdivision a. of this  
 50 subdivision.

51 **"§ 143-345.21. State employee ~~incentive bonus~~ suggestion program.**

1 (a) A State employee or team of State employees may receive an incentive bonus or  
2 bonuses in reward for suggestions or innovations resulting in monetary savings to the State,  
3 increased revenues to the State, or improved quality of services delivered to the public.

4 (b) Repealed by Session Laws 2001-424, s. 7.2(c).

5 (b1) The amount of savings generated by suggestions and innovations shall be  
6 determined after a 12-month period of implementation. No incentive bonus shall be paid prior  
7 to the expiration of 12 months, and payment may be delayed further as reasonably required to  
8 ensure that a complete cost implementation cycle is evaluated fully.

9 (c) Any savings are to be calculated using the actual expenditures for a program,  
10 activity, or service compared to the budgeted amount for the same, if an amount has been  
11 budgeted for the program, activity, or service. The savings calculation shall include the amount  
12 of any reversions in excess of the baseline reversion. Any savings realized through ~~the State~~  
13 ~~Employee Incentive Bonus Program~~ NC-Thinks shall be weighed against continued service to  
14 the public and the assurance that there is not a negative impact on State programs.

15 (d) If a suggestion or innovation affects a program, activity, or service for which no  
16 separate budgeted amount has been made, the State Coordinator, in conjunction with the  
17 agency evaluator or agency fiscal officer, or both for that suggestion or innovation, shall  
18 determine the budgetary impact of the suggestion or innovation.

19 (e) Federal and local government funds and corporate and foundation grant funds are  
20 excluded from ~~the SEIBP~~ NC-Thinks.

21 (f) The Department of Administration shall establish the ~~SEIBP~~ NC-Thinks reserve  
22 fund in which all savings for all suggestions shall be deposited as earned. Each participating  
23 agency shall be responsible for transferring savings to the ~~SEIBP~~ NC-Thinks reserve fund. The  
24 funds may be encumbered as needed to ensure payment to the General Fund, to the suggester,  
25 and for distribution as required by G.S. 143-345.22. The Department of Administration shall  
26 provide the ~~SEIBP~~ NC-Thinks reserve fund summary at the close of each fiscal year to the  
27 Office of State Budget and Management and to the participating agencies. The Office of State  
28 Budget and Management shall have oversight responsibility for ensuring that the required  
29 reversions and transfers are made to the General Fund, and that all encumbered funds are  
30 accounted for and paid as required by law.

31 (g) No distribution of suggester awards shall occur until reversion requirements to the  
32 General Fund are met and distributions as required by G.S. 143-345.22 are satisfied and  
33 verified by the Office of State Budget and Management. When all of the requirements of  
34 G.S. 143-345.22 are fulfilled, the Department of Administration shall transfer to the suggester's  
35 agency funds required to award the suggester. The suggester's agency shall make the suggestion  
36 award and ensure that all taxes and withholding requirements are met.

37 (h) Implementation costs may be prorated over a maximum of three years for  
38 suggestions or innovations that are capital intensive, involve leading-edge technology, or  
39 involve unconventional processes that require longer than 12 months for implementation. The  
40 amount of the average annual savings minus the average annual implementation cost shall be  
41 used as the basis for the agency to recommend a suggester award. The State Suggestion Review  
42 Committee shall consult the Office of State Budget and Management to make the final award  
43 determination in these cases.

44 (i) There is established in the Department of Administration a nonreverting fund to be  
45 administered by the Office of State Personnel for the training and education of permanent State  
46 employees to address specific mission critical needs and objectives. Funds shall be credited  
47 from ~~the SEIBP~~ NC-Thinks to the fund as provided by this Article.

48 **"§ 143-345.22. Allocation of incentive bonus funds; nonmonetary recognition.**

49 (a) If a State employee's suggestion or innovation results in a monetary savings or  
50 increased revenue to the State, the funds saved or increased shall be distributed according to the  
51 following scale or subject to guidelines as set forth by the funding source:

1 (1) Twenty percent (20%) of the annualized savings or increased revenues, up to  
2 a maximum of twenty thousand dollars (\$20,000) for any one State  
3 employee, to constitute gainsharing. If a team of State employees is the  
4 suggester, the bonus provided in this subdivision shall be divided equally  
5 among the team members, except that no team member shall receive in  
6 excess of twenty thousand dollars (\$20,000), nor shall the team receive an  
7 aggregate amount in excess of one hundred thousand dollars (\$100,000).  
8 These funds shall not revert.

9 (2) Thirty percent (30%) allocated as follows:

10 a. Ten percent (10%) to the implementing agency for nonrecurring  
11 budget items to be used (i) by the implementing agency to provide  
12 equipment, supplies, training, and limited but appropriate recognition  
13 for the division, section, or group responsible for the implementation  
14 of the cost-saving measure and (ii) to meet other similar needs within  
15 the agency.

16 b. Ten percent (10%) to the Department of Administration for  
17 augmenting funding for the management and administration of ~~the~~  
18 SEIBP-NC-Thinks. These funds shall not revert.

19 c. Ten percent (10%) to the State employee education and training fund  
20 administered by the Office of State Personnel under  
21 G.S. 143-342.21(i). These funds shall not revert.

22 (3) The remainder to the General Fund for nonrecurring budget items.

23 (a1) Of the pool of funds identified in subsection (a) of this section, only the General  
24 Fund appropriations shall be subject to reversion, except during declared budget emergencies.  
25 Under nonemergency budget conditions, SEIBP-NC-Thinks funds arising from savings at The  
26 University of North Carolina, the North Carolina Community Colleges System, the Highway  
27 Trust Fund, enterprise funds, and receipt-supported organizations shall be exempt from the  
28 General Fund reversion requirements.

29 (b) The budget of a State agency shall not be reduced in the following fiscal year by an  
30 amount similar to the monetary savings or increased revenues realized by ~~the State Employee~~  
31 Incentive Bonus Program-NC-Thinks. The agency budget shall be reduced in subsequent years  
32 only if structural or organizational changes are made that warrant the reductions, including the  
33 transfer of responsibility for an activity or service to another agency or the elimination of some  
34 function of State government.

35 (c) If a suggestion or innovation results in improved quality of services to the public or  
36 to other State agencies, departments, and institutions, but not in monetary savings to the State,  
37 the suggester shall receive a nonmonetary award in the form of a certificate, leave with pay, or  
38 other similar recognition.

39 **"§ 143-345.23. Suggestion and review process; role of agency coordinator and agency**  
40 **evaluator.**

41 (a) The process for a State employee or team of State employees to submit a  
42 cost-saving or revenue-increasing proposal shall begin with the employee or team of employees  
43 submitting the suggestion or innovation to an agency coordinator. The agency coordinator, in  
44 conjunction with an agency evaluator, shall review the suggestion or innovation for submission  
45 to the State Review Committee established in G.S. 143-345.24.

46 (b) An agency coordinator shall be appointed by the head of each participating agency  
47 to serve as liaison between the agency, the suggester, the agency evaluator, and the SEIBP  
48 NC-Thinks office. The duties of the agency coordinator shall include:

49 (1) Serving as an information source and maintaining sufficient forms necessary  
50 to submit suggestions.

- 1 (2) Presenting, in conjunction with the agency evaluator, the recommendation  
2 for an award to the State Suggestion Review Committee.
- 3 (3) Working in conjunction with the agency evaluator to process a particular  
4 suggestion or innovation within 180 days, except when there are extenuating  
5 circumstances.

6 An agency may have more than one coordinator if required to provide sufficient services to  
7 State employees.

8 (c) An agency evaluator shall be designated by the management of the implementing  
9 agency to evaluate one or more suggestions. The duties of an agency evaluator shall include:

- 10 (1) Receiving from the agency coordinator and reviewing within 90 days, when  
11 possible, the feasibility and effectiveness of cost-saving or  
12 revenue-increasing measures suggested by State employees.
- 13 (2) Being knowledgeable of the subject program, activity, or service.
- 14 (3) Determining, in conjunction with the agency fiscal officer, the budgetary  
15 impact of a suggestion or innovation.
- 16 (4) Judging impartially both the positive and negative effects of a suggestion or  
17 innovation on the current functions of the subject program, activity, or  
18 service.

19 (d) The executive secretary shall be responsible for general oversight and coordination  
20 of the ~~State Employee Incentive Bonus Program-NC-Thinks~~. The State coordinator shall be an

- 29 (2) A representative of the Office of State Budget and Management.
- 30 (3) A representative of the Office of State Personnel.
- 31 (4) A representative of The University of North Carolina.
- 32 (5) A representative of the Department of Justice.
- 33 (6) A representative of the Department of Labor.
- 34 (7) One State employee appointed by the Speaker of the House of  
35 Representatives.
- 36 (8) One State employee appointed by the President Pro Tempore of the Senate.

5 State. By January 1, 2002, the Office of State Personnel shall establish a policy regarding

7 (b) Decisions regarding the award of bonuses by the agency coordinator and the State

22 "e. The transferee, an agent of the transferee, or others acting in concert  
23 with the transferee are engaged in the business of foreclosure rescue  
24 transactions. For purposes of this section 'engaged in the business of  
25 foreclosure rescue transactions' means arranging, controlling, either  
26 directly or indirectly, or otherwise participating in more than one  
27 foreclosure rescue transaction in a five-year period."

28 **SECTION 15.(b)** If Senate Bill 1015, 2009 Regular Session, becomes law, then  
29 G.S. 75-122, as enacted by Section 2 of Senate Bill 1015, reads as rewritten:

30 "**§ 75-122. Remedies.**

31 A violation of G.S. 75-121 is an unfair trade practice under G.S. 75-1.1, G.S. 75-1.1,  
32 provided that the failure of the transferee to obtain an appraisal shall not, by itself, be a  
33 violation of G.S. 75-121 where there is clear and convincing evidence that the purchase price  
34 exceeded fifty percent (50%) of the fair market value of the property. A homeowner may bring  
35 an action for the recovery of damages, to void a prohibited foreclosure rescue transaction, as  
36 well as for declaratory or equitable relief for a violation of this Article. The provisions of this  
37 section shall not be enforceable against a bona fide purchaser for value. The rights and  
38 remedies provided herein are cumulative to, and not a limitation of, any other rights and  
39 remedies provided by law or equity. Nothing in this Chapter shall be construed to subject an  
40 individual homeowner selling his or her primary residence to liability under G.S. 75-1.1."

41 **SECTION 15.(c)** This section becomes effective October 1, 2010, and applies to  
42 transactions entered on or after that date.

43 **SECTION 16.** Except as otherwise provided, this act is effective when it becomes  
44 law.
