A BILL TO BE ENTITLED

AN ACT TO REQUIRE THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO PROVIDE LAW ENFORCEMENT OFFICERS AND AGENCIES WITH ANY INFORMATION REQUESTED FOR THE PURPOSE OF LOCATING INDIVIDUALS THAT ARE RECEIVING ANY SERVICES FROM THE DEPARTMENT AND FOR WHOM LAW ENFORCEMENT HAS AN ACTIVE INVESTIGATION OR ANY OUTSTANDING CRIMINAL PROCESS ISSUED BY A JUDICIAL OFFICIAL.

**SECTION 1.** Article 18 of Chapter 15A of the General Statutes is amended by adding a new section to read:

"Article 18.

## "Identification Documents.

## "§ 15A-306. Department of Health and Human Services to provide personal identification information for service recipients to law enforcement for investigative purposes.

- (a) The Department of Health and Human Services, and any division thereof, shall provide personal identification information of individuals receiving any service or benefits from the Department of Health and Human Services or any of its divisions when requested in writing, on a form developed by the Department of Health and Human Services, by a law enforcement agency or officer which states the information being requested is to further an investigation or to locate a fugitive. The information requested by a law enforcement agency or officer shall be limited to the following information about the individual:
  - (1) Full name.
  - (2) Date of birth.
  - (3) Social security number.
  - (4) Addresses on file, including past and present if known.
  - (5) Phone numbers on file, including past and present if known.
    - (6) Name of any immediate family member(s), if known.
    - (7) <u>Immediate family members' addresses and phone numbers, including past and present if known.</u>
- Information prohibited by federal law from being released shall not be subject to disclosure pursuant to this section.
- (b) For the purposes of this section, the term immediate family includes wife, husband, mother, father, brother, sister, son, daughter, grandmother, grandfather, grandson, and
