A BILL TO BE ENTITLED

AN ACT TO REPEAL THE REQUIREMENT THAT MOTOR VEHICLES REGISTERED IN THIS STATE HAVE AN ANNUAL SAFETY INSPECTION, TO ELIMINATE THE REQUIREMENT THAT WINDOW TINTING BE INSPECTED AT AN INSPECTION STATION BY A LICENSED SAFETY INSPECTOR, TO ELIMINATE THE AFFIRMATIVE DEFENSE TO AN UNSAFE TIRES CHARGE, TO ELIMINATE THE REQUIREMENT THAT A VEHICLE BE SUBJECT TO A SAFETY INSPECTION BEFORE A CHARGE FOR TINTED WINDOWS MAY BE MADE, TO DEVELOP AND IMPLEMENT A MANAGEMENT IMPROVEMENT PLAN FOR THE MOTOR VEHICLE EMISSIONS INSPECTION PROGRAM, ADMINISTERED BY THE DIVISION OF MOTOR VEHICLES, WHICH WILL INCREASE EFFICIENCY, REDUCE COSTS, AND IMPROVE CUSTOMER SERVICE, AND TO REQUIRE THE FISCAL RESEARCH DIVISION OF THE GENERAL ASSEMBLY TO CONDUCT A FISCAL REVIEW OF THE DIVISION OF MOTOR VEHICLES EMISSIONS INSPECTION PROGRAM, AS RECOMMENDED BY THE JOINT LEGISLATIVE PROGRAM EVALUATION OVERSIGHT COMMITTEE BASED ON RECOMMENDATIONS FROM THE PROGRAM EVALUATION DIVISION.

The General Assembly of North Carolina enacts:

SECTION 1. Article 3A of Chapter 20 of the General Statutes reads as rewritten:

"Article 3A.

"Safety and Emissions Inspection Program.

"Part 1. Safe Use of Streets and Highways.

"§ 20-183.1: Repealed by Session Laws 1993 (Reg. Sess., 1994), c. 754, s. 3.

"Part 2. ~~Safety and Emissions Inspections of Certain Vehicles.~~

"§ 20-183.2. Description of vehicles subject to ~~safety or emissions inspection~~; definitions.

(a) ~~Safety.~~—A motor vehicle is subject to a safety inspection in accordance with this Part if it meets all of the following requirements:

(1) It is subject to registration with the Division under Article 3 of this Chapter.

(2) It is not subject to inspection under 49 C.F.R. Part 396, the federal Motor Carrier Safety Regulations.

(3) It is not a trailer whose gross weight is less than 4,000 pounds or a house trailer.

(a1) ~~Safety Inspection Exceptions.~~—The following vehicles shall not be subject to a safety inspection pursuant to this Article:

(1) Historic vehicles, as defined in G.S. 20-79.4(b)(63).

- 1 (2) ~~Buses titled to a local board of education and subject to the school bus~~
2 ~~inspection requirements specified by the State Board of Education and~~
3 ~~G.S. 115C-248.~~
- 4 (b) ~~Emissions.~~Emissions Inspections. – A motor vehicle is subject to an emissions
5 inspection in accordance with this Part if it meets all of the following requirements:
- 6 (1) It is subject to registration with the Division under Article 3 of this Chapter,
7 except for motor vehicles operated on a federal installation as provided in
8 sub-subdivision e. of subdivision (5) of this subsection.
- 9 (2) It is not a trailer whose gross weight is less than 4,000 pounds, a house
10 trailer, or a motorcycle.
- 11 (3) **(Effective until January 1, 2014 or until contingency met – see Editor's**
12 **note)** It is a 1996 or later model.
- 13 (3) **(For delayed effective date, see Editor's note)** It is (i) a 1996 or later
14 model and older than the three most recent model years or (ii) a 1996 or later
15 model and has 70,000 miles or more on its odometer.
- 16 (4) Repealed by Session Laws 1999-328, s. 3.11, effective July 21, 1999.
- 17 (5) It meets any of the following descriptions:
- 18 a. It is required to be registered in an emissions county.
- 19 b. It is part of a fleet that is operated primarily in an emissions county.
- 20 c. It is offered for rent in an emissions county.
- 21 d. It is a used vehicle offered for sale by a dealer in an emissions
22 county.
- 23 e. It is operated on a federal installation located in an emissions county
24 and it is not a tactical military vehicle. Vehicles operated on a federal
25 installation include those that are owned or leased by employees of
26 the installation and are used to commute to the installation and those
27 owned or operated by the federal agency that conducts business at
28 the installation.
- 29 f. It is otherwise required by 40 C.F.R. Part 51 to be subject to an
30 emissions inspection.
- 31 (6) It is not licensed at the farmer rate under G.S. 20-88(b).
- 32 (7) It is not a new motor vehicle, as defined in G.S. 20-286(10)a. and has been a
33 used motor vehicle, as defined in G.S. 20-286(10)b., for 12 months or more.
34 However, a motor vehicle that has been leased or rented, or offered for lease
35 or rent, is subject to an emissions inspection when it either:
- 36 a. Has been leased or rented, or offered for lease or rent, for 12 months
37 or more.
- 38 b. Is sold to a consumer-purchaser.
- 39 (8) It is not a privately owned, nonfleet motor home or house car, as defined in
40 G.S. 20-4.01(27)d2., that is built on a single chassis, has a gross vehicle
41 weight of more than 10,000 pounds, and is designed primarily for
42 recreational use.
- 43 (9) It is not a plug-in electric vehicle as defined in G.S. 20-4.01(28a).
- 44 (10) It is not a fuel cell electric vehicle as defined in G.S. 20-4.01(12a).
- 45 (c) Definitions. – The following definitions apply in this Part:
- 46 (1) Electronic inspection authorization. – An inspection authorization that is
47 generated electronically through the electronic accounting system that
48 creates a unique nonduplicating authorization number assigned to the
49 vehicle's inspection receipt upon successful passage of an inspection. The
50 term "electronic inspection authorization" shall include the term "inspection

1 sticker" during the transition period to use of electronic inspection
2 authorizations.

3 (2) Emissions county. – A county listed in G.S. 143-215.107A(c) and certified
4 to the Commissioner of Motor Vehicles as a county in which the
5 implementation of a motor vehicle emissions inspection program will
6 improve ambient air quality.

7 (3) Federal installation. – An installation that is owned by, leased to, or
8 otherwise regularly used as the place of business of a federal agency.

9 **"§ 20-183.3. Scope of safety inspection and an emissions inspection.**

10 (a) ~~Safety. — A safety inspection of a motor vehicle consists of an inspection of the~~
11 ~~following equipment to determine if the vehicle has the equipment required by Part 9 of Article~~
12 ~~3 of this Chapter and if the equipment is in a safe operating condition:~~

13 (1) ~~Brakes, as required by G.S. 20-124.~~

14 (2) ~~Lights, as required by G.S. 20-129 or G.S. 20-129.1.~~

15 (3) ~~Horn, as required by G.S. 20-125(a).~~

16 (4) ~~Steering mechanism, as required by G.S. 20-123.1.~~

17 (5) ~~Windows and windshield wipers, as required by G.S. 20-127. To determine~~
18 ~~if a vehicle window meets the window tinting restrictions, a safety~~
19 ~~inspection mechanic must first determine, based on use of an automotive~~
20 ~~film check card or knowledge of window tinting techniques, if after factory~~
21 ~~tint has been applied to the window. If after factory tint has been applied, the~~
22 ~~mechanic must use a light meter approved by the Commissioner to~~
23 ~~determine if the window meets the window tinting restrictions.~~

24 (6) ~~Directional signals, as required by G.S. 20-125.1.~~

25 (7) ~~Tires, as required by G.S. 20-122.1.~~

27 (9) ~~Exhaust system and emissions control devices, as required by G.S. 20-128.~~
28 ~~For a vehicle that is subject to an emissions inspection in addition to a safety~~
29 ~~inspection, a visual inspection of the vehicle's emissions control devices is~~
30 ~~included in the emissions inspection rather than the safety inspection.~~

32 (b1) Emissions. – An emissions inspection of a motor vehicle consists of a visual
33 inspection of the vehicle's emissions control devices to determine if the devices are present, are
34 properly connected, and are the correct type for the vehicle and an analysis of data provided by
35 the on-board diagnostic (OBD) equipment installed by the vehicle manufacturer to identify any
36 deterioration or malfunction in the operation of the vehicle that violates standards for the model
37 year of the vehicle set by the Environmental Management Commission. To pass an emissions
38 inspection a vehicle must pass both the visual inspection and the OBD analysis. ~~When an~~
39 ~~emissions inspection is performed on a vehicle, a safety inspection must be performed on the~~
40 ~~vehicle as well.~~

41 (c) Reinspection After Failure. – The scope of a reinspection of a vehicle that has been
42 repaired after failing an inspection is the same as the original inspection unless the vehicle is
43 presented for reinspection within 60 days of failing the original inspection. ~~If the vehicle is~~
44 ~~presented for reinspection within this time limit and the inspection the vehicle failed was a~~
45 ~~safety inspection, the reinspection is limited to an inspection of the equipment that failed the~~
46 ~~original inspection.~~ ~~If the vehicle is presented for reinspection within this time limit and the~~
47 ~~inspection the vehicle failed was an emissions inspection, limit, the reinspection is limited to the~~
48 ~~portion of the inspection the vehicle failed and any other portion of the inspection that would be~~
49 ~~affected by repairs made to correct the failure.~~

50 **"§ 20-183.4. License required to perform safety inspection; qualifications for license.**

1 (a) ~~License Required.~~—A safety inspection must be performed by one of the following
2 methods:

3 (1) ~~At a station that has a safety inspection station license issued by the Division~~
4 ~~and by a mechanic who is employed by the station and has a safety~~
5 ~~inspection mechanic license issued by the Division.~~

6 (2) ~~At a place of business of a person who has a safety self-inspector license~~
7 ~~issued by the Division and by an individual who has a safety inspection~~
8 ~~mechanic license issued by the Division.~~

9 (b) ~~Station Qualifications.~~—An applicant for a license as a safety inspection station
10 must meet all of the following requirements:

11 (1) ~~Have a place of business that has adequate facilities, space, and equipment to~~
12 ~~conduct a safety inspection. A place of business designated in a station~~
13 ~~license that has been suspended or revoked cannot be the designated place~~
14 ~~for any other license applicant during the period of the suspension or~~
15 ~~revocation, unless the Division finds that operation of the place of business~~
16 ~~as an inspection station during this period by the license applicant would not~~
17 ~~defeat the purpose of the suspension or revocation because the license~~
18 ~~applicant has no connection with the person whose license was suspended or~~
19 ~~revoked or because of another reason. A finding made by the Division under~~
20 ~~this subdivision must be set out in a written statement that includes the~~
21 ~~finding and the reason for the finding.~~

22 (2) ~~Regularly employ at least one mechanic who has a safety inspection~~
23 ~~mechanic license.~~

24 (3) ~~Designate the individual who will be responsible for the day-to-day~~
25 ~~operation of the station. The individual designated must be of good character~~
26 ~~and have a reputation for honesty.~~

27 (4) ~~Have equipment and software approved by the Division to transfer~~
28 ~~information on safety inspections to the Division by electronic means.~~
29 ~~During the initial implementation of the electronic inspection process, the~~
30 ~~vendor selected by the Division shall provide the equipment and software at~~
31 ~~no cost to a station that holds a license on October 1, 2008.~~

32 (c) ~~Mechanic Qualifications.~~—An applicant for a license as a safety inspection
33 mechanic must meet all of the following requirements:

34 (1) ~~Have successfully completed an eight-hour course approved by the Division~~
35 ~~that teaches students about the safety equipment a motor vehicle is required~~
36 ~~to have to pass a safety inspection and how to conduct a safety inspection~~
37 ~~using equipment to electronically transmit the vehicle information and~~
38 ~~inspection results.~~

39 (2) ~~Have a drivers license.~~

40 (3) ~~Be of good character and have a reputation for honesty.~~

41 (d) ~~Self-Inspector Qualifications.~~—An applicant for a license as a safety self-inspector
42 must meet all of the following requirements:

43 (1) ~~Operate a fleet of at least 10 vehicles that are subject to a safety inspection.~~

44 (2) ~~Regularly employ or contract with an individual who has a safety inspection~~
45 ~~mechanic license and who will perform a safety inspection on the vehicles~~
46 ~~that are part of the self-inspector's fleet.~~

47 **"§ 20-183.4A. License required to perform emissions inspection; qualifications for**
48 **license.**

49 (a) License Required. – An emissions inspection must be performed by one of the
50 following methods:

- 1 (1) At a station that has an emissions inspection station license issued by the
2 Division and by a mechanic who is employed by the station and has an
3 emissions inspection mechanic license issued by the Division.
- 4 (2) At a place of business of a person who has an emissions self-inspector
5 license issued by the Division and by an individual who has an emissions
6 inspection mechanic license.
- 7 (b) Station Qualifications. – An applicant for a license as an emissions inspection
8 station must meet all of the following requirements:
- 9 ~~(1) Have a license as a safety inspection station.~~
- 10 (2) Repealed by Session Law 2000-134, s. 15, effective January 1, 2006.
- 11 (2a) Have equipment to analyze data provided by the on-board diagnostic (OBD)
12 equipment approved by the Environmental Management Commission.
- 13 (3) Have equipment and software to transfer information on emissions
14 inspections to the Division by electronic means. During the initial
15 implementation of the electronic inspection process, the vendor selected by
16 the Division shall provide the software at no cost to a station that holds a
17 license on October 1, 2008.
- 18 (4) Regularly employ at least one mechanic who has an emissions inspection
19 mechanic license.
- 20 (c) Mechanic Qualifications. – An applicant for a license as an emissions inspection
21 mechanic must meet all of the following requirements:
- 22 ~~(1) Have a license as a safety inspection mechanic.~~
- 23 (2) Repealed by Session Law 2000-134, s. 15, effective January 1, 2006.
- 24 (2a) Have successfully completed an eight-hour course approved by the Division
25 that teaches students about the causes and effects of the air pollution
26 problem, the purpose of the emissions inspection program, the vehicle
27 emission standards established by the United States Environmental
28 Protection Agency, the emission control devices on vehicles, how to conduct
29 an emissions inspection using equipment to analyze data provided by the
30 on-board diagnostic (OBD) equipment approved by the Environmental
31 Management Commission, and any other topic required by 40 C.F.R. §
32 51.367 to be included in the course. Successful completion requires a
33 passing score on a written test and on a hands-on test in which the student is
34 required to conduct an emissions inspection of a motor vehicle.
- 35 (d) Self-Inspector Qualifications. – An applicant for a license as an emissions
36 self-inspector must meet all of the following requirements:
- 37 ~~(1) Have a license as a safety self-inspector.~~
- 38 (2) Operate a fleet of at least 10 vehicles that are subject to an emissions
39 inspection.
- 40 (3) Repealed by Session Law 2000-134, s. 15, effective January 1, 2006.
- 41 (3a) Have, or have a contract with a person who has, equipment to analyze data
42 provided by the on-board diagnostic (OBD) equipment approved by the
43 Environmental Management Commission.
- 44 (4) Regularly employ or contract with an individual who has an emissions
45 inspection mechanic license and who will perform an emissions inspection
46 on the vehicles that are part of the self-inspector's fleet.

47 **"§ 20-183.4B. Application for license; duration of license; renewal of mechanic license.**

- 48 (a) Application. – An applicant for a license issued under this Part must complete an
49 application form provided by the Division. The application must contain the applicant's name
50 and address and any other information needed by the Division to determine whether the
51 applicant is qualified for the license. The Division must review an application for a license to

1 determine if the applicant qualifies for the license. If the applicant meets the qualifications, the
2 Division must issue the license. If the applicant does not meet the qualifications, the Division
3 must deny the application and notify the applicant in writing of the reason for the denial.

4 (b) Duration of License. – ~~A safety inspection mechanic license expires four years after~~
5 ~~the date it is issued.~~ An emissions mechanic inspection license expires two years after the date
6 it is issued. ~~A safety inspection station license, an~~ An emissions inspection station
7 ~~license,~~ license and a self-inspector license are effective until surrendered by the license holder
8 or suspended or revoked by the Division.

9 (c) Renewal of Mechanic License. – ~~A safety or an~~ An emissions inspection mechanic
10 may apply to renew a license by filing an application with the Division on a form provided by
11 the Division. To renew an emissions inspection mechanic license, an applicant must have
12 successfully completed a four-hour emissions refresher course approved by the Division within
13 nine months of applying for renewal. Successful completion requires a passing score on a
14 written test and on a hands-on test in which the student is required to conduct an emissions
15 inspection of a motor vehicle.

16 **"§ 20-183.4C. When a vehicle must be inspected; 10-day trip permit.**

17 (a) Inspection. – A vehicle that is subject to ~~a safety inspection,~~ an emissions
18 ~~inspection, or both~~ inspection must be inspected as follows:

- 19 (1) A new vehicle must be inspected before it is sold at retail in this State. Upon
20 purchase, a receipt approved by the Division must be provided to the new
21 owner certifying compliance.
- 22 (1a) A new motor vehicle dealer who is also licensed pursuant to this Article
23 may, notwithstanding subdivision (1) of this section, examine the ~~safety and~~
24 emissions control devices on a new motor vehicle and perform such services
25 necessary to ensure the motor vehicle conforms to the required specifications
26 established by the manufacturer and contained in its predelivery check list.
27 The completion of the predelivery inspection procedure required or
28 recommended by the manufacturer on a new motor vehicle shall constitute
29 the inspection required by subdivision (1) of this section. For the purposes of
30 this subdivision, the date of inspection shall be deemed to be the date of the
31 sale of the motor vehicle to a purchaser.
- 32 (2) A used vehicle must be inspected before it is offered for sale at retail in this
33 State by a dealer. Upon purchase, a receipt approved by the Division must be
34 provided to the new owner certifying compliance.
- 35 (3) Repealed by Session Law 2007-503, s. 5, effective October 1, 2008.
- 36 (4) Except as authorized by the Commissioner for a single period of time not to
37 exceed 12 months from the initial date of registration, a new or used vehicle
38 acquired by a resident of this State from outside the State must be inspected
39 before the vehicle is registered with the Division.
- 40 (5) Except as authorized by the Commissioner for a single period of time not to
41 exceed 12 months from the initial date of registration, a vehicle owned by a
42 new resident of this State who transfers the registration of the vehicle from
43 the resident's former home state to this State must be inspected before the
44 vehicle is registered with the Division.
- 45 (5a) Repealed by Session Law 2007-503, s. 5, effective October 1, 2008.
- 46 (6) A vehicle that has been inspected in accordance with this Part must be
47 inspected by the last day of the month in which the registration on the
48 vehicle expires.
- 49 (7) A vehicle that is required to be inspected in accordance with this Part may be
50 inspected 90 days prior to midnight of the last day of the month as
51 designated by the vehicle registration sticker.

1 (8) A new or used vehicle acquired from a retailer or a private sale in this State
2 and registered with the Division with a new registration or a transferred
3 registration must be inspected in accordance with this Part when the current
4 registration expires unless it has received a passing inspection within the
5 previous 12 months.

6 (9) Repealed by Session Laws 2010-97, s. 3, effective July 20, 2010.

7 (10) An unregistered vehicle may be registered with the Division in accordance
8 with G.S. 20-50(b) for a period not to exceed 10 days prior to the vehicle
9 receiving a passing inspection in accordance with this Part.

10 (11) A person who owns a vehicle located outside of this State when its
11 emissions inspection becomes due may obtain an emissions inspection in the
12 jurisdiction where the vehicle is located, in lieu of a North Carolina
13 emissions inspection, as long as the inspection meets the requirements of 40
14 C.F.R. § 51.

15 (b) Permit. – The Division may issue a 10-day trip permit to a person that authorizes the
16 person to drive a vehicle whose inspection authorization or registration has expired. The permit
17 may only be issued when the person has furnished proof of financial responsibility. The permit
18 must describe the vehicle whose inspection authorization or registration has expired. The
19 permit authorizes the person to drive the described vehicle for a period not to exceed 10 days
20 from the date of issuance.

21 (c) Exemption. – The Division may issue a temporary exemption from the inspection
22 requirements of this Article for any vehicle that has been determined by the Division to be
23 principally garaged, as defined under G.S. 58-37-1(11), in this State and is primarily operated
24 outside a county subject to emissions inspection requirements or outside of this State.

25 **"§ 20-183.4D. Procedure when a vehicle is inspected.**

26 (a) Receipt. – ~~When a safety inspection mechanic or an emissions inspection mechanic~~ inspects a vehicle, the mechanic must give the person who brought the vehicle in for inspection
27 an inspection receipt. The inspection receipt must state the date of the inspection, identify the
28 mechanic performing the inspection, identify the station or self-inspector where the inspection
29 was performed, and list the components of the inspection performed and indicate for each
30 component whether the vehicle passed or failed. A vehicle that fails a component of an
31 inspection may be repaired at any repair facility chosen by the owner or operator of the vehicle.

32 (b) Electronic Inspection Authorization. – ~~When a vehicle that is subject to a safety~~
33 ~~inspection only passes the safety inspection, the safety inspection mechanic who performed the~~
34 ~~inspection must issue an electronic inspection authorization to the vehicle at the place~~
35 ~~designated by the Division.~~ When a vehicle that is subject to both a safety inspection and an
36 emissions inspection passes both inspections or passes the safety inspection and/or has a waiver
37 for the emissions inspection, the emissions mechanic performing the inspection must issue an
38 electronic inspection authorization to the vehicle at the place designated by the Division.

39 (c), (d) Repealed by Session Law 2007-503, s. 6, effective October 1, 2008.

40 (e) When Electronic Inspection Authorization Expires. – An electronic inspection
41 authorization issued under this Part expires at midnight of the last day of the month designated
42 by the vehicle registration sticker of the following year.

43 **"§ 20-183.5. When a vehicle that fails an emissions inspection may obtain a waiver from**
44 **the inspection requirement.**

45 (a) Requirements. – The Division may issue a waiver for a vehicle, excluding a vehicle
46 owned or being held for retail sale by a motor vehicle dealer, that meets all of the following
47 requirements:

48 (1) Fails an emissions inspection because it passes the visual inspection but fails
49 the analysis of data provided by the on-board diagnostic (OBD) equipment.
50

- 1 (2) Has documented repairs costing at least the waiver amount made to the
2 vehicle to correct the cause of the failure. The waiver amount is two hundred
3 dollars (\$200.00).
- 4 (3) Is reinspected and again fails the inspection because it passes the visual
5 inspection but fails the analysis of data provided by the on-board diagnostic
6 (OBD) equipment.
- 7 (4) Meets any other waiver criteria required by 40 C.F.R. § 51.360, or as
8 designated by the Division.

9 (b) Procedure. – To obtain a waiver, a person must contact a local enforcement office of
10 the Division. Before issuing a waiver, an employee of the Division must review the inspection
11 receipts issued for the inspections of the vehicle, review the documents establishing what
12 repairs were made to the vehicle and at what cost, review any statement denying warranty
13 coverage of the repairs made, and do a visual inspection of the vehicle, if appropriate, to
14 determine if the documented repairs were made. The Division must issue a waiver if it
15 determines that the vehicle qualifies for a waiver. A person to whom a waiver is issued must
16 present the waiver to the self-inspector or inspection station performing the inspection to obtain
17 an electronic inspection authorization.

18 (c) Repairs. – The following repairs and their costs cannot be considered in determining
19 whether the cost of repairs made to a vehicle equals or exceeds the waiver amount:

- 20 (1) Repairs covered by a warranty that applies to the vehicle.
- 21 (2) Repairs needed as a result of tampering with an emission control device of
22 the vehicle.
- 23 (3) Repairs made by an individual who is not professionally engaged in the
24 business of repairing vehicles.
- 25 (4) OBD diagnostics without corresponding repairs.

26 (d) Electronic Inspection Authorization. – An electronic inspection authorization issued
27 to a vehicle after the vehicle receives a waiver from the requirement of passing the emissions
28 inspection expires at the same time it would if the vehicle had passed the emissions inspection.

29 ~~"§ 20-183.5A. When a vehicle that fails a safety inspection because of missing emissions
30 control devices may obtain a waiver.~~

31 ~~(a) Requirements. The Division may issue a waiver for a vehicle that meets all of the

(c) Fee Distribution. – Fees collected for electronic inspection authorizations are payable to the Division of Motor Vehicles. 28 of the emissions inspection program. A technical violation is a violation that is not a serious
29 violation, a minor violation, or another type of offense under this Part.

30 (b) Penalty Schedule. – The Division must take the following action for a violation:

- 31 (1) Type I. – For a first or second Type I violation by an emissions
32 self-inspector or an emissions inspection station, assess a civil penalty of two
33 hundred fifty dollars (\$250.00) and suspend the license of the business for
34 six months. For a third or subsequent Type I violation within three years by
35 an emissions self-inspector or an emissions inspection station, assess a civil
36 penalty of one thousand dollars (\$1,000) and revoke the license of the
37 business for two years.

38 For a first or second Type I violation by an emissions inspection
39 mechanic, assess a civil penalty of one hundred dollars (\$100.00) and
40 suspend the mechanic's license for six months. For a third or subsequent
41 Type I violation within seven years by an emissions inspection mechanic,
42 assess a civil penalty of two hundred fifty dollars (\$250.00) and revoke the
43 mechanic's license for two years.

- 44 (2) Type II. – For a first or second Type II violation by an emissions
45 self-inspector or an emissions inspection station, assess a civil penalty of one
46 hundred dollars (\$100.00). For a third or subsequent Type II violation within
47 three years by an emissions self-inspector or an emissions inspection station,
48 assess a civil penalty of two hundred fifty dollars (\$250.00) and suspend the
49 license of the business for 90 days.

50 For a first or second Type II violation by an emissions inspection
51 mechanic, assess a civil penalty of fifty dollars (\$50.00). For a third or

1 subsequent Type II violation within seven years by an emissions inspection
2 mechanic, assess a civil penalty of one hundred dollars (\$100.00) and
3 suspend the mechanic's license for 90 days.

- 4 (3) Type III. – For a first or second Type III violation by an emissions
5 self-inspector, an emissions inspection station, or an emissions inspection
6 mechanic, send a warning letter. For a third or subsequent Type III violation
7 within three years by the same emissions license holder, assess a civil
8 penalty of twenty-five dollars (\$25.00).

9 (c) Station or Self-Inspector Responsibility. – It is the responsibility of an emissions
10 inspection station and an emissions self-inspector to supervise the emissions mechanics it
11 employs. A violation by an emissions inspector mechanic is considered a violation by the
12 station or self-inspector for whom the mechanic is employed.

13 (d) Missing Stickers. – The Division must assess a civil penalty against an emissions
14 inspection station, a windshield replacement station, or an emissions self-inspector that cannot
15 account for an emissions inspection sticker issued to it. A station or a self-inspector cannot
16 account for a sticker when the sticker is missing and the station or self-inspector cannot
17 establish reasonable grounds for believing the sticker was stolen or destroyed by fire or another
18 accident.

19 (d1) Penalty for Missing Stickers. – The amount of the penalty is twenty-five dollars
20 (\$25.00) for each missing sticker. If a penalty is imposed under subsection (b) of this section as
21 the result of missing stickers, the monetary penalty that applies is the higher of the penalties
22 required under this subsection and subsection (b); the Division may not assess a monetary
23 penalty as a result of missing stickers under both this subsection and subsection (b) of this
24 section. Imposition of a monetary penalty under this subsection does not affect suspension or
25 revocation of a license required under subsection (b) of this section.

26 (e) Mechanic Training. – An emissions inspection mechanic whose license has been
27 suspended or revoked must retake the course required under G.S. 20-183.4A and successfully
28 complete the course before the mechanic's license can be reinstated. Failure to successfully
29 complete this course continues the period of suspension or revocation until the course is
30 completed successfully.

48 passed the inspection or for which the vehicle received a waiver.
49 (5) Be unable to account for five or more electronic inspection authorizations at
50 any one time upon the request of an auditor of the Division.

- 1 (6) ~~Perform a safety-only inspection on a vehicle that is subject to both a safety~~
2 ~~and an emissions inspection.~~
- 3 (7) Transfer an electronic inspection authorization from one vehicle to another.
- 4 (b) Type II. – It is a Type II violation for an emissions self-inspector, an emissions
5 inspection station, or an emissions inspection mechanic to do any of the following:
- 6 (1) Use the identification code of another to gain access to an emissions
7 analyzer or to equipment to analyze data provided by on-board diagnostic
8 (OBD) equipment.
- 9 (2) Keep compliance documents in a manner that makes them easily accessible
10 to individuals who are not inspection mechanics.
- 11 (3) Issue ~~a safety electronic inspection authorization~~ or an emissions electronic
12 inspection authorization on a vehicle that is required to have one of the
13 following emissions control devices but does not have it:
- 14 a. Catalytic converter.
- 15 b. PCV valve.
- 16 c. Thermostatic air control.
- 17 d. Oxygen sensor.
- 18 e. Unleaded gas restrictor.
- 19 f. Gasoline tank cap.
- 20 g. Air injection system.
- 21 h. Evaporative emissions system.
- 22 i. Exhaust gas recirculation (EGR) valve.
- 23 (4) Issue ~~a safety electronic inspection authorization~~ or an emissions electronic
24 inspection authorization on a vehicle without performing a visual inspection
25 of the vehicle's exhaust system and checking the exhaust system for leaks.

- 39 (d) Other Acts. – The lists in this section of the acts that are Type I, Type II, or Type III
40 violations are not the only acts that are one of these types of violations. The Division may
41 designate other acts that are a Type I, Type II, or Type III violation.
- 42 **"§ 20-183.8D. Suspension or revocation of license.**
- 43 (a) ~~Safety. — The Division may suspend or revoke a safety self-inspector license, a~~
44 ~~safety inspection station license, and a safety inspection mechanic license issued under this Part~~
45 ~~if the license holder fails to comply with this Part or a rule adopted by the Commissioner to~~
46 ~~implement this Part.~~
- 47 (b) Emissions. – The Division may suspend or revoke an emissions self-inspector
48 license, an emissions inspection station license, and an emissions inspection mechanic license
49 issued under this Part for any of the following reasons:
- 50 (1) The suspension or revocation is imposed under G.S. 20-183.8B.

1 (2) Failure to pay a civil penalty imposed under G.S. 20-183.8B within 30 days
2 after it is imposed.

5 **summary action.**

7 (b) Notice of Charges. – When the Division decides to charge an inspection station, a
8 self-inspector, or a mechanic with a violation that could result in the suspension or revocation
9 of the person's license, the Division must deliver a written statement of the charges to the
10 affected license holder. The statement of charges must inform the license holder of the right to
11 request a hearing, instruct the person on how to obtain a hearing, and inform the license holder
12 of the effect of not requesting a hearing. The license holder has the right to a hearing before the
13 license is suspended or revoked. G.S. 20-183.8G sets out the procedure for obtaining a hearing.

14 (c) Exception for Summary Action. – The right granted by subsection (b) of this section
15 to have a hearing before a license is suspended or revoked does not apply if the Division
16 summarily suspends or revokes the license after a judge has reviewed and authorized the
17 proposed action. A license issued to an inspection station, a self-inspector, or a mechanic is a

41 make the request to the Division within 10 days after receiving the statement of the charges. A
42 person who does not request a hearing within this time limit waives the right to a hearing.

43 The Division must hold a hearing requested under this subsection within 30 days after
44 receiving the request. The hearing must be held at the location designated by the Division.
45 Suspension or revocation of the license is stayed until a decision is made following the hearing.

46 If a person does not request a hearing within the time allowed for making the request, the
47 proposed suspension or revocation becomes effective the day after the time for making the
48 request ends. If a person requests a hearing but does not attend the hearing, the proposed
49 suspension or revocation becomes effective the day after the date set for the hearing.

50 (c) Hearing After Summary Action. – When the Division summarily suspends a license
51 issued under this Part after judicial review and authorization of the proposed action, the person

1 whose license was suspended or revoked may obtain a hearing by filing with the Division a
2 written request for a hearing. The request must be filed within 10 days after the person was
3 notified of the summary action. The Division must hold a hearing requested under this
4 subsection within 14 days after receiving the request.

5 (d) All Other Hearings. – When this section gives a person the right to a hearing and
6 subsection (b) or (c) of this section does not apply to the hearing, the person may obtain a
7 hearing by filing with the Division a written request for a hearing. The request must be filed
8 within 10 days after the person receives written notice of the action for which a hearing is
9 requested. The Division must hold a hearing within 90 days after the Division receives the
10 request.

11 (e) Review by Commissioner. – The Commissioner may conduct a hearing required
12 under this section or may designate a person to conduct the hearing. When a person designated
13 by the Commissioner holds a hearing and makes a decision, the person who requested the
14 hearing has the right to request the Commissioner to review the decision. The procedure set by
15 the Division governs the review by the Commissioner of a decision made by a person
16 designated by the Commissioner.

17 (f) Decision. – A decision made after a hearing on the imposition of a monetary penalty
18 against a motorist for an emissions violation or on a Type I, II, or III emissions violation by an
19 emissions license holder must uphold any monetary penalty, license suspension, license
20 revocation, or warning required by G.S. 20-183.8A or G.S. 20-183.8B, respectively, if the
21 decision contains a finding that the motorist or license holder committed the act for which the
22 monetary penalty, license suspension, license revocation, or warning was imposed. A decision
23 made after a hearing on any other action may uphold or modify the action.

24 (g) Judicial Review. – Article 4 of Chapter 150B of the General Statutes governs
25 judicial review of an administrative decision made under this section."

(4) Limousine Vehicles. – For-hire passenger vehicles on call or demand which do not solicit passengers indiscriminately for hire between points along streets or highways, shall be taxed at the same rate as for-hire passenger vehicles under G.S. 20-87(1) but shall be issued appropriate registration plates to distinguish such vehicles from taxicabs.

(5) Private Passenger Vehicles. – There shall be paid to the Division annually, as of the first day of January, for the registration and licensing of private passenger vehicles, fees according to the following classifications and schedules:

Private passenger vehicles of not more than fifteen passengers\$28.00
Private passenger vehicles over fifteen passengers.....31.00

Provided, that a fee of only one dollar (\$1.00) shall be charged for any vehicle given by the federal government to any veteran on account of any disability suffered during war so long as such vehicle is owned by the original donee or other veteran entitled to receive such gift under Title 38, section 252, United States Code Annotated.

(6) Private Motorcycles. – The base fee on private passenger motorcycles shall be fifteen dollars (\$15.00); except that when a motorcycle is equipped with an additional form of device designed to transport persons or property, the base fee shall be twenty-two dollars (\$22.00). An additional fee of three dollars (\$3.00) is imposed on each private motorcycle registered under this subdivision in addition to the base fee. The revenue from the additional fee, in addition to any other funds appropriated for this purpose, shall be used to fund the Motorcycle Safety Instruction Program created in G.S. 115D-72.

(7) Dealer License Plates. – The fee for a dealer license plate is the regular fee for each of the first five plates issued to the same dealer and is one-half the regular fee for each additional dealer license plate issued to the same dealer. The "regular fee" is the fee set in subdivision (5) of this section for a private passenger motor vehicle of not more than 15 passengers.

(8) Driveaway Companies. – Any person engaged in the business of driving new motor vehicles from the place of manufacture to the place of sale in this State for compensation shall pay a fee of one-half of the amount that would otherwise be payable under this section for each set of plates.

(9) House Trailers. – In lieu of other registration and license fees levied on house trailers under this section or G.S. 20-88, the registration and license fee on house trailers shall be eleven dollars (\$11.00) for the license year or any portion thereof.

(10) Special Mobile Equipment. – The fee for special mobile equipment for the license year or any part of the license year is two times the fee in subdivision (5) for a private passenger motor vehicle of not more than 15 passengers.

(11) Any vehicle fee determined under this section according to the weight of the vehicle shall be increased by the sum of three dollars (\$3.00) to arrive at the total fee.

(12) Low-Speed Vehicles. – The fee for a low-speed vehicle is the same as the fee for private ~~passengers~~passenger vehicles of not more than 15 passengers.

1 (b) An additional fee of one dollar (\$1.00) is imposed on each vehicle registered under
 2 this section, in addition to the base fee and any other additional fee required. The revenue
 3 derived from this fee shall be distributed as follows:

1 (5) Appropriate allocation of personnel and resources to accomplish program

3 The plan shall meet both federal and State reporting requirements.

4 **SECTION 7.** The Division of Motor Vehicles shall present the management
5 improvement plan for the Motor Vehicle Emissions Inspection program, authorized by Article
6 3A of Chapter 20 of the General Statutes, to the Joint Legislative Transportation Oversight
7 Committee and the Joint Environment and Natural Resources Oversight Committee no later
8 than December 31, 2013. The Division of Motor Vehicles shall report to the Joint Legislative
9 Transportation Oversight Committee annually, not later than January 15 of each year, on the
10 prior fiscal year and include any recommended legislation that will increase efficiency, reduce
11 costs, and improve customer service.

12 **SECTION 8.** The Fiscal Research Division of the General Assembly shall conduct
13 a fiscal review of the Motor Vehicle Emissions Inspection program. The fiscal review shall
14 include:

15 (1) A determination of whether the fees charged for inspections is adequate.

16 (2) An assessment of revenue projections.

17 (3) A determination of whether adjustments need to be made to current
18 inspection fees.

19 (4) A proposal for how inspection fees should be determined.

20 (5) An assessment of how inspection program budgets are planned and what
21 changes are needed to improve efficiency.

22 The Fiscal Research Division of the General Assembly shall report its findings to
23 the Joint Legislative Transportation Oversight Committee, the Joint Environment and Natural
24 Resources Oversight Committee, the Joint Program Evaluation Oversight Committee, and the
25 Program Evaluation Division of the General Assembly no later than May 1, 2014.

26 **SECTION 9.** Sections 1, 2, and 3 of this act become effective October 1, 2013, and
27 apply to motor vehicles inspected or registered on or after that date. The remainder of this act is
28 effective when it becomes law.
