Short Title: Wake Board of Commissioners Vacancies. (Local)

Sponsors: Senators Barringer and Hunt (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT CONCERNING FILLING OF VACANCIES ON THE BOARD OF
3 COMMISSIONERS OF WAKE COUNTY.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. Article 4 of Chapter 153A of the General Statutes is amended by
6 adding a new section to read:

7 "§ 153A-27.2. Vacancies on the board of commissioners in certain counties.

8 (a) This section applies to Wake County only, which is not subject to G.S. 153A-27.

9 (b) If a vacancy occurs on the board of commissioners, the remaining members of the
10 board shall appoint a qualified person to fill the vacancy. If the vacating member was elected as
11 the nominee of a political party, the board of commissioners shall consult the county executive
12 committee of that party before filling the vacancy. The board shall vote on that nomination
13 within 30 days of its submission, and, if it is not approved, the board shall request that county
14 executive committee to submit another name. The board shall vote on that second nomination
15 within 30 days of its submission, and, if it is not approved, the board may appoint any person
16 eligible under subsection (d) of this section. If the remaining board members are unable to fill
17 the vacancy within 30 days of the failure to approve the second nomination and the vacating
18 member was elected as the nominee of a political party, a special primary election shall be
19 called under subsection (e) of this section.

20 (c) If the vacancy occurs later than 90 days before the general election held after the
21 first two years of the term, the appointment to fill the vacancy is for the remainder of the
22 unexpired term. Otherwise, the term of the person appointed to fill the vacancy extends to the
23 first Monday in December next following the first general election held more than 90 days after
24 the day the vacancy occurs; at that general election, a person shall be elected to the seat vacated
25 for the remainder of the unexpired term.

26 (d) To be eligible for appointment to fill a vacancy, a person must (i) be a member of
27 the same political party as the member being replaced, if that member was elected as the
28 nominee of a political party, and (ii) be a resident of the same district as the member being
29 replaced, if the county is divided into electoral districts.

30 (e) If a special primary election is required under subsection (b) of this section, the
31 county board of commissioners shall call that special primary election for the purpose of
32 allowing the members of the party with which the vacating member was affiliated when elected
33 to make a recommendation. The special primary election shall be conducted in accordance with
34 Article 10 of Chapter 163 of the General Statutes, except that the county board of elections
35 may, with the approval of the State Board of Elections, set deadlines for filing notices of
36 candidacy and for absentee voting in the special primary election. The date of the special

1 primary election shall be set by the county board of commissioners but the date shall be
2 governed by G.S. 163-287. Only persons who are affiliated with the party may vote, except that
3 if the party has allowed unaffiliated voters to participate in primary elections of that party under
4 G.S. 163-119 then unaffiliated voters may also participate. No such special primary shall be
5 held, however, if (i) less than 120 days remain in the term of office, or (ii) if the vacancy is
6 being filled for the remainder of the term at the mid-term election under subsection (c) of this
7 section and less than 120 days remain until the date of that election. The county board of
8 commissioners shall immediately upon the certification of the primary returns appoint the
9 winner to serve until the first Monday in December following the next general election which
10 occurs after the date of the vacancy. This subsection applies only if the vacating member was
11 elected as the nominee of a political party.

12 (g) If the number of vacancies on the board is such that a quorum of the board cannot
13 be obtained for any action under this section, the chairman of the board shall appoint enough
14 members to make up a quorum. If the number of vacancies on the board is such that a quorum
15 of the board cannot be obtained and the office of chairman is vacant, the clerk of superior court
16 of the county shall fill the vacancies upon the request of any remaining member of the board or
17 upon the petition of any registered voters of the county."

18 **SECTION 2.** This act is effective when it becomes law but only applies to
19 vacancies occurring on or after that date.
