A BILL TO BE ENTITLED

AN ACT TO MAKE BASE BUDGET APPROPRIATIONS FOR CURRENT OPERATIONS
OF STATE DEPARTMENTS, INSTITUTIONS, AND AGENCIES, AND FOR OTHER
PURPOSES.

The General Assembly of North Carolina enacts:

PART I. INTRODUCTION AND TITLE OF ACT

TITLE OF ACT

SECTION 1.1. This act shall be known as "The Current Operations and Capital
Improvements Appropriations Act of 2014."

INTRODUCTION

SECTION 1.2. The appropriations made in this act are for maximum amounts
necessary to provide the services and accomplish the purposes described in the budget. Savings
shall be effected where the total amounts appropriated are not required to perform these
services and accomplish these purposes and, except as allowed by the State Budget Act, or this
act, the savings shall revert to the appropriate fund at the end of each fiscal year as provided in
G.S. 143C-1-2(b).

SECTION 2.1. Appropriations from the General Fund of the State for the
maintenance of the State departments, institutions, and agencies, and for other purposes as

for the 2014-2015 fiscal year.

 2 rewritten:

4 **"SECTION 2.2.(c)** Notwithstanding the provisions of G.S. 143C-4-3, the State Controller
 5 shall transfer a total of one hundred fifty million dollars (\$150,000,000) from the unreserved
 6 fund balance to the Repairs and Renovations Reserve on June 30, 2013, and a total of ~~twelve~~
 7 ~~million seven hundred fifty one thousand one hundred thirty seven dollars (\$12,751,137)~~
 8 eighty-nine million ninety-eight thousand eight hundred thirty-seven dollars (\$89,098,837) to

 40 I & M Air Pollution Control Account established under G.S. 143-215.3A(b1) shall be credited
 41 to the State's General Fund.

42 **SECTION 2.2.(e)** Notwithstanding G.S. 105-449.125, seven hundred fifty
 43 thousand dollars (\$750,000) of the revenue collected by the Secretary of Revenue from the
 44 motor fuel excise tax levied under Part 7 of Article 36C of Chapter 105 of the General Statutes
 45 that would otherwise be credited to the Water and Air Quality Account shall be credited to the
 46 State's General Fund.

47 **SECTION 2.2.(f)** Notwithstanding G.S. 106-65.104, the unallotted and
 48 unexpended balance of funds in the Bedding Law Account on June 30, 2014, shall be
 49 transferred to the General Fund.

1 **SECTION 2.2.(g)** Notwithstanding any other provision of law, fees collected for
2 e-commerce transactions during the 2014-2015 fiscal year that would have been credited to the
3 Reserve for E-Commerce shall be credited to the State's General Fund.

4 **SECTION 2.2.(h)** Notwithstanding the use requirements provided in Section 2 of
5 S.L. 2003-404, the State Controller shall transfer the sum of two million four hundred thousand
6 dollars (\$2,400,000) from the special trust fund created by S.L. 2003-404 to the General Fund
7 to be used for the purposes expressed and allocated by this act.

8 **SECTION 2.2.(i)** Notwithstanding any other provision of law to the contrary,
9 effective July 1, 2014, the State Controller shall transfer five million two hundred fifty-five

 14 e. Advertising which states a total of payments to be paid over a period
 15 of time shall state the present value of the prize.
 16 f. Advertising which states the probability of winning a prize shall not
 17 omit the value of the lowest prize to be won.
 18 g. Advertising which states the odds of winning a prize must, at a
 19 minimum, disclose the odds of winning the prize with the largest
 20 value.
 21 h. No advertising or sponsorship may take place in connection with any
 22 high school or collegiate sport or high school or collegiate sporting
 23 event.

25 **SECTION 5.2.(e)** G.S. 18C-115 reads as rewritten:

26 **"§ 18C-115. Reports.**

27 (a) Reports on Operation of the Commission. – The Commission shall send quarterly
 28 and annual reports on the operations of the Commission to the Governor, State Treasurer, ~~the~~
 29 ~~Lottery Oversight Committee, the Joint Legislative Oversight Committee on the North Carolina~~
 30 State Lottery, and to the General Assembly. The reports shall include complete statements of
 31 lottery revenues, prize disbursements, expenses, net revenues, and all other financial
 32 transactions involving lottery funds, including the occurrence of any audit.

33 (b) Disclosure of Proceeds from Lottery Funding. – Each State department or agency
 34 receiving lottery funds shall use its established communications channels to inform the public
 35 about amounts received and activities supported by lottery proceeds."

36 **SECTION 5.2.(f)** G.S. 18C-130 reads as rewritten:

37 **"§ 18C-130. Types of lottery games; lottery games and lottery advertising; certain**
 38 **disclosures and information to be provided.**

39 (a) Unless the General Assembly approves, the Commission may use only draw-style
 40 games and instant scratch-off games as types of lottery games.~~The Commission shall determine~~
 41 ~~the types of lottery games that may be used in the Lottery. Games may include instant lotteries,~~
 42 ~~online games, games played on computer terminals or other devices, and other games~~
 43 ~~traditional to a lottery or that have been conducted by any other state government-operated~~
 44 ~~lottery.~~

45 (b) In lottery games using tickets, each ticket in a particular game shall have printed on
 46 it a unique number distinguishing it from every other ticket in that lottery game and an
 47 abbreviated form of the game-play rules, including resources for responsible ~~gaming~~
 48 gambling information. In lottery games using tickets, ~~each~~ no ticket may have printed on it a depiction of
 49 one or more cartoon ~~characters, whose primary appeal is not to minors.~~ characters. In lottery
 50 games using tickets with preprinted winners, the overall estimated odds of winning prizes shall

1 be printed on each ticket. No name or photograph of a current or former elected official shall
2 appear on the tickets of any lottery game.

3 ...
4 (e) Lottery advertising shall be tastefully designed and presented in a manner to
5 minimize the appeal of lottery games to minors. The use of ~~cartoon characters or~~ false,
6 misleading, unfair, or deceptive information in lottery advertising is ~~prohibited~~ prohibited and
7 shall constitute an unfair and deceptive trade practice under G.S. 75-1.1. ~~All advertising~~
8 ~~promoting the sale of lottery tickets or shares for a particular game shall include the actual or~~
9 ~~estimated overall odds of winning the game.~~

10 (f) The Commission shall make available on its Web site a detailed tabulation of the
11 estimated number of prizes of each particular prize denomination that are expected to be
12 awarded in each lottery game ~~or~~ and the estimated odds of winning ~~these prizes~~ each prize at
13 the time that lottery game is offered for sale to the public.

14 ...
15 (h) The University of North Carolina shall develop and make available to the
16 Department of Public Instruction course and professional development materials explaining the
17 probabilities and other mathematical features of a lottery game for inclusion as a component of
18 high school courses in civics and mathematics. The University of North Carolina shall also

6 applied for, has sought renewal of, has received, has been denied, has

22 potential contractor's contract is subcontracted, the potential contractor shall
23 disclose all of the information required by this section for the subcontractor
24 as if the subcontractor were itself a potential contractor.

23 consult with the Joint Legislative Commission on Governmental Operations prior to
24 establishing or increasing a fee to the level authorized or anticipated in this act.

25 **SECTION 6.2.(b)** Notwithstanding G.S. 150B-21.1A(a), an agency may adopt an
26 emergency rule in accordance with G.S. 150B-21.1A to establish or increase a fee as authorized
27 by this act if the adoption of a rule would otherwise be required under Article 2A of Chapter
28 150B of the General Statutes.

30 **EXPENDITURES OF FUNDS IN RESERVES LIMITED**

31 **SECTION 6.3.** All funds appropriated by this act into reserves may be expended
32 only for the purposes for which the reserves were established.

42 dispute, lawsuit, or part of the dispute or lawsuit or (ii) the involvement of the State or State
43 agency in the dispute, lawsuit, or part of the dispute or lawsuit. This term includes settlement
44 agreements, stipulation agreements, consent judgments, and consent decrees.

45 (b) Prohibition. – The following restrictions shall apply:

46 (1) Funds received by the State or a State agency from a settlement or other final
47 order or judgment of the court shall not be transferred or expended pursuant
48 to G.S. 143C-6-4 and shall remain unexpended until the funds are
49 appropriated by the General Assembly.

50 (2) The Attorney General, any subordinate who has been delegated the authority
51 to negotiate or approve a settlement, and any private counsel retained to

1 represent a State agency shall have no authority to include or agree to terms
2 or conditions in any settlement that authorizes the expenditure, transfer, or
3 award of funds to any person or entity other than (i) a party to the dispute or
4 lawsuit or (ii) a consumer entitled to a refund or the recovery of damages.

5 (c) Exception. – This section does not apply to funds received by the Department of
6 Health and Human Services to the extent those funds represent the recovery of previously
7 expended Medicaid funds.

8 (d) Recommendation. – The Attorney General may provide a nonbinding written
9 recommendation to the chairs of the Senate and House Appropriations Committees for their
10 consideration as to what purpose the funds subject to the prohibitions in subsection (b) of this
11 section should be appropriated for.

12 (e) Overrealized Receipts. – Any provision of law authorizing the expenditure of
13 overrealized receipts shall not apply to the funds referred to in subdivision (1) of subsection (b)
14 of this section unless the language of the law specifically references this section or specifically
15 references funds received by the State or a State agency from a settlement or other final order
16 or judgment of the court.

17 (f) Required Disposition. – If the terms of a federal grant, another provision of State or
18 federal law, or the State Constitution require a specific disposition of funds received from a
19 settlement or other final order or judgment of the court, nothing in this section shall be
20 construed to supersede, or authorize a deviation from, that specific disposition. Furthermore,
21 nothing in this subsection shall be construed to abrogate the requirement that funds drawn from
22 the State treasury be in consequence of appropriations made by law.

23 (g) Required Submission. – In addition to any other report or filing that may be required
24 by law, and unless the settlement is sealed pursuant to a written order of the court in accordance
25 with G.S. 132-1.3 or federal law, the Attorney General's Office shall submit a copy to the
26 Legislative Library of any settlement or other final order or judgment of the court in which the
27 State or a State agency receives funds. The submission required by this subsection shall be
28 made within 60 days of the date (i) the settlement is entered into or (ii) the final order or
29 judgment of the court is entered. Any information deemed confidential by State or federal law
30 shall be redacted from the copy of the settlement or other final order or judgment of the court
31 prior to submitting it to the Legislative Library."

32 **SECTION 6.6.(b)** This section is effective July 1, 2014, and applies to settlements
33 entered into on or after that date and other final orders or judgments of the court entered on or
34 after that date.

35 **ORDER OF APPROPRIATIONS BILLS**

36 **SECTION 6.8.** G.S. 143C-5-2 reads as rewritten:

38 (a) Each house of the General Assembly shall first pass its version of the Current

43 G.S. 166A-19.3.
- 44 (2) An appropriations bill making adjustments to the current year budget.
- 45 (3) An appropriations bill authorizing continued operations at current funding
46 levels.

47 (b) The provisions of subsection (a) of this section shall apply to each fiscal year of the
48 biennium."

REPORTING ON AGENCY REORGANIZATIONS AND MOVEMENTS OF POSITIONS

SECTION 6.10. Article 6 of Chapter 143C of the General Statutes is amended by adding a new section to read:

"§ 143C-6-12. Quarterly report on State agency reorganizations and movements of positions.

The Office of State Budget and Management shall report quarterly to the Joint Legislative Commission on Governmental Operations and the appropriate Joint Legislative Oversight Committee on reorganizations of State agencies and movements of State agency positions. Each report submitted pursuant to this section shall include all of the following information for the previous quarter:

- (1) A list of all reorganizations within State agencies or between State agencies.
- (2) A list of all positions moved within a State agency or between State agencies.
- (3) A statement of the purpose of each reorganization and position movement undertaken and of the legal authority under which each reorganization and position movement was made."

CONTINGENCY AND EMERGENCY FUND

SECTION 6.12. Section 6.1 of S.L. 2013-360 reads as rewritten:

"SECTION 6.1. For the 2013-2015 fiscal biennium and notwithstanding the provisions of G.S. 143C-4-4(b), funds appropriated to the Contingency and Emergency Fund may be used only for expenditures required (i) by a court or Industrial Commission ~~order or order~~, (ii) to respond to events as authorized under G.S. 166A-19.40(a) of the North Carolina Emergency Management ~~Act.~~ Act, or (iii) for litigation expenses incurred by State agencies in defense of the State during the 2014-2015 fiscal year, in an amount not to exceed seven hundred fifty thousand dollars (\$750,000), as approved by the Office of State Budget and Management.

These funds shall not be used for other statutorily authorized purposes or for any other contingencies and emergencies."

DEPARTMENT OF ADMINISTRATION/EUGENICS PROGRAM AMENDMENTS

SECTION 6.13.(a) G.S. 143B-426.51 reads as rewritten:

"§ 143B-426.51. Compensation payments.

(a) A claimant determined to be a qualified recipient under this Part shall receive ~~lump sum~~ compensation in the amount determined by this subsection from funds appropriated to the Department of State Treasurer for these purposes. ~~Except as provided by the succeeding sentence, the amount of compensation for each qualified recipient is the sum of ten million dollars (\$10,000,000) divided by the total number of qualified recipients, and all such payments shall be made on June 30, 2015. The State Treasurer shall reduce the ten million dollars (\$10,000,000) by holding out a pro rata amount per claimant for any cases in which there has not been a final determination of the claim on June 30, 2015. Payments made to persons determined to be qualified claimants after that date shall be made upon such determination, and if after final adjudication of all claims there remains a balance from the funds held out, they shall be paid pro rata to all qualified claimants.~~ A qualified recipient shall receive compensation in the form of two payments. The initial payment and largest payment shall be made in October 2014. A second and final payment shall be made after the exhaustion of all appeals arising from the denial of eligibility for compensation under this Part.

The initial payment to each qualified recipient will be calculated by adding together the number of qualified recipients as of October 1, 2014, and the number of claims outstanding that are pending, then dividing that total number into the sum of ten million dollars (\$10,000,000). The initial payment checks shall be remitted by October 31, 2014.

1 The final payment calculation will be made by taking the balance of compensation funds
2 remaining after the exhaustion of appeals and dividing that sum equally between the number of
3 qualified recipients determined finally to be eligible to receive compensation. The final
4 payment checks shall be remitted within 90 days of the exhaustion of the last appeal. Any
5 qualified claimant who was successful on appeal and who did not receive an initial payment
6 shall be paid an amount equal to the initial payment amount, plus the amount from the final
7 payment calculation.

8 The State Controller and the State Treasurer shall collaborate to facilitate the administration
9 of this section so as to effectuate the compensation of qualified recipients as soon as
10 practicable.

11 (b) If any claimant shall die during the pendency of a claim, or after being determined
12 to be a qualified recipient, any payment shall be made to the estate of the decedent.

13 (c) A qualified recipient may assign compensation received pursuant to subsection (a)
14 of this section to a trust established for the benefit of the qualified recipient.

15 (d) It is the public policy of this State that funds awarded for the compensation of
16 sterilization victims under this Part may be used only for the purpose of benefiting victims and
17 shall not be used to pay attorneys' fees arising from representation at the Office of Justice for
18 Sterilization Victims, before the Industrial Commission, or on appeal. The General Assembly
19 finds that qualified recipients have suffered a unique harm that calls for a unique remedy and
20 that there are sufficient sources of assistance and pro bono legal representation available to
21 protect their interests. Therefore, any agreement for the acceptance of attorneys' fees is null and
22 void unless counsel has sought and received an opinion from the North Carolina State Bar that
23 the fee arrangement is reasonable under the Rules of Professional Conduct.

24 (e) By December 1, 2014, the Office shall submit all remaining claim forms to the
25 Industrial Commission for appropriate disposition in accordance with this Part."

26 **SECTION 6.13.(b)** G.S. 143B-426.52(a) reads as rewritten:

27 "(a) An individual shall be entitled to compensation as provided for in this Part if a claim

The SCIO shall report to the Joint Legislative Oversight Committee on Information Technology on the details of the plan prior to implementation. The plan shall contain all of the following:

- (1) A detailed description for development and implementation of the portal, to include a list of anticipated applications to be implemented during the State fiscal years of 2013-2017.
- (2) A description of how the portal will be implemented, including the use of outside vendors, detailed information on vendor participation, and potential costs.
- (3) Detailed information on the anticipated total cost of ownership of the portal and any applications proposed for implementation during the State fiscal years of 2013-2017, including the amount of any payments to be made to any vendors supporting the project for each application and the portal as a whole.
- (4) A funding model that limits the costs to the State.
- (5) If outsourced, a detailed, fully executable plan to return portal operations to the State, with associated ~~costs and a detailed analysis that demonstrates that it is more cost effective to use a vendor than to develop an application internally.~~ costs.
- (6) A provision requiring that any fees to support the operation of the portal must be authorized by the ~~General Assembly.~~ State Chief Information Officer."

Funding appropriated to the IT Fund for Enterprise Resource Planning (ERP) shall be used by the State Chief Information Officer, in conjunction with the NC Government Efficiency and Reform Initiative (NC GEAR) and the State Controller, to develop a strategic implementation plan for a Statewide Enterprise Resource Planning System. The plan shall be submitted to the Joint Legislative Oversight Committee on Information Technology by January 31, 2015."

INFORMATION TECHNOLOGY SERVICES/EMPLOYEES EXEMPTED FROM STATE HUMAN RESOURCES ACT

SECTION 7.17. G.S. 126-5(c1) is amended by adding a new subdivision to read:

"(c1) Except as to the provisions of Articles 6 and 7 of this Chapter, the provisions of this Chapter shall not apply to:

...

- (31) Employees of the Office of Information Technology Services hired on or after July 1, 2014."

ITS/BUDGET AND REPORTING INFORMATION TECHNOLOGY EXPENDITURES

16 17 FUNDS FOR ACADEMICALLY GIFTED CHILDREN

18 SECTION 8.2. The State Board of Education shall allocate additional funds for
19 academically or intellectually gifted children on the basis of one thousand two hundred
20 thirty-nine dollars and sixty-five cents (\$1,239.65) per child for the 2014-2015 fiscal year. A
21 local school administrative unit shall receive funds for a maximum of four percent (4%) of its

Teachers and instructional support personnel may be moved off of the "M" salary schedule or discontinue receiving salary supplements if they are not meeting the requirements of subdivision (4) of subsection (a) of this section in that year.

45 **COURSES**

46 **SECTION 8.17.** Section 8.27(d) of S.L. 2013-360 reads as rewritten:

47 **"SECTION 8.27.(d)** Of the funds appropriated to the Department of Public Instruction to
48 implement the requirements of this section, ten million eight hundred thirty-one thousand one
49 hundred eighty-four dollars (\$10,831,184) for the 2014-2015 fiscal year shall be used to fund

26 **COMPETITIVE GRANTS TO IMPROVE AFTER-SCHOOL SERVICES**

27 **SECTION 8.19.(a)** Of the funds appropriated by this act for the At-Risk Student
28 Services Alternative School Allotment for the 2014-2015 fiscal year, the State Board of
29 Education shall use five million dollars (\$5,000,000) for the After-School Quality Improvement
30 Grant Program administered by the Department of Public Instruction. It is the intent of the
31 General Assembly to appropriate five million dollars (\$5,000,000) for this purpose in each year
32 of the 2015-2017 fiscal biennium. Of the funds appropriated for the program, the Department
33 of Public Instruction may use up to two hundred thousand dollars (\$200,000) for each fiscal

35 **SECTION 8.19.(b)** The purpose of the After-School Quality Improvement Grant
36 Program is to pilot after-school learning programs for at-risk students that raise standards for
37 student academic outcomes by focusing on the following:

- 38 (1) Use of an evidence-based model with a proven track record of success.
- 39 (2) Inclusion of rigorous, quantitative performance measures to confirm their
40 effectiveness during the grant cycle and at the end-of-grant cycle.
- 41 (3) Full integration with State performance measures and student academic
42 goals.
- 43 (4) Expansion for wider use in North Carolina.
- 44 (5) Prioritization of science, technology, engineering, and mathematics (STEM)
45 learning opportunities.
- 46 (6) Expansion of student access to learning activities and academic support that
47 strengthen student engagement and leverage community-based resources,
48 which may include organizations that provide mentoring services and
49 private-sector employer involvement.

50 **SECTION 8.19.(c)** Local school administrative units and nonprofits working in
51 collaboration with local school administrative units may participate in the program, as set forth

1 in this section, and are eligible to receive two-year grants of up to five hundred thousand
2 dollars (\$500,000) a year, based on the proposed number of students served, with an option for
3 a third year of funding. At least seventy percent (70%) of students served by the program must
4 qualify for free or reduced-price meals.

30 enforcement agencies when substantial modifications such as new facilities or modifications to
31 doors and windows are made to school buildings. Local school administrative units shall also
32 be responsible for providing local law enforcement agencies with updated access to school
33 building key storage devices such as KNOX[®] boxes when changes are made to these boxes or
34 devices.

35 (b) The Department of Public Instruction, in consultation with the Department of Public
36 Safety, shall develop standards and guidelines for the preparation and content of schematic
37 diagrams and necessary updates. Local school administrative units may use these standards and
38 guidelines to assist in the preparation of their schematic diagrams.

39 (c) Schematic diagrams are not considered a public record as the term "public record" is
40 defined under G.S. 132-1 and shall not be subject to inspection and examination under
41 G.S. 132-6.

42 **"§ 115C-105.54. Schematic diagrams and emergency response information provided to**
43 **Division of Emergency Management.**

44 (a) Each local school administrative unit shall provide the following to the Division of
45 Emergency Management (Division) at the Department of Public Safety: (i) schematic diagrams,
46 including digital schematic diagrams, and (ii) emergency response information requested by the
47 Division for the School Risk Management Plan (SRMP) and the School Emergency Response
48 Plan (SERP). Local school administrative units shall also provide updated schematic diagrams
49 and emergency response information to the Division when such updates are made. The
50 Division shall ensure that the diagrams and emergency response information are securely stored
51

1 and distributed as provided in the SRMP and SERP to first responders, emergency personnel,
 2 and school personnel and approved by the Department of Public Instruction.

3 (b) The schematic diagrams and emergency response information are not considered a
 4 public record as the term "public record" is defined under G.S. 132-1 and shall not be subject to
 5 inspection and examination under G.S. 132-6."

6 **SECTION 8.20.(c)** The schematic diagrams referenced in subsection (b) of this
 7 section shall be provided to local law enforcement agencies and the Division of Emergency

 29 teacher. Most of the teacher's remaining time shall be spent in
 30 one or more of the following: mentoring teachers, doing
 31 demonstration lessons for teachers, writing curricula,
 32 developing and leading staff development programs for
 33 teachers; ~~or~~

34 2. In work within the employee's area of certification or
 35 licensure, if the employee is employed in an area of NBPTS
 36 certification other than direct classroom
 37 instruction; instruction; or

38 3. As an instructional coach, as classified by the Department of
 39 Public Instruction, in a Title I school. As used in this
 40 sub-sub-subdivision, a Title I school is a school identified
 41 under Part A of Title I of the Elementary and Secondary
 42 Education Act of 1965, as amended."

44 **JLEOC STUDY DIAGNOSTIC READING ASSESSMENTS FOR READ TO ACHIEVE**

45 **SECTION 8.22.(a)** The Joint Legislative Education Oversight Committee shall
 46 study the formative and diagnostic reading assessments required by the Department of Public
 47 Instruction to meet the provisions of the Read to Achieve Program. The study shall examine
 48 whether there are additional options for formative and diagnostic reading assessments that
 49 would provide local school administrative units with additional flexibility in meeting the
 50 requirements of Read to Achieve, and if fewer assessment instruments or data-gathering
 51 activities could be used. When considering additional assessments, the Committee shall review

1 the assessments to see if they could be used with the Education Value-Added Assessment

4 other assessments that may be used in analyzing student growth for the purposes of the teacher
5 evaluation instrument for kindergarten through second grade teachers. In identifying additional
6 options for both formative and diagnostic reading assessments, and other assessments for
7 analyzing student growth for the purposes of the teacher evaluation, the Committee shall
8 consider at least the following factors:

- 9 (1) The time required for conducting assessments.
- 10 (2) The level of integration of assessment results with instructional support for
11 teachers and students.
- 12 (3) The timeliness in reporting assessment results to teachers and administrators.
- 13 (4) The ability to provide timely and useful assessment results to parents and
14 guardians.

15 **SECTION 8.22.(b)** The Joint Legislative Education Oversight Committee shall
16 report the results of the study required by subsection (a) of this section to the General Assembly
17 prior to the convening of the 2015 General Assembly.

18 19 **SUPPLY OF EMERGENCY EPINEPHRINE AUTO-INJECTORS ON SCHOOL** 20 **PROPERTY**

21 **SECTION 8.23.(a)** Article 25A of Chapter 115C of the General Statutes is
22 amended by adding a new section to read:

23 **"§ 115C-375.2A. School supply of epinephrine auto-injectors.**

24 (a) A local board of education shall provide for a supply of emergency epinephrine
25 auto-injectors on school property and at school-sponsored events on school grounds for use by
26 trained school personnel to provide emergency medical aid to persons suffering from an
27 anaphylactic reaction. Each school shall store in a secure but easily accessible location a
28 minimum of two epinephrine auto-injectors. For purposes of this section, "school property"
29 does not include transportation to or from school.

30 (b) For the purposes of this section and G.S. 115C-375.2, "epinephrine auto-injector"
31 means a disposable drug delivery system with a spring-activated, concealed needle that is
32 designed for emergency administration of epinephrine to provide rapid, convenient first aid for
33 persons suffering a potentially fatal reaction to anaphylaxis.

34 (c) The principal shall designate one or more school personnel, as part of the medical
35 care program under G.S. 115C-375.1, to receive initial training and annual retraining from a
36 school nurse or qualified representative of the local health department regarding the storage and
37 emergency use of an epinephrine auto-injector. Notwithstanding any other provision of law to
38 the contrary, the school nurse or other designated school personnel who has received training
39 under this subsection shall obtain a prescription for epinephrine auto-injectors from a
40 physician, physician assistant, or nurse practitioner of the local health department serving the
41 area in which the local school administrative unit is located.

42 (d) The principal shall collaborate with appropriate school personnel to develop an
43 emergency action plan for the use of epinephrine auto-injectors in an emergency. The plan shall
44 include at least the following components:

- 45 (1) Standards and procedures for the storage and emergency use of epinephrine
46 auto-injectors by trained school personnel.
- 47 (2) Techniques for recognizing symptoms of anaphylaxis.
- 48 (3) Emergency follow-up procedures, including calling emergency services and
49 contacting a student's parent and physician.
- 50 (4) Instruction and certification in cardiopulmonary resuscitation.

1 (e) A supply of emergency epinephrine auto-injectors provided in accordance with this
2 section shall not be used as the sole medication supply for students known to have a medical
3 condition requiring the availability or use of an epinephrine auto-injector. Those students may
4 be authorized to possess and self-administer their asthma medication on school property under
5 G.S. 115C-375.2.

6 (f) A local board of education, its members, employees, designees, agents, or
7 volunteers, and a physician, physician assistant, or nurse practitioner of the local health
8 department shall not be liable in civil damages to any party for any act authorized by this
9 section or for any omission relating to that act unless that act or omission amounts to gross
10 negligence, wanton conduct, or intentional wrongdoing."

11 **SECTION 8.23.(b)** G.S. 115C-238.29F(a) reads as rewritten:

12 (a) Health and Safety Standards. – A charter school shall meet the same health and
13 safety requirements required of a local school administrative unit. The Department of Public
14 Instruction shall ensure that charter schools provide parents and guardians with information
15 about meningococcal meningitis and influenza and their vaccines at the beginning of every
16 school year. This information shall include the causes, symptoms, and how meningococcal
17 meningitis and influenza are spread and the places where parents and guardians may obtain
18 additional information and vaccinations for their children.

19 The Department of Public Instruction shall also ensure that charter schools provide parents
20 and guardians with information about cervical cancer, cervical dysplasia, human
21 papillomavirus, and the vaccines available to prevent these diseases. This information shall be
22 provided at the beginning of the school year to parents of children entering grades five through
23 12. This information shall include the causes and symptoms of these diseases, how they are
24 transmitted, how they may be prevented by vaccination, including the benefits and possible

29 in subsequent pregnancies, including induced abortion, smoking, alcohol consumption, the use
30 of illicit drugs, and inadequate prenatal care.

31 The Department of Public Instruction shall also ensure that charter schools provide students
32 in grades nine through 12 with information annually on the manner in which a parent may
33 lawfully abandon a newborn baby with a responsible person, in accordance with G.S. 7B-500.

34 The Department of Public Instruction shall also ensure that the guidelines for individual
35 diabetes care plans adopted by the State Board of Education under G.S. 115C-12(31) are
36 implemented in charter schools in which students with diabetes are enrolled and that charter
37 schools otherwise comply with the provisions of G.S. 115C-375.3.

38 The Department of Public Instruction shall ensure that charter schools comply with
39 G.S. 115C-375.2A. The board of directors of a charter school shall provide the school with a
40 supply of emergency epinephrine auto-injectors necessary to carry out the provisions of
41 G.S. 115C-375.2A."

42 **SECTION 8.23.(c)** G.S. 115C-238.66(7) reads as rewritten:

43 (7) Health and safety. – The board of directors shall require that the regional
44 school meet the same health and safety standards required of a local school
45 administrative unit.

46 The Department of Public Instruction shall ensure that regional schools
47 comply with G.S. 115C-375.2A. The board of directors of a regional school
48 shall provide the school with a supply of emergency epinephrine

33 when it is determined that administration of a standardized test of reading

37 G.S. 115C-83.7(b)(4), as amended by that act, reads as rewritten:

38 "(4) Students who demonstrate, through a student reading portfolio, reading

44 **RURAL CHARTER SCHOOL DEVELOPMENT PILOT PROGRAM**

45 **SECTION 8.31.(a)** Parents for Educational Freedom in North Carolina, Inc.,
46 (PEFNC) shall use up to three hundred thousand dollars (\$300,000) in nonrecurring funds made
47 available to it under this act for the 2014-2015 fiscal year to provide grant funding to
48 participants for the development of up to 12 charter schools in counties with currently less than
49 a sixty-five percent (65%) average passage rate on end-of-grade and end-of-course tests. State
50 funds shall only be used to provide grants to participants in the pilot program and shall not be
51 used by PEFNC for its overhead costs in administering the program.

2 the basis of one dollar (\$1.00) in grant funds for every one dollar (\$1.00) in nongrant funds.
3 Matching funds shall not include other State funds. Matching funds may include in-kind
4 contributions.

5 **SECTION 8.31.(c)** PEFNC shall require that grant recipients participating in the
6 pilot program meet at least all of the following conditions:

- 7 (1) The recipient is seeking approval by the State Board of Education to operate
8 a charter school or is in the planning year required before beginning

- 10 (2) The charter school shall be located in a county with less than a sixty-five
11 percent (65%) average passage rate on end-of-grade and end-of-course tests.

25 the local policy shall appear in any school unit publication that sets forth the comprehensive
26 rules, procedures, and standards of conduct for schools within the school unit and in any
27 student and school employee handbook."

28 **SECTION 8.32.(b)** This section applies beginning with the 2014-2015 school year.

29 30 **CLARIFY SCHOOL COUNSELORS WORK DUTIES**

31 **SECTION 8.33.(a)** G.S. 115C-316.1(b) reads as rewritten:

38 **SECTION 8.33.(b)** Section 8.35(b) of S.L. 2013-360 is repealed.

39 40 **FUNDS FOR CHARTER SCHOOL CLOSURE**

41 **SECTION 8.34.(a)** G.S. 115C-238.29F(i) is repealed.

42 **SECTION 8.34.(b)** Article 16 of Chapter 115C of the General Statutes is amended
43 by adding a new section to read:

44 "**§ 115C-238.29L. Dissolution of a charter school.**

45 (a) Funds Reserved for Closure Proceedings. – A charter school shall maintain, for the
46 purposes of ensuring payment of expenses related to closure proceedings in the event of a
47 voluntary or involuntary dissolution of the charter school, one or more of the options set forth
48 in this subsection. The minimum aggregate value of the options chosen by the charter school
49 shall be fifty thousand dollars (\$50,000). The State Board of Education shall not allocate any
50 funds under G.S. 115C-238.29H to a charter school unless the school has provided
51 documentation to the State Board that the charter school has met the requirements of this

1 subsection. Permissible options to satisfy the requirements of this subsection include one or
2 more of the following:

3 (1) An escrow account.

4 (2) A letter of credit.

5 (3) A bond.

6 (4) A deed of trust.

7 (b) Distribution of Assets. – Upon dissolution of a charter school, all net assets of the
8 charter school purchased with public funds shall be deemed the property of the local school
9 administrative unit in which the charter school is located."

10 **SECTION 8.34.(c)** G.S. 115C-238.29G(a1) reads as rewritten:

11 "(a1) The State Board shall adopt criteria for adequate performance by a charter school
12 and shall identify charter schools with inadequate performance. The criteria shall include a
13 requirement that a charter school which demonstrates no growth in student performance and
14 has annual performance composites below sixty percent (60%) in any two years in a three-year
15 period is inadequate.

16 ...

17 (2) If a charter school is inadequate and has had a charter for more than five
18 years, the State Board is authorized to terminate, not renew, or seek
19 applicants to assume the charter through a competitive bid process
20 established by the State Board. The State Board shall develop rules on the
21 assumption of a charter by a new entity that include all aspects of the
22 operations of the charter school, including the status of the employees.
23 Public assets would transfer to the new entity and not revert to the local
24 school administrative unit in which the charter school is located pursuant to
25 G.S. 115C-238.29F(i);G.S. 115C-238.29L(b)."

26 **SECTION 8.34.(d)** This section applies to charter schools that submit applications
27 for an initial charter or the renewal of a charter to the State Board of Education on or after the
28 effective date of this act.

30 VIRTUAL CHARTER SCHOOL PILOT PROGRAM

31 **SECTION 8.35.(a)** Notwithstanding G.S. 115C-238.29D or any other provision of
32 law to the contrary, the State Board of Education shall establish a pilot program to authorize the
33 operation of two virtual charter schools serving students in kindergarten through twelfth grade.
34 The State Board shall establish an application process to allow student enrollment in the
35 selected virtual charter schools beginning with the 2015-2016 school year. A virtual charter
36 school participating in the pilot may serve any grade span of students in kindergarten through
37 twelfth grade. The pilot program shall continue for a period of four school years and shall end
38 with the 2018-2019 school year.

39 **SECTION 8.35.(b)** The virtual charter schools participating in the pilot program
40 authorized by this section shall be subject to the statutes and rules applicable to charter schools
41 pursuant to Part 6A of Article 16 of Chapter 115C of the General Statutes, except as follows:

42 (1) The maximum student enrollment in any participating school shall be no
43 greater than 1,500 in its first year of operation and may increase by twenty
44 percent (20%) for each participating school up to a maximum student
45 enrollment of 2,592 in the fourth year of the pilot. The State Board of
46 Education may waive this maximum student enrollment threshold, beginning
47 in the fourth year of the school's operation, if the State Board determines that
48 doing so would be in the best interest of North Carolina students.

49 (2) The maximum overall ratio of teachers to students for kindergarten through
50 eighth grade shall be 1:50, and for ninth through twelfth grade shall be
51 1:150.

- 1 (3) A student who regularly fails to participate in courses may be withdrawn
2 from enrollment pursuant to procedures adopted by the virtual charter
3 school. The procedures adopted by the virtual charter school shall ensure
4 that (i) fair notice is provided to the parent and student and (ii) an
5 opportunity is provided, prior to withdrawal of the student by the school, for
6 the student and parent to demonstrate that failure to participate in courses is
7 due to a lawful absence recognized under Part I of Article 26 of Chapter
8 115C of the General Statutes and any applicable rules adopted by the State
9 Board of Education.

10 **SECTION 8.35.(c)** In addition to the operating requirements applicable to a virtual
11 charter school participating in the pilot program pursuant to Part 6A of Article 16 of Chapter
12 115C of the General Statutes, the following requirements shall apply to a participating virtual
13 charter school:

- 14 (1) The school shall maintain an administrative office within North Carolina. In
15 addition, the school shall maintain at least one testing center or meeting
16 place within each of the eight State Board of Education districts where the
17 participating students reside, to allow educators and administrators from the
18 school to meet students and parents.
- 19 (2) If the school contracts with a third party for the provision of administrative
20 staff, such staff fulfilling the equivalent positions of superintendent,
21 principal, or business officer shall be residents of North Carolina.
- 22 (3) All teaching staff shall carry the appropriate State certification to instruct
23 any course and shall receive professional development in virtual instruction
24 pursuant to the school's application to the State Board of Education to
25 participate in the pilot program within 30 days of the employee's date of hire.
26 At least ninety percent (90%) of the teaching staff shall reside within North
27 Carolina.
- 28 (4) The school shall have a withdrawal rate below twenty-five percent (25%). A
29 student enrolled in a school with the intent expressed prior to enrollment of
30 only being enrolled for a finite period of time within the school year shall
31 not be counted in the measured withdrawal rate. The school shall keep a
32 written record of a student's stated intent for finite enrollment. A count of
33 school attendance shall be taken at least once during each semester for
34 funding purposes.
- 35 (5) The school shall ensure that each student is assigned a learning coach. The
36 learning coach shall provide (i) daily support and supervision of students, (ii)
37 ensure student participation in online lessons, and (iii) coordinate teacher-led
38 instructional sessions and State assessments.

39 **SECTION 8.35.(d)** Notwithstanding G.S. 115C-238.29B and G.S. 115C-238.29D,
40 a participating virtual charter school that is successful in meeting the requirements of this
41 section and the applicable requirements of Part 6A of Article 16 of Chapter 115C of the
42 General Statutes during the period of the pilot program shall be eligible to be approved by the
43 State Board of Education, at its discretion, without additional application requirements.

44 **SECTION 8.35.(e)** The State Board of Education shall provide State funding to a
45 virtual charter school participating in the pilot program as provided in G.S. 115C-238.29H(a)
46 and G.S. 115C-238.29H(a1). The amount allocated pursuant to G.S. 115C-238.29H(a)(1) shall
47 not, however, include the allocation for low-wealth counties supplemental funding and the
48 allocation for small county supplemental funding. Virtual charter schools participating in the
49 pilot program shall also be subject to the requirements in G.S. 115C-238.29H(b) through
50 G.S. 115C-238.29H(d). The amount of local funds provided to participating schools pursuant to

1 G.S. 115C-238.29H(b) shall be the lesser of seven hundred ninety dollars (\$790.00) per pupil
2 or the amount computed in accordance with G.S. 115C-238.29H(b).

3 **SECTION 8.35.(f)** A participating virtual charter school that does not comply with
4 the provisions of this section may result in deferment or termination of enrollment expansion,
5 or termination of a pilot. Schools are subject to presentation of data to the State Board of
6 Education at the call of the Chair of the State Board with a minimum of 21 days' notice.

7 **SECTION 8.35.(g)** The State Board shall report on the initial implementation of
8 the pilot program to the Joint Legislative Education Oversight Committee by November 15,

- 21 (6) "Teacher" means a person meeting each of the following requirements:

 26 3. A regular, not expired, vocational license.
 27 b. Whose major responsibility is to teach or directly supervise teaching

 30 c. Who is employed to fill a full-time, permanent position.
 31 d. Who is not a career teacher as defined in G.S. 115C-325(a)(1c).

The programs shall include methods to determine whether an employee's performance has improved student learning, the development and implementation of appropriate professional growth and mandatory improvement plans, the process for contract nonrenewal, and the dismissal process under Part 3 and Part 3A of Article 22 of this Chapter. The Board of Governors shall ensure that the subject matter of the training programs is incorporated into the masters in school administration programs offered by the constituent institutions. The State Board, in collaboration with the Board of Governors, also shall develop in-service programs for licensed public school employees that may be included in a mandatory improvement plan created under G.S. 115C-333(b) or G.S. 115C-333.1(b). The Board of Governors shall use the professional development programs for public school employees that are under its authority to make this training available at locations that are geographically convenient to local school administrative units."

 45 assistant principals on the salary schedule, except for principals in alternative schools and in
 46 cooperative innovative high schools, shall be determined in accordance with the following
 47 schedule:

7 The number of teachers supervised includes teachers and assistant principals paid

11 innovative high school programs shall be the Principal III level. Principals in alternative
12 schools who supervise 33 or more teachers shall be classified according to the number of
13 teachers supervised.

14 **SECTION 9.11.(c)** A principal shall be placed on the step on the salary schedule
15 that reflects total number of years of experience as a certified employee of the public schools
16 and an additional step for every three years of experience serving as a principal on or before
17 June 30, 2009. A principal or assistant principal shall also continue to receive any additional
18 State-funded percentage increases earned for the 1997-1998, 1998-1999, and 1999-2000 school
19 years for improvement in student performance or maintaining a safe and orderly school.

20 **SECTION 9.11.(d)** Principals and assistant principals with certification based on
21 academic preparation at the six-year degree level shall be paid a salary supplement of one
22 hundred twenty-six dollars (\$126.00) per month and at the doctoral degree level shall be paid a
23 salary supplement of two hundred fifty-three dollars (\$253.00) per month.

24 **SECTION 9.11.(e)** Longevity pay for principals and assistant principals shall be as
25 provided for State employees under the North Carolina Human Resources Act.

26 **SECTION 9.11.(f)** If a principal is reassigned to a higher job classification because
27 the principal is transferred to a school within a local school administrative unit with a larger
28 number of State-allotted teachers, the principal shall be placed on the salary schedule as if the
29 principal had served the principal's entire career as a principal at the higher job classification.

30 If a principal is reassigned to a lower job classification because the principal is
31 transferred to a school within a local school administrative unit with a smaller number of
32 State-allotted teachers, the principal shall be placed on the salary schedule as if the principal
33 had served the principal's entire career as a principal at the lower job classification.

34 This subsection applies to all transfers on or after the effective date of this section,
35 except transfers in school systems that have been created, or will be created, by merging two or
36 more school systems. Transfers in these merged systems are exempt from the provisions of this
37 subsection for one calendar year following the date of the merger.

38 **SECTION 9.11.(g)** Participants in an approved full-time master's in-school
39 administration program shall receive up to a 10-month stipend at the beginning salary of an
40 assistant principal during the internship period of the master's program. The stipend shall not
41 exceed the difference between the beginning salary of an assistant principal plus the cost of
42 tuition, fees, and books and any fellowship funds received by the intern as a full-time student,
43 including awards of the Principal Fellows Program. The Principal Fellows Program or the
44 school of education where the intern participates in a full-time master's in-school administration
45 program shall supply the Department of Public Instruction with certification of eligible
46 full-time interns.

47 **SECTION 9.11.(h)** During the 2013-2015 fiscal biennium, the placement on the
48 salary schedule of an administrator with a one-year provisional assistant principal's certificate
49 shall be at the entry-level salary for an assistant principal or the appropriate step on the teacher
50 salary schedule, whichever is higher.

"SECTION 35.13.(c) Longevity pay for superintendents, assistant superintendents, associate superintendents, directors/coordinators, supervisors, and finance officers shall be as provided for State employees under the State Personnel Act.

"SECTION 35.13.(d) Superintendents, assistant superintendents, associate superintendents, directors/coordinators, supervisors, and finance officers with certification based on academic preparation at the six-year degree level shall receive a salary supplement of one hundred twenty-six dollars (\$126.00) per month in addition to the compensation provided pursuant to this section. Superintendents, assistant superintendents, associate superintendents, directors/coordinators, supervisors, and finance officers with certification based on academic preparation at the doctoral degree level shall receive a salary supplement of two hundred fifty-three dollars (\$253.00) per month in addition to the compensation provided for under this section.

"SECTION 35.13.(e) The State Board of Education shall not permit local school administrative units to transfer State funds from other funding categories for salaries for public school central office administrators.

"SECTION 35.13.(f) The annual salaries of all permanent, full-time personnel paid from the Central Office Allotment shall ~~remain unchanged for the 2013-2015 fiscal biennium.~~be increased by one thousand dollars (\$1,000)."

NONCERTIFIED PERSONNEL SALARIES

SECTION 9.13. Section 35.14 of S.L. 2013-360 reads as rewritten:

13 **SECTION 9.14.(b)** Effective July 1, 2014, any permanent certified personnel
14 employed on July 1, 2014, and paid at the top teacher salary schedule applicable to them for the
15 2013-2014 school year shall receive a one-time bonus, payable monthly, equivalent to two
16 percent (2%).

18 **CAREER PATHWAYS PILOT PROGRAM**

19 **SECTION 9.15.(a)** Pilot. – The State Board of Education shall establish a
20 three-year career pathways program pilot, as provided in this section, for selected local school
21 administrative units to develop a career pathways program to provide for, in addition to base
22 salary and other applicable local supplements, differentiated pay for classroom teachers based
23 on a teacher's demonstrated effectiveness and additional responsibilities in advanced roles. For
24 the purposes of this section, a classroom teacher is a teacher who works in the classroom
25 providing instruction and who is not instructional support personnel.

26 **SECTION 9.15.(b)** Request for Proposal Requirements. – No later than September
27 15, 2014, the State Board shall develop a Request for Proposal (RFP) for local boards of
28 education to participate in the pilot. As part of the RFP, the State Board of Education shall
29 establish the duties that are associated with advanced roles for classroom teachers. Local boards
30 of education shall submit RFPs for consideration no later than January 1, 2015. The RFP shall
31 require local boards of education to include in their proposals a career pathway plan that meets,
32 at a minimum, the following criteria:

- 33 (1) Career pathway teacher eligibility and duties. -
34 a. Enable eligible classroom teachers to progress within their careers
35 and become career pathway teachers by doing any of the following:

41 b. Provide information in a form readily accessible to both teachers and

43 pathway teacher.
44 c. Require a classroom teacher to be rated as highly effective on the
45 North Carolina Teacher Evaluation instrument to be eligible to be a
46 career pathway teacher. A highly effective classroom teacher is a
47 teacher who receives, on the North Carolina Teacher Evaluation
48 instrument, a rating of at least accomplished on each of the teacher
49 evaluation standards and who exceeds expected student growth based
50 on three years of teacher evaluation data as calculated by the State
51 Board of Education.

- 1 d. Increase the amount of time during the school day for a career
2 pathway teacher to plan, collaborate, and participate in on-the-job
3 development or leadership of others.
- 4 e. Establish equally stringent eligibility requirements for a career
5 pathway teacher to remain in an advanced role as those required to
6 initially attain that role.
- 7 f. Establish a procedure for determining whether a career pathway
8 teacher is successfully performing the additional duties associated
9 with the career pathway.
- 10 g. Ensure that career pathway teachers may opt out of the career
11 pathways plan by voluntarily relinquishing additional duties
12 associated with the career pathway. Voluntary relinquishment of
13 duties associated with the career pathway shall not be considered a
14 demotion under Part 3 or Part 3A of Article 22 of Chapter 115C of
15 the General Statutes.
- 16 (2) Career pathway salary bonuses. -
- 17 a. Pay career pathway salary supplements of at least ten percent (10%)
18 of the State teacher salary schedule to career pathway teachers who
19 assume advanced roles.
- 20 b. Pay career pathway salary supplements of at least twenty-five
21 percent (25%) of the State teacher salary schedule to career pathway
22 teachers who lead teams of two or more other teachers and are the
23 teachers of record for all students served by the teaching team.
- 24 c. Require that career pathway salary supplements be paid as a bonus or
25 supplement to the teacher's regular salary and not be included in the
26 average salary calculation used for budgeting State allotments.
- 27 d. Require that a career pathway teacher who (i) fails to maintain a
28 rating of highly effective or (ii) is not successfully performing the
29 additional duties associated with the career pathway shall be paid
30 only the salary applicable to him or her on the State salary schedule
31 and any other local supplements that would otherwise apply to the
32 teacher's compensation.
- 33 e. Require that a teacher who opts out of the career pathways plan shall
34 be paid only the salary applicable to him or her on the State salary
35 schedule and any other local supplements that would otherwise apply
36 to the teacher's compensation.
- 37 (3) Career pathways plan funding. – Achieves financial sustainability for career
38 pathways salary supplements, as provided in subdivision (2) of this
39 subsection, by reallocating other funds, including local, private, State, or
40 federal funds.
- 41 (4) System goals. -
- 42 a. Develop measures for determining how the career pathways plan
43 shall do at least the following:
- 44 1. Improve the quality of classroom instruction.
- 45 2. Increase the attractiveness of teaching.
- 46 3. Encourage the recognition, impact, and retention of
47 high-quality teachers.
- 48 b. Increase the percentage of students in the local school administrative
49 unit with a highly effective teacher as their teacher of record in at
50 least English Language Arts, math, social studies, and science to a
51 minimum of seventy-five percent (75%) of students in that subject by

1 the third year of implementation through the career pathways
2 program.

3 **SECTION 9.15.(c)** Selection of Pilot Units. – By March 15, 2015, the State Board
4 of Education shall review the RFPs submitted by local boards of education in accordance with
5 subsection (b) of this section and shall select for the first cohort of the pilot program eight local
6 school administrative units that meet the following criteria:

- 7 (1) Two school districts with an average daily membership (ADM) equal to or
8 less than 4,000.
- 9 (2) Two school districts with an ADM of 4,001 to 10,000.
- 10 (3) Two school districts with an ADM of 10,001 to 30,000.
- 11 (4) Two school districts with an ADM of 30,001 or more.

12 **SECTION 9.15.(d)** Pilot Implementation. – The local school administrative units
13 selected for the pilot shall implement their approved career pathways plans beginning with the
14 2015-2016 school year and ending with the 2017-2018 school year. The local boards of
15 education for each approved pilot local school administrative unit shall report annually no later
16 than August 15 following each school year of the pilot to the State Board of Education on the
17 following:

- 18 (1) The methodology for measurement and outcomes determined by the board
19 for how the career pathways plan has accomplished the following:
 - 20 a. Improved the quality of classroom instruction.
 - 21 b. Increased the attractiveness of teaching.
 - 22 c. Encouraged the recognition, impact, and retention of high-quality
23 teachers.
- 24 (2) The percentage of students with a highly effective teacher as their teacher of
25 record for English Language Arts, math, social studies, and science.

26 **SECTION 9.15.(e)** Second Cohort of Pilot. – It is the intent of the General
27 Assembly, subject to the availability of funds, that the State Board of Education shall select a
28 second cohort of eight local school administrative units using the process and requirements set
29 forth in this section to begin a career pathways program pilot in the 2016-2017 school year.

30 **SECTION 9.15.(f)** Pilot Evaluation. – The State Board of Education shall report
31 annually beginning October 15, 2015, until the conclusion of all the pilots, including a second
32 cohort as described in subsection (e) of this section, on all aspects of the implementation and
33 evaluation of the pilot career pathways plans to the offices of the President Pro Tempore of the
34 Senate and the Speaker of the House of Representatives, the Senate Appropriations/Base
35 Budget Committee, the House Committee on Appropriations, the Senate Appropriations
36 Committee on Education/Higher Education, the House Appropriations Subcommittee on
37 Education, the Fiscal Research Division, and the Joint Legislative Education Oversight
38 Committee.

39 **SECTION 9.15.(g)** Career Pathways Plan Statewide Recommendation. – The State
40 Board of Education shall evaluate implementation and success of the pilot plans and identify
41 successful, reliable elements to develop recommendations to the General Assembly for a career
42 pathways plan that could be implemented by a local board of education in its local school
43 administrative unit. The career pathways plan may contain multiple career pathway options, as
44 well as a default career pathway program, and shall be designed to improve the quality of
45 classroom instruction, increase the attractiveness of teaching, and encourage the recognition,
46 impact, and retention of high-quality teachers. The State Board of Education shall report no
47 later than October 15, 2018, on the statewide career pathways plan to the offices of the
48 President Pro Tempore of the Senate and the Speaker of the House of Representatives, the

3 **SECTION 9.15.(h)** Career Pathways Plan Rules. – The State Board of Education
4 shall adopt rules necessary to carry out the provisions of this section. Notwithstanding Article
5 2A of Chapter 150B of the General Statutes, the State Board of Education shall be exempt from
6 rule making in establishing rules to carry out the career pathways pilot program set forth in this
7 section.

8 **SECTION 9.15.(i)** Career Pathways Plan Administration. – The State Board of
9 Education, in consultation with the Office of the Governor, shall be responsible for
10 administration of the career pathways plan pilot program and shall dedicate up to three
11 full-time staff positions. One position shall be assigned as the primary administrator of the
12 program. The primary administrator shall (i) lead oversight of pilot local school administrative
13 unit selection and career pathway development and piloting, (ii) lead assessments of pilots for
14 career pathways plan recommendations, and (iii) provide information about progress toward
15 goals of this section and activities undertaken to implement this section to the Governor, State
16 Board of Education, and State Superintendent of Public Instruction. Two additional positions
17 shall be assigned to assist the primary administrator.

18 **SECTION 9.15.(j)** Matching Funds for Career Pathways Plan. – The career
19 pathways pilot program shall provide one hundred dollars (\$100.00) per ADM for teacher
20 salary supplements for up to twenty-five percent (25%) of ADM in each pilot local school
21 administrative unit. State funding allocated to local school administrative units for the career
22 pathways program pilot shall be matched by the unit at a minimum of one dollar (\$1.00) of
23 matching funds for every one dollar (\$1.00) of State funds to pay supplements to teachers in the
24 career pathways program. Matching funds may include the reallocation of other funds,
25 including local, private, State, or federal funds.

26 **SECTION 9.15.(k)** Flexible Funding for Career Pathways Plan Pilot Local School
27 Administrative Units. – Notwithstanding G.S. 115C-105.25(5b), beginning with the 2015-2016
28 fiscal year, the State Board of Education shall increase flexibility in the use of State funds for
29 pilot local school administrative units by allowing positions allocated for classroom teachers
30 and instructional support personnel to be converted to dollar equivalents for the purpose of
31 transferring funds into the career pathways program for those local school administrative units
32 participating in the program. These positions shall be converted at the first step of the "A"
33 Teacher Salary Schedule effective for that fiscal year.

34 **SECTION 9.15.(l)** G.S. 150B-1(d) reads as rewritten:

35 "(d) Exemptions from Rule Making. – Article 2A of this Chapter does not apply to the
36 following:

37 ...

38 (26) The State Board of Education with respect to the career pathways pilot
39 program established by the 2013 General Assembly. The program authorizes
40 local school administrative units to develop a program for differentiated pay
41 for classroom teachers based on a teacher's demonstrated effectiveness and
42 assumption of advanced roles."

44 **PROCESS FOR PERIODICALLY REVISING ENROLLMENT TIERS**

45 **SECTION 10.2.** The State Board of Community Colleges shall develop a process
46 for periodically reviewing and revising how courses and programs are classified into tiers in the
47 enrollment funding model. The process shall be developed by March 1, 2015, and reported to
48 the Office of State Budget and Management and the Fiscal Research Division of the North
49 Carolina General Assembly.

1 The State Board of Community Colleges shall identify those courses and programs
2 in high-need areas and may suggest any revisions to the model. These revisions shall be
3 submitted as part of their budget requests for the 2017-2019 fiscal biennium.
4

5 **REVENUES/EXPENDITURES/FEES COLLECTED AND ASSESSED BY THE**
6 **MANUFACTURING SOLUTIONS CENTER AND THE TEXTILE TECHNOLOGY**
7 **CENTER**

8 **SECTION 10.3.** The State Board of Community Colleges shall report, no later than
9 January 15, 2015, to the Joint Legislative Education Oversight Committee, the Fiscal Research
10 Division, and the Office of State Budget and Management a summary of the revenues and
11 expenditures for the Manufacturing Solutions Center at Catawba Valley Community College
12 and for the Textile Technology Center at Gaston College during the 2012-2013 and 2013-2014
13 fiscal years. The report shall include information on the structure of the fees assessed and the
14 total fees collected by each Center.
15

16 **JLEOC STUDY ON VOCATIONAL TRAINING FOR INDIVIDUALS WITH**
17 **INTELLECTUAL DISABILITIES**

18 **SECTION 10.4.(a)** The Joint Legislative Education Oversight Committee shall
19 study at least the following issues related to vocational training for individuals with intellectual
20 disabilities:

- 21 (1) Model programs for implementation on a systemwide basis at community
22 college campuses and constituent institutions of The University of North
23 Carolina for training and developing vocational expertise and job readiness
24 in students with intellectual disabilities.
- 25 (2) Enhancing employment outcomes for individuals with intellectual
26 disabilities.
- 27 (3) Barriers to employment for individuals with intellectual disabilities.
- 28 (4) Establishment and expansion of partnerships between community colleges,
29 constituent institutions of The University of North Carolina, the Department
30 of Health and Human Services, Division of Vocational Rehabilitative
31 Services, and community-based organizations that offer job training and job
32 placement opportunities for individuals with intellectual disabilities.
- 33 (5) Policies for ensuring that students with intellectual disabilities are prepared
34 for higher educational opportunities upon completion of their elementary
35 and secondary school education.
- 36 (6) Policies for transition planning and job training for students with intellectual
37 disabilities as they complete their elementary and secondary school
38 education.

39 **SECTION 10.4.(b)** The Joint Legislative Education Oversight Committee shall
40 report the results of the study required by subsection (a) of this section to the General Assembly
41 prior to the convening of the 2015 General Assembly.
42

43 **EXTEND AUTHORITY TO REORGANIZE THE COMMUNITY COLLEGES**
44 **SYSTEM OFFICE**

45 **SECTION 10.5.(a)** Section 10.1(b) of S.L. 2013-360 reads as rewritten:

48 **PERMIT THE BOARD OF COMMUNITY COLLEGES TO TRANSFER CERTAIN**
49 **FUNDS TO DEPARTMENT OF COMMERCE TO OFFSET APPRENTICESHIP**
50 **FEES**

1 **SECTION 10.6.(a)** Notwithstanding any other provision of law, of the funds
2 appropriated by this act for the Customized Industry Training Program for the 2014-2015 fiscal
3 year, the State Board of Community Colleges shall transfer three hundred thousand dollars
4 (\$300,000) to the Department of Commerce to offset fee revenue lost when apprenticeship fees
5 assessed pursuant to G.S. 94-12 are waived.

6 **SECTION 10.6.(b)** This section shall expire June 30, 2015.

7
8 **COMMUNITY COLLEGES AND UNC STUDY BILATERAL AGREEMENTS**
9 **REGARDING TRANSFER PROCESS**

10 **SECTION 10.7.(a)** The Board of Governors of The University of North Carolina
11 and the State Board of Community Colleges shall jointly study the various bilateral agreements
12 and partnerships that exist between constituent institutions of The University of North Carolina
13 and the community colleges throughout the State. The study shall specifically focus on those
14 agreements and partnerships that aid in the transfer process and those agreements and
15 partnerships that encourage or require students to complete some coursework at a community
16 college before attending or transferring to a constituent institution. The study shall also provide
17 data on the agreements and partnerships, to the extent this information is available, on all of the
18 following:

- 19 (1) A description of the agreement or partnership;
20 (2) The number of years it has been in existence;
21 (3) The number of participants by year; and
22 (4) An analysis of student outcomes after a transfer under the agreement or
23 partnership.

24 **SECTION 10.7.(b)** The findings of the study shall be reported to the Joint
25 Legislative Education Oversight Committee and the Senate Appropriations Committee on
26 Education/Higher Education and the House Appropriations Subcommittee on Education by
27 February 1, 2015. The final report shall also include recommendations on replication and
28 expansion possibilities for the various agreements and partnerships.

29
30 **FUNDS FOR THE CAPE FEAR BOTANICAL GARDENS**

31 **SECTION 10.8.** Of the funds allocated to Fayetteville Technical Community
32 College by the Community Colleges System Office for the 2014-2015 fiscal year, Fayetteville
33 Technical Community College may use up to fifty thousand dollars (\$50,000) to support the
34 Cape Fear Botanical Garden as part of the Fayetteville Technical Community College
35 Horticulture Technology/Management program.

37 **PART XI. UNIVERSITIES**

38
39 **DISTINGUISHED PROFESSOR ENDOWMENT TRUST FUND**

40 **SECTION 11.1.(a)** Part 4A of Article 1 of Chapter 116 of the General Statutes is
41 amended by adding a new section to read:

42 "**§ 116-41.14A. Distinguished Professor Endowment Trust Funds; no State match**
43 **requirement.**

44 Notwithstanding any other provision of this Part, no State match shall be required to use
45 private donations and gifts that were or are intended by the donor for the Distinguished
46 Professorships. However, if the written terms of a particular donation or gift required a State
47 match, then this section shall not apply without the written consent of the donor."

48 **SECTION 11.1.(b)** G.S. 116-41.13 reads as rewritten:

49 "**§ 116-41.13. Distinguished Professors Endowment Trust Fund; purpose.**

50 The General Assembly of North Carolina recognizes that the public university system
51 would be greatly strengthened by the addition of distinguished scholars. It further recognizes

1 that private as well as State support is preferred in helping to obtain distinguished scholars for
2 the State universities and that private support will help strengthen the commitment of citizens
3 and organizations in promoting excellence throughout all State universities. It is the intent of
4 the General Assembly to establish a trust fund to provide the opportunity to each State
5 university to receive and match challenge grants to create endowments for selected
6 distinguished professors to occupy chairs within the university. The associated foundations that
7 serve the universities shall solicit and receive gifts from private sources ~~to provide for matching~~
8 ~~funds to the trust fund challenge grants~~ for the establishment of endowments for chairs within
9 ~~universities.~~ universities and to provide matching funds to the trust fund challenge grants when
10 matching funds are available."
11

12 **UNC TO FUND NORTH CAROLINA RESEARCH CAMPUS**

13 **SECTION 11.2.** Of the funds appropriated in this act to the Board of Governors of
14 The University of North Carolina, the Board of Governors shall use twenty-nine million dollars
15 (\$29,000,000) to support UNC-related activities at the North Carolina Research Campus at
16 Kannapolis.
17

18 **REPORT ON INSTITUTIONAL TRUST FUNDS**

19 **SECTION 11.4.** G.S. 116-36.1(e) reads as rewritten:

20 "(e) Each institution shall submit such reports or other information concerning its trust
21 fund accounts as may be required by the ~~Board.~~ Board or by the Director of the Budget."
22

23 **REPORT ON ACADEMIC SUMMER BRIDGE**

24 **SECTION 11.5.** No later than November 1, 2014, the Board of Governors of The
25 University of North Carolina shall report to the Office of State Budget and Management and
26 the Joint Legislative Education Oversight Committee on the impact of Academic Summer
27 Bridge programs on student outcomes. At a minimum, the report shall include information by
28 institution on graduation rates, average time to degree, and student academic performance at
29 multiple intervals over a four-year course of study.
30

31 **OPERATION OF 4-H CAMPS AND USE OF VARIOUS SITES OF DEFUNCT 4-H** 32 **CAMPS AND TRANSFER 4-H CAMP SERTOMA/MOORE SPRINGS TO THE** 33 **STATE PARKS SYSTEM.**

34 **SECTION 11.7.(a)** Part 5 of Article 1 of Chapter 116 of the General Statutes is
35 amended by adding a new section to read:

36 **"§ 116-43.20. Operation of 4-H camps.**

37 (a) North Carolina State University shall not close the 4-H camps listed in subdivisions
38 (1) through (3) of this subsection. Further, North Carolina State University shall continue to
39 operate each of those camps as 4-H camps and to offer programs and services at the sites of
40 each of those camps at a level that is at least equivalent to the programs and services offered at
41 each site as of June 30, 2013. The following three 4-H camps are to continue and are to be
42 operated as 4-H camps as provided by this subsection:

43 (1) Eastern 4-H Center located in Columbia, NC.

44 (2) Millstone 4-H Camp located near Ellerbe, NC.

45 (3) Betsy-Jeff Penn 4-H Educational Center located near Reidsville, NC.

46 (b) The 4-H camps that were located at the sites listed in subdivisions (1) and (2) of this
47 subsection have ceased to operate as 4-H camps. At the request of the board of county
48 commissioners of any county that is the site of one of the defunct 4-H camps listed in this
49 subsection, North Carolina State University shall consult with the board regarding actions that
50 may be taken to reopen the 4-H camp in that county and other options that may be available for
51 the use of the site.

1 Within 90 days after any consultation with a board of county commissioners conducted
2 pursuant to this subsection, North Carolina State University shall submit a written report to the
3 Joint Legislative Education Oversight Committee, the Senate Appropriations Committee on
4 Education/Higher Education, the House of Representatives Appropriations Subcommittee on
5 Education, and the Fiscal Research Division regarding the feasibility of reopening the site as a
6 4-H camp and any other options considered for the use of the site.

7 The list of defunct 4-H camps follows:

8 (1) Anita-Alta 4-H Camp in the Pisgah National Forest in Lenoir, NC.

9 (2) Swannanoa 4-H Camp located at Swannanoa, NC.

10 (c) North Carolina State University shall take all practicable measures to operate the
11 4-H camps in a manner that will generate a positive fund balance in the institutional trust funds
12 that account for the activities of the 4-H camps."

13 **SECTION 11.7.(b)** Article 7 of Chapter 146 of the General Statutes is amended by
14 adding a new section to read:

15 **"§ 146-30.1. Application of net proceeds of disposition or use of real property allocated to**
16 **the 4-H Camping Program.**

17 (a) Limitation. – Notwithstanding G.S. 146-30 or any other provision of law, and
18 subject to the limitations contained in any applicable deed, the net proceeds of any disposition
19 of, use of, or activity on real property allocated to the 4-H Camping Program shall be used
20 solely for the operation of the 4-H Camping Program, for the acquisition of real property for
21 the 4-H Camping Program, or for the funding of an endowment to support these purposes.
22 These proceeds shall not be used to pay any debt or other financial obligation owed to a State
23 agency that arose prior to the effective date of this section.

24 (b) Definition of Net Proceeds. – For purposes of this section, the term "net proceeds"
25 shall have the same meaning as in G.S. 146-30.

26 (c) No Supplanting of General Fund Support. – It is the intent of the General Assembly
27 that appropriations for the 4-H Camping Program not be reduced as a result of the realization of
28 proceeds under this section. Instead, the General Assembly intends that the amount of
29 appropriations be determined as if no proceeds had been realized under this section. The
30 Director of the Budget shall not decrease the recommended continuation budget requirements
31 for the 4-H Camping Program as a result of proceeds being realized under this section.

32 (d) Proceeds Must Be Appropriated. – Nothing in this section shall be construed to
33 appropriate the proceeds described in this section."

40 Springs property to the Department of Environment and Natural Resources. The General
41 Assembly authorizes the Department of Environment and Natural Resources to add this
42 property to the State Parks System as provided in G.S. 113-44.14(b).

43 **SECTION 11.7.(e)** Of the funds appropriated by this act for the 2014-2015 fiscal

6 ~~payment schedule~~ Authority, in consultation with The University of North Carolina, the North
7 Carolina Community College System, and the North Carolina Independent Colleges and
8 Universities, shall study ways to structure its financial aid payment schedules to encourage
9 students to complete an average of 30 credit hours per academic year. The State Education
10 Assistance Authority shall make an interim report to the Joint Legislative Education Oversight
11 Committee by March 1, 2014, regarding the measures implemented by the Authority pursuant
12 to this subsection. March 1, 2015, on its progress or lack thereof in developing such schedules
13 and shall make a final report to the Joint Legislative Education Oversight Committee by

24 Board of Governors of The University of North Carolina may, in its discretion, provide
25 regulations under which a full-time faculty member of the rank of full-time instructor or above,
26 and any full-time staff member of The University of North Carolina may during the period of
27 normal employment enroll for not more than ~~two~~ three courses per year in The University of
28 North Carolina free of charge for ~~tuition, tuition and fees,~~ provided such enrollment does not
29 interfere with normal employment obligations and further provided that such enrollments are
30 not counted for the purpose of receiving general fund appropriations."

31 **SECTION 11.9.(b)** This section applies to the 2014-2015 fall academic semester
32 and each subsequent academic semester.

33
34 **REPORT ON COLLEGE FOUNDATION OF NORTH CAROLINA SUSTAINABILITY**

35 **SECTION 11.11.** No later than December 1, 2014, the State Education Assistance
36 Authority shall report to the Office of State Budget and Management and the Fiscal Research
37 Division of the General Assembly on its progress toward funding operations of the College
38 Foundation of North Carolina entirely from non-General Fund sources. This report shall
39 include all of the following:

- 40 (1) The status of fundraising efforts to date.
- 41 (2) A detailed plan and time line for generating additional revenues.
- 42 (3) Estimated expenditures and revenues by type for the next four fiscal years.
- 43 (4) Potential reduction measures and alternative funding options should General
44 Fund appropriations not be provided in the next biennium.

45
46 **TUITION ASSISTANCE TO VETERANS WHO PARTICIPATE IN THE YELLOW**
47 **RIBBON PROGRAM AND THEIR SPOUSES AND DEPENDENT RELATIVES**

48 **SECTION 11.12.(a)** Article 14 of Chapter 116 of the General Statutes is amended
49 by adding a new section to read:

50 "**§ 116-143.8. Tuition assistance for certain veterans and their dependents.**

- 51 (a) The following definitions apply in this section:

1 (1) Institution of higher education. – Has the same meaning as in
2 G.S. 116-143.1(a)(1).

3 (2) Yellow Ribbon Program. – Yellow Ribbon G.I. Education Enhancement
4 Program, 38 U.S.C. § 3317.

5 (b) Either the Board of Governors of The University of North Carolina or one or more
6 constituent institutions shall annually enter into an agreement with the United States Secretary
7 of Veterans Affairs to participate in the Yellow Ribbon Program. The State Board of
8 Community Colleges or one or more community colleges shall annually enter into an
9 agreement with the United States Secretary of Veterans Affairs to participate in the Yellow
10 Ribbon Program. The agreements shall include all of the following terms:

11 (1) A grant of ninety percent (90%) of the cost of tuition and mandatory fees not
12 otherwise covered shall be provided for every eligible veteran or eligible
13 spouse or dependent relative of a veteran who is enrolled or will be enrolled
14 as an undergraduate student at a constituent institution or as a student at a
15 community college.

16 (2) To be eligible for grants under the Yellow Ribbon Program, a student must
17 meet all program requirements established by the federal government. In
18 addition, to be eligible for a Yellow Ribbon grant in which the school share
19 of the grant is paid with State appropriation, a student must be enrolled as an
20 undergraduate student at a constituent institution or as a student at a North
21 Carolina community college.

22 (c) This section is not intended to prohibit constituent institutions from using private
23 funds to provide Yellow Ribbon grants for students enrolled in master's or doctoral level
24 programs.

25 (d) The General Assembly encourages private institutions of higher education in North
26 Carolina to participate in the Yellow Ribbon Program."

27 **SECTION 11.12.(b)** It is the intent of the General Assembly to establish two
28 reserve funds for the purpose of forward funding tuition assistance to students who participate
29 in the Yellow Ribbon Program. Therefore, the General Assembly establishes the two following
30 reserve funds:

31 (1) There is established the UNC Yellow Ribbon Reserve to be managed by the
32 Board of Governors of The University of North Carolina. Of the funds
33 appropriated by this act to the Board of Governors, the sum of four million
34 eight hundred sixty-three thousand two hundred seventy-six dollars
35 (\$4,863,276) shall be allocated to the UNC Yellow Ribbon Reserve and
36 shall be held in reserve for the 2014-2015 fiscal year. Beginning with the
37 2015-2016 fiscal year, the funds in the UNC Yellow Ribbon Reserve shall
38 be used to fund undergraduate tuition assistance to participants in the Yellow
39 Ribbon Program for the 2015-2016 academic year and each subsequent
40 academic year.

41 (2) There is established the Community College Yellow Ribbon Reserve to be
42 managed by the State Board of Community Colleges. Of the funds
43 appropriated by this act to the Community Colleges System Office, the sum
44 of one million dollars (\$1,000,000) shall be allocated to the Community
45 College Yellow Ribbon Reserve and shall be held in reserve for the
46 2014-2015 fiscal year. Beginning with the 2015-2016 fiscal year, the funds
47 in the Community College Yellow Ribbon Reserve shall be used to fund
48 tuition assistance to participants in the Yellow Ribbon Program for the
49 2015-2016 academic year and each subsequent academic year.

50 **SECTION 11.12.(c)** The Board of Governors and the State Board of Community
51 Colleges shall each report to the Joint Legislative Education Oversight Committee by January

1, 2015, regarding their planned participation in the Yellow Ribbon Program for the 2015-2016 academic year. Each report shall include the following information:

- (1) The number and identity of constituent institutions or community colleges that will participate in the Yellow Ribbon Program.
- (2) The methodology used by each governing board to select the institutions of higher education that will participate in the Yellow Ribbon Program.
- (3) For each institution that will participate, the maximum number of students and the maximum award amount per student.
- (4) A list of the institutions of higher education that will not participate in the Yellow Ribbon Program and the reason each institution is not participating.

SECTION 11.12.(d) Subsection (a) of this section applies to the 2015-2016 academic year and each subsequent academic year.

STUDY UNIVERSITY TUITION

SECTION 11.15.(a) The Joint Legislative Education Oversight Committee shall study the increasing cost of attendance for resident and nonresident students attending The University of North Carolina. In doing so, the Committee shall consider, at a minimum, all of the following:

- (1) The tuition and mandatory fees at the constituent institutions of The University of North Carolina.
- (2) How changes in tuition and fees in recent years have compared to overall economic inflation.
- (3) The funding available to offset increases in the cost of attendance, which could include non-General Fund revenues and the availability of State- and non-State-funded financial aid.
- (4) The tuition cost controls or limits that may have been implemented in other states.
- (5) The desirability of encouraging students seeking an undergraduate degree to enroll first in a community college for college credit and then enroll in a constituent institution to complete the requirements for the undergraduate degree.

SECTION 11.15.(b) The Joint Legislative Education Oversight Committee shall report the results of the study required by subsection (a) of this section to the General Assembly prior to the convening of the 2015 General Assembly.

UNC REVERSIONS

However, the amount carried forward under this section shall not exceed two and one-half percent (2 1/2%) of the General Fund appropriation. The Director of the Budget, under the authority set forth in G.S. 143C-6-2 shall establish the~~

~~General Fund current operations credit balance remaining in each budget code of each institution.~~ Of the General Fund current operations appropriations credit balance remaining at the end of each fiscal year in each of the budget codes listed in this subsection, any amount of the General Fund appropriation for that budget code for that fiscal year (i) may be carried forward to the next fiscal year in that budget code, (ii) is appropriated in that budget code, and (iii) may be used for any of the purposes set out in subsection (f) of this section. However, the amount carried forward in each budget code under this subsection shall not exceed two and one-half percent (2.5%) of the General Fund appropriation in that budget code. The Director of the Budget, under the authority set forth in G.S. 143C-6-2, shall establish the General Fund current operations credit balance remaining in each budget code.

- (c) Repealed by Session Laws 1998-212, s. 11(a).
- (d) Repealed by Session Laws 1998-212, s. 11(b).

~~(e) Notwithstanding G.S. 143C-1-2 of the General Fund current operations appropriations credit balance remaining in Budget Code 16010 of the Office of General Administration of The University of North Carolina, any amount of the General Fund appropriation for that fiscal year may be carried forward in that budget code to the next fiscal year and is appropriated for one time expenditures that will not impose additional financial obligations on the State. However, the amount carried forward under this subsection shall not exceed two and one-half percent (2 1/2%) of the General Fund appropriation. The Director of the Budget, under the authority set forth in G.S. 143C-6-2, shall establish the General Fund current operations credit balance remaining in Budget Code 16010 of the Office of General Administration of The University of North Carolina. The funds shall not be used to support positions.~~

(f) Funds carried forward pursuant to subsection (a) of this section may be used for one-time expenditures, provided, however, that the expenditures shall not impose additional financial obligations on the State and shall not be used to support positions."

SECTION 11.17.(b) G.S. 116-14(b2) reads as rewritten:

"(b2) The President, in consultation with the State Auditor and the Director of the Office of State Human Resources, shall ascertain that the management staff and internal financial controls are in place and continue in place to successfully administer the additional authority authorized under G.S. 116-14(b1) and ~~G.S. 116-30.3(e)~~ G.S. 116-30.3. All actions taken by the President pursuant to G.S. 116-14(b1) and ~~G.S. 116-30.3(e)~~ G.S. 116-30.3 are subject to audit by the State Auditor."

SECTION 11.17.(c) This section applies to the 2014-2015 fiscal year and each subsequent fiscal year.

UNC SET NONRESIDENT TUITION RATES

SECTION 11.18. Notwithstanding the provisions of S.L. 2013-360, the Board of Governors of The University of North Carolina may set nonresident undergraduate tuition rates for the 2014-2015 fiscal year at any level deemed appropriate by the Board of Governors; however, the systemwide total in new tuition receipts due to these changes must be at least twenty-seven million two hundred forty-three thousand one hundred fifty-seven dollars (\$27,243,157) for the 2014-2015 fiscal year.

UNC STRATEGIC PLAN FUNDS

SECTION 11.19. Section 11.13 of S.L. 2013-360 reads as rewritten:

"SECTION 11.13. Of the funds appropriated by this act to the Board of Governors of The University of North Carolina for the 2013-2015 fiscal biennium, the Board of Governors may spend a sum of up to fifteen million dollars (\$15,000,000) ~~for the 2013-2014 fiscal year and a sum of up to fifteen million dollars (\$15,000,000) for the 2014-2015 fiscal year~~ on a recurring basis to implement provisions of The University of North Carolina Strategic Plan as set out in the report "Our Time, Our Future: The University of North Carolina Compact with North Carolina. These funds are in addition to any new funds appropriated for The University of North Carolina by this act."

REPORT ON FUNDING OF STATE MEDICAL SCHOOLS

SECTION 11.20. The University of North Carolina System, working with the appropriate constituent institutions and health systems, shall report to the Joint Legislative Oversight Committee on Health and Human Services and the Joint Legislative Education Oversight Committee on how the medical schools are funded. The report shall include a detailed explanation of the sources of all income within both a current and historical context, noting any changes in funding sources and amounts over time. The report shall also include a detailed explanation of operating expenses so that they may be compared to income. The report required by this section is due by October 1, 2014, and shall be based on the most recent audited fiscal year practicable.

STUDY ON ESTABLISHMENT OF NEW OPTOMETRY SCHOOLS

SECTION 11.21.(a) By December 1, 2014, the Board of Governors of The University of North Carolina shall evaluate and report to the Joint Legislative Education Oversight Committee, the Joint Legislative Oversight Committee on Health and Human Services, and the Fiscal Research Division on the feasibility of establishing a school of optometry at one or more of the following constituent institutions:

- (1) The University of North Carolina at Chapel Hill.
- (2) The University of North Carolina at Pembroke.
- (3) East Carolina University.
- (4) Elizabeth City State University.
- (5) Fayetteville State University.
- (6) North Carolina Agricultural and Technical State University.
- (7) North Carolina Central University.
- (8) Winston-Salem State University.

SECTION 11.21.(b) The report by the Board of Governors pursuant to subsection (a) of this section shall include at least all of the following:

- (1) A breakdown of any projected capital, operational, or other expenditures necessary for establishing and operating a school of optometry affiliated with the institution.
- (2) A breakdown of all funds available to assist the institution with these expenses.
- (3) A projected number of applicants for the affiliated school of optometry.

SECTION 11.21.(c) The North Carolina Independent Colleges and Universities, Inc., (NCICU) is encouraged to examine and report by December 1, 2014, to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division on the feasibility of establishing a school of optometry affiliated with an NCICU college or university. The report should include at least all of the following:

- 1 (1) A breakdown of any projected capital, operational, or other expenditures
2 necessary for establishing and operating a school of optometry affiliated
3 with the institution.
- 4 (2) A breakdown of all funds available to assist the institution with these
5 expenses.
- 6 (3) A projected number of applicants for the affiliated school of optometry.
7

8 **UNC MANAGEMENT FLEXIBILITY REDUCTION**

9 **SECTION 11.22.** Section 11.5 of S.L. 2013-360 reads as rewritten:

10 **"SECTION 11.5.(a)** The management flexibility reduction for The University of North
11 Carolina shall not be allocated by the Board of Governors to the constituent institutions and
12 affiliated entities using an across-the-board method but shall be done in a manner that
13 recognizes the importance of the academic missions and differences among The University of

29 in those funds that can be used to assist with operating costs. In addition, the campuses of the

44 **"SECTION 11.5.(c)** The University of North Carolina shall report on the implementation
45 of the management flexibility reduction in subsection (a) of this section to the Office of State
46 Budget and Management and the Fiscal Research Division no later than ~~October 1, 2013.~~
47 October 1, 2014. This report shall identify both of the following by campus:

- 48 (1) The total number of positions eliminated by type (faculty/nonfaculty).
- 49 (2) The low-performing, redundant, and low-enrollment programs that were
50 eliminated."

SECTION 11.23. Section 1.38(a) and Section 1.38(c) of S.L. 2011-266 are repealed.

ECSU STUDY

SECTION 11.24.(a) The General Assembly finds that Elizabeth City State University had its origins established during the 1891 legislative session and is a key educational and economic resource for northeastern North Carolina. The Joint Legislative Education Oversight Committee shall evaluate and study strategies to address any financial or enrollment concerns.

SECTION 11.24.(b) The Joint Legislative Education Oversight Committee shall examine, at a minimum, any plans of The University of North Carolina Board of Governors or of Elizabeth City State University to restore Elizabeth City State University to more financially sustainable conditions, including the strategies described in Elizabeth City State University's March 2014, document titled, "Rightsizing ECSU: The Need for Financial Stability". Further, the General Assembly urges that, in conducting the study described in subsection (a) of this section, the JLEOC's work include consultation with the Board of Trustees of Elizabeth City State University and any other appropriate parties.

SECTION 11.24.(c) The Joint Legislative Education Oversight Committee shall report the results of the study required by this section to the General Assembly prior to the convening of the 2015 General Assembly. The report shall include recommendations, if any, for actions by the General Assembly to address such financial and enrollment concerns.

"SECTION 12A.2.(a) Of the funds appropriated in this act to the Department of Health and Human Services, Division of Central Management and Support, the sum of nine million five hundred twenty-nine thousand one hundred thirty-four dollars (\$9,529,134) in recurring funds for ~~each year of the 2013-2015 fiscal biennium, the 2013-2014 fiscal year and the sum of~~ nine million three hundred three thousand nine hundred eleven dollars (\$9,303,911) in recurring funds for the 2014-2015 fiscal year, the sum of three hundred seventeen thousand four hundred dollars (\$317,400) in nonrecurring funds for each year of the 2013-2015 fiscal biennium, and the sum of three million eight hundred fifty-two thousand five hundred dollars (\$3,852,500) appropriated in Section 12J.1 of this act in Social Services Block Grant funds for each year of the 2013-2015 fiscal biennium shall be used to allocate funds for nonprofit organizations.

...

"SECTION 12A.2.(d) It is the intent of the General Assembly that, beginning fiscal year 2014-2015, the Department implement a competitive grants process for nonprofit funding. To that end, the Department shall develop a plan that establishes a competitive grants process to be administered by the Division of Central Management and Support. The Department shall develop a plan that, at a minimum, includes each of the following:

- (1) A request for application (RFA) process to allow nonprofits to apply for and receive State funds on a competitive basis.

- 1 (2) A requirement that nonprofits match a minimum of ten percent (10%) of the
2 total amount of the grant award.
- 3 (3) A requirement that the Secretary prioritize grant awards to those nonprofits
4 that are able to leverage non-State funds in addition to the grant award.
- 5 (4) A process that awards grants to nonprofits ~~dedicated to providing~~ that have
6 the capacity to provide services on a statewide basis and that support any of
7 the following State health and wellness initiatives:
- 8 a. A program targeting advocacy, support, education, or residential
9 services for persons diagnosed with autism.
- 10 ~~b. A comprehensive program of education, advocacy, and support~~
11 ~~related to brain injury and those affected by brain injury.~~
- 12 c. A system of residential supports for those afflicted with substance
13 abuse addiction.
- 14 d. A program of advocacy and supports for individuals with intellectual
15 and developmental disabilities or severe and persistent mental illness,
16 substance abusers, or the elderly.
- 17 e. Supports and services to children and adults with developmental
18 disabilities or mental health diagnoses.
- 19 f. A food distribution system for needy individuals.
- 20 g. The provision and coordination of services for the homeless.
- 21 h. The provision of services for individuals aging out of foster care.
- 22 i. Programs promoting wellness, physical activity, and health education
23 programming for North Carolinians.
- 24 j. A program focused on enhancing vision screening through the State's
25 public school system.
- 26 k. Provision for the delivery of after-school services for apprenticeships
27 or mentoring at-risk youth.
- 28 l. The provision of direct services for amyotrophic lateral sclerosis
29 (ALS) and those diagnosed with the disease.
- 30 m. The provision of assistive information technology services for blind
31 and disabled persons.
- 32 n. A comprehensive smoking prevention and cessation program that
33 screens and treats tobacco use in pregnant women and postpartum
34 mothers.
- 35 (5) Ensures that funds received by the Department to implement the plan
36 supplement and do not supplant existing funds for health and wellness
37 programs and initiatives.

40 FUNDS FOR STATEWIDE HEALTH INFORMATION EXCHANGE

41 SECTION 12A.2.(a) It is the intent of the General Assembly:

9 represent the State share for the maximum amount of approved federal matching funds for
10 allowable Medicaid administrative costs related to the HIE Network.

11 **SECTION 12A.2.(c)** By March 1, 2015, the NC HIE shall report to the Joint
12 Legislative Oversight Committee on Health and Human Services, the Joint Legislative
13 Oversight Committee on Information Technology, and the Fiscal Research Division on its use
14 of (i) State appropriations allocated to the NC HIE pursuant to this section and (ii) federal
15 matching funds received by the NC HIE for costs related to the HIE Network. The report shall
16 include a detailed, audited report of all State and federal funds received by the NC HIE and all
17 expenditures from these funds.

- 41 (5) The Department shall not make monthly payments authorized by this section
42 to a group home on behalf of a resident during the pendency of an appeal by

- 44 (6) The Department shall terminate all monthly payments pursuant to this
45 section on June 30, 2015, or upon depletion of the funds appropriated in this

- 48 (7) Each group home that receives the monthly payments authorized by this
49 section shall submit to the Department a list of all funding sources for the

7 **SECTION 12A.7.(d)** By no later than April 1, 2015, the Department of Health and

48 **"SECTION 12B.3.(b)** Fees Beginning October 1, 2014, fees for families who are required
 49 to share in the cost of care shall be established based on a ten percent (10%) of gross family
 50 income and adjusted for family size. Fees shall be determined as follows: income. Co-payments
 51 shall not be prorated for part-time care.

7 **"SECTION 12B.4.(a)** The Department of Health and Human Services shall allocate child
8 care subsidy voucher funds to pay the costs of necessary child care for minor children of needy
9 families. The mandatory thirty percent (30%) North Carolina Partnership for Children, Inc.,
10 subsidy allocation under G.S. 143B-168.15(g) shall constitute the base amount for each
11 county's child care subsidy allocation. The Department of Health and Human Services shall use
12 the following method when allocating federal and State child care funds, not including the
13 aggregate mandatory thirty percent (30%) North Carolina Partnership for Children, Inc.,
14 subsidy allocation:

17 ~~seventy five percent (75%) of the State median income~~ the applicable
18 federal poverty level percentage set forth in Section 12B.3(a) of this act, as
19 amended.
- 20 (2) No county's allocation shall be less than ninety percent (90%) of its State
21 fiscal year 2001-2002 initial child care subsidy allocation.
- 22 (3) For fiscal years 2013-2014 and 2014-2015, the Division of Child
23 Development and Early Education shall base the formula identified in
24 subdivision (1) of this subsection on the same data source used for the
25 2012-2013 fiscal year.
- 26 (4) The Department of Health and Human Services shall allocate to counties all
27 State funds appropriated for child care subsidy and shall not withhold funds
28 during the 2013-2014 and 2014-2015 fiscal years.

29 **"SECTION 12B.4.(b)** The Department of Health and Human Services may reallocate
30 unused child care subsidy voucher funds in order to meet the child care needs of low-income
31 families. Any reallocation of funds shall be based upon the expenditures of all child care
32 subsidy voucher funding, including North Carolina Partnership for Children, Inc., funds within
33 a county.

34 **"SECTION 12B.4.(c)** When implementing the formula under subsection (a) of this
35 section, the Department of Health and Human Services, Division of Child Development and
36 Early Education, shall include the market rate increase in the formula process, rather than
37 running these increases outside of the formula process. Additionally, the Department shall do
38 the following:

- 39 (1) Beginning fiscal year 2014-2015, use one-third implementation of the new
40 Census data allocation formula every two years, provided the following
41 applies regarding increases to a county's allocation:
 - 42 a. For the 2014-2015 fiscal year allocations, a county that did not have
43 a child care subsidy waiting list during the 2013-2014 fiscal year
44 shall not receive an increase in its allocation due to the new
45 allocation formula directed in this subdivision.
 - 46 b. Beginning fiscal year 2015-2016, a county whose spending
47 coefficient is below ninety-five percent (95%) in the previous fiscal
48 year shall not receive an increase in its allocation in the following
49 fiscal year. The Division may waive this requirement and allow an
50 increase if the spending coefficient is below ninety-five percent
51 (95%) due to extraordinary circumstances, such as a State or federal

1 disaster declaration in the affected county. By October 1st of each

29 SUBPART XII-C. DIVISION OF SOCIAL SERVICES

31 CHILD PROTECTIVE SERVICES IMPROVEMENT INITIATIVE

32 SECTION 12C.1.(a) Findings and Intent. – The General Assembly makes the
33 following findings:

- 34 (1) Child Protective Services' policy from the Department of Health and Human
35 Services, Division of Social Services, recommends that the average child
36 protective services caseload be no greater than 10 families at any time for
37 workers performing child protective services assessments and 10 families at
38 any time for staff providing in-home services. However, data suggests that in
39 43 of the counties in this State, 21 have a caseload size of over 15 cases per
40 worker; and further, in nine of those 21 counties, there is an average
41 caseload size of over 20 cases per worker.
- 42 (2) During the 2013-2014 fiscal year, county departments of social services lost
43 federal funding for child protective services under the Temporary Assistance
44 of Needy Families (TANF) Block Grant and Title IV-E funding. However,
45 the number of Child Protective Services investigations has grown by twenty
46 percent (20%) from fiscal year 2002 to fiscal year 2012.
- 47 (3) There is no current, statewide data available on the performance of county
48 departments of social services regarding child protective services.
- 49 (4) There exists the potential for a conflict of interest to arise when a county
50 department of social services has been appointed as guardian for both (i) a
51 child who is the subject of a report of abuse, neglect, or dependency that

1 would be investigated by Child Protective Services and (ii) for the parent or
2 legal guardian of the child.

3 It is the intent of the General Assembly to (i) reduce caseload size for Child
4 Protective Services' workers to the recommended standard, (ii) provide adequate resources for
5 county departments of social services to provide child protective services for abused, neglected,
6 and dependent children, (iii) provide for a comprehensive evaluation of various functions and
7 funding regarding child protective services, and (iv) study ways to reduce conflicts of interest
8 regarding guardianship and child protective services. To that end, the General Assembly
9 supports the initiatives and the allocation of funds for child welfare services as described in this
10 section.

11 **SECTION 12C.1.(b)** Funds for Child Protective Services. – Of the funds
12 appropriated in this act to the Department of Health and Human Services, Division of Social
13 Services, the sum of eight million three hundred twenty-six thousand six hundred twenty-seven
14 dollars (\$8,326,627) shall be allocated to provide additional child protective services workers at
15 county departments of social services to reduce caseloads to the recommended standard.

16 **SECTION 12C.1.(c)** Funds for In-Home Services. – Of the funds appropriated in
17 this act to the Department of Health and Human Services, Division of Social Services, the sum
18 of four million five hundred thousand dollars (\$4,500,000) shall be allocated for Child Welfare
19 in-home services to provide and coordinate interventions and services that focus on child safety
20 and protection, family preservation, and the prevention of further abuse or neglect.

21 **SECTION 12C.1.(d)** Funds for Oversight of Child Welfare Services. – Of the
22 funds appropriated in this act to the Department of Health and Human Services, Division of
23 Social Services, the sum of seven hundred fifty thousand dollars (\$750,000) shall be allocated
24 to fund nine positions to the Division to enhance oversight of child welfare services in county
25 departments of social services. These positions shall be used to monitor, train, and provide
26 technical assistance to the county departments of social services to ensure children and families
27 are provided services that address the safety, permanency, and well-being of children served by
28 child welfare services.

29 **SECTION 12C.1.(e)** Pilot Program. – Of the funds appropriated in this act to the
30 Department of Health and Human Services, Division of Social Services, the sum of three
31 hundred thousand dollars (\$300,000) shall be used to establish and implement a child protective
32 services pilot program. The funds shall be used to enhance coordination of services and
33 information among county departments of social services, local law enforcement agencies, the
34 court system, guardian ad litem programs, and other agencies as deemed appropriate by the
35 Department. The Department shall determine the number of sites that may participate in the
36 pilot program and include regions that are geographically diverse.

37 The Division shall make a progress report on the pilot program to the Senate
38 Appropriations Committee on Health and Human Services, the House of Representatives
39 Appropriations Subcommittee on Health and Human Services, and the Fiscal Research
40 Division no later than March 1, 2015. The Division shall make a final report of its findings and
41 recommendations on the pilot program to the Joint Legislative Oversight Committee on Health
42 and Human Services no later than March 1, 2016.

43 **SECTION 12C.1.(f)** Statewide Evaluation. – Of the funds appropriated in this act
44 to the Department of Health and Human Services, Division of Social Services, the sum of
45 seven hundred thousand dollars (\$700,000) shall be used to provide for a comprehensive,
46 statewide evaluation of the State's child protective services system. The Division of Social
47 Services shall contract for an independent evaluation of the system, which evaluation shall
48 include developing recommendations on the following:

- 49 (1) The performance of county departments of social services as related to child
50 protective services.
- 51 (2) Caseload sizes.

- 1 (3) The administrative structure of the child protective services system in the
- 2 State.
- 3 (4) Adequacy of funding.
- 4 (5) Child protective services' worker turnover.
- 5 (6) Monitoring and oversight of county departments of social services.

6 The Division shall report the findings and recommendations from the evaluation to
 7 the Joint Legislative Oversight Committee on Health and Human Services no later than January
 8 1, 2016.

9 **SECTION 12C.1.(g)** Study Conflicts of Interest/Public Guardianship and Child
 10 Protective Services. – The Department of Health and Human Services, Division of Social
 11 Services, shall study the issue of conflicts of interest in child welfare cases as related to public
 12 guardianship. In conducting the study, the Department shall consider the following regarding
 13 addressing potential conflicts of interest:

- 14 (1) Creating internal firewalls to prevent information sharing and influence
- 15 among staff members involved with the conflicting cases.
- 16 (2) Creating a formal or an informal "buddy system" allowing a county with a
- 17 conflict to refer a case to a neighboring county.
- 18 (3) Referring the guardianship to a corporate guardian until the child welfare
- 19 case is resolved.
- 20 (4) Having the Department assume responsibility for either the guardianship or
- 21 the child welfare case.
- 22 (5) Recommending legislation to permit the clerk the option to appoint a public
- 23 agency or official, other than the Director of Social Services, to serve as a
- 24 disinterested public agent in exceptional circumstances only.
- 25 (6) Any other issues specific to this matter the Department deems appropriate.

26 The Division shall submit a final report of its findings and recommendations to the
 27 Senate Appropriations Committee on Health and Human Services, the House of
 28 Representatives Appropriations Subcommittee on Health and Human Services, and the Fiscal
 29 Research Division no later than February 1, 2015.

1 **SECTION 12C.3.(a)** The purpose of this section is to enable the Eastern Band of
2 Cherokee Indians to assume responsibility for certain social services, healthcare benefit
3 programs, ancillary services, including Medicaid administrative and service related functions,
4 and related reimbursements.

5 **SECTION 12C.3.(b)** Beginning October 1, 2014, or upon federal approval, the
6 Eastern Band of Cherokee Indians may begin assuming the responsibility for the Supplemental
7 Nutrition Assistance Program (SNAP). When the Eastern Band of Cherokee Indians assumes
8 responsibility for SNAP, then any State statutes, portions of statutes, or rules relating to the
9 provision of social services regarding SNAP services by a county department of social services
10 for members of the Eastern Band of Cherokee Indians shall no longer apply to the Tribe, and
11 the functions, administration, and funding requirements relating to those social services are
12 thereby delegated to the Eastern Band of Cherokee Indians.

13 No later than October 1, 2015, and with the exception of services related to special
14 assistance, childcare, and adult care homes, the Eastern Band of Cherokee Indians may assume
15 responsibility for other programs as described under G.S. 108A-25(e), enacted in subsection (c)
16 of this section. When the Eastern Band of Cherokee Indians assumes responsibility for any of
17 those other programs, then any State statutes, portions of statutes, or rules relating to the
18 provision of services for those programs by a county department of social services for members
19 of the Eastern Band of Cherokee Indians shall no longer apply to the Tribe, and the functions,
20 administration, and funding requirements relating to those programs are thereby delegated to
21 the Eastern Band of Cherokee Indians.

22 **SECTION 12C.3.(c)** G.S. 108A-25 reads as rewritten:

23 **"§ 108A-25. Creation of ~~programs~~programs; assumption by federally recognized tribe of**
24 **programs.**

26 (e) When any federally recognized Native American tribe within the State assumes

46 borne by the State shall be allocated directly to the Eastern Band of
47 Cherokee Indians rather than to those counties.

48 (2) Any portion of nonfederal matching funds borne by counties for public
49 assistance and social services programs and related administrative costs shall
50 be borne by the Eastern Band of Cherokee Indians."

1 **SECTION 12C.3.(e)** No later than October 1, 2014, the Department of Health and
 2 Human Services, Division of Medical Assistance, shall submit to the Centers for Medicare and
 3 Medicaid Services (CMS) Medicaid and NC Health Choice state plan amendments and
 4 Medicaid waivers necessary to achieve the following:

- 5 (1) To effectuate the changes required by this section.
- 6 (2) To address the healthcare needs identified in community health assessments
 7 and plans conducted by the Eastern Band of Cherokee Indians, provided that
 8 changes to Medicaid and NC Health Choice services made by the state plan
 9 amendments or waivers will be one hundred percent (100%) federally
 10 funded. If any state plan amendments or waivers authorized by this
 11 subdivision will increase the state share of administrative or other costs, the
 12 Department shall report the anticipated increased costs to the Joint
 13 Legislative Oversight Committee on Health and Human Services.

14 The state plan amendments and waivers authorized by this section shall have an
 15 effective date no later than October 1, 2015.

29 or habilitation.

30 (4) A report of the guardian's efforts to restore competency.

31 (5) A report of the guardian's efforts to seek alternatives to guardianship.

32 (6) If the guardian is a disinterested public agent or corporation, a report of the
33 efforts to identify alternative guardians.

34 (7) The guardian's recommendations for implementing a more limited
35 guardianship, preserving for the ward the opportunity to exercise rights that
36 are within the ward's comprehension and judgment.

37 (8) Any additional reports or information required by the clerk.

38 (a2) The guardian may include in each status report additional information pertaining to
39 the ward's best interests.

40 (b) Each status report shall be filed (i) under the guardian's oath or affirmation that the
41 report is complete and accurate so far as ~~he~~ the guardian is informed and can
42 ~~determine.~~ determine or (ii) with the signature of a disinterested, competent witness to a
43 statement by the guardian that the report is complete and accurate so far as the guardian is
44 informed and can determine. Status reports filed with the signature of a disinterested,
45 competent witness shall include the full name, address, and telephone number of the witness.

46 (b1) The clerk shall make status reports submitted by corporations or disinterested public
47 agents available to the Director, or the Director's designee, of the Division of Aging and Adult
48 Services within the Department of Health and Human Services. The Director, or the Director's
49 designee, shall review the status reports in connection with the Department's regular program of
50 oversight for these categories of guardians.

1 (c) A clerk or designated agency that receives a status report shall not make the status
2 report available to anyone other than the guardian, the ward, the court, or State or local human
3 ~~resource-services~~ agencies providing services to the ward.

4 (d) The clerk, on the clerk's own motion, or any interested party, may file a motion in
5 the cause pursuant to G.S. 35A-1207 with the clerk in the county where the guardianship is

7 consideration of any matters contained in the status report."

10 INCREASED FEE FOR PRIVATE WELL-WATER TESTING

11 SECTION 12E.3.(a) G.S. 130A-5(16) reads as rewritten:

12 "(16) To charge a fee of up to ~~fifty five dollars (\$55.00)~~ seventy-four dollars
13 (\$74.00) for analyzing private well-water samples sent to the State
14 Laboratory of Public Health by local health departments. The fee shall be
15 imposed only for analyzing samples from newly constructed and existing
16 wells. The fee shall be computed annually by the Director of the State
17 Laboratory of Public Health by analyzing the previous year's testing at the
18 State Laboratory of Public Health, and applying the amount of the total cost
19 of the private well-water testing, minus State appropriations that support this
20 effort. The fee includes the charge for the private well-water panel test kit."

21 SECTION 12E.3.(b) Subsection (a) of this section becomes effective July 1, 2014,
22 and applies to private well-water samples analyzed on or after that date.

23 SECTION 12E.3.(c) The Department of Health and Human Services, Division of
24 Public Health, shall, in consultation with local health departments and the Department of
25 Environment and Natural Resources, study options for reducing or waiving the private
26 well-water testing fee established in subsection (a) of this section for households with incomes
27 at or below three hundred percent (300%) of the current federal poverty level. The Department
28 shall report its findings and recommendations, including any recommended legislation, to the
29 Joint Legislative Oversight Committee on Health and Human Services, the Environmental
30 Review Commission, and the Fiscal Research Division by December 1, 2014.

32 OPERATIONAL EFFICIENCIES FOR OFFICE OF THE CHIEF MEDICAL 33 EXAMINER

34 SECTION 12E.6.(a) G.S. 130A-382 reads as rewritten:

35 "**§ 130A-382. County medical examiners; appointment; term of office; vacancies.**

36 ~~One or more county medical examiners for each county shall be appointed by the Chief~~
37 ~~Medical Examiner~~The Chief Medical Examiner shall appoint one or more county medical
38 examiners for each county for a three-year term. County medical examiners shall be appointed
39 from a list of physicians licensed to practice medicine in this State submitted by the medical
40 society of the county in which the appointment is to be made. If no names are submitted by the
41 society, the Chief Medical Examiner shall appoint one or more medical examiners from
42 physicians in the county licensed to practice medicine in this State. In the event no licensed
43 physician in a county accepts an appointment, the Chief Medical Examiner may appoint as
44 acting county medical examiner one or more physicians licensed to practice medicine in this
45 State from other counties, a licensed physician assistant, a nurse, a coroner, or an individual
46 who has taken an approved course of training as required by the Chief Medical Examiner. The
47 acting county medical examiner shall have all the duties and authority of the physician medical
48 examiner except to perform autopsies.In appointing medical examiners for each county, the
49 Chief Medical Examiner shall give preference to physicians licensed to practice medicine in
50 this State but may also appoint licensed physician assistants, nurse practitioners, nurses,
51 coroners, or emergency medical technician paramedics. A medical examiner may serve more

1 than one county. The Chief Medical Examiner may take jurisdiction in any case or appoint
2 another medical examiner to do so."

3 **SECTION 12E.6.(b)** By December 1, 2014, the Department of Health and Human
4 Services, Division of Public Health, shall study and report to the Joint Legislative Oversight
5 Committee on Health and Human Services on the adequacy of the current fee paid by the State
6 and counties (i) pursuant to G.S. 130A-387 for investigations and reports and (ii) pursuant to
7 G.S. 130A-389 for autopsies. The report due under this subsection shall include
8 recommendations for any fee increase deemed necessary by the Department as well as an
9 explanation and documentation to support the recommended fee increase.

10 **SECTION 12E.6.(c)** A portion of the funds appropriated in this act to the
11 Department of Health and Human Services, Division of Public Health, for the Office of the
12 Chief Medical Examiner for the 2014-2015 fiscal year shall be used by the Department to
13 establish a system of oversight to achieve operational efficiencies and improve quality
14 assurance with respect to postmortem medicolegal examinations conducted under the authority
15 of the Office of the Chief Medical Examiner pursuant to Part 1 of Article 16 of Chapter 130A
16 of the General Statutes. In establishing the system of oversight required by this subsection, the
17 Department shall develop and implement uniform protocols for conducting postmortem
18 medicolegal examinations in accordance with established best practices for these examinations.

20 **ADJUST REPORTING DATE FOR DIABETES COORDINATION REPORT**

21 **SECTION 12E.7.** G.S. 130A-221.1(b) reads as rewritten:

22 "(b) On or before ~~December~~January 1 of each ~~even-numbered~~odd-numbered year, the
23 entities referenced in subsection (a) of this section shall collectively submit a report to the Joint
24 Legislative Oversight Committee on Health and Human Services and the Fiscal Research
25 Division. The report shall provide the following:

- 26 (1) An assessment of the financial impact that each type of diabetes has on each
27 entity and collectively on the State. This assessment shall include: the
28 number of individuals with diabetes served by the entity, the cost of diabetes

31 financial toll or impact diabetes and related complications places on each

39 referenced in subsection (a) of this section, as it relates to activities,
40 programs, and messaging to manage, treat, and prevent all types of diabetes
41 and the complications from diabetes.
- 42 (4) The development of and revisions to detailed action plans for preventing and
43 controlling diabetes and related complications. The plans shall identify
44 proposed action steps to reduce the impact of diabetes, pre-diabetes, and
45 related diabetic complications; identify expected outcomes for each action
46 step; and establish benchmarks for preventing and controlling diabetes.
- 47 (5) A detailed budget identifying needs, costs, and resources required to
48 implement the plans identified in subdivision (4) of this subsection,
49 including a list of actionable items for consideration by the Committee."

17 **TRAUMATIC BRAIN INJURY FUNDING**

18 **SECTION 12F.1.** Of the funds appropriated to the Department of Health and
19 Human Services, Division of Mental Health, Developmental Disabilities, and Substance Abuse
20 Services, for the 2014-2015 fiscal year, the sum of two million three hundred seventy-three
21 thousand eighty-six dollars (\$2,373,086) shall be used exclusively to support traumatic brain
22 injury (TBI) services as follows:

- 23 (1) The sum of three hundred fifty-nine thousand two hundred eighteen dollars
24 (\$359,218) shall be used to fund contracts with the Brain Injury Association
25 of North Carolina, Carolinas Rehabilitation, or other appropriate service
26 providers.
27 (2) The sum of seven hundred ninety-six thousand nine hundred thirty-four
28 dollars (\$796,934) shall be used to support residential programs across the
29 State that are specifically designed to serve individuals with TBI.
30 (3) The sum of one million two hundred sixteen thousand nine hundred
31 thirty-four dollars (\$1,216,934) shall be used to support requests submitted
32 by individual consumers for assistance with residential support services,
33 home modifications, transportation, and other requests deemed necessary by
34 the consumer's local management entity and primary care physician.

35
36 **REPORT ON STRATEGIES FOR IMPROVING MENTAL HEALTH,**
37 **DEVELOPMENTAL DISABILITIES, AND SUBSTANCE ABUSE SERVICES**

38 **SECTION 12F.3.(a)** The Department of Health and Human Services (Department)
39 shall submit a report to the Joint Legislative Oversight Committee on Health and Human
40 Services and the Fiscal Research Division by November 1, 2014, that includes all of the
41 following components:

- 42 (1) A strategy for improving communication and coordination among all
43 divisions within the Department that administer funds or programs related to
44 the delivery of behavioral health services, especially regarding the most
45 appropriate and efficient uses of public and private inpatient behavioral
46 health services. The Department shall include as part of its strategy a process
47 to address shortages and deficiencies identified in the annual State Medical
48 Facilities Plan.
49 (2) A plan developed in collaboration with local management entities that have
50 been approved to operate as managed care organizations (LME/MCOs) to
51 increase access to, and availability of, community-based outpatient crisis and

1 emergency services for the stabilization and treatment of individuals
2 experiencing mental health, developmental disability, or substance abuse
3 crises in settings other than local hospital emergency departments and
4 State-operated psychiatric hospitals.

5 (3) A plan to ensure that a comprehensive array of outpatient treatment and
6 crisis prevention and intervention services are available and accessible to
7 children, adolescents, and adults in every LME/MCO catchment area. The
8 plan shall ensure that an adequate number of crisis stabilization units are
9 available in each LME/MCO catchment area. The plan shall include specific
10 strategies for increasing the number of Facility-Based Crisis Programs for
11 Children and Adolescents in high-need areas of the State and the availability
12 of Professional Treatment Services in Facility-Based Crisis Programs for
13 Children and Adolescents as defined in section 4.b.(8)(k) of the current
14 Medicaid State Plan. The plan shall further describe in detail all actions
15 necessary to implement those strategies, including a description of how the
16 Department's funds will be utilized.

17 (4) Findings and recommendations for increasing the inventory of inpatient
18 psychiatric and substance abuse services within the State. In developing its
19 findings and recommendations, the Department shall examine the
20 advantages and disadvantages of increasing this inventory of services
21 through (i) additional State-operated facilities, (ii) community hospital beds,
22 (iii) United States Veterans Administration beds, and (iv) community-based
23 services that decrease the need for inpatient treatment.

24 (5) A plan for offering hospitals and other entities incentives to apply for
25 licenses to begin offering new inpatient behavioral health services, or to
26 begin operating existing licensed beds that are currently unstaffed, or both.

27 (6) Recommendations on the use of the existing Cherry Hospital buildings after
28 patients and operations are relocated to the replacement facility. In
29 developing its findings and recommendations, the Department shall conduct
30 a study that includes development of an inventory and assessment of the
31 condition of every building located on the existing Cherry Hospital campus.
32 The study shall include an examination of the feasibility of using the existing
33 Cherry Hospital facility to provide community-based and facility-based
34 behavioral health services, including additional child and adolescent
35 inpatient beds.

36 (7) A method by which the Division of Health Service Regulation can begin
37 tracking and separately reporting no later than January 1, 2015, on the
38 inventory of inpatient behavioral health beds for children ages six through
39 12 and for adolescents over age 12.

40 (8) A status update on the implementation of each component of the 2008
41 Mental Health Commission Workforce Development Plan.

42 **SECTION 12F.3.(b)** The Department shall submit a report to the House
43 Appropriations Subcommittee on Health and Human Services, the Senate Appropriations
44 Committee on Health and Human Services, the Joint Legislative Oversight Committee on
45 Health and Human Services, and the Fiscal Research Division by March 1, 2015, that includes
46 all of the following components:

47 (1) A comprehensive strategy, developed in collaboration with stakeholders
48 deemed relevant by the Department, to address the dearth of licensed child
49 and adolescent inpatient psychiatric beds in facilities throughout the State.
50 The strategy shall do all of the following:

- 1 a. Ensure that an adequate inventory of child and adolescent beds are
- 2 available in each LME/MCO catchment area.
- 3 b. Include the development and implementation of a child and
- 4 adolescent psychiatric bed registry to provide real-time information
- 5 on the number of beds available at each licensed and nonlicensed
- 6 facility in the State.
- 7 c. Include recommendations as to any regulatory changes necessary to
- 8 ensure safety and quality in Facility-Based Crisis Programs for
- 9 Children and Adolescents.
- 10 (2) Recommendations for meaningful outcome measures to be implemented by
- 11 State-operated alcohol and drug abuse treatment centers to assess the impact
- 12 of inpatient treatment on an individual's substance use following discharge
- 13 from a State-operated alcohol and drug abuse treatment center. The
- 14 recommendations shall include a proposed time line for implementation of
- 15 these outcome measures.
- 16

17 **REPORT AND PLAN REGARDING BUDGET SHORTFALLS WITHIN THE**
18 **DIVISION OF MENTAL HEALTH, DEVELOPMENTAL DISABILITIES, AND**
19 **SUBSTANCE ABUSE SERVICES**

20 **SECTION 12F.4.** By December 1, 2014, the Department of Health and Human
21 Services shall provide a report to the Joint Legislative Oversight Committee on Health and
22 Human Services and the Fiscal Research Division on the budget shortfalls within the
23 Department as a result of liabilities associated with (i) the provision of community services for
24 the treatment of mental illness, developmental disabilities, and substance abuse disorders and
25 (ii) the State-operated health care facilities under the jurisdiction of the Department. The report
26 shall include a detailed explanation of all of the following:

- 27 (1) A history of the annual budget shortfalls since 2008 and all the contributing
- 28 factors.
- 29 (2) An explanation of actions taken by the Department and the Office of State
- 30 Budget and Management to address these budget shortfalls.
- 31 (3) A plan for eliminating these budget shortfalls.
- 32

33 **FUNDS APPROPRIATED TO IMPLEMENT RECOMMENDATIONS OF THE JOINT**
34 **LEGISLATIVE OVERSIGHT COMMITTEE ON HEALTH AND HUMAN**
35 **SERVICES REGARDING BEHAVIORAL HEALTH CRISIS SERVICES**

36 **SECTION 12F.5.(a)** The following definitions apply in this section:

- 37 (1) Facility-Based Crisis Center. – A 24-hour residential facility licensed under
- 38 10A NCAC 27G .5000 to provide facility-based crisis service as described in
- 39 10A NCAC 27G .5001.
- 40 (2) Secretary. – The Secretary of the North Carolina Department of Health and
- 41 Human Services.
- 42 (3) Behavioral Health Urgent Care Center. – An outpatient facility that provides
- 43 walk-in crisis assessment, referral, and treatment by licensed behavioral
- 44 health professionals with prescriptive authority to individuals with an urgent
- 45 or emergent need for mental health, intellectual or developmental
- 46 disabilities, or substance abuse services.

47 **SECTION 12F.5.(b)** From funds appropriated in this act to the Department of
48 Health and Human Services, Division of Mental Health, Developmental Disabilities, and
49 Substance Abuse Services, for community services for the 2014-2015 fiscal year, the Division
50 shall use five million twenty-eight thousand six hundred seventy-seven dollars (\$5,028,677) in
51 recurring funds to accomplish the following:

- 1 (1) To increase the number of co-located or operationally linked behavioral
2 health urgent care centers and facility-based crisis centers.
- 3 (2) To increase the number of facility-based crisis centers designated by the
4 Secretary as facilities for the custody and treatment of involuntary clients
5 pursuant to G.S. 122C-252 and 10A NCAC 26C .0101. The Department
6 shall give priority to areas of the State experiencing a shortage of these types
7 of facilities.
- 8 (3) To provide reimbursement for services provided by facility-based crisis
9 centers.
- 10 (4) To establish facility-based crisis centers for children and adolescents.

11 12 **SUBPART XII-G. DIVISION OF HEALTH SERVICE REGULATION**

13 14 **TECHNICAL CORRECTION TO CERTIFICATE OF NEED EXEMPTION FOR** 15 **REPLACEMENT OF PREVIOUSLY APPROVED EQUIPMENT**

16 **SECTION 12G.1.(a)** G.S. 131E-184(f) reads as rewritten:

17 "(f) The Department shall exempt from certificate of need review the purchase of any
18 replacement equipment that exceeds the two million dollar (\$2,000,000) threshold set forth in
19 ~~G.S. 131E-176(22)~~ G.S. 131E-176(22a) if all of the following conditions are met:

- 20 (1) The equipment being replaced is located on the main campus.
- 21 (2) The Department has previously issued a certificate of need for the equipment
22 being replaced. This subdivision does not apply if a certificate of need was
23 not required at the time the equipment being replaced was initially purchased
24 by the licensed health service facility.
- 25 (3) The licensed health service facility proposing to purchase the replacement
26 equipment shall provide prior written notice to the Department, along with
27 supporting documentation to demonstrate that it meets the exemption criteria
28 of this subsection."

29 **SECTION 12G.1.(b)** This section is effective when it becomes law.

30 31 **STUDY CONCERNING EXPANSION OF HEALTH CARE COST REDUCTION AND** 32 **TRANSPARENCY ACT TO ADDITIONAL HEALTH CARE PROVIDERS**

33 **SECTION 12G.3.** By December 1, 2014, the Department of Health and Human
34 Services shall study and submit a written report to the Joint Legislative Oversight Committee
35 on Health and Human Services and the Fiscal Research Division summarizing its
36 recommendations for extending North Carolina's Health Care Cost Reduction and
37 Transparency Act of 2013 (the Act) to additional health care providers. The report shall
38 identify all of the following:

- 39 (1) Recommended categories of additional health care providers that should be
40 subject to the requirements of the Act.
- 41 (2) Recommended data to be collected for the purpose of transparency from
42 each category of identified health care providers.
- 43 (3) Recommended exemptions, if any, from certain requirements of the Act for
44 each category of identified health care providers.
- 45 (4) Recommended effective dates for the applicability of the Act to each
46 category of identified health care providers.

47 48 **MORATORIUM ON HOME CARE AGENCY LICENSES FOR IN-HOME AIDE** 49 **SERVICES**

50 **SECTION 12G.4.** For the period commencing July 1, 2014, and ending July 1,
51 2016, and notwithstanding the provisions of the Home Care Agency Licensure Act set forth in

1 Part 3 of Article 6 of Chapter 131E of the General Statutes or any rules adopted pursuant to that
2 Part, the Department of Health and Human Services shall not issue any licenses for home care
3 agencies as defined in G.S. 131E-136(2) that intend to offer in-home aide services. This
4 prohibition does not apply to companion and sitter services and shall not restrict the
5 Department from doing any of the following:

- 6 (1) Issuing a license to a certified home health agency as defined in
7 G.S. 131E-176(12) that intends to offer in-home aide services.
- 8 (2) Issuing a license to an agency that needs a new license for an existing home
9 care agency being acquired.
- 10 (3) Issuing a license for a new home care agency in any area of the State upon a
11 determination by the Secretary of the Department of Health and Human
12 Services that increased access to care is necessary in that area.

13 MORATORIUM ON SPECIAL CARE UNIT LICENSES

14 **SECTION 12G.5.** Section 12G.1(a) of S.L. 2013-360 reads as rewritten:

15 "SECTION 12G.1.(a) For the period beginning July 31, 2013, and ending ~~July 1,~~
16 ~~2016,~~ July 1, 2015, the Department of Health and Human Services, Division of Health Service
17 Regulation (Department), shall not issue any licenses for special care units as defined in
18 G.S. 131D-4.6 and G.S. 131E-114. This prohibition shall not restrict the Department from
19 doing any of the following:

- 20 (1) Issuing a license to a facility that is acquiring an existing special care unit.
- 21 (2) Issuing a license for a special care unit in any area of the State upon a
22 determination by the Secretary of the Department of Health and Human
23 Services that increased access to this type of care is necessary in that area
24 during the ~~three-year~~ two-year moratorium imposed by this section.
- 25 (3) Processing all completed applications for special care unit licenses received
26 by the Division of Health Service Regulation along with the applicable
27 license fee prior to June 1, 2013.
- 28 (4) Issuing a license to a facility that was in possession of a certificate of need as
29 of July 31, 2013, that included authorization to operate special care unit
30 beds."

31 PROHIBITION ON YOUTH USING TANNING EQUIPMENT

32 **SECTION 12G.6.(a)** G.S. 104E-9.1(a) reads as rewritten:

33 "(a) Operators of tanning equipment and owners of tanning facilities subject to rules
34 adopted pursuant to this Chapter shall comply with or ensure compliance with the following:

- 35 (1) The operator shall provide to each consumer a warning statement that
36 defines the potential hazards and consequences of exposure to ultraviolet
37 radiation. Before allowing the consumer's initial use of the tanning
38 equipment, the operator shall obtain the signature of the consumer on the
39 warning statement acknowledging receipt of the warning.
- 40 (2) The operator shall not allow a person ~~13 years and younger~~ under 18 years of
41 age to use tanning equipment without a written prescription from the
42 person's medical physician specifying the nature of the medical condition
43 requiring the treatment, the number of visits, and the time of exposure for
44 each visit. equipment.
- 45 (3) Neither an operator nor an owner shall claim or distribute promotional
46 materials that claim that using tanning equipment is safe or free from risk or
47 that using tanning equipment will result in medical or health benefits."

48 **SECTION 12G.6.(b)** This section becomes effective October 1, 2014.

SUBPART XII-H. DIVISION OF MEDICAL ASSISTANCE (MEDICAID)**APPROPRIATION FOR MEDICAID REFORM TO BE USED SOLELY FOR MEDICAID REFORM**

SECTION 12H.1. Funds appropriated elsewhere in this act to the Department of Health and Human Services, Division of Medical Assistance, for Medicaid reform may be used only for Medicaid reform and, notwithstanding the State Budget Act, may not be used for any other purpose, such as funding any shortfalls in the Medicaid program.

REINSTATE MEDICAID ANNUAL REPORT

SECTION 12H.2. The Department of Health and Human Services, Division of Medical Assistance, shall reinstate the publication of the Medicaid Annual Report and accompanying tables, which was discontinued after 2008. The Division shall publish the report and tables on its Web site and shall not publish copies in print.

MODIFY INTENSIVE IN-HOME SERVICE

SECTION 12H.4. No later than October 1, 2014, the Department of Health and Human Services, Division of Medical Assistance, shall modify the service definition for the Intensive In-Home Service to reflect a team-to-family ratio of one Intensive In-Home team to 12 families for both the Medicaid and NC Health Choice programs.

TRAUMATIC BRAIN INJURY WAIVER

SECTION 12H.6. The Department of Health and Human Services, Division of Medical Assistance, and Division of Mental Health, Developmental Disabilities, and Substance Abuse Services, in conjunction with the North Carolina Traumatic Brain Injury Advisory Council, shall design and draft a 1915(c) waiver to add a new service package for Medicaid eligibles with traumatic brain injury (TBI). This draft waiver may be based on an update to the 2010 report on a waiver to serve individuals with traumatic brain injury. The Department shall report the draft waiver, other findings, and any additional options to provide Medicaid services to those suffering from TBI to the House Appropriations Subcommittee on Health and Human Services and the Senate Appropriations Committee on Health and Human Services by February 1, 2015. The Department may submit drafts of the waiver to the Centers for Medicare and Medicaid Services (CMS) to solicit feedback but shall not submit the waiver for CMS approval until authorized by the General Assembly.

DRUG REIMBURSEMENT USING AVERAGE ACQUISITION COST

SECTION 12H.8.(a) If federal drug pricing changes to use average acquisition cost for ingredients, then the Department of Health and Human Services, Division of Medical Assistance, shall, notwithstanding Section 12H.13(f) of S.L. 2013-360, adjust the rate for dispensing drugs to offset the impact to providers of any such changes to using average acquisition cost. In adjusting the rates for dispensing drugs, the Department shall do the following:

- (1) Raise dispensing fees to make the shift to using average acquisition cost budget neutral.
- (2) Maintain a distinction between the dispensing fees for preferred and brand drugs.

Any actions taken under this subsection shall be reported (i) to the chairs of the House Appropriations Committee, the Senate Appropriations/Base Budget Committee, and the Joint Legislative Oversight Committee on Health and Human Services, (ii) to the Fiscal Research Division, and (iii) to the Office of State Budget and Management. Any State plan amendments

1 required to implement this subsection shall not be subject to the 90 day prior submission
2 requirement of G.S. 108A-54.1A(e), as amended by Section 12H.21 of this act.

3 **SECTION 12H.8.(b)** By August 1, 2015, the Department of Health and Human
4 Services, Division of Medical Assistance, shall issue a request for proposals (RFP) for a
5 contractor to perform a statewide drug dispensing fee study. The Department shall use the
6 funds appropriated elsewhere in this budget for this study as the State share to draw down
7 additional federal Medicaid funds for this study.

8 9 **SUBSTITUTION OF GENERIC DRUGS FOR UNAVAILABLE PREFERRED DRUGS**

10 **SECTION 12H.8A.** If the Department of Health and Human Services, Division of
11 Medical Assistance, finds that there are net General Fund savings to the Medicaid program
12 from doing so, then the Division may allow a pharmacist to substitute and dispense a generic
13 drug in place of a preferred drug without prior authorization, subject to all of the following
14 being true:

- 15 (1) The Division normally requires the dispensing of the preferred drug over the
16 equivalent generic drug.
- 17 (2) The pharmacist has not been able to acquire the preferred drug from at least
18 two separate wholesalers within the two weeks prior to dispensing the
19 generic substitute.
- 20 (3) The pharmacist maintains records of the failed attempts to acquire the
21 preferred drug. Such records shall be open to inspection and audit by the
22 Division.
- 23 (4) The prescriber has not indicated that the preferred drug is "medically
24 necessary."

25 For purposes of this section, "savings to the Medicaid program" shall not be limited to savings
26 within the prescription drug service area, but shall also include savings in other areas of the
27 program such as savings from not having to send the prescription back to the prescriber for
28 prior authorization of the generic substitution or savings from instances where missed doses
29 may lead to negative and costly patient outcomes.

30 31 **CONTRACTED STUDY OF PERSONAL CARE SERVICES OPTIONS**

32 **SECTION 12H.10.** The Joint Legislative Oversight Committee on Health and
33 Human Services shall engage a contractor to study issues related to reforming and redesigning
34 personal care services (PCS) while meeting the State's obligations under the Americans with
35 Disabilities Act and the United States Supreme Court's decision in *Olmstead v. L.C. ex rel.*
36 *Zimring*, 527 U.S. 581 (1999). The study shall examine the following issues:

- 37 (1) What categories of Medicaid recipients are currently receiving PCS, and in
38 what settings are they being served?
- 39 (2) What is the total number of Medicaid recipients receiving PCS in each
40 category, and what is the anticipated growth in each category?
- 41 (3) What is the current cost of serving Medicaid recipients in each setting, and
42 specifically, the sources of public funding utilized to serve those
43 individuals?
- 44 (4) What alternative, more cost-effective assistance models could be
45 implemented for each category of Medicaid recipient?
- 46 (5) Specifically, whether more cost-effective assistance could be offered
47 through the new 1915(i) State plan home- and community-based services
48 and 1915 waiver options for each category of Medicaid recipient.
- 49 (6) Recommendations regarding what outcomes the redesigned program should
50 be designed to achieve.

1 (7) The impact of reforming and redesigning personal care services on appeals
2 and litigation.

3 (8) Other areas as deemed appropriate by the chairs of the Joint Legislative
4 Oversight Committee on Health and Human Services.

5 The study shall also address the quality of resident care within adult care homes and
6 the adequacy of State oversight of adult care homes, including inspections, procedures, and
7 processes.

8 No later than December 1, 2015, the contractor shall report the results and
9 recommendations of the study to the Joint Legislative Oversight Committee on Health and
10 Human Services. The Department of Health and Human Services shall give the contractor full
11 access to all data necessary to complete the study and the report. The Department of Health and
12 Human Services shall make payments to the contractor hired by the Joint Legislative Oversight
13 Committee on Health and Human Services from funds appropriated elsewhere in this budget
14 for this contract as well as from federal Medicaid matching funds available for this contract.
15

16 ADULT CARE HOME COST REPORTING

17 **SECTION 12H.11.** The Department of Health and Human Services shall require
18 compliance with the adult care home cost reporting requirements set forth in G.S. 131D-4.2.
19 The Department shall make available the data collected from the cost reporting in a
20 character-separated values (CSV) plain text format or other file format that may easily be
21 imported into software used for spreadsheets, databases, and data analytics.

43 follows:

4 The Department of Health and Human Services shall not make any other modifications to the

6 **SECTION 12H.13.(b)** Beginning on December 31, 2014, and annually thereafter,
7 UNC and ECU shall submit an annual report based on their preceding fiscal year to the Joint
8 Legislative Oversight Committee on Health and Human Services containing all of the
9 following information for each individual provider for whom this supplemental payment is
10 received:

- 11 (1) For each service provided by the provider and for which the supplemental
12 payment is received, the location where the service was provided, including
13 county, municipality, and zip code.
- 14 (2) The percentage of the provider's total time spent serving Medicaid recipients
15 annually that is for services provided at locations other than the ECU Brody

29 transfer by twenty-five and nine-tenths percent (25.9%) there are funds for the State share

16 Community Alternatives Program for Persons with Mental Retardation/Developmental
17 Disabilities (CAP-MR/DD)) services or such assessments are otherwise allowed by the Centers
18 for Medicare & Medicaid Services (CMS) through waivers and (ii) the providers of such
19 services are willing to participate in an assessment program, then the Department of Health and
20 Human Services, Division of Medical Assistance, may implement a Medicaid assessment

- 9 (3) The anticipated savings to the Medicaid program.
- 10 (4) A detailed fiscal analysis supporting any calculation of anticipated savings.

17 federal government, the Department shall post the amendment on its Web site and notify the

If mediation is accepted, the mediation must be completed within 25 days of submission of the request for appeal. Upon completion of the mediation, the mediator shall inform OAH and the Department within 24 hours of the resolution by facsimile or electronic messaging. If the parties have resolved matters in the mediation, OAH shall dismiss the case. OAH shall not conduct a hearing of any contested Medicaid case until it has received notice from the mediator assigned that either: (i) the mediation was unsuccessful, or (ii) the petitioner has rejected the offer of mediation, or (iii) the petitioner has failed to appear at a scheduled mediation. Nothing in this subsection shall restrict the right to a contested case hearing. If the recipient accepts an offer of mediation and then fails to attend mediation without good cause, OAH shall dismiss the contested case.

...."

SECTION 12H.27.(b) G.S. 108D-15(i) reads as rewritten:

"(i) Mediation. – Upon receipt of an appeal request form as provided by G.S. 108D-15(f) or other clear request for a hearing by an enrollee, OAH shall immediately notify the Mediation Network of North Carolina, which shall contact the enrollee within five days to offer mediation in an attempt to resolve the dispute. If mediation is accepted, the mediation must be completed within 25 days of submission of the request for appeal. Upon completion of the mediation, the mediator shall inform OAH and the LME/MCO within 24 hours of the resolution by facsimile or electronic messaging. If the parties have resolved matters in the mediation, OAH shall dismiss the case. OAH shall not conduct a hearing of any contested case involving a dispute of a managed care action until it has received notice from the mediator assigned that either (i) the mediation was unsuccessful, (ii) the petitioner has rejected the offer of mediation, or (iii) the petitioner has failed to appear at a scheduled mediation. Nothing in this subsection shall restrict the right to a contested case hearing. If the enrollee accepts an offer of mediation and then fails to attend mediation without good cause, OAH shall dismiss the contested case."

SECTION 12H.27.(c) This section is effective October 1, 2014, and applies to appeals of notices of adverse determination mailed on or after that date and appeals of notices of resolution mailed on or after that date.

EXTEND EXISTING IMAGE UTILIZATION MANAGEMENT SERVICES CONTRACT; CONTAIN COSTS OF FUTURE CONTRACTS

SECTION 12H.30.(a) The Department of Health and Human Services, Division of Medical Assistance, shall renegotiate the existing contract for imaging utilization management services in order to achieve five million five hundred thousand dollars (\$5,500,000) in annual savings of net General Fund appropriations.

SECTION 12H.30.(b) The Department of Health and Human Services, Division of Medical Assistance, shall issue a request for proposals (RFP) for a contract for imaging utilization management services to ascertain whether the State can achieve better savings with an alternative vendor and, if so, enter into a contract with the alternative vendor. Such an RFP shall incorporate the same requirements as those specified in Section 10.68B of S.L. 2009-451, which was enacted by Section 6 of S.L. 2009-575.

4 Appropriations Committee on Health and Human Services, and (iii) the Fiscal Research
5 Division.

6 7 **NONEMERGENCY MEDICAL TRANSPORTATION CONTRACT**

8 **SECTION 12H.31.** The Department of Health and Human Services, Division of
9 Medical Assistance, shall develop and issue a request for proposal for a contract beginning
10 January 1, 2015, for the statewide management of Medicaid nonemergency medical
11 transportation services.

12 13 **AMBULANCE TRANSPORTS TO CRISIS CENTERS**

14 **SECTION 12H.32.** The Department of Health and Human Services, Division of
15 Medical Assistance, shall study the practice of reimbursing for ambulance transports that divert
16 individuals in mental health crisis from hospital emergency departments to alternative
17 appropriate locations for care. The Department shall study existing pilot programs in North
18 Carolina, as well as other states, and shall specifically study expansion of the Wake County
19 Emergency Medical Services (EMS) Advanced Practice Paramedics pilot program. The study
20 shall do the following:

- 21 (1) Propose necessary Medicaid and mental health policy changes.
- 22 (2) Identify funding needs.
- 23 (3) Identify available funding sources.
- 24 (4) Identify any other actions that would be necessary to facilitate

33 reimbursement methodology as is used for Implanon and Mirena.

34 **SECTION 12H.33.(b)** Any State plan amendment required to implement this
35 section shall not be subject to the 90-day prior submission requirement of G.S. 108A-54.1A(e).

36 37 **STUDY BOTOX REIMBURSEMENT**

38 **SECTION 12H.33A.** Prior to the convening of the 2015 General Assembly, the
39 Joint Legislative Oversight Committee on Health and Human Services shall study the issue of
40 implementing uniform Medicaid reimbursement rates for Botox for physicians and
41 pharmacists.

42 43 **REPORT ON PACE PROGRAM**

44 **SECTION 12H.34.(a)** By September 1, 2014, the Department of Health and
45 Human Services, Division of Medical Assistance, shall report to the Joint Legislative Oversight
46 Committee on Health and Human Services with the following information on the Program of
47 All-Inclusive Care for the Elderly (PACE):

- 48 (1) The number of individuals being served in each of the PACE service areas.
- 49 (2) A description of the program enrollment criteria and enrollment process.
- 50 (3) Detailed figures showing how funding for the program has been spent during
51 the past two fiscal years.

- 1 (4) The per member per month cost of serving individuals through the PACE
2 program compared to the cost of serving individuals in a nursing home.
3 (5) An estimate of how many PACE participants would enter a nursing home if
4 they were not enrolled with the PACE program.

5 **SECTION 12H.34.(b)** By December 1, 2014, the Department of Health and
6 Human Services, Division of Medical Assistance, shall submit an additional report to the Joint
7 Legislative Oversight Committee on Health and Human Services with the following
8 information on the Program of All-Inclusive Care for the Elderly (PACE):

- 9 (1) An update on all of the information required by subsection (a) of this
10 section.
11 (2) A comparison of North Carolina's PACE program to PACE programs in
12 other states.
13 (3) Recommendations for how to make the program sustainable.
14

15 **ALLOW FOR THE MOVEMENT OF CERTAIN MEDICAID RECIPIENTS**

16 **SECTION 12H.35.** Individuals served pursuant to the State's Section 1915(b)/(c)
17 managed care waiver are exempt from Medicaid home origin requirements for the purposes of
18 services provided under the Section 1915(b)/(c) managed care waiver. Medicaid provided for
19 individuals served pursuant to the State's Section 1915(b)/(c) managed care waiver shall be
20 based on the individual's Medicaid current county of residence. Notwithstanding the forgoing,
21 however, Section 1915(c) innovations waiver slots shall be portable and recognized uniformly
22 throughout all counties of North Carolina; an individual who receives an innovations waiver in
23 one county shall not be required to reapply in another county if that individual moves or seeks
24 services in another county.

26 **APPOINTMENT AND CONFIRMATION OF MEDICAID DIRECTOR**

27 **SECTION 12H.36.(a)** Effective July 1, 2014, and applying to Directors of the
28 Division of Medical Services appointed on or after that date, G.S. 108A-54 is amended by
29 adding a new subsection to read:

30 "**§ 108A-54. Authorization of Medical Assistance Program; administration.**

31 ...

32 (e) The Medicaid Program shall be managed by the Director of the Division of Medical
33 Assistance (Medicaid Director), who shall be recommended by the Secretary of Health and
34 Human Services and appointed by the Governor, subject to confirmation by the General
35 Assembly by joint resolution. The term of office for the Medicaid Director shall be five years
36 beginning upon the date of qualification for office. In case of a vacancy in the office of
37 Medicaid Director for any reason prior to the expiration of his or her term of office, the name
38 of his or her successor for a new five year term shall be submitted by the Governor to the
39 General Assembly not later than 60 days after the vacancy arises. If a vacancy arises in the
40 office when the General Assembly is not in session, the Medicaid Director shall be appointed
41 by the Governor to serve on an interim basis pending confirmation by the General Assembly.

42 Upon failure of the Governor to submit a name at least 90 days before the expiration of a
43 term or within 60 days of occurrence of a vacancy, the President Pro Tempore of the Senate
44 and the Speaker of the House of Representatives jointly shall submit a name of an appointee to
45 the General Assembly. The appointment shall then be made by enactment of a bill. The bill
46 shall state the name of the person being appointed, the office to which the appointment is being
47 made, the effective date of the appointment, the date of expiration of the term, the city and state
48 of residence of the appointee, and that the appointment is made upon the joint recommendation
49 of the Speaker of the House of Representatives and the President Pro Tempore of the Senate.
50 Nothing precludes any member of the General Assembly from proposing an amendment to any
51 bill making such an appointment.

1 The Medicaid Director may be removed by either the Secretary of Health and Human
2 Services or the Governor for any of the grounds set forth in G.S. 143B-13(b), (c), or (d)."

3 **SECTION 12H.36.(b)** The Director of the Division of Medical Assistance
4 (Medicaid Director) serving as of July 1, 2014, shall continue to serve until a successor is
5 appointed under 108A-54(e).

7 **ALIGN ANNUAL MEDICAID BASIC BILLING UNIT LIMITS TO FISCAL YEAR**

8 **SECTION 12H.37.(a)** Beginning July 1, 2015, the Department of Health and
9 Human Services, Division of Medical Assistance, shall require that annual Medicaid billing
10 unit limits for services managed by the LME/MCOs be based upon the fiscal year, provided
11 that this standardization can be accomplished with no net fiscal impact on General Fund
12 appropriations.

13 **SECTION 12H.37.(b)** Any State Plan Amendment required to implement this
14 section shall not be subject to the 90-day prior submission requirement of G.S. 108A-54.1A(e).

18 **CONTROL OF DATA DISCLOSED TO THE NORTH CAROLINA HEALTH** 19 **INFORMATION EXCHANGE BY REQUIRED PARTICIPANTS**

20 **SECTION 12L.1.(a)** G.S. 90-413.3A(b) reads as rewritten:

21 "(b) Any hospital, as defined in ~~G.S. 131E-76(e)~~, G.S. 131E-76(3) that has an electronic
22 health record system shall connect to the ~~NC HIE~~ HIE Network and submit individual patient
23 demographic and clinical data on services paid for with Medicaid funds, based upon the
24 findings set forth in subsection (a) of this section and notwithstanding the voluntary nature of
25 the NC HIE under G.S. 90-413.2. The NC HIE shall give the Department of Health and Human
26 Services real-time access to data and information ~~contained in the NC HIE~~ disclosed through
27 the HIE Network. At the request of the Director of the Fiscal Research, Bill Drafting, Research,
28 or Program Evaluation Divisions of the General Assembly, the NC HIE shall provide the
29 professional staff of these Divisions with data and information responsive to the Director's
30 request. Prior to providing the General Assembly's staff with any data or information disclosed
31 through the HIE Network pursuant to this subsection, the NC HIE shall redact any personal
32 identifying information in a manner consistent with the standards specified for de-identification
33 of health information under the HIPAA Privacy Rule, 45 C.F.R. 164.15, as amended."

34 **SECTION 12L.1.(b)** G.S. 90-413.3A is amended by adding a new subsection to
35 read:

36 "(c) Any data disclosed through the HIE Network pursuant to subsection (b) of this
37 section shall be and will remain the sole property of the State. Any data or product derived
38 from the data disclosed to the HIE Network pursuant to subsection (b) of this section, including
39 a consolidation or analysis of the data, shall be and will remain the sole property of the State.
40 The NC HIE shall not allow proprietary information it receives pursuant to this section to be
41 used by any person or entity for commercial purposes."

42 **SECTION 12L.1.(c)** In order to ensure the successful, uninterrupted operation of
43 the statewide health information exchange network (HIE Network), the Department of Health
44 and Human Services (Department) shall develop a transition plan for transferring the
45 responsibilities imposed on the NC HIE under Article 29A of the General Statutes to another
46 entity in the event the NC HIE is unable or unwilling to continue overseeing and administering
47 the HIE Network. The Department shall develop the plan in consultation with the Office of
48 Information Technology Services and the NC HIE and submit the plan to the Joint Legislative
49 Oversight Committee on Health and Human Services and the Fiscal Research Division no later
50 than February 1, 2015.

REINSTATEMENT OF HOSPITAL SETOFF DEBT COLLECTION

SECTION 12I.4.(a) G.S. 105A-2(9) reads as rewritten:

"(9) State agency. – Any of the following:

- a. A unit of the executive, legislative, or judicial branch of State government, ~~except for the following:~~
 - 1. ~~Any school of medicine, clinical program, facility, or practice affiliated with one of the constituent institutions of The University of North Carolina that provides medical care to the general public.~~
 - 2. ~~The University of North Carolina Health Care System and other persons or entities affiliated with or under the control of The University of North Carolina Health Care System government.~~
- b. A local agency, to the extent it administers a program supervised by the Department of Health and Human Services or it operates a Child Support Enforcement Program, enabled by Chapter 110, Article 9, and Title IV, Part D of the Social Security Act.
- c. A community college."

SECTION 12I.4.(b) This section is effective when it becomes law and applies to tax refunds determined by the Department of Revenue on or after that date.

9 **"SECTION 12J.1.(b)** Information to Be Included in Block Grant Plans. – The Department
10 of Health and Human Services shall submit a separate plan for each Block Grant received and
11 administered by the Department, and each plan shall include the following:

- 12 (1) A delineation of the proposed allocations by program or activity, including
13 State and federal match requirements.
- 14 (2) A delineation of the proposed State and local administrative expenditures.
- 15 (3) An identification of all new positions to be established through the Block
16 Grant, including permanent, temporary, and time-limited positions.
- 17 (4) A comparison of the proposed allocations by program or activity with two
18 prior years' program and activity budgets and two prior years' actual program
19 or activity expenditures.
- 20 (5) A projection of current year expenditures by program or activity.
- 21 (6) A projection of federal Block Grant funds available, including unspent
22 federal funds from the current and prior fiscal years.

23 **"SECTION 12J.1.(c)** Changes in Federal Fund Availability. – If the Congress of the
24 United States increases the federal fund availability for any of the Block Grants or contingency
25 funds and other grants related to existing Block Grants administered by the Department of
26 Health and Human Services from the amounts appropriated in this section, the Department
27 shall allocate the increase proportionally across the program and activity appropriations
28 identified for that Block Grant in this section. In allocating an increase in federal fund
29 availability, the Office of State Budget and Management shall not approve funding for new
30 programs or activities not appropriated in this section.

31 If the Congress of the United States decreases the federal fund availability for any of
32 the Block Grants or contingency funds and other grants related to existing Block Grants
33 administered by the Department of Health and Human Services from the amounts appropriated
34 in this section, the Department shall develop a plan to adjust the block grants based on reduced
35 federal funding.

36 Notwithstanding the provisions of this subsection, for fiscal years 2013-2014 and
37 2014-2015, increases in the federal fund availability for the Temporary Assistance to Needy
38 Families (TANF) Block Grant shall be used only for the North Carolina Child Care Subsidy
39 program to pay for child care in four- or five-star rated facilities for four-year-old
40 ~~children~~ children and shall not be used to supplant State funds.

41 Prior to allocating the change in federal fund availability, the proposed allocation
42 must be approved by the Office of State Budget and Management. If the Department adjusts the
43 allocation of any Block Grant due to changes in federal fund availability, then a report shall be
44 made to the Joint Legislative Oversight Committee on Health and Human Services, the Joint
45 Legislative Commission on Governmental Operations, and the Fiscal Research Division.

46 **"SECTION 12J.1.(d)** Except as otherwise provided, appropriations from federal Block
47 Grant funds are made for each year of the fiscal biennium ending June 30, 2015, according to
48 the schedule enacted for State fiscal years 2013-2014 and 2014-2015 or until a new schedule is
49 enacted by the General Assembly.

50 **"SECTION 12J.1.(e)** All changes to the budgeted allocations to the Block Grants or
51 contingency funds and other grants related to existing Block Grants administered by the

1 Department of Health and Human Services that are not specifically addressed in this section
2 shall be approved by the Office of State Budget and Management, and the Office of State
3 Budget and Management shall consult with the Joint Legislative Commission on Governmental
4 Operations for review prior to implementing the changes. The report shall include an itemized
5 listing of affected programs, including associated changes in budgeted allocations. All changes
6 to the budgeted allocations to the Block Grants shall be reported immediately to the Joint
7 Legislative Oversight Committee on Health and Human Services and the Fiscal Research
8 Division. This subsection does not apply to Block Grant changes caused by legislative salary
9 increases and benefit adjustments.

10 "SECTION 12J.1.(e1) Except as otherwise provided, the Department of Health and
11 Human Services shall have flexibility to transfer funding between the Temporary Assistance to
12 Needy Families (TANF) Block Grant and the TANF Emergency Contingency Funds Block
13 Grant so long as the total allocation for the line items within those block grants remains the
14 same.

15 16 **"TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDS**

17 **"SECTION 12J.1.(f)** The sum of eighty-two million four hundred eighty-five thousand
18 four hundred ninety-five dollars (\$82,485,495) appropriated in this section in TANF funds to
19 the Department of Health and Human Services, Division of Social Services, for each year of
20 the 2013-2015 fiscal biennium shall be used for Work First County Block Grants. The Division
21 shall certify these funds in the appropriate State-level services based on prior year actual
22 expenditures. The Division has the authority to realign the authorized budget for these funds
23 among the State-level services based on current year actual expenditures.

24 **"SECTION 12J.1.(g)** The sum of two million four hundred eighty-two thousand two
25 hundred sixty dollars (\$2,482,260) appropriated in this section in TANF funds to the
26 Department of Health and Human Services, Division of Social Services, for each year of the
27 2013-2015 fiscal biennium shall be used to support administration of TANF-funded programs.

28 **"SECTION 12J.1.(h)** The sum of nine million four hundred twelve thousand three
29 hundred ninety-one dollars (\$9,412,391) appropriated in this section to the Department of
30 Health and Human Services, Division of Social Services, in TANF funds for each year of the
31 2013-2015 fiscal biennium for child welfare improvements shall be allocated to the county
32 departments of social services for hiring or contracting staff to investigate and provide services
33 in Child Protective Services cases; to provide foster care and support services; to recruit, train,
34 license, and support prospective foster and adoptive families; and to provide interstate and
35 post-adoption services for eligible families.

36 Counties shall maintain their level of expenditures in local funds for Child Protective
37 Services workers. Of the Block Grant funds appropriated for Child Protective Services workers,
38 the total expenditures from State and local funds for fiscal years 2013-2014 and 2014-2015
39 shall not be less than the total expended from State and local funds for the 2012-2013 fiscal
40 year.

41 **"SECTION 12J.1.(i)** The sum of two million twenty-six thousand eight hundred
42 seventy-seven dollars (\$2,026,877) appropriated in this section in TANF funds to the
43 Department of Health and Human Services, Special Children Adoption Fund, for each year of
44 the 2013-2015 fiscal biennium shall be used in accordance with G.S. 108A-50.2. The Division
45 of Social Services, in consultation with the North Carolina Association of County Directors of
46 Social Services and representatives of licensed private adoption agencies, shall develop
47 guidelines for the awarding of funds to licensed public and private adoption agencies upon the
48 adoption of children described in G.S. 108A-50 and in foster care. Payments received from the
49 Special Children Adoption Fund by participating agencies shall be used exclusively to enhance
50 the adoption services program. No local match shall be required as a condition for receipt of
51 these funds.

1 "SECTION 12J.1.(j) The sum of six hundred thirty-two thousand four hundred sixteen
2 dollars (\$632,416) appropriated in this section to the Department of Health and Human
3 Services in TANF funds for each year of the 2013-2015 fiscal biennium shall be used to
4 continue support for the Child Welfare Collaborative.

5
6 **"SOCIAL SERVICES BLOCK GRANT**

7 "SECTION 12J.1.(k) The sum of twenty-nine million four hundred twenty-two thousand
8 one hundred thirty-seven dollars (\$29,422,137) appropriated in this section in the Social
9 Services Block Grant to the Department of Health and Human Services, Division of Social
10 Services, for ~~each year of the 2013-2015 fiscal biennium~~ the 2013-2014 fiscal year and the sum
11 of twenty-seven million four hundred twenty-seven thousand fifteen dollars (\$27,427,015)
12 appropriated in this section in the Social Services Block Grant for the 2014-2015 fiscal year
13 shall be used for county block grants. The Division shall certify these funds in the appropriate
14 State-level services based on prior year actual expenditures. The Division has the authority to
15 realign the authorized budget for these funds among the State-level services based on current
16 year actual expenditures.

17 "SECTION 12J.1.(l) The sum of one million three hundred thousand dollars (\$1,300,000)
18 appropriated in this section in the Social Services Block Grant to the Department of Health and
19 Human Services, Division of Social Services, for each year of the 2013-2015 fiscal biennium
20 shall be used to support various child welfare training projects as follows:

- 21 (1) Provide a regional training center in southeastern North Carolina.
- 22 (2) Provide training for residential child caring facilities.
- 23 (3) Provide for various other child welfare training initiatives.

24 "SECTION 12J.1.(m) The Department of Health and Human Services is authorized,
25 subject to the approval of the Office of State Budget and Management, to transfer Social
26 Services Block Grant funding allocated for departmental administration between divisions that
27 have received administrative allocations from the Social Services Block Grant.

28 "SECTION 12J.1.(n) Social Services Block Grant funds appropriated for the Special
29 Childrens Adoption Incentive Fund will require a fifty percent (50%) local match.

30 "SECTION 12J.1.(o) The sum of five million forty thousand dollars (\$5,040,000)
31 appropriated in this section in the Social Services Block Grant for each year of the 2013-2015
32 fiscal biennium shall be allocated to the Department of Health and Human Services, Division
33 of Social Services. The Division shall allocate these funds to local departments of social
34 services to replace the loss of Child Protective Services State funds that are currently used by
35 county government to pay for Child Protective Services staff at the local level. These funds
36 shall be used to maintain the number of Child Protective Services workers throughout the State.
37 These Social Services Block Grant funds shall be used to pay for salaries and related expenses
38 only and are exempt from 10A NCAC 71R .0201(3) requiring a local match of twenty-five
39 percent (25%).

40 "SECTION 12J.1.(p) The sum of three million eight hundred fifty-two thousand five
41 hundred dollars (\$3,852,500) appropriated in this section in the Social Services Block Grant to
42 the Department of Health and Human Services, Division of Central Management and Support,
43 shall be used for DHHS competitive block grants pursuant to Section 12A.2 of this act for each
44 year of the 2013-2015 fiscal biennium. These funds are exempt from the provisions of 10A
45 NCAC 71R .0201(3).

46 "SECTION 12J.1.(q) The sum of three hundred seventy-five thousand dollars (\$375,000)
47 appropriated in this section in the Social Services Block Grant for each year of the 2013-2015
48 fiscal biennium to the Department of Health and Human Services, Division of Social Services,
49 shall be used to continue support for the Child Advocacy Centers and are exempt from the
50 provisions of 10A NCAC 71R .0201(3).

1 "SECTION 12J.1.(r) The sum of three million nine hundred seventy-eight thousand three
2 hundred sixty dollars (\$3,978,360) appropriated in this section in the Social Services Block
3 Grant for each year of the 2013-2015 fiscal biennium to the Department of Health and Human
4 Services, Divisions of Social Services and Aging and Adult Services, shall be used for
5 guardianship services pursuant to Chapter 35A of the General Statutes. The Department may
6 expend funds appropriated in this section to support (i) existing corporate guardianship
7 contracts during the 2013-2014 and 2014-2015 fiscal years and (ii) guardianship contracts
8 transferred to the State from local management entities or managed care organizations during
9 the 2013-2014 and 2014-2015 fiscal years.

10 11 **"LOW-INCOME HOME ENERGY ASSISTANCE BLOCK GRANT**

12 "SECTION 12J.1.(s) Additional emergency contingency funds received may be allocated
13 for Energy Assistance Payments or Crisis Intervention Payments without prior consultation
14 with the Joint Legislative Commission on Governmental Operations. Additional funds received
15 shall be reported to the Joint Legislative Commission on Governmental Operations and the
16 Fiscal Research Division upon notification of the award. The Department of Health and Human
17 Services shall not allocate funds for any activities, including increasing administration, other
18 than assistance payments, without prior consultation with the Joint Legislative Commission on
19 Governmental Operations.

20 "SECTION 12J.1.(t) The sum of fifty million eight hundred seventy-six thousand four
21 hundred forty dollars (\$50,876,440) appropriated in this section in the Low-Income Home
22 Energy Assistance Block Grant for each year of the 2013-2015 fiscal biennium to the
23 Department of Health and Human Services, Division of Social Services, shall be used for
24 energy assistance payments for the households of (i) elderly persons age 60 and above with
25 income up to one hundred thirty percent (130%) of the federal poverty level and (ii) disabled
26 persons eligible for services funded through the Division of Aging and Adult Services.

27 County departments of social services shall submit to the Division of Social Services an
28 outreach plan for targeting households with 60-year-old household members no later than
29 August 1 of each year. The outreach plan shall comply with the following:

- 30 (1) Ensure that eligible households are made aware of the available assistance
31 with particular attention paid to the elderly population age 60 and above and
32 disabled persons receiving services through the Division of Aging and Adult
33 Services.
- 34 (2) Include efforts by the county department of social services to contact other
35 State and local governmental entities and community-based organizations to

40 41 **"CHILD CARE AND DEVELOPMENT FUND BLOCK GRANT**

42 "SECTION 12J.1.(u) Payment for subsidized child care services provided with federal
43 TANF funds shall comply with all regulations and policies issued by the Division of Child
44 Development for the subsidized child care program.

45 "SECTION 12J.1.(v) If funds appropriated through the Child Care and Development Fund
46 Block Grant for any program cannot be obligated or spent in that program within the obligation
47 or liquidation periods allowed by the federal grants, the Department may move funds to child
48 care subsidies, unless otherwise prohibited by federal requirements of the grant, in order to use
49 the federal funds fully.

50 51 **"SUBSTANCE ABUSE PREVENTION AND TREATMENT BLOCK GRANT**

1 "SECTION 12J.1.(v1) The sum of two hundred fifty thousand dollars (\$250,000)
2 appropriated in this section in the Substance Abuse Prevention and Treatment Block Grant to
3 the Department of Health and Human Services, Division of Mental Health, Developmental
4 Disabilities, and Substance Abuse Services, for the 2014-2015 fiscal year shall be allocated to
5 the Department of Administration, Division of Veterans Affairs, to establish a call-in center to
6 assist veterans in locating service benefits and crisis services. The call-in center shall be staffed
7 by certified veteran peers within the Division of Veterans Affairs and trained by the Division of
8 Mental Health, Developmental Disabilities, and Substance Abuse Services.

9
10 **"MATERNAL AND CHILD HEALTH BLOCK GRANT**

11 "SECTION 12J.1.(w) If federal funds are received under the Maternal and Child Health
12 Block Grant for abstinence education, pursuant to section 912 of Public Law 104-193 (42
13 U.S.C. § 710), for the 2013-2014 fiscal year or the 2014-2015 fiscal year, then those funds shall
14 be transferred to the State Board of Education to be administered by the Department of Public
15 Instruction. The Department of Public Instruction shall use the funds to establish an abstinence
16 until marriage education program and shall delegate to one or more persons the responsibility
17 of implementing the program and G.S. 115C-81(e1)(4) and (4a). The Department of Public
18 Instruction shall carefully and strictly follow federal guidelines in implementing and
19 administering the abstinence education grant funds.

20 "SECTION 12J.1.(x) The Department of Health and Human Services shall ensure that
21 there will be follow-up testing in the Newborn Screening Program."

37 jointly submit a copy of the proposal and report on the results of the economic needs
38 assessment to the Chairs of the House of Representatives Appropriations Subcommittee on
39 Natural and Economic Resources, the Chairs of the Senate Appropriations Committee on
40 Natural and Economic Resources, the Agriculture and Forestry Awareness Study Commission,
41 and the Fiscal Research Division by January 1, 2015.

43 **BEDDING LAW ACCOUNT FUND**

44 SECTION 13.1A. The Department of Agriculture and Consumer Services may use
45 funds from the Bedding Law Account for the information technology needs of the Structural
46 Pest Control & Pesticides Division of the Department.

48 **REPEAL COTTON WAREHOUSE FUND**

49 SECTION 13.1B.(a) Effective June 30, 2014, G.S. 106-435 is repealed, and the
50 unallotted and unexpended funds in the Cotton Warehouse Fund on that date shall be

1 transferred to the Research Stations Division of the Department of Agriculture and Consumer
2 Services and used to support the operations of the Division.

32 bulbs and flowers and other agricultural products having a domestic or foreign market, shall be
33 permitted and encouraged to act jointly and in cooperation with growers, handlers, dealers and
34 processors of such products in promoting and stimulating, by advertising and other methods,
35 the increased production, use and sale, domestic and foreign, of any and all of such agricultural
36 commodities. The provisions of this Article, however, shall not include the agricultural
37 products of tobacco, strawberries, strawberry plants, porcine animals, or equines, with respect
38 to which separate provisions have been made.

39 (b) The "Got to be NC" marketing campaign of the Department of Agriculture and
40 Consumer Services shall be the official agricultural marketing campaign for the State."

42 DACS RESEARCH STATIONS

43 **SECTION 13.8.** G.S. 106-6.3 reads as rewritten:

44 **"§ 106-6.3. Create special revenue fund for research stations.**

45 The Research Stations Fund is established as a special revenue fund within the Department
46 of Agriculture and Consumer Services, Division of Research Stations. This Fund shall consist
47 of receipts from the sale of commodities produced on the Department's research stations and
48 any gifts, bequests, or grants for the benefit of this Fund. No General Fund appropriations shall
49 be credited to this Fund. Any balance exceeding one million dollars (\$1,000,000) remaining-in

1 otherwise invest in research stations operated by the Department's Research ~~Station~~ Stations

4 **CERTIFICATION OF PRIVATE PESTICIDE APPLICATORS**

5 **SECTION 13.10.(a)** G.S. 143-440(b) reads as rewritten:

6 "(b) The Board may include in any such restricted use regulation the time and conditions
7 of sale, distribution, or use of such restricted use pesticides, may prohibit the use of any
8 restricted use pesticide for designated purposes or at designated times; may require the
9 purchaser or user to certify that restricted use pesticides will be used only as labeled or as
10 further restricted by regulation; may require the certification and recertification of private
11 applicators, and charge a fee of up to ten dollars (\$10.00), with the fee set at a level to make the
12 certification/recertification program self-supporting, and, after opportunity for a hearing, may
13 suspend, revoke or modify the certification for violation of any provision of this Article, or any
14 rule or regulation adopted thereunder; may adopt rules to classify private applicators; and may,
15 if it deems it necessary to carry out the provisions of this Part, require that any or all restricted
16 use pesticides shall be purchased, possessed, or used only under permit of the Board and under
17 its direct supervision in certain areas and/or under certain conditions or in certain quantities or
18 concentrations except that any person licensed to sell such pesticides may purchase and possess
19 such pesticides without a permit. The Board may require all persons issued such permits to
20 maintain records as to the use of the restricted use pesticides. The Board may authorize the use
21 of restricted use pesticides by persons licensed under the North Carolina Structural Pest Control
22 Act without a permit. A nonrefundable fee of ten dollars (\$10.00) shall be charged for each
23 examination required by this section. This examination fee is in addition to the certification or
24 recertification fee, and any other fee authorized pursuant to any other provision of Article 4C of
25 Chapter 106 of the General Statutes."

26 **SECTION 13.10.(b)** G.S. 106-65.24 reads as rewritten:

27 **"§ 106-65.24. Definitions.**

28 As used in this Article:

29 ...

30 (23) "Structural pest control" means the control of wood-destroying organisms or
31 household pests (including, but not limited to, animals such as moths,
32 cockroaches, ants, beetles, flies, mosquitoes, ticks, wasps, bees, fleas, mites,
33 silverfish, millipedes, centipedes, sowbugs, crickets, termites, wood borers,
34 etc.), including the identification of infestations or infections, the making of
35 inspections, the use of pesticides, including insecticides, repellents,
36 attractants, rodenticides, fungicides, and fumigants, as well as all other
37 substances, mechanical devices or structural modifications under whatever
38 name known, for the purpose of preventing, controlling and eradicating
39 insects, vermin, rodents and other pests in household structures, commercial
40 buildings, and other structures (including household structures, commercial
41 buildings and other structures in all stages of construction), and outside
42 areas, as well as all phases of fumigation, including treatment of products by
43 vacuum fumigation, and the fumigation of railroad cars, trucks, ships, and
44 airplanes, or any one or any combination thereof. Structural pest control
45 shall not include ancillary activities such as furniture moving, cleaning,
46 maintenance, or repair of property that may be performed in association with
47 the control of wood-destroying organisms or household pests as described in
48 this subdivision.

49"

50 **SECTION 13.10.(c)** G.S. 106-65.25 reads as rewritten:

1 "§ 106-65.25. Phases of structural pest control; prohibited acts; license required;
2 exceptions.

3 ...
4 (i) Nothing in this Article shall limit or restrict the ability of a person engaged in
5 activities ancillary to structural pest control as set forth in G.S. 106-65.24(23) to be engaged in
6 such activities, whether as an employee, independent contractor, or otherwise, for one or more
7 structural pest control licensees."

8 9 INCREASE FEES ASSOCIATED WITH NATIONAL POULTRY IMPROVEMENT 10 PLAN

24 bird.
25 (2) An annual recertification fee of ten dollars (\$10.00), plus ten cents (10¢) per
26 bird."

27 28 FEES FOR FOREST MANAGEMENT PLANS

50 all of the elements of a Type I transfer, as defined in G.S. 143A-6.

12 engaged in transporting, buying, or selling them for such use; (iv) to insure that animals
13 confined in pet shops, kennels, animal shelters and auction markets are provided humane care
14 and treatment; (v) to prohibit the sale, trade or adoption of those animals which show physical
15 signs of infection, communicable disease, or congenital abnormalities, unless veterinary care is
16 assured subsequent to sale, trade or adoption.

17 **"§ 19A-22. Animal Welfare Section in ~~Animal Health Division of Department of~~**
18 **Agriculture and Consumer ServicesLaw Enforcement Division of the**
19 **Department of Public Safety created; Director.**

20 There is hereby created within the ~~Animal Health Division of the North Carolina~~
21 ~~Department of Agriculture and Consumer Services~~,Law Enforcement Division of the
22 Department of Public Safety, a new section thereof, to be known as the Animal Welfare
23 Section of said division.

24 The ~~Commissioner of Agriculture~~Secretary of the Department of Public Safety is hereby

 2 association that cares for stray animals that has been favorably assessed by
 3 the operator of the animal shelter through the application of written
 4 standards.

5 (5c) "Boarding kennel" means a facility or establishment which regularly offers
 6 to the public the service of boarding dogs or cats or both for a fee. Such a
 7 facility or establishment may, in addition to providing shelter, food and
 8 water, offer grooming or other services for dogs and/or cats.

9 (6) "~~Commissioner~~"Secretary means the ~~Commissioner of Agriculture of the~~
 10 ~~State of North Carolina~~ Secretary of the Department of Public Safety.

11 (7) "Dealer" means any person who sells, exchanges, or donates, or offers to
 12 sell, exchange, or donate animals to another dealer, pet shop, or research
 13 facility; provided, however, that an individual who breeds and raises on his
 14 own premises no more than the offspring of five canine or feline females per
 15 year, unless bred and raised specifically for research purposes shall not be
 16 considered to be a dealer for the purposes of this Article.

17 (7a) "Department" means the Department of Public Safety.

18 (8) "Director" means the Director of the Animal Welfare Section of the ~~Animal~~
 19 ~~Health Division of the Department of Agriculture and Consumer Services~~
 20 Law Enforcement Division of the Department of Public Safety.

22 **"§ 19A-24. Powers of ~~Board of Agriculture~~Department of Public Safety.**

23 (a) The ~~Board of Agriculture~~Department of Public Safety shall:

24 (1) Establish standards for the care of animals at animal shelters, boarding
 25 kennels, pet shops, ~~and public auctions.~~ and animals sold by
 26 dealers to the public. A boarding kennel that offers dog day care services and

14 or revoked and may be renewed for like periods upon application in the manner provided.

19 (f) An animal that is surrendered to an animal shelter by the animal's owner and not

- 24 (3) Euthanized by a procedure approved by rules adopted by the ~~Department of~~

30 (j) Animal shelters shall maintain a record of all animals impounded at the shelter, shall

34 contain, at a minimum:

12 from contributions and grants from public or private sources.
13 (4) An annual transfer of two hundred fifty thousand dollars (\$250,000) in
14 receipts of the Animal Feed and Pet Food Branch within the Food and Drug
15 Protection Division of the Department of Agriculture and Consumer
16 Services, of which \$10,000 may be used to establish and publicize a fund to
17 accept additional private contributions for the operation of the Dealer
18 inspection program under Article 3 of this Chapter or the Spay/Neuter
19 program under this Article.
20 (5) An annual transfer of sixty-one thousand five hundred twenty-five dollars
21 (\$61,525) in receipts collected by the Department from the inspection fee
22 authorized by G.S. 106-284.40(a).

23 (b) Use. – The revenue in the Account shall be used by the ~~Department of Agriculture~~
24 ~~and Consumer Services~~Department of Public Safety as follows:

26 (c) Report. – In February of each year, the Department must report to the Joint
27 Legislative Commission on Governmental Operations and the Fiscal Research Division. The
28 report must contain information regarding all revenues and expenditures of the Spay/Neuter

31 **"§ 19A-64. Distributions to counties and cities from Spay/Neuter Account.**

33 (b) Application. – A county or city eligible for reimbursement of spaying and neutering
34 costs from the Spay/Neuter Account shall apply to the ~~Department of Agriculture and~~
35 ~~Consumer Services~~Department of Public Safety by the last day of January, April, July, and
36 October of each year to receive a distribution from the Account for that quarter. The application
37 shall be submitted in the form required by the Department and shall include an itemized listing

41 **Local Funding.**

7 **SECTION 13.14.(d)** G.S. 90-101(a2) reads as rewritten:

8 "(a2) An animal shelter may register under this section for the limited purpose of
9 obtaining, possessing, and using sodium pentobarbital and other drugs approved by the
10 Department in consultation with the North Carolina Veterinary Medical Association for the
11 euthanasia of animals lawfully held by the animal shelter. An animal shelter registered under
12 this section shall also register with the federal Drug Enforcement Agency under the federal
13 Controlled Substances Act. An animal shelter's acquisition of sodium pentobarbital and other
14 approved drugs for use in the euthanizing of animals shall be made only by the shelter's
15 manager or chief operating officer or by a licensed veterinarian.

24 Article 3 of Chapter 19A of the General Statutes and owned, operated, or maintained by a unit
25 of local government or under contract with a unit of local government for the purpose of
26 housing or containing seized, stray, homeless, quarantined, abandoned, or unwanted animals."

- 9 (2) Five hundred thousand dollars (\$500,000) for ~~each fiscal year of the~~
10 ~~2013-2015 biennium~~ the 2013-2014 fiscal year to the North Carolina
11 Agricultural Water Resources Assistance Program to fund projects in the
12 following counties: Avery, Buncombe, Burke, Cherokee, Clay, Graham,
13 Haywood, Henderson, Jackson, Macon, Madison, McDowell, Mitchell,
14 Swain, Transylvania, Watauga, Yancey.
- 15 (2a) Five hundred thousand dollars (\$500,000) for the 2014-2015 fiscal year to
16 WNC Communities to fund lighting efficiency projects for public schools in
17 areas served by the organization. Of the funds allocated in this subdivision,
18 WNC Communities may use up to fifty thousand dollars (\$50,000) for
19 administrative expenses.
- 20 (3) One million dollars (\$1,000,000) for each fiscal year of the 2013-2015
21 biennium to North Carolina Agricultural Development and Farmland
22 Preservation Trust Fund to be used, notwithstanding G.S. 106-744, to award
23 funds in the following counties: Avery, Buncombe, Burke, Cherokee, Clay,
24 Graham, Haywood, Henderson, Jackson, Macon, Madison, McDowell,
25 Mitchell, Swain, Transylvania, Watauga, Yancey.
- 26 (4) Two hundred forty thousand dollars (\$240,000) for each fiscal year of the
27 2013-2015 biennium to the Appalachian Energy Center at Appalachian State
28 University.

29 "**SECTION 13.3.(b)** Funds allocated under subdivision (1) of subsection (a) of this section
30 shall not be used to acquire ~~land~~ land or purchase conservation easements."

33 34 **AGENCIES REPORT ON FEDERAL GRANTS**

35 **SECTION 14.1.** The Department of Environment and Natural Resources, the
36 Wildlife Resources Commission, the Department of Labor, the Department of Commerce, and
37 the Department of Agriculture shall review every federal grant received by the respective
38 departments and report no later than February 1, 2015, to the Chairs of the House of
39 Representatives Appropriations Subcommittee on Natural and Economic Resources, the Chairs
40 of the Senate Appropriations Committee on Natural and Economic Resources, and the Fiscal
41 Research Division regarding the source and amount of the grant, the match required for the
42 grant from State funds, and any conditions, limitations, restrictions, or additional actions or
43 programs the department is required to fulfill or undertake as a result of accepting the grant.
44

45 **NER FACILITIES AND ADMINISTRATIVE FEES**

46 **SECTION 14.2.** The Department of Agriculture, the Department of Commerce, the
47 North Carolina Biotechnology Center, and the Department of Environment and Natural
48 Resources shall negotiate indirect cost waivers with every constituent institution of The
49 University of North Carolina performing State-funded research for the Center or the respective

- b. Licenses issued by the Division of Marine Fisheries and Wildlife Resources Commission held by the nominee or any business in which the nominee has a financial interest.
- c. The nominee's membership in, affiliation with, or employment by any organization or group pertaining to the management or use of the State's fisheries or wildlife resources.

Disclosure statements shall be treated as public records under Chapter 132 of the General Statutes and shall be updated on an annual basis.

(2) Voting/conflict of interest. – A member of the Commission shall not vote on any issue before the Commission that would have a "significant and predictable effect" on the member's financial interest. For purposes of this

subdivision, "significant and predictable effect" means there is or may be a close causal link between the decision of the Commission and an expected disproportionate financial benefit to the member that is shared only by a minority of persons within the same industry sector or gear group. A member of the Commission shall also abstain from voting on any petition submitted by an advocacy group of which the member is an officer or sits as a member of the advocacy group's board of directors. A member of the Commission shall not use the member's official position as a member of the Commission to secure any special privilege or exemption of substantial value for any person. No member of the Commission shall, by the member's conduct, create an appearance that any person could improperly influence the member in the performance of the member's official duties.

(3) Regular attendance. – It shall be the duty of each member of the Commission to regularly attend meetings of the Commission.

(h) Removal. – The Governor may remove, as provided in G.S. 143B-13, any member of the Commission for misfeasance, malfeasance, or nonfeasance. For purposes of this subsection, malfeasance shall include, but is not limited to, any of the following:

(1) Any criminal conviction of a member for violation of any hunting or fishing laws of the State or rules promulgated by the Marine Fisheries Commission or Wildlife Resources Commission.

(2) Any citation of a member or a company owned, in whole or in part, by the member for violation of any hunting or fishing laws of the State or rules promulgated by the Marine Fisheries Commission or Wildlife Resources Commission.

38 channel from Back Sound to Lookout Back, channels connected to federal navigation channels,
39 Lockwoods Folly River, Manteo/Shallowbag Bay, including Oregon Inlet, Masonboro Inlet,
40 New River, New Topsail Inlet, Rodanthe, Rollinson, Shallotte River, Silver Lake Harbor, and
41 the waterway connecting Pamlico Sound and Beaufort Harbor."

43 **COAL ASH MANAGEMENT**

44 **SECTION 14.20.** Of the funds appropriated in this act to the Department of
45 Environment and Natural Resources for coal ash management, the Department may use up to

(d) ~~Notwithstanding any other provision of law, the North Carolina Wildlife Resources Commission shall issue captivity licenses, captivity permits, or transportation permits to any person possessing cervids that were held in captivity by that person prior to May 17, 2002, if the Executive Director finds that the applicant has come into compliance with all applicable rules related to the holding of cervids in captivity by January 1, 2004, and that issuance of such license or permit does not pose unreasonable risk to the conservation of wildlife resources.~~

(e) ~~Any captivity license, captivity permit, or cervids held contrary to the provisions of this section may be subject to forfeiture and disposition in accordance with the provisions of G.S. 113-137 or G.S. 113-276.2."~~

SECTION 14.26.(c) The Department of Agriculture and Consumer Services shall study the risks associated with the spread of Chronic Wasting Disease, also known as transmissible spongiform encephalopathy, due to the importation of cervids from outside the State. The Department shall report no later than February 1, 2015, to the Chairs of the Appropriations Subcommittee on Natural and Economic Resources of the House of Representatives, the Chairs of the Appropriations Committee on Natural and Economic Resources of the Senate, and the Fiscal Research Division with its proposals and recommendations for the best methods of minimizing the potential cost to the State associated

SECTION 15.5.(a) The Office of State Budget and Management, in conjunction with the Office of the State Controller and the Department of Commerce, shall transfer the unencumbered cash balances in the following funds as of June 30, 2014, to Commerce Administration (Budget Code 14600-1111):

- (2) 24609-2535 – NC Green Business Fund
- (3) 24609-2562 – One North Carolina Small Business Fund
- (4) 24613-2622 – Main Street Solutions

42 recurring funds for the 2014-2015 fiscal year shall be used to meet the State matching funds
43 requirement for Community Development Block Grant (CDBG) funds. All or a portion of these
44 funds shall be used to purchase and install a new grants management software program in the
45 2014-2015 fiscal year.

46 **SECTION 15.9.(b)** Effective July 1, 2014, the Secretary of Commerce shall reduce
47 expenditures in the amount of six hundred thirty-seven thousand five hundred dollars

23 **SECTION 16B.3.(e)** This section applies to fees assessed on or after July 1, 2014.

24 **MOBILE VIPER RADIOS FOR THE STATE HIGHWAY PATROL**

25 **SECTION 16B.5.** The Department of Public Safety shall use the sum of two
26 million eight hundred ninety-four thousand one hundred eighty-eight dollars (\$2,894,188) of
27 funds available to the Division of Law Enforcement to purchase mobile VIPER radios for the
28 State Highway Patrol. The Department is encouraged to use funds transferred to the State from
29 federal asset forfeiture programs for this purpose.

30 **STATE CAPITOL POLICE/RECEIPT-SUPPORTED POSITIONS**

31 **SECTION 16B.6.(a)** The State Capitol Police may contract with State agencies for
32 the creation of receipt-supported positions to provide security services to the buildings
33 occupied by those agencies.

34 **SECTION 16B.6.(b)** The State Capitol Police shall report the creation of any
35 position pursuant to this section to the Chairs of the House Appropriations Subcommittee on

24 consecutive or nonconsecutive, the court ~~determines-determines~~, as provided in this subsection.
25 For probationary sentences for misdemeanors, including impaired driving under G.S. 20-138.1,

27 facility. In addition to any other conditions of probation which the court may impose, the court
28 shall impose, when imposing a period or periods of imprisonment as a condition of special
29 probation, the condition that the defendant obey the Rules and Regulations of the Division of
30 Adult Correction of the Department of Public Safety governing conduct of inmates, and this
31 condition shall apply to the defendant whether or not the court imposes it as a part of the
32 written order. ~~Except for probationary sentences for misdemeanors, including impaired~~
33 driving under G.S. 20-138.1, if imprisonment is for continuous periods, the confinement may
34 be in the custody of either the Division of Adult Correction of the Department of Public Safety
35 or a local confinement facility. Noncontinuous periods of imprisonment under special probation
36 may only be served in a designated local confinement or treatment facility. Except for
37 probationary sentences of impaired driving under G.S. 20-138.1, the total of all periods of
38 confinement imposed as an incident of special probation, but not including an activated

8 G.S. 20-138.1, other than imprisonment required as a condition of special probation under

10 on Governmental Operations on the anticipated savings and on safety considerations prior to
11 entering any prison maintenance contract under this section."

12 **ADULT AND JUVENILE INMATE MEDICAL COSTS**

A prison unit under lease to a county pursuant to the provisions of this section for use as a jail is exempt for the period of the lease from any of the minimum standards adopted by the Secretary of Health and Human Services pursuant to G.S. 153A-221 for the housing of adult prisoners that would subject the unit to greater standards than those required of a unit of the State prison system.

In addition, the Department of Public Safety may use available funds to reopen and convert closed facilities for use as treatment and behavior modification facilities for offenders serving a period of confinement in response to violation pursuant to G.S. 15A-1344(d2)."

JUSTICE REINVESTMENT ACT/LIMITED AUTHORITY TO RECLASSIFY VACANT POSITIONS

8 "**§ 18B-500. Alcohol law-enforcement agents.**

9 (a) Appointment. – The ~~Secretary of Public Safety~~Director of the State Bureau of
10 Investigation shall appoint alcohol law-enforcement agents and other enforcement personnel.
11 The ~~Secretary of Public Safety~~Director may also appoint regular employees of the Commission
12 as alcohol law-enforcement agents. Alcohol law-enforcement agents shall be designated as
13 "alcohol law-enforcement agents". Persons serving as reserve alcohol law-enforcement agents
14 are considered employees of the Alcohol Law Enforcement ~~Section~~Branch for workers'
15 compensation purposes while performing duties assigned or approved by the ~~Director~~Head of
16 the Alcohol Law Enforcement Section~~Branch~~ or the ~~Director's~~Head's designee.

17 (b) Subject Matter Jurisdiction. – After taking the oath prescribed for a peace officer, an
18 alcohol law-enforcement agent shall have authority to arrest and take other investigatory and
19 enforcement actions for any criminal offense. The primary responsibility of an agent shall be
20 enforcement of the ~~ABC laws, lottery laws, and Article 5 of Chapter 90 (The Controlled~~
21 ~~Substances Act)~~; however, an agent may perform any law enforcement duty assigned by the
22 ~~Secretary of Public Safety or the Governor.~~ABC and lottery laws.

24 (g) Shifting of Personnel From One District to Another. – The ~~Director~~Head of the
25 Alcohol Law Enforcement ~~Section~~Branch, under rules adopted by the Department of Public
26 Safety may, from time to time, shift the forces from one district to another or consolidate more
27 than one district force at any point for special purposes. Whenever an agent of the Alcohol Law
28 Enforcement Section is transferred from one district to another for the convenience of the State
29 or for reasons other than the request of the agent, the Department shall be responsible for
30 transporting the household goods, furniture, and personal apparel of the agent and members of

36 **SECTION 22.1.(a)** Chapter 120 of the General Statutes is amended by adding a
37 new Article to read:

39 "Joint Legislative Oversight Committee on General Government.

40 "**§ 120-295. Creation and membership of Joint Legislative Oversight Committee on**
41 **General Government.**

42 (a) The Joint Legislative Oversight Committee on General Government is established.
43 The Committee consists of 14 members as follows:

- 44 (1) Seven members of the Senate appointed by the President Pro Tempore of the
45 Senate, at least two of whom are members of the minority party; and
- 46 (2) Seven members of the House of Representatives appointed by the Speaker of
47 the House of Representatives, at least two of whom are members of the
48 minority party.

49 (b) Terms on the Committee are for two years and begin on the convening of the
50 General Assembly in each odd-numbered year. Members may complete a term of service on
51 the Committee even if they do not seek reelection or are not reelected to the General Assembly,

1 but resignation or removal from service in the General Assembly constitutes resignation or
2 removal from service on the Committee.

3 (c) A member continues to serve until a successor is appointed. A vacancy shall be
4 filled within 30 days by the officer who made the original appointment.

5 **"§ 120-296. Purpose and powers of Committee.**

6 (a) The Joint Legislative Oversight Committee on General Government shall examine
7 on a continuing basis the services provided by the departments and agencies set out in this
8 subsection in order to make ongoing recommendations to the General Assembly on ways to
9 improve the effectiveness, efficiency, and quality of State government services. The Committee
10 has the following powers and duties:

11 (1) Study the programs, organization, operations, and policies of the following
12 agencies:

13 a. Department of Administration.

14 b. Department of State Auditor.

15 c. Department of Cultural Resources.

16 d. Housing Finance Agency.

17 e. Department of Insurance.

18 f. Office of Administrative Hearings.

19 g. Office of State Human Resources.

20 h. Department of Revenue.

21 i. Department of Secretary of State.

22 j. State Ethics Commission.

23 k. Department of State Treasurer.

24 (2) Review compliance of budget actions directed by the General Assembly.

25 (3) Monitor expenditures, deviations, and changes made by the agencies set out
26 in subsection (a) of subdivision (1) of this section to the certified budget.

27 (4) Review policy changes as directed by law.

28 (5) Receive presentations of reports from agencies directed in the law, including
29 audits, studies, and other reports.

30 (6) Review any issues that arise during the interim period between sessions of
31 the General Assembly and provide a venue for any of these issues to be
32 heard in a public setting.

33 (7) Monitor the quality of services provided by general government agencies to
34 other agencies and the public.

35 (8) Identify opportunities for general government agencies to coordinate and
36 collaborate to eliminate duplicative functions.

37 (9) Have presentations and reports on any other matters that the Committee
38 considers necessary to fulfill its mandate.

39 (b) The Committee may make reports to the General Assembly. A report to the General
40 Assembly may contain legislation needed to implement a recommendation of the Committee.

41 **"§ 120-297. Organization of Committee.**

42 (a) The President Pro Tempore of the Senate and the Speaker of the House of
43 Representatives shall each designate a cochair of the Joint Legislative Oversight Committee on
44 General Government. The Committee shall meet upon the joint call of the cochairs.

45 (b) A quorum of the Committee is five members. No action may be taken except by a
46 majority vote at a meeting at which a quorum is present. While in the discharge of its official
47 duties, the Committee has the powers of a joint committee under G.S. 120-19 and
48 G.S. 120-19.1 through G.S. 120-19.4.

49 (c) Members of the Committee shall receive subsistence and travel expenses as
50 provided in G.S. 120-3.1. The Committee may contract for consultants or hire employees in
51 accordance with G.S. 120-32.02. The Legislative Services Commission, through the Legislative

1 Services Officer, shall assign professional staff to assist the Committee in its work. Upon the
2 direction of the Legislative Services Commission, the Directors of Legislative Assistants of the
3 Senate and of the House of Representatives shall assign clerical staff to the Committee. The
4 expenses for clerical employees shall be borne by the Committee.

5 (d) The Committee cochairs may establish subcommittees for the purpose of examining
6 issues relating to services provided by particular divisions within the State's general
7 government departments.

8 **"§ 120-298. Reports to Committee.**

9 Whenever a department, office, or agency set out in subdivision (a)(1) of G.S. 120-296 is
10 required by law to report to the General Assembly or to any of its permanent committees or
11 subcommittees on matters affecting the services the department or agency provides, the
12 department or agency shall transmit a copy of the report to the cochairs of the Joint Legislative
13 Oversight Committee on General Government."

14 **SECTION 22.1.(b)** This section is effective when it becomes law.
15

16 **STUDY OF THE COSTS OF HEALTH INSURANCE MANDATES**

17 **SECTION 22.2.(a)** The Legislative Research Commission may study the issue of
18 existing health insurance mandates. The goal of the study would be to provide a complete
19 picture of the overall impact of the health insurance mandates on individuals, employers, health
20 insurance companies, the providers of health care, the General Fund, and the State economy.
21 To that end, the study should consider the following:

- 22 (1) The costs to individuals and employers of the health insurance mandates,
23 including increased premiums or other cost sharing. This analysis shall
24 include estimates of additional premium costs attributable to particular
25 mandates.
- 26 (2) The cost to the State for mandates that apply to the State Health Plan for
27 Teachers and State Employees. This analysis shall include estimates of
28 additional premium costs attributable to particular mandates.
- 29 (3) The cost to health insurance companies of adding mandated coverage to
30 their plans, including the costs of modifying existing plans to include new
31 mandates.
- 32 (4) The benefits to individuals of the health insurance mandates, including an
33 estimate of how many individuals benefit from particular mandates and a
34 comparison of the costs of mandated covered procedures to the costs of the
35 procedures if coverage were not mandated.
- 36 (5) The benefits to employers through increased productivity, less time absent
37 from work, or other appropriate benefits from mandating the insurance
38 coverage of particular services or treatments.
- 39 (6) For mandates of a screening or preventative nature, a cost estimate of the
40 savings attributable to early detection and treatment.
- 41 (7) The benefits to providers of services mandated to be covered by health
42 insurance.
- 43 (8) Any other related items deemed appropriate by the Legislative Research
44 Commission.

45 **SECTION 22.2.(b)** The Legislative Research Commission may study the creation
46 of a process to review the costs of proposed future health benefit mandates and make
47 recommendations based on its study. Such a process should be designed to aid the General
48 Assembly to better understand the complete costs and benefits of proposed health insurance
49 mandates, both to the individual beneficiaries of the mandates and to the State's health system
50 and economy. Such a process should be more involved than the current actuarial note process
51 for mandates that apply to the State Health Plan for Teachers and State Employees and should

1 consider the same items listed in the subdivisions of subsection (a) of this section for proposed
2 future health benefit mandates.

3 **SECTION 22.2.(c)** In order to assess the feasibility and cost of (i) the study
4 contemplated by subsection (a) of this section and (ii) the review process contemplated by
5 subsection (b) of this section, the Legislative Research Commission may engage the services of
6 a contract manager to design, issue, and manage requests for information (RFIs) from experts
7 in health insurance and economics who may be able to study health insurance mandates.

8 **SECTION 22.2.(d)** The Legislative Research Commission may use up to the sum
9 of five hundred thousand dollars (\$500,000), which is appropriated in this act for fiscal year
10 2014-2015, nonrecurring, for the studies authorized under this section and for engaging the
11 services of a contract manager as provided in subsection (c) of this section.
12

13 **STATUTE OF REPOSE STUDY COMMISSION**

14 **SECTION 22.3.(a)** There is created the Statute of Repose Study Commission.

15 **SECTION 22.3.(b)** Membership. – The Statute of Repose Study Commission shall
16 consist of 10 members, five members of the Senate appointed by the President Pro Tempore of
17 the Senate and five members of the House of Representatives appointed by the Speaker of the
18 House of Representatives.

24 the members of the Commission constitutes a quorum.

25 **SECTION 22.3.(d)** Compensation; Administration. – Members of the Statute of
26 Repose Study Commission shall receive per diem, subsistence, and travel allowances in
27 accordance with G.S. 120-3.1. The Commission, while in the discharge of its official duties,
28 may exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through
29 G.S. 120-19.4. The Commission may meet in the Legislative Building or the Legislative Office
30 Building.

31 The Legislative Services Commission, through the Legislative Services Officer,
32 shall assign professional staff to assist the Commission in its work. The House of
33 Representatives' and the Senate's Directors of Legislative Assistants shall assign clerical staff to
34 the Commission, and the expenses relating to the clerical employees shall be borne by the
35 Commission.

36 **SECTION 22.3.(e)** Purpose. – The Statute of Repose Study Commission shall
37 study whether the 10-year period of repose set out in G.S. 1-52(16) should be amended, or
38 whether other change in the laws of North Carolina should be enacted, in light of the opinion of
39 the United States Supreme Court in *CTS Corp. v. Waldburger et al.*, No. 13-339 (June 9, 2014)
40 (slip op.). The Commission shall report its findings and recommendations and any legislative
41 proposals to the 2015 Regular Session of the General Assembly.

42 **SECTION 22.3.(f)** Commission Termination. – The Statute of Repose Study
43 Commission shall terminate on the filing of its report or upon the convening of the 2015
44 General Assembly, whichever is earlier.

45 **SECTION 22.3.(g)** The Legislative Services Commission shall allocate monies to
46 fund the work of the Statute of Repose Study Commission from funds available to the General
47 Assembly.

7 Officer shall not allocate any funds to continue or renew licenses for the online job application
8 and career portal currently utilized by OSHR.

9 **SECTION 22A.1.(b)** Nothing in this section is intended, nor shall it be construed,
10 to impair any valid contract relating to its subject matter.

11
12 **OFFICE OF STATE HUMAN RESOURCES/JLOCGG REVIEW OF TEMPORARY**
13 **SOLUTIONS**

14 **SECTION 22A.2.(a)** The Joint Legislative Oversight Committee on General
15 Government (Committee) created by Section 22.1 of this act shall review the effectiveness and
16 efficiency of the Temporary Solutions staffing service of the Office of State Human Resources
17 (OSHR). As part of its review, the Committee shall:

- 18 (1) Review the OSHR's administrative surcharge charged to State agencies.
- 19 (2) Review the administrative structure of the Temporary Solutions staffing

- 30 (7) Consider any other matters pertaining to the Temporary Solutions staffing
31 service.

32 By January 30, 2015, the Committee shall report to the 2015 General Assembly on
33 its recommendations and any legislative proposals relating to the Temporary Solutions staffing
34 service.

35 **SECTION 22A.2.(b)** By September 1, 2014, the OSHR shall:

- 36 (1) Conduct a customer satisfaction survey that focuses on measuring State
37 agencies' perceptions of the Temporary Solutions staffing service. At a
38 minimum, the survey shall provide for ratings in the categories of
39 promptness in placements, responsiveness to agency staffing needs, and
40 identification and referral of qualified persons for temporary staffing
41 requirements.
- 42 (2) Report the results of the survey required by this subsection to the
43 Committee, along with OSHR's plan to address any issues identified by the
44 survey.

45
46 **EXTEND REORGANIZATION THROUGH REDUCTION PROGRAM**

47 **SECTION 22A.3.(a)** Section 8.3 of S.L. 2013-382 reads as rewritten:

48 "**SECTION 8.3.** This Part is effective when it becomes law and expires ~~June 30, 2014.~~
49 June 30, 2015. The Office of State Personnel and the Office of State Budget and Management
50 shall report to the Joint Legislative Commission on Governmental Operations on January 31,

10 administrative assistance, including staff, to the commission and reimbursement expenses for
11 the Commission and five percent (5%) each fiscal year shall be allocated to North Carolina
12 New Schools Project. North Carolina New Schools Project shall use the funds to establish a
13 peer learning network for all grantees to ensure high-quality implementation of grant programs
14 that lead to strong results for students. The peer learning network shall (i) share effective
15 practices and lessons learned among grantees; (ii) bring together grantee teachers and leaders
16 for intensive development that sustains focus on instruction, academic rigor, and skills
17 development; and (iii) benchmark grantee data against State and national standards. North
18 Carolina New Schools Project shall also advise grantees in fund-raising.

19 **SECTION 23.1.(b)** G.S. 115C-64.16(f) reads as rewritten:

22 recipient shall submit to the Commission an annual report for the preceding grant year that

1 G.S. 120-121, who have experience in businesses operating in North
2 Carolina.

3 (b1) Members appointed by the Governor or the General Assembly shall serve for
4 three-year terms and can be reappointed at the completion of their terms.

14 **PART XXV. OFFICE OF THE STATE AUDITOR**

15
16 **PRIVATE AUDIT OF PENSION FUND**

17 **SECTION 25.1.(a)** In addition to all other audits and reports required by law, the
18 State Treasurer shall prepare and issue, for the 2014-2015 fiscal year, a set of financial
19 statements regarding the investment programs for the Retirement Systems enumerated in
20 G.S. 147-69.2(b)(8). These financial statements shall be audited by a commercial independent
21 third-party audit firm selected and engaged by the State Auditor based upon selection criteria
22 developed by the State Auditor in consultation with the State Treasurer. The audit firm's report
23 and the financial statements shall be provided to the State Controller and the General Assembly
24 no later than January 1, 2016.

25 **SECTION 25.1.(b)** Supplementary information accompanying the financial
26 statements required by subsection (a) of this section shall include a discussion of the
27 Retirement Systems' risk and returns compared to benchmarks, total management fees and
28 incentives paid, and comparisons to peer cost benchmarks.

- 1 (6) The Auditor is authorized and directed in ~~his~~the Auditor's reports of audits or
2 reports of special investigations to make any comments, suggestions, or
3 recommendations ~~he~~the Auditor deems appropriate concerning any aspect of
4 such agency's activities and operations.
- 5 (7) The Auditor ~~shall~~may charge and collect from each examining and licensing
6 board the actual cost of each audit of such board. Costs collected under this
7 subdivision shall be based on the actual expense incurred by the Auditor's
8 office in making such audit and the affected agency shall be entitled to an
9 itemized statement of such costs. Amounts collected under this subdivision
10 shall be deposited into the general fund as nontax revenue.
- 11 (8) The Auditor shall examine as often as may be deemed necessary the
12 accounts kept by the Treasurer, and if ~~he~~the Auditor discovers any
13 irregularity or deficiency therein, unless the same be rectified or explained to
14 his satisfaction, report the same forthwith in writing to the General
15 Assembly, with copy of such report to the Governor and Attorney General.
16 In addition to regular audits, the Auditor shall check the treasury records at
17 the time a Treasurer assumes office (not to succeed ~~himself~~),himself or
18 herself), and therein charge ~~him~~the Treasurer with the balance in the
19 treasury, and shall check the Treasurer's records at the time ~~he~~the Treasurer
20 leaves office to determine that the accounts are in order.
- 21 (9) The Auditor may examine the accounts and records of any bank or financial
22 institution relating to transactions with the State Treasurer, or with any State
23 agency, or ~~he~~the Auditor may require banks doing business with the State to
24 furnish ~~him~~the Auditor information relating to transactions with the State or

- 26 (10) The Auditor may, as often as ~~he~~the Auditor deems advisable, conduct a
27 detailed review of the bookkeeping and accounting systems in use in the

29 funds. Such examinations will be for the purpose of evaluating the adequacy
30 of systems in use by these agencies and institutions. In instances where the
31 Auditor determines that existing systems are outmoded, inefficient, or
32 otherwise inadequate, ~~he~~the Auditor shall recommend changes to the State
33 Controller. The State Controller shall prescribe and supervise the installation
34 of such changes, as provided in G.S. 143B-426.39(2).
- 35 (11) The Auditor shall, through appropriate tests, satisfy ~~himself~~himself or
36 herself concerning the propriety of the data presented in the Comprehensive
37 Annual Financial Report and shall express the appropriate auditor's opinion
38 in accordance with generally accepted auditing standards.
- 39 (12) The Auditor shall provide a report to the Governor and Attorney General,
40 and other appropriate officials, of such facts as are in ~~his~~the Auditor's
41 possession which pertain to the apparent violation of penal statutes or
42 apparent instances of malfeasance, misfeasance, or nonfeasance by an
43 officer or employee.
- 44 (13) At the conclusion of an audit, the Auditor or ~~his~~the Auditor's designated
45 representative shall discuss the audit with the official whose office is subject
46 to audit and submit necessary underlying facts developed for all findings and
47 recommendations which may be included in the audit report. On audits of
48 economy and efficiency and program results, the auditee's written response
49 shall be included in the final report if received within 30 days from receipt of
50 the draft report.

(14) The Auditor shall notify the General Assembly, the Governor, the Chief Executive Officer of each agency audited, and other persons as the Auditor deems appropriate that an audit report has been published, its subject and title, and the locations, including State libraries, at which the report is available. The Auditor shall then distribute copies of the report only to those who request a report. The copies shall be in written or electronic form, as requested. He shall also file a copy of the audit report in the Auditor's office, which will be a permanent public record; ~~Provided, nothing record.~~ In addition, the Auditor may publish on his or her Web site any reports from audits of State agencies not directly conducted by the Auditor. Nothing in this subsection shall be construed as authorizing or permitting the publication of information whose disclosure is otherwise prohibited by law.

...."

STATE AUDITOR/REPORT EVIDENCE OF CRIMINAL MISCONDUCT

SECTION 25.3.(a) G.S. 147-64.6(c) is amended by adding a new subdivision to read:

"(c) The Auditor shall be responsible for the following acts and activities:

...
 (19) Whenever the Auditor believes that information received or collected by the Auditor may be evidence of a violation of any of the provisions of Chapter 138A of the General Statutes, Chapter 120C of the General Statutes, or Article 14 of Chapter 120 of the General Statutes, the Auditor shall report that information to the State Ethics Commission and the Secretary of State as appropriate. The Auditor shall be bound by interpretations issued by the State Ethics Commission as to whether or not any information reported by the Auditor under this subdivision involves or may involve a violation of Chapter 138A of the General Statutes, Chapter 120C of the General Statutes, or Article 14 of Chapter 120 of the General Statutes. Nothing in this subdivision shall be construed to limit the Auditor's authority under subdivision (1) of this subsection.

19 in the 2015 calendar year to construct or substantially rehabilitate a qualified North Carolina
20 low-income housing development. The criteria shall support the financing of similar types of
21 developments as provided in G.S. 105-129.42, and shall be developed in partnership with
22 developers of low-income housing in the State who receive a federal low-income housing tax
23 credit under section 42 of the Code. The Agency shall take into consideration all eligible
24 sources of funding for each development project, including whether there are other eligible
25 sources of funding available for the development project. No loan made to a taxpayer under this
26 subsection shall exceed one million dollars (\$1,000,000) if the low-income housing
27 development is located in a low-income county, as designated by the Agency; seven hundred
28 fifty thousand dollars (\$750,000) in a moderate-income county, as designated by the Agency;
29 and two hundred fifty thousand dollars (\$250,000) in a high-income county, as designated by
30 the Agency.

11 (a) There is annually appropriated out of the State Highway Fund a sum equal to ten
12 and four-tenths percent (10.4%) of the net amount after refunds that was produced during the
13 fiscal year by the tax imposed under Article 36C of Chapter 105 of the General Statutes and on
14 the equivalent amount of alternative fuel taxed under Article 36D of that Chapter. One-half of
15 the amount appropriated shall be allocated in cash on or before October 1 of each year to the
16 cities and towns of the State in accordance with this section. The second one-half of the amount
17 appropriated shall be allocated in cash on or before January 1 of each year to the cities and
18 towns of the State in accordance with this section. The appropriation from the Highway Fund
19 shall be based on revenue collected during the fiscal year preceding the date the distribution is
20 made.

21 Seventy-five percent (75%) of the funds appropriated for cities and towns shall be
22 distributed among the several eligible municipalities of the State in the percentage proportion
23 that the population of each eligible municipality bears to the total population of all eligible
24 municipalities according to the most recent annual estimates of population as certified to the
25 Secretary of Revenue by the State Budget Officer. This annual estimation of population shall
26 include increases in the population within the municipalities caused by annexations
27 accomplished through July 1 of the calendar year in which these funds are distributed.
28 Twenty-five percent (25%) of said fund shall be distributed among the several eligible
29 municipalities of the State in the percentage proportion that the mileage of public streets in
30 each eligible municipality which does not form a part of the State highway system bears to the
31 total mileage of the public streets in all eligible municipalities which do not constitute a part of
32 the State highway system.

33 It shall be the duty of the mayor of each municipality to report to the Department of
34 Transportation such information as it may request for its guidance in determining the eligibility
35 of each municipality to receive funds under this section and in determining the amount of
36 allocation to which each is entitled. Upon failure of any municipality to make such report
37 within the time prescribed by the Department of Transportation, the Department of
38 Transportation may disregard such defaulting unit in making said allotment.

39 The funds to be allocated under this section shall be paid in cash to the various eligible
40 municipalities on or before October 1 and January 1 of each year as provided in this section.
41 Provided that eligible municipalities are authorized within the discretion of their governing

43 reconstruction, widening, or improving streets of such municipalities at any time after January

45 received by such municipality during the preceding fiscal year, in anticipation of the receipt of
46 funds under this section during the next fiscal year, to be paid for out of such funds when
47 received.

4 a municipality and open to use by the general public, and having an average width of not less

7 receive funds under this section submit to it a statement, certified by a registered engineer or
8 surveyor of the total number of miles of streets in such municipality. The Department of
9 Transportation may in its discretion require the certification of mileage on a biennial basis.

a. Requirements. – To be eligible for remote renewal under this subdivision, a person must meet all of the following requirements:

1. The license holder possesses a valid, unexpired Class C drivers license that was issued when the person was at least 18 years old.

2. The license holder's current license includes no restrictions other than a restriction for corrective lenses.

3. The license holder attests, in a manner designated by the Division, that (i) the license holder is a resident of the State and currently resides at the address on the license to be renewed, (ii) the license holder's name as it appears on the license to be renewed has not changed, and (iii) all other information required by the Division for an in-person renewal under this Article has been provided completely and truthfully.

4. The most recent renewal was an in-person renewal and not a remote renewal under this subdivision.

5. The license holder is otherwise eligible for renewal under this subsection.

b. Waiver of requirements. – When renewing a drivers license pursuant to this subdivision, the Division may waive the examination and photograph that would otherwise be required for the renewal.

c. Duration of remote renewal. – A renewed drivers license issued to a person by remote renewal under this subsection expires on the birthday of the licensee in the fourth year after issuance.

- 1 d. Rules. – The Division shall adopt rules to implement this
2 subdivision.
3 e. Federal law. – Nothing in this subdivision shall be construed to
4 supersede any more restrictive provisions for renewal of drivers
5 licenses prescribed by federal law or regulation."

48 made from the previous year's Program, and the reasons for the changes.

- 49 (4a) To approve a schedule of State highway maintenance projects and their
50 anticipated cost. This schedule is designated the Highway Maintenance
51 Improvement Program and is established in G.S. 136-44.3A. The Board shall

1 publish the schedule on the Department's Web site by April 1 of each year.
2 The document that contains the Highway Maintenance Improvement
3 Program shall include the anticipated funding sources for the improvement
4 projects included in the Highway Maintenance Improvement Program, a list
5 of any changes made from the previous year's Highway Maintenance
6 Improvement Program, and the reasons for the changes.

7 (5) To consider and advise the Secretary of Transportation upon any other
8 transportation matter that the Secretary may refer to it.

10 **SECTION 34.11.(b)** Article 2A of Chapter 136 of the General Statutes is amended
11 by adding a new section to read:

12 **"§ 136-44.3A. Highway Maintenance Improvement Program.**

13 (a) Definitions. – The following definitions apply in this Article:

14 (1) Cape seal treatment. – A chip seal treatment followed by a slurry seal
15 treatment.

16 (2) Chip seal treatment. – A type of pavement preservation treatment applied to
17 existing asphalt pavement. The treatment involves spraying an asphalt
18 emulsion onto the roadway, applying a layer of aggregate chips, and rolling
19 the chips into the emulsion. This term includes single, double, and triple chip
20 seal treatments.

21 (3) Highway Maintenance Improvement Program. – The schedule of State
22 highway maintenance projects required under G.S. 143B-350(f)(4a).

23 (4) Highway Maintenance Improvement Program Needs Assessment. – A report
24 of the amount of funds needed, the number of affected lane miles, and the
25 percentage of the primary and secondary system roads that are rated to need
26 a resurfacing or pavement preservation treatment within the Highway
27 Maintenance Improvement Program's three-year time period but are not
28 programmed due to funding constraints.

29 (5) Microsurfacing treatment. – A type of pavement preservation treatment that
30 involves mixing fine aggregate, asphalt emulsion, minerals, water, and a
31 polymer additive and applying the mixture to the roadway.

32 (6) Pavement preservation treatment. – Include full width surface treatments
33 used to extend or renew the pavement life prior to resurfacing.

34 (7) Rehabilitation. – A contract resurfacing maintenance program that involves
35 applying multiple layers of pavement that exceed two inches.

36 (8) Resurfacing. – A contract resurfacing program that involves applying one
37 layer that does not exceed two inches of pavement.

38 (9) Slurry seal treatment. – A type of pavement preservation treatment that
39 involves mixing fine aggregate, asphalt emulsion, minerals, and water and
40 applying the mixture to the roadway.

41 (b) Road Quality Improvement of Pavement Preservation Treatments. – It is the intent
42 of the General Assembly that (i) the Department use asphalt pavement preservation treatments
43 that are high quality, long lasting, and provide a smooth road surface and (ii) the Department
44 increase its contractual use of slurry seals on secondary system roads and microsurfacing
45 treatments on primary system roads for pavement preservation treatments. Except as otherwise
46 provided in this section, the Department shall only use slurry seal treatment, microsurfacing
47 treatment, triple chip seal treatment, or cape seal treatment for asphalt pavement preservation
48 treatments.

49 (c) Highway Maintenance Improvement Program. – After the annual inspection of
50 roads within the State highway system, each highway division shall determine and report to the
51 Chief Engineer on the need for rehabilitation, resurfacing, or pavement preservation treatments.

1 The Chief Engineer shall establish a three-year priority list for each highway division based on
2 the Chief Engineer's estimate of need. In addition, the Chief Engineer shall establish a
3 three-year improvement schedule, sorted by county, for rehabilitation, resurfacing, and
4 pavement preservation treatment activities. The schedule shall be based on the amount of funds
5 appropriated to the contract resurfacing program and the pavement preservation program in the
6 fiscal year preceding the issuance of the Highway Maintenance Improvement Program for all
7 three years of the Highway Maintenance Improvement Program. State funding for projects
8 included in the Highway Maintenance Improvement Program shall be limited to funds
9 appropriated from the State Highway Fund.

10 (d) Contract Maintenance Resurfacing Program Letting Schedule. – Beginning in the
11 2015-2016 fiscal year, and based on the amount of funds appropriated in the prior fiscal year by
12 the General Assembly to the Department for the contract maintenance resurfacing program, the

15 (e) Single Chip Seal Treatment Prohibited on Certain Roads, Streets, and Access
16 Routes. – Except as authorized in subsection (f) of this section, and unless used in combination
17 with a slurry seal treatment or microsurfacing treatment, the Department shall not use chip seal
18 treatment on primary roads, subdivision streets, or access routes for Surface Transportation
19 Assistance Act Dimensioned Vehicles.

20 (f) Authorized Use of Single Chip Seal Treatment on Secondary Roads. – The
21 Department may use single chip seal treatments on secondary roads only under any of the
22 following conditions:

23 (1) The secondary road has a daily traffic volume of less than 100 vehicles.

24 (2) The chip seal treatment is used in combination with a slurry seal treatment or
25 microsurfacing treatment.

26 (3) The condition of the secondary road requires a rough surface to improve
27 traction, such as a secondary road in a mountainous community or another
28 area with low skid resistance.

29 (g) Report – The Department shall submit the Highway Maintenance Improvement
30 Program and Highway Maintenance Improvement Program Needs Assessment to the General
31 Assembly by April 1 each year. If the General Assembly is in session, the Department shall
32 report to the House of Representatives Appropriations Subcommittee on Transportation, the
33 Senate Appropriations Committee on the Department of Transportation, and the Fiscal
34 Research Division. If the General Assembly is not in session, the Department shall report to the
35 Joint Legislative Transportation Oversight Committee and the Fiscal Research Division."

2 system based on traffic data, and a ranking of the most congested areas
3 based on travel time reliability and the average number of congested hours,
4 together with the Department's recommendations for congestion reduction
5 and mobility improvement.

6 ~~On the basis of the report and from funds available, the Department of Transportation shall~~
7 ~~develop a statewide annual maintenance program for the State highway system, which shall be~~
8 ~~subject to the approval of the Board of Transportation and is consistent with performance~~
9 ~~standards.~~

10"

11 **SECTION 34.11.(d)** G.S. 136-44.16 reads as rewritten:

12 **"§ 136-44.16. Authorized use of contract maintenance resurfacing program funds.**

13 (a) Of the contract maintenance resurfacing program funds appropriated by the General
14 Assembly to the Department of Transportation, an amount not to exceed fifteen percent (15%)
15 of the Board of Transportation's allocation of these funds may be used for widening existing
16 narrow pavements.

17 (b) The use of slurry seal and microsurfacing treatments for pavement preservation
18 treatments are authorized uses of contract maintenance resurfacing program funds."

19 **SECTION 34.11.(e)** 2014-2015 Contract Maintenance Resurfacing Program
20 Letting Schedule. – Beginning in the 2014-2015 fiscal year, and based on the amount of funds
21 appropriated in the prior fiscal year by the General Assembly to the Department for the contract
22 maintenance resurfacing program, the Department shall let contracts that total at least sixty
23 percent (60%) of contract resurfacing program funds included in its certified budget by
24 September 1, 2014. The Department shall let contracts that total a minimum of seventy percent
25 (70%) of the current fiscal year's contract maintenance resurfacing program funds by October
26 1, 2014.

27 **SECTION 34.11.(f)** Article 2A of Chapter 136 of the General Statutes is amended
28 by adding a new section to read:

29 **"§ 136-44.17. Pavement preservation program.**

30 (a) Program Established. – The Department of Transportation shall establish the
31 pavement preservation program.

32 (b) Eligible Activities or Treatments. – Applications eligible for funding under the

- 35 (1) Chip seals, slurry seals, and cape seals.

44 (10) Partial-depth or full-depth repairs and reclamations.
45 (11) Ultra-thin whitetopping.
46 (12) Thin lift and sand asphalt overlays.

47 (c) Ineligible Activities or Treatments. – The pavement preservation program shall not
48 include the following preservation activities or treatments:

- 49 (1) Contract resurfacing activities or major pavement rehabilitation treatments
50 and pretreatments that are used in combination with a resurfacing treatment,
51 such as profile milling or chip seals.

- 1 (2) Routine maintenance activities used to maintain and preserve the condition
2 of roads. Treatments include, but are not limited to, asphalt crack sealing,
3 pothole patching, rut filling, cleaning of roadside ditches and structures,
4 shoulder maintenance, and retracing of pavement markings.
5 (3) Maintenance and preservation activities performed on bridges or culverts.
6 (4) Activities related to positive guidance or signal maintenance program
7 functions."

8 **SECTION 34.11.(g)** Establishment of Account. – The Department of
9 Transportation shall establish a new account within its maintenance account to receive funds
10 allocated under this section for pavement preservation. Except for slurry seal and
11 microsurfacing treatments, the Department shall only use funds from this account to pay for
12 eligible pavement preservation activities and treatments listed in G.S. 136-44.17(b), as enacted
13 by subsection (f) of this section.

14 **SECTION 34.11.(h)** 2014-2015 Outsourcing Target. – Of funds allocated in this
15 act for pavement preservation, no more than eighty-five percent (85%) may be used for projects
16 undertaken by the Department, with the remaining funds used for projects outsourced to private
17 contractors.

18 **SECTION 34.11.(i)** Future Outsourcing Targets. – The Department shall increase
19 its use of outsourcing of pavement preservation activities to reach the following targets for
20 outsourcing of pavement preservation projects:

- 21 (1) Thirty percent (30%) of pavement preservation program funds allocated by
22 the 2015-2016 fiscal year.

50 **SECTION 34.13.(a)** The Department of Transportation shall seek to increase the
51 use of contracts to further privatize preconstruction work where practical, economical, and

likely to lead to increased efficiency. In doing so, the Department of Transportation shall meet each of the following privatization requirements:

- (1) Increase the outsourcing of all activities performed by the Department's Preconstruction and Technical Services units to seventy percent (70%) of the total cost of activities performed by those units in fiscal year 2014-2015, excluding the cost of activities performed by the Turnpike Authority, the Structures Design and Management unit, and the Bridge Program.
- (2) Increase the outsourcing of all activities performed by the Department's Roadway Design unit to sixty percent (60%) of the total cost of activities performed by that unit in fiscal year 2014-2015.
- (3) Increase the outsourcing of all activities performed by the Department's Project Development and Environmental Analysis unit to sixty-five percent (65%) of the total cost of activities performed by that unit in fiscal year 2014-2015.
- (4) The Department's Right-of-Way unit shall increase the total expenditures for outsourced activity by five percent (5%) in fiscal year 2014-2015.

SECTION 34.13.(b) The Department may credit any reduction in expenditures due to a reduction in force towards meeting the requirements imposed by subsection (a) of this section.

SECTION 34.13.(c) The Department shall increase contracts for construction of transportation projects on a design-build basis awarded under the provisions of G.S. 136-28.11.

SECTION 34.13.(d) The Department shall report no later than October 1, 2014, and quarterly thereafter, to the Joint Legislative Transportation Oversight Committee and the Fiscal Research Division regarding its implementation of this section, including any reductions in force used to meet privatization requirements.

DOT SIGNAGE

SECTION 34.14.(a) G.S. 136-89.56 reads as rewritten:

"§ 136-89.56. Commercial enterprises.

No commercial enterprises or activities shall be authorized or conducted by the Department of Transportation, or the governing body of any city or town, within or on the property acquired for or designated as a controlled-access facility, as defined in this Article, except for:

- (1) Materials displayed at welcome centers which shall be directly related to travel, accommodations, tourist-related activities, tourist-related services, and attractions. The Department of Transportation shall issue rules regulating the display of these materials. These materials may contain advertisements for real estate; and
- (2) Vending machines permitted by the Department of Transportation and placed by the Division of Services for the Blind, Department of Health and Human Services, as the State licensing agency designated pursuant to Section 2(a)(5) of the Randolph-Sheppard Act (20 USC 107a(a)(5)). The Department of Transportation shall regulate the placing of the vending machines in highway rest areas and shall regulate the articles to be dispensed. In order to permit the establishment of adequate fuel and other service facilities by private owners or their lessees for the users of a controlled-access facility, the Department of Transportation shall permit access to service or frontage roads within the publicly owned right-of-way of any controlled-access facility established or designated as provided in this Article, at points which, in the opinion of the Department of Transportation, will best serve the public interest. The location of such fuel and other service facilities may be indicated to the users of the controlled-access facilities by

1 appropriate signs, the size, style, and specifications of which shall be
2 determined by the Department of Transportation.

3 The location of fuel, gas, food, lodging, camping, and attraction facilities may be indicated
4 to the users of the controlled-access facilities by appropriate logos placed on signs owned,
5 controlled, and erected by the Department of Transportation. The owners, operators or lessees
6 of fuel, gas, food, lodging, camping, and attraction facilities who wish to place a logo
7 identifying their business or service on a sign shall furnish a logo meeting the size, style and
8 specifications determined by the Department of Transportation and shall pay the Department
9 ~~for the costs of initial installation and subsequent maintenance. The fees for logo sign~~
10 ~~installation and maintenance shall be set by the Board of Transportation based on cost.~~ a fee set
11 by the Board of Transportation. The Board shall set the fee to cover the initial costs of signs,
12 sign installation, and maintenance, and the costs of administering the program."

13 **SECTION 34.14.(b)** G.S. 136-140.19 reads as rewritten:

14 "**§ 136-140.19. Department Board of Transportation to adopt rules to implement the**
15 **TODS program.**

16 The ~~Department~~ Board of Transportation shall adopt rules to implement the TODS program
17 created by this Article. The rules shall include all of the following:

27 **SECTION 34.14.(c)** G.S. 106-22.5(a) reads as rewritten:

28 "**§ 106-22.5. Agricultural tourism signs.**

29 (a) The Department of Agriculture and Consumer Services shall work with the
30 Department of Transportation to provide directional signs on major highways at or in
31 reasonable proximity to the nearest interchange or within one mile leading to an agricultural
32 facility that promotes tourism by providing tours and on-site sales or samples of North Carolina
33 agricultural products to area tourists. The Department shall follow the sign location and
34 placement rules for the Department of Transportation's Tourist-Oriented Directional Signs as
35 authorized by G.S. 136-140.19."

37 STATE PARKS AND TRAILS SIGNAGE

38 **SECTION 34.15.(a)** The Department of Transportation, in conjunction with the
39 State Parks and Recreation Division of the Department of Environment and Natural Resources,
40 the Department of Commerce, and Friends of the Mountains-to-Sea Trail, Inc., a nonprofit
41 corporation, shall study the use of highway signage as a means of improving the North Carolina
42 residents' and tourists' awareness of State parks, including historic and cultural sites as well as
43 the Mountains-to-Sea Trail. The study shall include the creation of an action plan and five-
44 month implementation time line, which shall include measures to address all of the following:

- 45 (1) Whether signs currently located on or near highways in this State are
46 sufficient in number, location, and size and presentation to make travelers on
47 the highways of this State aware of the existence and location of all State
48 parks, including historic and cultural sites as well as the Mountains-to-Sea
49 Trail.

1 (2) Whether signs currently located on or near highways in this State adequately
2 inform travelers that portions of the roads they travel on are part of the
3 current route of the Mountains-to-Sea Trail.

4 (3) What measures could be taken to improve the efficacy of highway signage in
5 achieving the goals described in subdivisions (1) and (2) of this subsection.

6 (4) What the costs and benefits of implementing the measures described in
7 subdivision (3) of this subsection would be.

8 **SECTION 34.15.(b)** No later than December 1, 2014, the Department of
9 Transportation shall report the results of the study required by this section, including the action
10 plan and implementation time line, to the chairs of the Joint Legislative Transportation
11 Oversight Committee and to the Fiscal Research Division. The action plan shall be
12 implemented by April 1, 2015.

13 14 **DOT STAFFING**

15 **SECTION 34.16.(a)** The Department of Transportation shall review the
16 organization and staffing of the Division of Highways and the Division of Preconstruction and
17 identify areas of unnecessary duplication within management structures and variations in the
18 number of employees reporting to persons identified as supervisors. Based on its review, the
19 Department shall create and implement a plan for staffing changes and staffing efficiencies.
20 The plan should reduce layers of management to the level needed for carrying out the
21 Department's functions and responsibilities and ensure that employees designated as
22 supervisors have workloads and staff size that are appropriate given the function or task for
23 which that supervisor has responsibility.

24 **SECTION 34.16.(b)** The Department shall report its progress on implementing this
25 section to the Joint Legislative Transportation Oversight Committee and the Fiscal Research
26 Division no later than December 1, 2014.

27 28 **BOARD OF TRANSPORTATION TO STUDY FEES, SPONSORSHIP, AND** 29 **PRIVATIZATION**

30 **SECTION 34.17.(a)** The Board of Transportation shall study how fees,
31 sponsorship, or privatization might be used to reduce the use of public funds for services
32 provided by the Department. The services the Board shall study include, but are not limited to,
33 the following:

34 (1) Inspection of streets and bridges within a private development for future
35 addition to the State highway system.

36 (2) Inspection, site review, and permitting of the installation of driveways by
37 private parties providing access to a component of the State highway system.

38 (3) Review and inspection of encroachments onto the State highway system.

39 (4) Lease or sale of property related to the resolution of encroachments or the
40 disposition of surplus right-of-way.

41 (5) Review of or consultation on development plats or plans.

42 (6) Review, engineering, or consultation regarding drainage issues,
43 improvements, or maintenance adjacent to components of the State highway
44 system.

45 (8) Training sessions or workshops offered to private consultants and
46 contractors.

47 (9) Review and engineering consultation regarding traffic plans.

48 **SECTION 34.17.(b)** The Board shall also study the existing fee structure for
49 services performed by Highway Division personnel and identify any fees that no longer cover
50 the direct and indirect costs incurred by the Department to perform the service.

1 **SECTION 34.17.(c)** The Department of Transportation shall report on the Board's
2 study and recommendations for fee adjustments or additions to the Joint Legislative
3 Transportation Oversight Committee and the Fiscal Research Division no later than December
4 1, 2014. This report shall also include recommendations from the Board on the use of
5 sponsorships for activities, programs, or functions currently performed by the Department or
6 the privatization of these functions, and include the following information:

- 7 (1) The current cost of activities proposed for sponsorship support or
8 privatization.
- 9 (2) The potential receipts that could reasonably be collected through
10 sponsorships or the cost-savings achieved through privatization.
- 11 (3) A proposed process for the screening and selection of sponsors.
- 12 (4) Mock-ups of potential sponsorship signage on materials, buildings, vehicles,
13 vessels, or other locations.
- 14 (5) Any administrative, statutory, or regulatory changes needed for the
15 Department to proceed with sponsorship or privatization programs.

16 17 **RENAME SYSTEM PRESERVATION PROGRAM**

18 **SECTION 34.18.** The Department of Transportation shall rename the "system
19 preservation program" (fund center 1500/157839) the "bridge program." Funds allocated to this
20 program shall be used for improvements to culverts associated with a component of the State
21 highway system or for structurally deficient and functionally obsolete bridges. All projects
22 funded under this program, with the exception of inspection, pre-engineering, contract
23 preparation, contract administration and oversight, and planning activities, shall be outsourced
24 to private contractors.

25 26 **HIGHWAY FUND CREDIT RESERVE**

27 **SECTION 34.19.(a)** G.S. 136-44.2 is amended by adding a new subsection to read:
28 "**§ 136-44.2. Budget and appropriations.**

29 ...
30 (f1) The credit reserve for the Highway Fund consists of the following:

- 31 (1) The unreserved credit balance in the Highway Fund on the last day of the
32 fiscal year to the extent the balances exceed the amount estimated for that
33 date in the Current Operations Appropriations Act for the following fiscal
34 year.
- 35 (2) The unallotted and unencumbered balances on the last day of the fiscal year
36 for the following:
 - 37 a. Funds appropriated from the Highway Fund for the multimodal
38 programs of the Department, consisting of funds for bicycle and
39 pedestrian, railroad, aviation, and public transportation programs,
40 excluding funds deposited in the Freight Rail & Rail Crossing Safety
41 Improvement Fund.
 - 42 b. Funds appropriated from the Highway Fund for the construction
43 programs of the Department, consisting of funds for secondary
44 construction, access and public service roads, spot safety
45 improvement, contingency, small urban construction, and economic
46 development programs.
- 47 (3) The unencumbered and unexpended balances on the last day of the fiscal
48 year for the following:
 - 49 a. Central and program administration.
 - 50 b. Transfers to other State agencies or departments not used or returned.

(4) The remaining balance for (i) any open project that has been inactive for two or more years after construction of the project has been completed or (ii) any project that is not obligated during the first two fiscal years in which funds are appropriated."

SECTION 34.19.(b) The sum of twelve million dollars (\$12,000,000) of the unallotted and unexpended balance of funds within the Bicycle program (fund center 1500/0036), Ferry Operations (fund center 1500/7825), Railroad program (fund center 1500/7829), Airports program (fund center 1500/7830), and the Public Transportation program (fund center 1500/7831), excluding funds deposited in the Freight Rail & Rail Crossing Safety Improvement Fund, shall be transferred to the Highway Fund as appropriated and allocated by this act.

SALE OF CERTAIN FORMER NC RAILROAD PROPERTIES

SECTION 34.20.(a) Subject to the right of first refusal in subsection (b) of this section, the Department of Administration shall dispose of the following parcels following the procedures set out in Chapter 146 of the General Statutes:

SECTION 34.20.(b) Before the Department disposes of any property described in subsection (a) of this section, the city of Morehead City, Carteret County, or the city and county jointly, shall be given the right of first refusal to purchase, lease, or rent any or all of the parcels. The right of first refusal shall expire on June 30, 2015.

SECTION 34.20.(c) Following expiration of the right of first refusal period set forth in subsection (b) of this section, or upon written notice from the city of Morehead City and Carteret County waiving the right of first refusal, the Department shall dispose of the properties in any manner authorized by Chapter 146 of the General Statutes other than by gift.

SECTION 34.20.(d) Notwithstanding G.S. 146-30, the Department shall deposit the net proceeds from the disposition of the properties into the Freight Rail & Rail Crossing Safety Improvement Fund of the Highway Fund.

MAINTENANCE CONDITION ASSESSMENT PROGRAM CHANGES

SECTION 34.21. G.S. 136-44.3 reads as rewritten:

"§ 136-44.3. Maintenance program.

The Department shall establish performance standards for the maintenance and operation of the State highway system. In each even-numbered year, the Department of Transportation shall survey the condition of the State highway system and shall prepare a report of the findings of the survey. The report shall provide both quantitative and qualitative descriptions of the condition of the system and shall provide estimates of the following:

- (1) The annual cost to meet and sustain the established performance standards for the ~~primary and secondary~~ State highway system, delineated by costs to the primary or secondary system, to include: (i) routine maintenance and operations, (ii) system preservation, and (iii) pavement and bridge rehabilitation, include the following categories of work: (i) contract resurfacing, (ii) pavement preservation, (iii) routine highway maintenance, (iv) disasters and emergencies, (v) structurally sound bridge maintenance, and (vi) structurally unsound bridge rehabilitation, repair, or replacement.
- (2) Projected system condition and corresponding optimal funding requirements for a seven-year plan to sustain established performance standards. The

1 report shall also identify target levels of service for each maintenance
2 activity and assess historical program performance across divisions,
3 including project delivery rates, staffing, and direct and indirect costs. The
4 Department shall clearly denote prioritized maintenance needs and
5 recommended resource allocations and distribution methods to achieve each
6 target.

7 (3) Any significant variations in system conditions among highway divisions.
8 The report should include an examination of how well the highway divisions
9 streamline project delivery, maximize efficiency, and prioritize spending
10 based on needs and make recommendations on ways to improve these
11 processes. The report should analyze the cost of delivering maintenance
12 activities by division and make recommendations on how to reduce these
13 costs regionally and statewide.

14 (4) An assessment of the level of congestion throughout the primary highway
15 system based on traffic data, and a ranking of the most congested areas
16 based on travel time reliability and the average number of congested hours,
17 together with the Department's recommendations for congestion reduction
18 and mobility improvement.

19 (5) An analysis of existing highway division staffing levels and
20 recommendations to ensure staffing levels are distributed appropriately
21 based on need.

22 (6) A cross-divisional comparison summary document, not to exceed one page
23 in length, which includes the divisional performance data described in
24 subdivision (2) of this section as well as the most deficient roads and bridges
25 in each division.

26 On the basis of the report and from funds available, the Department of Transportation shall
27 develop a statewide annual maintenance program for the State highway system, which shall be
28 subject to the approval of the Board of Transportation and is consistent with performance
29 standards.

30 The report on the condition of the State highway system and maintenance funding needs
31 shall be presented to the Joint Legislative Transportation Oversight Committee by December
32 31 of each even-numbered year, and copies shall be made available to any member of the
33 General Assembly upon request."

35 **DIVISION OF MOTOR VEHICLES POSITION FUNDING**

36 **SECTION 34.22.** Notwithstanding any other provision of law, the Department of
37 Transportation may use funds appropriated for the 2014-2015 fiscal year from the Highway
38 Trust Fund to continue funding positions within the Division of Motor Vehicles that were
39 funded by the Highway Trust Fund during the 2013-2014 fiscal year.

41 **DOT CASH MANAGEMENT**

42 **SECTION 34.23.(a)** G.S. 143C-6-11 reads as rewritten:

43 **"§ 143C-6-11. Highway appropriation.**

8 (k) The Department of Transportation shall do all of the following:

- 9 (1) Utilize cash flow financing to the extent possible to fund transportation
10 projects with the goal of reducing the combined average daily cash balance
11 of the Highway Fund and the Highway Trust Fund to an amount equal to ~~the~~
12 ~~twelve percent (12%) of the combined estimate of the yearly receipts of the~~
13 ~~Funds.~~ between fifteen and twenty percent (15-20%) of the total
14 appropriations for the current fiscal year from those funds. In projecting cash
15 balances in future years, the Department shall use the estimated cash flow as
16 specified in the Current Operations Appropriation Act. Any federal funds on
17 hand shall not be considered as cash for the purposes of this subsection. The
18 target amount shall include an amount necessary to make all municipal-aid
19 funding requirements of the Department.
20 (2) Establish necessary management controls to facilitate use of cash flow
21 financing, such as establishment of a financial planning committee,
22 development of a monthly financing report, establishment of appropriate
23 fund cash level targets, review of revenue forecasting procedures, and
24 reduction of accrued unbilled costs.
25 (3) Report annually, on October 1 of each year, to the Joint Legislative
26 Transportation Oversight Committee on its cash management policies and
27 results."

28 **SECTION 34.23.(b)** The Board of Transportation shall study the Department's
29 cash management policies and identify ways to strengthen these policies in order to prevent
30 excessive cash balances. The Department shall report to the House of Representatives
31 Appropriations Subcommittee on Transportation, the Senate Appropriations Committee on
32 Department of Transportation, and the Fiscal Research Division by April 1, 2015, on the
33 findings from this study and any resulting policy changes made based on the findings of the
34 study.

35 **SECTION 34.23.(c)** In any month in which the Department's total cash balance on
36 hand from the Highway Fund and the Highway Trust Fund exceeds one billion dollars

47 The report shall include an explanation from the Department of the reasons the cash

30 ~~in the toll setting methodology by the Board of Transportation.~~

31 (d) ~~Use of Toll Proceeds.~~—~~The Department of Transportation shall credit the proceeds~~
32 ~~from tolls collected on North Carolina Ferry System routes and receipts generated under~~
33 ~~subsection (e) of this section to reserve accounts within the Highway Fund for each of the~~
34 ~~Highway Divisions in which system terminals are located and fares are earned. For the~~
35 ~~purposes of this subsection, fares are earned based on the terminals from which a passenger trip~~
36 ~~originates and terminates. Commuter pass receipts shall be credited proportionately to each~~

38 ~~Division. The proceeds credited to each reserve account shall be used exclusively for~~

44 (f) Authority to Generate Certain Receipts. – The Department of Transportation,
45 notwithstanding any other provision of law, may operate or contract for the following
46 receipt-generating activities and use the proceeds for ferry passenger vessel replacement
47 ~~projects in the manner set forth in subsection (e) of this section:~~and other ferry system capital
48 needs:

- 49 (1) Operation of, concessions on the ferries and at ferry facilities to provide to
50 passengers on the ferries food, drink, and other refreshments, personal
51 comfort items, Internet access, and souvenirs publicizing the ferry system.

- 1 (2) ~~The Sponsorships, including, but not limited to, the sale of naming rights to~~
2 any ferry vessel, ferry route, or ferry facility.
- 3 (3) Advertising on or within any ferry vessel, ~~vessel or at any ferry facility,~~
4 ~~including~~ including, but not limited to, display advertising and advertising
5 delivered to passengers through the use of video monitors, public address
6 systems installed in passenger areas, and other electronic media.
- 7 (4) Any other receipt-generating activity not otherwise forbidden by applicable
8 law pertaining to public health or safety.

9 The Department may issue rules to implement this subsection.

10 (f1) Ferry Capital Improvement Account. – The following shall be credited to a reserve
11 account in the Highway Fund which shall be designated as the Ferry Capital Improvement
12 Account:

- 13 (1) Net receipts generated under subsection (f) of this section.
- 14 (2) The unallotted and unencumbered balances on the last day of the fiscal year
15 of funds appropriated from the Highway Fund to the Ferry Division.
- 16 (3) Any other funds available from appropriations by the General Assembly or
17 from contributions and grants from public or private sources.

18 Funds credited to the account shall be used for prioritized improvements to the vessels and
19 facilities of the North Carolina Ferry System.

20 (g) Confidentiality of Personal Information. – Identifying information obtained by the
21 Department related to operation of the ferry system is not a public record under Chapter 132 of
22 the General Statutes and is subject to the disclosure limitations in 18 U.S.C. § 2721 of the
23 federal Driver's Privacy Protection Act. The Department shall maintain the confidentiality of all
24 information required to be kept confidential under 18 U.S.C. § 2721(a), as well as any financial
25 information, transaction history, and information related to the collection of a ~~toll or~~ user fee

17 vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted,"
18 unless the plate is a special registration plate authorized in G.S. 20-79.4.

19 A registration plate issued by the Division for a private passenger vehicle or for a private
20 hauler vehicle licensed for 6,000 pounds or less shall ~~be~~ be, at the option of the owner, either (i)
21 a "First in Flight" ~~plate; plate or~~ (ii) a "First in Freedom" plate. A "First in Flight" plate shall
22 have the words "First in Flight" printed at the top of the plate above all other letters and
23 numerals. The background of the "First in Flight" plate shall depict the Wright Brothers biplane
24 flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. A "First
25 in Freedom" plate shall have the words "First in Freedom" printed at the top of the plate above
26 all other letters and numerals. The background of the "First in Freedom" plate may include an
27 image chosen by the Division that is representative of the Mecklenburg Declaration of 1775 or
28 the Halifax Resolves of 1776.

29 (b1) The following special registration plates do not have to be a "First in Flight" plate or
30 "First in Freedom" plate as provided in subsection (b) of this section. The design of the plates
31 that are not "First in Flight" plates or "First in Freedom" plates must be developed in
32 accordance with G.S. 20-79.4(a3). For special plates authorized in G.S. 20-79.7 on or after July
33 1, 2013, the Division may not issue the plate on a background under this subsection unless it
34 receives at least 200 applications for the plate in addition to the applications required under
35 G.S. 20-79.4 or G.S. 20-81.12.

37 **SECTION 34.28.(b)** G.S. 20-79(c) reads as rewritten:

If the amount of revenue in the Noncommercial Fund at the end of a month is less than this threshold amount, all of the remainder of the proceeds shall be credited to the Noncommercial Fund."

DRIVERS LICENSE TECHNICAL STANDARDS

"(n) Format. – A drivers license issued by the Division must be tamperproof and must contain all of the following information:

- (5) A physical description of the license holder, including sex, height, eye color, and hair color.
- (6) The license holder's date of birth.
- (7) An identifying number for the license holder assigned by the Division. The identifying number may not be the license holder's social security number.
- (8) Each class of motor vehicle the license holder is authorized to drive and any endorsements or restrictions that apply.
- (9) The license holder's signature.
- (10) The date the license was issued and the date the license expires.

The Commissioner shall ensure that applicants 21 years old or older are issued drivers licenses and special identification cards that are printed in a horizontal format. The Commissioner shall ensure that applicants under the age of 21 are issued drivers licenses and special identification cards that are printed in a vertical format, that distinguishes them from the horizontal format, for ease of identification of individuals under age 21 by members of industries that regulate controlled products that are sale restricted by age and law enforcement officers enforcing these laws.

At the request of an applicant for a drivers license, a license issued to the applicant must contain the applicant's race."

- (3) For employees of the judicial branch, for local supplementation as authorized by G.S. 7A-300.1.

The cumulative salary adjustment allowed under this subsection ~~for each fiscal year~~ during the ~~2013-2015 fiscal biennium~~ 2013-2014 fiscal year may exceed ten percent (10%) of annual salary only if the adjustment is approved in advance by the Office of State Budget and Management, The University of North Carolina Board of Governors, the Board of the North Carolina Community College System, the Legislative Services Commission, the local board of education, or other authorized body as appropriate.

USE OF FUNDS APPROPRIATED FOR LEGISLATIVELY MANDATED SALARY INCREASES

8 Safety, and the Chairs of the Senate Appropriations Committee on Justice and Public Safety.

9 fund a monthly benefit in an amount of one hundred seventy dollars (\$170.00) per month

11 are subject to the approval of the board who may appoint physicians to examine and evaluate
12 the disabled member prior to approval of the application, and annually thereafter. Any disabled

19 total of 240 months. The member shall upon attaining the age of 55 years be entitled to receive
20 a pension as provided by this section. All applications for disability are subject to the approval
21 of the board who may appoint physicians to examine and evaluate the disabled member prior to
22 approval of the application and annually thereafter.

23 (e) A member who, because the member's residence is annexed by a city under Part 2 or
24 Part 3 of Article 4A of Chapter 160A of the General Statutes, or whose department is closed
25 because of an annexation by a city under Part 2 or Part 3 of Article 4A of Chapter 160A of the
26 General Statutes, or whose volunteer department is taken over by a city or county, and because
27 of such annexation or takeover is unable to perform as a firefighter or rescue squad worker of
28 any status, and if the member has at least 10 years of service with the pension fund, may be
29 permitted to continue making a monthly contribution of ten dollars (\$10.00) to the fund until
30 the member has made contributions for a total of 240 months. The member upon attaining the
31 age of 55 years and completion of such contributions shall be entitled to receive a pension as
32 provided by this section. Any application to make monthly contributions under this section
33 shall be subject to a finding of eligibility by the Board of Trustees upon application of the
34 member.

35 (f) The pensions provided shall be in addition to all other pensions or benefits under
36 any other statutes of the State of North Carolina or the United States, notwithstanding any
37 exclusionary provisions of other pensions or retirement systems provided by law."

44 of individuals facing the same type of peril to areas of relative safety. The unit or squad must
45 comply with existing State statutes and with eligibility criteria established by the North
46 Carolina Association of Rescue and Emergency Medical Services, Inc.

47 (d) For the purposes of this section, "emergency medical services" or "EMS" has the
48 same meaning as in G.S. 131E-155(6). Unless otherwise more narrowly specified, an "EMS
49 unit" means either (i) an EMS provider licensed under G.S 131E-155.1 or (ii) a volunteer fire or
50 fire/rescue department that is part of its county's EMS system plan. The unit or squad must

fifty percent (50%) of the nonfederal portion of funds for the project. This subsection applies to

that are unencumbered and proposed for reallocation to provide the nonfederal portion of funds

31 **APPROPRIATIONS**

32 **SECTION 36.10.(a)** Of the funds appropriated in Section 36.2 of S.L. 2013-360,
33 as amended by Section 36.1 of this act, to the Office of State Budget and Management, the sum
34 of three million dollars (\$3,000,000) in nonrecurring funds for the 2014-2015 fiscal year shall
35 be allocated to the Office of State Budget and Management and transferred to the Department
36 of Cultural Resources in order to establish a Capital Improvement Project for the North
37 Carolina Battleship in accordance with this section. It is the intent of the General Assembly that
38 the North Carolina Battleship Commission raise at least five million dollars (\$5,000,000) in
39 non-State funds for the 2014-2015 fiscal year. The North Carolina Battleship Commission shall
40 not use funds transferred from the organization's endowment to its operating budget to achieve
41 the fund-raising targets set out in subsection (b) of this section.

42 **SECTION 36.10.(b)** For the 2014-2015 fiscal year, the Department of Cultural
43 Resources shall establish a Capital Improvement Project to construct a cofferdam for the North
44 Carolina Battleship that will enable completion of major hull repairs. Funds shall be transferred
45 to the Department of Cultural Resources from the Office of State Budget and Management as
46 follows:

- 47 (1) Upon raising the initial sum of three million dollars (\$3,000,000) in
48 non-State funding, the sum of one million dollars (\$1,000,000) shall be
49 transferred.
- 50 (2) Upon raising an additional sum of one million dollars (\$1,000,000) in

6 sum of three million dollars (\$3,000,000) shall be transferred to the Capital
7 Improvement Project for the North Carolina Battleship in the 2014-2015
8 fiscal year.

10 **TWO-THIRDS BONDS ACT OF 2014**

11 **SECTION 36.12.(a)** Short Title. – This section may be cited as the "Two-Thirds
12 Bonds Act of 2014."

13 **SECTION 36.12.(b)** Findings and Determinations. – It is the intent and purpose of
14 the General Assembly by this section to provide for the issuance of general obligation bonds or
15 notes of the State in order to provide funds for the cost of State capital facilities.

16 **SECTION 36.12.(c)** Definitions. – The following definitions apply in this section
17 unless the context otherwise requires:

- 18 (1) Bonds. – Bonds issued under this section.
- 19 (2) Cost. – The term includes all of the following:
- 20 a. The cost of constructing, reconstructing, renovating, repairing,
21 enlarging, acquiring, and improving State capital facilities, including
22 the acquisition of land, rights-of-way, easements, franchises,
23 equipment, machinery, furnishings, and other interests in real or
24 personal property acquired or used in connection with a State capital
25 facility.
- 26 b. The cost of engineering, architectural, and other consulting services
27 as may be required.
- 28 c. Administrative expenses and charges.
- 29 d. The cost of providing personnel to ensure effective project
30 management.
- 31 e. The cost of bond insurance, investment contracts, credit enhancement
32 and liquidity facilities, interest-rate swap agreements or other
33 derivative products, financial and legal consultants, and related costs
34 of bond and note issuance, to the extent and as determined by the
35 State Treasurer.
- 36 f. Finance charges, reserves for debt service, and other types of
37 reserves required pursuant to the terms of any bond or note or related
38 documents, interest before and during construction or acquisition of a
39 State capital facility and, if considered advisable by the State
40 Treasurer, for a period not exceeding two years after the estimated
41 date of completion of construction or acquisition.
- 42 g. The cost of bond insurance, investment contracts, credit enhancement
43 facilities and liquidity facilities, interest-rate swap agreements or
44 other derivative products, financial and legal consultants, and related
45 costs of the incurrence or issuance of any bond or note.
- 46 h. The cost of reimbursing the State for any payments made for any cost
47 described in this subdivision.
- 48 i. Any other costs and expenses necessary or incidental to the purposes
49 of this section.
- 50 (3) Credit facility. – An agreement entered into by the State Treasurer on behalf
51 of the State with a bank, savings and loan association or other banking

1 institution, an insurance company, reinsurance company, surety company or
2 other insurance institution, a corporation, investment banking firm or other
3 investment institution, or any financial institution or other similar provider
4 of a credit facility, which provider may be located within or without the
5 United States, such agreement providing for prompt payment of all or any
6 part of the principal or purchase price (whether at maturity, presentment or
7 tender for purchase, redemption or acceleration), redemption premium, if
8 any, and interest on any bonds or notes payable on demand or tender by the
9 owner, in consideration of the State agreeing to repay the provider of the
10 credit facility in accordance with the terms and provisions of such
11 agreement.

12 (4) Notes. – Notes issued under this section.

13 (5) Par formula. – A provision or formula adopted by the State to provide for the
14 adjustment, from time to time, of the interest rate or rates borne by any
15 bonds or notes, including the following:

16 a. A provision providing for such adjustment so that the purchase price
17 of such bonds or notes in the open market would be as close to par as
18 possible.

19 b. A provision providing for such adjustment based upon a percentage
20 or percentages of a prime rate or base rate, which percentage or
21 percentages may vary or be applied for different periods of time.

22 c. Such other provision as the State Treasurer may determine to be
23 consistent with this act and will not materially and adversely affect
24 the financial position of the State and the marketing of bonds or notes
25 at a reasonable interest cost to the State.

26 (6) State. – The State of North Carolina, including any State agency.

27 (7) State agency. – Any agency, institution, board, commission, bureau, council,
28 department, division, officer, or employee of the State. The term does not
29 include counties, municipal corporations, political subdivisions, local boards
30 of education, or other local public bodies.

31 **SECTION 36.12.(d)** Authorization of Bonds and Notes. – The State Treasurer is
32 authorized, by and with the consent of the Council of State, to issue and sell at one time or from
33 time to time general obligation bonds of the State to be designated "State of North Carolina
34 General Obligation Bonds," with any additional designations as may be determined, or notes of
35 the State, in the aggregate principal amount of up to two hundred sixty-three million seven
36 hundred twenty-five thousand dollars (\$263,725,000), this amount being not in excess of two-
37 thirds of the amount by which the State's outstanding indebtedness was reduced during the
38 fiscal biennium ended June 30, 2013, for the purpose of providing funds, with any other
39 available funds, for the purposes authorized by this section.

40 **SECTION 36.12.(e)** Uses of Bond and Note Proceeds. – The proceeds of bonds
41 and notes shall be used for financing the cost of State capital facilities as provided in this
42 section. Any additional moneys which may be received by grant from the United States of
43 America or any agency or department thereof or from any other source to aid in financing the
44 cost of any State capital facilities authorized by this section may be placed by the State
45 Treasurer in a separate fund or funds and shall be disbursed, to the extent permitted by the
46 terms of the grant, without regard to any limitations imposed by this section.

47 The proceeds of bonds and notes may be used with any other moneys made
48 available by the General Assembly for the cost of State capital facilities, including the proceeds
49 of any other State bond or special indebtedness issues, whether heretofore made available or
50 which may be made available at the session of the General Assembly at which this section is
51 ratified or any subsequent sessions. The proceeds of bonds and notes shall be expended and

1 disbursed under the direction and supervision of the Director of the Budget. The funds provided
2 by this section shall be disbursed for the purposes provided in this section upon warrants drawn
3 on the State Treasurer by the State Controller, which warrants shall not be drawn until
4 requisition has been approved by the Director of the Budget and which requisition shall be
5 approved only after full compliance with the State Budget Act, Chapter 143C of the General
6 Statutes.

7 The Office of State Budget and Management shall provide semiannual reports to the
8 Chairs of the Senate Appropriations Committees and the House Appropriations Subcommittees
9 and to the Fiscal Research Division on the expenditure of moneys authorized by this section.
10 The reports shall continue until the completion of the projects provided for in this section.

11 **SECTION 36.12.(f)** Allocation of Proceeds. – The proceeds of bonds and notes
12 shall be allocated and expended as provided in this subsection:

- 13 (1) A maximum aggregate principal amount of fifteen million four hundred
14 thousand dollars (\$15,400,000) to finance the capital facility costs of a
15 Western Crime Lab.
- 16 (2) A maximum aggregate principal amount of two hundred six million dollars
17 (\$206,000,000) to finance the capital facility costs of projects previously
18 authorized or subsequently to be authorized by the General Assembly to be
19 financed pursuant to Article 9 of Chapter 142 of the General Statutes but for
20 which some or all of the amount of bonds authorized to be issued under that
21 Article have not yet been issued. To the extent that bonds and notes are
22 issued pursuant to this subdivision, there shall be a corresponding reduction
23 in the amount of debt that has been authorized to be issued but has not been
24 issued pursuant to Article 9 of Chapter 142 of the General Statutes.
- 25 (3) A maximum aggregate principal amount of forty-two million three hundred
26 twenty-five thousand dollars (\$42,325,000) to finance the capital facility
27 costs of renovating the Albemarle Building.

28 **SECTION 36.12.(g)** Issuance of bonds and notes. –

- 29 (1) Terms and conditions. – Bonds or notes may bear a date or dates, may be
30 serial or term bonds or notes, or any combination thereof, may mature in
31 such amounts and at such time or times, not exceeding 40 years from their
32 date or dates, may be payable at such place or places, either within or
33 without the United States of America, in such coin or currency of the United
34 States of America as at the time of payment is legal tender for payment of
35 public and private debts, may bear interest at such rate or rates, which may
36 vary from time to time, and may be made redeemable before maturity, at the
37 option of the State or otherwise as may be provided by the State, at such
38 price or prices, including a price less than or greater than the face amount of
39 the bonds or notes, and under such terms and conditions, all as may be
40 determined by the State Treasurer, by and with the consent of the Council of
41 State.
- 42 (2) Signatures; form and denomination; registration. – Bonds or notes may be
43 issued in certificated or uncertificated form. If issued in certificated form,
44 bonds or notes shall be signed on behalf of the State by the Governor or shall
45 bear the Governor's facsimile signature, shall be signed by the State
46 Treasurer or shall bear the State Treasurer's facsimile signature, and shall
47 bear the Great Seal of the State, or a facsimile of the Seal shall be impressed
48 or imprinted thereon. If bonds or notes bear the facsimile signatures of the
49 Governor and the State Treasurer, the bonds or notes shall also bear a
50 manual signature which may be that of a bond registrar, trustee, paying
51 agent, or designated assistant of the State Treasurer. Should any officer

1 whose signature or facsimile signature appears on bonds or notes cease to be
2 such officer before the delivery of the bonds or notes, the signature or
3 facsimile signature shall nevertheless have the same validity for all purposes
4 as if the officer had remained in office until delivery. Bonds or notes may
5 bear the facsimile signatures of persons who at the actual time of the
6 execution of the bonds or notes shall be the proper officers to sign any bond
7 or note, although at the date of the bond or note such persons may not have
8 been such officers. The form and denomination of bonds or notes, including
9 the provisions with respect to registration of the bonds or notes and any
10 system for their registration, shall be as the State Treasurer may determine in
11 conformity with this section.

- 12 (3) Manner of sale; expenses. – Subject to the approval by the Council of State
13 as to the manner in which bonds or notes shall be offered for sale, whether at
14 public or private sale, whether within or without the United States, and
15 whether by publishing notices in certain newspapers and financial journals,
16 mailing notices, inviting bids by correspondence, negotiating contracts of
17 purchase or otherwise, the State Treasurer is authorized to sell bonds or
18 notes at one time or from time to time at any rates of interest, which may
19 vary from time to time, and at any prices, including a price less than or
20 greater than the face amount of the bonds or notes, as the State Treasurer
21 may determine. All expenses incurred in the preparation, sale, and issuance
22 of bonds or notes shall be paid by the State Treasurer from the proceeds of
23 bonds or notes or other available moneys.

- 24 (4) Notes; repayment. –

25 a. By and with the consent of the Council of State, the State Treasurer
26 is hereby authorized to borrow money and to execute and issue notes
27 of the State for the same, but only in the following circumstances and
28 under the following conditions:

- 29 1. For anticipating the sale of bonds, the issuance of which the
30 Council of State has approved, if the State Treasurer
31 considers it advisable to postpone the issuance of the bonds;
- 32 2. For the payment of interest on or any installment of principal
33 of any bonds then outstanding, if there are not sufficient
34 funds in the State treasury with which to pay the interest or
35 installment of principal as they respectively become due;
- 36 3. For the renewal of any loan evidenced by notes authorized in
37 this section;
- 38 4. For the purposes authorized in this section; and
- 39 5. For refunding bonds or notes as authorized in this section.

40 b. Funds derived from the sale of bonds or notes may be used in the
41 payment of any bond anticipation notes issued under this section.
42 Funds provided by the General Assembly for the payment of interest
43 on or principal of bonds shall be used in paying the interest on or
44 principal of any notes and any renewals thereof, the proceeds of
45 which shall have been used in paying interest on or principal of the
46 bonds.

- 47 (5) Refunding bonds and notes. – By and with the consent of the Council of
48 State, the State Treasurer is authorized to issue and sell refunding bonds and
49 notes pursuant to the provisions of the State Refunding Bond Act for the
50 purpose of refunding bonds or notes issued pursuant to this section. The
51 refunding bonds and notes may be combined with any other issues of State

1 bonds and notes similarly secured. Refunding bonds or notes may be issued
2 at any time prior to the final maturity of the debt obligation to be refunded.
3 The proceeds from the sale of any refunding bonds or notes shall be applied
4 to the immediate payment and retirement of the bonds or notes being
5 refunded or, if not required for the immediate payment of the bonds or notes
6 being refunded, the proceeds shall be deposited in trust to provide for the
7 payment and retirement of the bonds or notes being refunded and to pay any
8 expenses incurred in connection with the refunding. Money in a trust fund
9 may be invested in (i) direct obligations of the United States government, (ii)
10 obligations the principal of and interest on which are guaranteed by the
11 United States government, (iii) obligations of any agency or instrumentality
12 of the United States government if the timely payment of principal and
13 interest on the obligations is unconditionally guaranteed by the United States
14 government, or (iv) certificates of deposit issued by a bank or trust company
15 located in the State if the certificates are secured by a pledge of any of the
16 obligations described in (i), (ii), or (iii) above having an aggregate market
17 value, exclusive of accrued interest, equal at least to the principal amount of
18 the certificates so secured. This section does not limit the duration of any
19 deposit in trust for the retirement of bonds or notes being refunded but that
20 have not matured and are not presently redeemable, or if presently
21 redeemable, have not been called for redemption.

22 (6) Tax exemption. – Bonds and notes shall at all times be free from taxation by
23 the State or any political subdivision or any of their agencies, excepting
24 estate, inheritance or gift taxes, income taxes on the gain from the transfer of
25 bonds or notes, and franchise taxes. The interest on bonds or notes is not
26 subject to taxation as income.

27 (7) Investment eligibility. – Bonds and notes are securities in which all of the
28 following may invest, including capital in their control or belonging to them:
29 public officers, agencies, and public bodies of the State and its political
30 subdivisions, all insurance companies, trust companies, investment
31 companies, banks, savings banks, savings and loan associations, credit
32 unions, pension or retirement funds, other financial institutions engaged in
33 business in the State, executors, administrators, trustees, and other
34 fiduciaries. Bonds and notes are hereby made securities which may properly
35 and legally be deposited with and received by any officer or agency of the
36 State or political subdivision of the State for any purpose for which the
37 deposit of bonds, notes, or obligations of the State or any political
38 subdivision is now or may hereafter be authorized by law.

39 (8) Faith and credit. – The faith and credit and taxing power of the State are
40 hereby pledged for the payment of the principal of and the interest on bonds
41 and notes. The State expressly reserves the right to amend any provision of
42 this section to the extent it does not impair any contractual right of a bond
43 owner.

44 (9) Other agreements. – The State Treasurer may authorize, execute, obtain, or
45 otherwise provide for bond insurance, investment contracts, credit and
46 liquidity facilities, interest-rate swap agreements and other derivative
47 products, and any other related instruments and matters the State Treasurer
48 determines are desirable in connection with issuance, incurrence, carrying,
49 or securing of bonds or notes. The State Treasurer is authorized to employ
50 and designate any financial consultants, underwriters, and bond attorneys to

1 be associated with any bond or note issue under this section as the State
2 Treasurer considers necessary.

3 **SECTION 36.12.(h)** Variable Rate Demand Bonds and Notes. – In fixing the
4 details of bonds and notes, the State Treasurer may provide that any of the bonds or notes may:

- 5 (1) Be made payable from time to time on demand or tender for purchase by the
6 owner, if a credit facility supports the bonds or notes, unless the State
7 Treasurer specifically determines that a credit facility is not required upon a
8 finding and determination by the State Treasurer that the absence of a credit
9 facility will not materially and adversely affect the financial position of the
10 State and the marketing of the bonds or notes at a reasonable interest cost to
11 the State;
- 12 (2) Be additionally supported by a credit facility;
- 13 (3) Be made subject to redemption or a mandatory tender for purchase prior to
14 maturity;
- 15 (4) Bear interest at a rate or rates that may vary for any period of time, as may
16 be provided in the proceedings providing for the issuance of the bonds or
17 notes, including, without limitation, such variations as may be permitted
18 pursuant to a par formula; and
- 19 (5) Be made the subject of a remarketing agreement whereby an attempt is made
20 to remarket bonds or notes to new purchasers prior to their presentment for
21 payment to the provider of the credit facility or to the State.

22 If the aggregate principal amount payable by the State under a credit facility is in
23 excess of the aggregate principal amount of bonds or notes secured by the credit facility,
24 whether as a result of the inclusion in the credit facility of a provision for the payment of
25 interest for a limited period of time or the payment of a redemption premium or for any other
26 reason, then the amount of authorized but unissued bonds or notes during the term of such
27 credit facility shall not be less than the amount of such excess, unless the payment of such
28 excess is otherwise provided for by agreement of the State executed by the State Treasurer.

29 **SECTION 36.12.(i)** Interpretation of Section. –

- 30 (1) Additional method. – The foregoing subsections of this section shall be
31 deemed to provide an additional and alternative method for the doing of the
32 things authorized under it and shall be regarded as supplemental and
33 additional to powers conferred by other laws and shall not be regarded as in
34 derogation of any powers now existing.
- 35 (2) Statutory references. – References in this section to specific sections or
36 Chapters of the General Statutes or to specific acts are intended to be
37 references to such sections, Chapters, or acts as they may be amended from
38 time to time by the General Assembly.
- 39 (3) Broad construction. – This section, being necessary for the health and
40 welfare of the people of the State, shall be broadly construed to effect the
41 purposes thereof.
- 42 (4) Inconsistent provisions. – Insofar as the provisions of this section are
43 inconsistent with the provisions of any general, special, or local laws, or
44 parts thereof, the provisions of this section shall be controlling.
- 45 (5) Severability. – If any provision of this section or the application thereof to
46 any person or circumstance is held invalid, such invalidity shall not affect
47 other provisions or applications of the section which can be given effect
48 without the invalid provision or application, and to this end the provisions of
49 this section are declared to be severable.

50 **SECTION 36.12.(j)** This section is effective when it becomes law.

TRANSFER UNSPENT CAPITAL FUNDS TO PROJECT RESERVE ACCOUNT

SECTION 36.14. G.S. 143C-8-11 reads as rewritten:

"§ 143C-8-11. Reversion of ~~appropriation and lapse~~ ~~appropriation; lapse of project authorization~~ authorization; transfer of funds remaining after project completion.

(c) Funds Remaining After Project Completion. – The State Controller shall transfer any balance of State funds appropriated for a capital project that remains unspent and unencumbered two years after completion of the project in accordance with this section. If applicable law requires a particular disposition of the funds, then the transfer shall be made in accordance with that requirement. Otherwise, the transfer shall be made in accordance with the following requirements:

- (1) If the funds were initially allocated from the Reserve for Repairs and Renovations, then the funds shall be transferred to that Reserve.
- (2) All other funds shall be transferred to the Project Reserve Account created by G.S. 143C-8-10."

SITE PLANNING FOR NC SCHOOL OF SCIENCE AND MATHEMATICS

SECTION 36.15.(a) Having considered the study conducted by the Board of Governors, the North Carolina School of Science and Mathematics, and the Department of Public Instruction on the feasibility for a western campus of the North Carolina School of Science and Mathematics (School of Science and Math), the General Assembly finds that the establishment of a western School of Science and Math located on the campus of the North Carolina School for the Deaf or other State property adjoining that campus is desirable. The General Assembly further finds that the establishment of a western School of Science and Math at that location would be beneficial to the economic growth and workforce preparedness in western North Carolina and would extend the opportunity for the unique study experience provided by the School of Science and Math to a significant number of additional students with excellent academic records. Therefore, the Board of Governors and the Board of Trustees of the North Carolina School of Science and Mathematics shall jointly determine the most appropriate location, including the repurposing of property, at either the North Carolina School for the Deaf or other State-owned property adjoining the North Carolina School for the Deaf for the proposed western School of Science and Math.

SECTION 36.15.(b) The General Assembly authorizes advanced planning of the Western School of Science and Mathematics described in subsection (a) of this section to be funded in accordance with the following for the 2014-2015 fiscal year:

- (1) Notwithstanding G.S. 143C-8-12, as amended by Section 36.5 of this act, the Board of Governors of The University of North Carolina may use up to the sum of one million two hundred thousand dollars (\$1,200,000) in funds carried forward pursuant to G.S. 116-30.3 and G.S. 116-30.3B for advanced planning of the facility.
- (2) The Board of Governors may use up to the sum of eight hundred thousand dollars (\$800,000) in funds provided to it by a non-State entity, or combination of non-State entities, for advanced planning of the facility.
- (3) Once the two million dollars (\$2,000,000) that has been made available pursuant to subdivisions (1) and (2) of this section has been spent or encumbered, the Board of Governors may continue to fund advanced planning in accordance with G.S. 143C-8-7.

SECTION 36.15.(b1) The Board of Governors shall ensure that the one million two hundred thousand dollars (\$1,200,000) described in subdivision (b)(1) of this section is not spent for any purpose other than advanced planning of the facility described in subsection (a) of

1 this section. The Board of Governors may commence advanced planning with these funds as
2 soon as this section is effective, and if the eight hundred thousand dollars (\$800,000) described
3 in subdivision (b)(2) of this section is provided to the Board of Governors, the Board shall use
4 the one million two hundred thousand dollars (\$1,200,000) described in subdivision (b)(1) of
5 this section for this purpose.

6 **SECTION 36.15.(c)** No later than November 30, 2014, the Board of Governors
7 and the School of Science and Math shall report to the Joint Legislative Education Oversight
8 Committee regarding its progress on site selection and any other advanced planning for the
9 western School of Science and Math as described in subsection (a) of this section.

10 11 **REPORT ON APPALACHIAN STATE UNIVERSITY HEALTH SCIENCES** 12 **BUILDING**

13 **SECTION 36.16.(a)** No later than October 1, 2014, Appalachian State University
14 shall submit to the Board of Governors and to the Fiscal Research Division a detailed plan for
15 the construction and operation of the Health Sciences Building that will be located on its
16 campus. The report shall include information about the construction planning as well as several
17 options for financing the construction and operation of the facility.

18 **SECTION 36.16.(b)** The General Assembly authorizes planning of the Health
19 Sciences Building at Appalachian State University in an amount not to exceed the sum of seven
20 million two hundred two thousand eight hundred eighty-three dollars (\$7,202,883). This
21 amount represents the total amount authorized to be spent for planning this project. The
22 General Assembly has appropriated six million dollars (\$6,000,000) for this purpose in the
23 2013-2015 fiscal biennium and does not intend to appropriate additional funds for planning this
24 project in the future. Accordingly, the General Assembly hereby authorizes the remaining sum
25 of one million two hundred two thousand eight hundred eighty-three dollars (\$1,202,883) to be
26 funded with receipts or from other non-General Fund sources available to Appalachian State
27 University during the 2014-2015 fiscal year.

45 percent (1%) if net General Fund tax collections for fiscal year 2015-2016 exceed the targeted
46 amount of twenty billion nine hundred seventy-five million dollars (\$20,975,000,000).
47 Effective for taxable years beginning on or after January 1, 2017, the rate of tax set in
48 G.S. 105-130.3 is the rate determined in accordance with this section.

1 (3) State-certified historic structure. – A structure that is individually listed in
2 the National Register of Historic Places or is certified by the State Historic
3 Preservation Officer as contributing to the historic significance of a National
4 Register Historic District or a locally designated historic district certified by
5 the United States Department of the Interior.

6 (4) State Historic Preservation Officer. – The Deputy Secretary of Archives and
7 History or the Deputy Secretary's designee who acts to administer the

45 Any unused portion of the credit may be carried forward for the succeeding nine years. Any
46 carryforwards of the credit must be claimed against the same tax.

47 (c) Forfeiture for Disposition. – A taxpayer who is required under section 50 of the
48 Code to recapture all or part of the federal credit for rehabilitating an income-producing historic
49 structure located in this State forfeits the corresponding part of the State credit allowed under
50 G.S. 105-129.35 with respect to that historic structure. If the credit was allocated among the

1 owners of a pass-through entity, the forfeiture applies to the owners in the same proportion that
2 the credit was allocated.

3 (d) Forfeiture for Change in Ownership. – If an owner of a pass-through entity that has
4 qualified for the credit allowed under G.S. 105-129.35 disposes of all or a portion of the
5 owner's interest in the pass-through entity within five years from the date the rehabilitated
6 historic structure is placed in service and the owner's interest in the pass-through entity is
7 reduced to less than two-thirds of the owner's interest in the pass-through entity at the time the
8 historic structure was placed in service, the owner forfeits a portion of the credit. The amount
9 forfeited is determined by multiplying the amount of credit by the percentage reduction in
10 ownership and then multiplying that product by the forfeiture percentage. The forfeiture

12 Code. ~~The remaining allowable credit is allocated equally among the five years in which the~~
13 ~~credit is claimed.~~

14 (e) Exceptions to Forfeiture. – Forfeiture as provided in subsection (d) of this section is
15 not required if the change in ownership is the result of any of the following:

16 (1) The death of the owner.

17 (2) A merger, consolidation, or similar transaction requiring approval by the
18 shareholders, partners, or members of the taxpayer under applicable State
19 law, to the extent the taxpayer does not receive cash or tangible property in
20 the merger, consolidation, or other similar transaction.

21 (f) Liability From Forfeiture. – A taxpayer or an owner of a pass-through entity that
22 forfeits a credit under this section is liable for all past taxes avoided as a result of the credit plus

24 have been due if the credit had not been allowed. The past taxes and interest are due 30 days
25 after the date the credit is forfeited. A taxpayer or owner of a pass-through entity that fails to

28 (a) Creation and Purpose of Fund. – There is created in the Department of Commerce a
29 special, nonreverting account to be known as the Film and Entertainment Grant Fund to
30 provide funds to encourage the production of motion pictures, television shows, and
31 commercials and to develop the film-making industry within the State. The Department of
32 Commerce shall adopt guidelines providing for the administration of the program. Those
33 guidelines may provide for the Secretary to award the grant proceeds over a period of time, not
34 to exceed three years. Those guidelines shall include the following provisions, which shall
35 apply to each grant from the account:

36 (1) The funds are reserved for a production on which the production company
37 has qualifying expenses of at least the following:

38 a. For a feature-length film, ten million dollars (\$10,000,000).

39 b. For a video or television production, one million dollars (\$1,000,000)
40 per episode.

41 c. For a commercial for theatrical or television viewing, five hundred
42 thousand dollars (\$500,000).

43 (2) The funds are not used to provide a grant in excess of any of the following:

44 a. An amount more than twenty-five percent (25%) of the qualifying
45 expenses for the production.

46 b. An amount more than five million dollars (\$5,000,000) for a
47 feature-length film, more than five million dollars (\$5,000,000) for a
48 single episode of a television or video production, or two hundred
49 fifty thousand dollars (\$250,000) for a commercial for theatrical or
50 television viewing.

- 1 (3) The funds are not used to provide a grant to more than one production
2 company for a single production.
- 3 (4) The funds are not used to provide a grant for a production that meets one or
4 more of the following:
- 5 a. It contains material that is obscene, as defined in G.S. 14-190.1 or
6 material that is "harmful to minors" as defined in G.S. 14-190.13.
- 7 b. It has the primary purpose of political advertising, fund-raising, or
8 marketing, other than by commercial, a product, or service.
- 9 c. News programming, including weather, financial market, and current
10 events reporting.
- 11 d. Live sporting event programming, including pre-event and post-event
12 coverage and scripted sports entertainment. For purposes of this
13 exception, a live sporting event is a scheduled sporting competition,
14 game, or race that is originated solely by an amateur, collegiate, or
15 professional organization, institution, or association for live or
16 tape-delayed television or satellite broadcast. The term does not
17 include commercial advertising, an episodic television series, a
18 television pilot, a music video, a motion picture, or a documentary
19 production in which sporting events are presented through archived
20 historical footage or similar footage taken at least 30 days before it is
21 used.
- 22 e. Radio productions.
- 23 f. It is a talk, game, or awards show or other gala event. For purposes
24 of this exception, an awards show is television programming
25 involving the filming of a ceremony in which individuals, groups, or
26 organizations are given an award.
- 27 g. It fails to contain, in the end credits of the production, a statement
28 that the production was "Filmed in North Carolina," a logo provided
29 by the North Carolina Film Office, and an acknowledgement of the
30 regional film office responsible for the geographic area in which the
31 filming of the production occurred. Additionally, the production
32 company will offer marketing opportunities to be evaluated by the
33 North Carolina Film Office to ensure that they offer promotional
34 value to the State.
- 35 (5) Priority for the use of funds shall be given to productions that, based on
36 results of an economic impact assessment conducted by the Labor and
37 Economic Analysis Division, are reasonably anticipated to maximize the
38 economic benefits accruing to the State. The assessment shall include
39 consideration of at least the following factors:
- 40 a. Percentage of employees that are permanent residents in the State.
- 41 b. The extent to which the production features identifiable attractions or
42 State locales in a manner that would be reasonably expected to
43 induce visitation by nonresidents of the State to the attraction or
44 locale.
- 45 c. The extent to which the production invests in permanent
46 improvements to open, public spaces, commercial districts,
47 traditional downtown areas, public landmarks, residential areas, or
48 similar properties or areas.
- 49 d. The extent to which the production will be filmed in an economically
50 distressed county or area of the State.
- 51 e. The duration of production activities in the State.

1 **(b)** Definitions. – The following definitions apply in this section:

2 **(1)** Department. – The Department of Commerce.

3 **(2)** Employee. – A person who is employed for consideration for at least 35
4 hours a week and whose wages are subject to withholding under Article 4A
5 of Chapter 105 of the General Statutes.

6 **(3)** Highly compensated individual. – An individual who directly or indirectly
7 receives compensation in excess of one million dollars (\$1,000,000) for
8 personal services with respect to a single production. An individual receives
9 compensation indirectly when a production company pays a personal service
10 company or an employee leasing company that pays the individual.

11 **(4)** Loan out company. – A personal service corporation that employs an
12 individual who is hired by a film or digital media production company.

13 **(5)** Production. – Any of the following:

14 a. A motion picture intended for commercial distribution to a motion
15 picture theater or directly to the consumer viewing market that has a
16 running time of at least 75 minutes.

17 b. A video or television production or a commercial for theatrical or
18 television viewing. For a television series or any other production
19 intended to be shown in two or more episodes, the applicant may
20 elect to treat each episode as a separate production or to treat two or
21 more episodes as a single production for all purposes of this section.
22 A single application may be filed for two or more productions,
23 provided that the application clearly describes each separate
24 production.

25 **(6)** Production company. – Defined in G.S. 105-164.3.

26 **(7)** Qualifying expenses. – The sum of the amounts listed in the sub-
27 subdivisions of this subdivision substantiated pursuant to subsection (d) of
28 this section and spent in this State by a production company in connection
29 with a production, less the amount paid in excess of one million dollars
30 (\$1,000,000) to a highly compensated individual. The term does not include
31 the cost of financing for the production, bonding related to the production,
32 production-related insurance coverage obtained on the production, or
33 expenses for insurance coverage purchased from a related member.

34 a. Goods and services leased or purchased. For goods with a purchase
35 price of twenty-five thousand dollars (\$25,000) or more, the amount
36 included in qualifying expenses is the purchase price less the fair
37 market value of the good at the time the production is completed.
38 Goods and services includes the costs of tangible and intangible
39 property used for, and services performed primarily and customarily
40 in, production, including preproduction and postproduction and other
41 direct costs of producing the project in accordance with generally
42 accepted entertainment industry practices. Goods and services
43 exclude costs for development, marketing, and distribution.

44 b. Compensation and wages and payments on which withholding
45 payments are remitted to the Department of Revenue under Article
46 4A of Chapter 105 of the General Statutes. Payments made to a loan
47 out company for services provided in North Carolina shall be subject
48 to gross income tax withholding at the applicable rate under the
49 Article 4 of Chapter 105 of the General Statutes.

50 c. Employee fringe contributions, including health, pension, and
51 welfare contributions.

- 1 d. Per diems, stipends, and living allowances paid for work being
2 performed in this State.
- 3 (8) Related member. – Defined in G.S. 105-130.7A.
4 (9) Secretary. – The Secretary of Commerce.
- 5 (c) Application. – A production company shall apply, under oath, to the Secretary for a
6 grant on a form prescribed by the Secretary. The Secretary shall evaluate the applications to
7 ensure the production's content is created for entertainment purposes. The application shall
8 include all documentation and information the Secretary deems necessary to evaluate the grant
9 application.
- 10 (d) Substantiation. – The Secretary shall work with the North Carolina Film Office to
11 adopt guidelines to provide a process to verify the actual qualifying expenses of a certified
12 production. The Secretary may not release grant funds until the substantiation process required
13 by this subsection is complete and the final verified amount of qualified expenses is
14 determined. The process shall require each of the following:
- 15 (1) The production company shall submit all the qualifying expenses for the
16 production and data substantiating the qualifying expenses, including
17 documentation on the net expenditure on equipment and other tangible
18 personal property to an independent certified public accountant licensed in
19 this State.
- 20 (2) The accountant shall conduct a compliance audit, at the certified
21 production's expense, pursuant to guidelines established by the Secretary and
22 submit the results as a report, along with the required substantiating data, to
23 the production company and the North Carolina Film Office.
- 24 (3) The North Carolina Film Office shall review the report and advise the
25 Department on the final verified amount of qualifying expenses made by the
26 certified production.
- 27 (e) Report. – The Department shall provide to the Department of Revenue, and the
28 Department of Revenue must include in the economic incentives report required by
29 G.S. 105-256, the following information, itemized by production company:
- 30 (1) The location of sites used in a production for which a grant was awarded.
31 (2) The qualifying expenses, classified by whether the expenses were for goods,
32 services, or compensation paid by the production company.
- 33 (3) The number of people employed in the State with respect to grants awarded,
34 including the number of residents of the State employed.
- 35 (4) The total cost of the grants awarded.
- 36 (f) NC Film Office. – To claim a grant under this section, a production company must
37 notify the Division of Tourism, Film, and Sports Development in the Department of Commerce
38 of its intent to apply for a grant. The notification must include the title of the production, the
39 name of the production company, a financial contact for the production company, the proposed
40 dates on which the production company plans to begin filming the production, and any other
41 information required by the Division.
- 42 (g) Guidelines. – The Department of Commerce shall develop guidelines related to the
43 administration of the Film and Entertainment Grant Fund and to the selection of productions
44 that will receive grants from the Fund. At least 20 days before the effective date of any
45 guidelines or nontechnical amendments to the guidelines, the Department of Commerce shall
46 publish the proposed guidelines on the Department's Web site and provide notice to persons
47 who have requested notice of proposed guidelines. In addition, the Department must accept oral
48 and written comments on the proposed guidelines during the 15 business days beginning on the
49 first day that the Department has completed these notifications."

50 **SECTION 37.8.(b)** G.S. 150B-1(d) is amended by adding a new subdivision to
51 read:

1 "(d) Exemptions from Rule Making. – Article 2A of this Chapter does not apply to the
2 following:

3 ...

4 (18) The Department of Commerce and the Economic Investment Committee in
5 developing criteria and administering the Job Maintenance and Capital
6 Development Fund under G.S. 143B-437.012.

7 (18a) The Department of Commerce in administering the Film and Entertainment
8 Grant Fund under G.S. 143B-437.02A.

10 **SECTION 37.8.(c)** Notwithstanding anything in this act or in the N.C. House of
11 Representatives Appropriations Committee Report on the Continuation, Expansion, and Capital
12 Budgets for Senate Bill 744, dated June 11, 2014, to the contrary, the reduction for the
13 Management Flexibility Reserve for the Department of Commerce shall be five dollars (\$5.00)
14 greater than the amount in the Report, and five dollars (\$5.00) shall be used for grants for the
15 Film and Entertainment Grant Fund created by this section. No funds appropriated to the
16 following divisions of the Department of Commerce, regardless of whether any of those funds
17 are later transferred to a nonprofit entity to perform any functions performed by the divisions,
18 may be used for the Film and Entertainment Grant Fund created by this section:

19 (1) Small Business & Entrepreneurship.

20 (2) Tourism, Film, and Sports Development.

21 (3) Marketing and Customer Service.

22 (4) Business and Industry Development.

23 (5) International Trade Division.

24 **SECTION 37.8.(d)** This Part becomes effective January 1, 2015, and expires July
25 1, 2020. The Secretary shall not award a grant for any qualifying expenses for which a taxpayer
26 receives a tax credit under G.S. 105-130.47 or G.S. 105-151.29.

27 28 **PART XXXVIII. MISCELLANEOUS PROVISIONS**

29 30 **STATE BUDGET ACT APPLIES**

31 **SECTION 38.1.** The provisions of the State Budget Act, Chapter 143C of the
32 General Statutes, are reenacted and shall remain in full force and effect and are incorporated in
33 this act by reference.

34 35 **COMMITTEE REPORT**

36 **SECTION 38.2.(a)** The N.C. House of Representatives Appropriations Committee
37 Report on the Continuation, Expansion, and Capital Budgets for Senate Bill 744, dated June 11,
38 2014, which was distributed in the House of Representatives and used to explain this act, shall
39 indicate action by the House of Representatives on this act and shall, therefore, be used to
40 construe this act, as provided in the State Budget Act, Chapter 143C of the General Statutes, as
41 appropriate, and for these purposes shall be considered a part of this act and, as such, shall be
42 printed as a part of the Session Laws.

43 **SECTION 38.2.(b)** The budget enacted by the General Assembly is for the
44 maintenance of the various departments, institutions, and other spending agencies of the State
45 for the 2014-2015 budget as provided in G.S. 143C-3-5. This budget includes the
46 appropriations of State funds as defined in G.S. 143C-1-1(d)(25).

47 The Director of the Budget submitted recommended adjustments to the budget to
48 the General Assembly in May 2014 in the document "The Governor of North Carolina's
49 Recommended Budget Adjustments" for the 2014-2015 fiscal year for the various departments,
50 institutions, and other spending agencies of the State. The adjustments to these documents
51 made by the General Assembly are set out in the Committee Report.

1 **SECTION 38.2.(c)** The budget enacted by the General Assembly shall also be
2 interpreted in accordance with G.S. 143C-5-5, the special provisions in this act, and other
3 appropriate legislation.

4 In the event that there is a conflict between the line-item budget certified by the
5 Director of the Budget and the budget enacted by the General Assembly, the budget enacted by
6 the General Assembly shall prevail.

7
8 **REPORT BY FISCAL RESEARCH DIVISION ON CHANGES TO 2014-2015**
9 **BUDGET/PUBLICATION**

10 **SECTION 38.3.(a)** The Fiscal Research Division of the Legislative Services
11 Commission shall issue a report on budget actions taken by the 2013 Regular Session of the
12 General Assembly in 2014. The report shall be in the form of a revision of the Committee
13 Report adopted for Senate Bill 744 pursuant to G.S. 143C-5-5 and shall include all
14 modifications made to the 2014-2015 budget prior to sine die adjournment of the 2013 Regular
15 Session.

16 **SECTION 38.3.(b)** The Director of the Fiscal Research Division of the Legislative
17 Services Commission shall send a copy of the report issued pursuant to this section to the
18 Director of the Budget. The report shall be published on the General Assembly's Internet Web
19 site for public access.

20
21 **MOST TEXT APPLIES ONLY TO 2014-2015 FISCAL YEAR**

22 **SECTION 38.4.** Except for statutory changes or other provisions that clearly
23 indicate an intention to have effects beyond the 2014-2015 fiscal year, the textual provisions of
24 this act apply only to funds appropriated for, and activities occurring during, the 2014-2015
25 fiscal year.

26
27 **EFFECT OF HEADINGS**

28 **SECTION 38.5.** The headings to the parts and sections of this act are a
29 convenience to the reader and are for reference only. The headings do not expand, limit, or
30 define the text of this act, except for effective dates referring to a part.

31
32 **APPROPRIATIONS LIMITATIONS AND DIRECTIONS APPLY**

33 **SECTION 38.6.(a)** Except where expressly repealed or amended by this act, the
34 provisions of S.L. 2013-360, S.L. 2013-363, S.L. 2013-364, and S.L. 2013-397 remain in
35 effect.

36 **SECTION 38.6.(b)** Notwithstanding any modifications by this act in the amounts
37 appropriated, except where expressly repealed or amended, the limitations and directions for
38 the 2014-2015 fiscal year in S.L. 2013-360, S.L. 2013-363, S.L. 2013-364, and S.L. 2013-397
39 that applied to appropriations to particular agencies or for particular purposes apply to the
40 newly enacted appropriations and budget reductions of this act for those same particular
41 purposes.

42
43 **SEVERABILITY**

44 **SECTION 38.7.** If any section or provision of this act is declared unconstitutional
45 or invalid by the courts, it does not affect the validity of this act as a whole or any part other
46 than the part so declared to be unconstitutional or invalid.

47
48 **EFFECTIVE DATE**

49 **SECTION 38.8.** Except as otherwise provided, this act becomes effective
50 July 1, 2014.
