8	The General Assembly of North Carolina enacts:				
9	SECTION 1. G.S. 20-4.02 reads as rewritten:				
10	"§ 20-4.02. (Quadrennial adjustment of certain fees.<u>fees</u> and rates.			
11	(a) Adjustment for Inflation. – Beginning July 1, 2020, and every four years thereafter, the				
12	Division shall adjust the fees chargedand rates imposed pursuant to the statutes listed in this				
13	subsection for inflation in accordance with the Consumer Price Index computed by the Bureau of				
14	Labor Statistics, Statistics. The adjustment for per transaction rates in subdivision (8a) of this				
15	subsection shall be rounded to the nearest cent and all other adjustments under this subsection				
16	shall be rounded to the nearest twenty-five cents (25ϕ) :

3 (c) Rules. – The provisions of Chapter 150B of the General Statutes shall not apply to the 4 inflation adjustment of fees required by this section.

5 (d) Consultation and Publication. - At least 90 days prior to adjusting the feesmaking an adjustment pursuant to subsection (a) of this section, and notwithstanding any provision of 6 7 G.S. 12-3.1 to the contrary, the Division shall (i) consult with the Joint Legislative Commission on 8 Governmental Operations, (ii) provide a report to the chairs of the Senate Appropriations 9 Committee on Department of Transportation and the House of Representatives Appropriations 10 Committee on Transportation, and (iii) publish notice of the fees that will be in effect in the offices 11 of the Division and on the Division's Web site."

SECTION 2. G.S. 20-63(h) reads as rewritten:

13 "(h) Commission Contracts for Issuance of Plates and Certificates. – All registration plates, 14 registration certificates, and certificates of title issued by the Division, outside of those issued 15 from the office of the Division located in Wake, Cumberland, or Mecklenburg Counties and those issued and handled through the United States mail, shall be issued insofar as practicable and 16 17 possible through commission contracts entered into by the Division for the issuance of the plates and certificates in localities throughout North Carolina, including military installations within this 18 19 State, with persons, firms, corporations or governmental subdivisions of the State of North 20 Carolina. The Division shall make a reasonable effort in every locality, except as noted above, to 21 enter into a commission contract for the issuance of the plates and certificates and a record of 22 these efforts shall be maintained in the Division. In the event the Division is unsuccessful in 23 making commission contracts, it shall issue the plates and certificates through the regular 24 employees of the Division. Whenever registration plates, registration certificates, and certificates 25 of title are issued by the Division through commission contract arrangements, the Division shall 26 provide proper supervision of the distribution. Nothing contained in this subsection allows or 27 permits the operation of fewer outlets in any county in this State than are now being operated.

28 The terms of a commission contract entered under this subsection shall specify the duration of 29 the contract and either include or incorporate by reference standards by which the Division may 30 supervise and evaluate the performance of the commission contractor. The duration of an initial 31 commission contract may not exceed eight years and the duration of a renewal commission 32 contract may not exceed two years. The Division may award monetary performance bonuses, not 33 to exceed an aggregate total of ninety thousand dollars (\$90,000) annually, to commission 34 contractors based on their performance.

35 The amount of compensation payable to a commission contractor is determined on a per 36 transaction basis. The collection of the highway use tax is and the removal of an inspection stop are each considered a separate transaction for which one dollar and thirty cents (\$1.30) compensation 37 38 shall be paid. The issuance of a limited registration "T" sticker and the collection of property tax 39 are each considered a separate transaction for which compensation at the rate of one dollar and 40 thirty cents (\$1.30) and one dollar and eight cents (\$1.08) respectively, shall be paid by counties 41 and municipalities as a cost of the combined motor vehicle registration renewal and property tax 42 collection system. The performance at the same time of one or more of the transactions below is 43 considered a single transaction for which one dollar and forty-six cents (\$1.46) compensation shall 44 be paid:"
