A JOINT RESOLUTION (1) RESCINDING ALL EXTANT APPLICATIONS BY THE 1 2 GENERAL ASSEMBLY HERETOFORE MADE DURING ANY SESSION THEREOF TO 3 THE CONGRESS OF THE UNITED STATES OF AMERICA TO CALL A CONVENTION 4 PURSUANT TO THE TERMS OF ARTICLE V OF THE UNITED STATES 5 CONSTITUTION FOR PROPOSING ONE OR MORE AMENDMENTS TO THAT 6 CONSTITUTION, (2) URGING THE LEGISLATURES OF OTHER STATES TO DO THE 7 SAME, AND (3) DIRECTING THAT COPIES OF THIS RESOLUTION BE SENT TO 8 SPECIFIED PERSONS.

9 Whereas, the General Assembly, acting with the best of intentions, has, at various 10 times and during various sessions, previously made applications to the Congress of the United States either to call one or more conventions to propose a single amendment concerning a specific 11 12 subject or to call a general convention to propose an unspecified and unlimited number of amendments to the Constitution of the United States, pursuant to the provisions of Article V of the 13 14 Constitution of the United States thereof; and

15 Whereas, former Associate Justice of the United States Supreme Court Arthur J. Goldberg and other leading constitutional scholars agree that such a convention may propose 16 sweeping changes to the Constitution, notwithstanding any limitations or restrictions to the 17 contrary purportedly imposed by the states in applying for such a convention or conventions, 18 19 thereby creating an imminent peril to the well-established rights of the citizens and the duties of 20 various levels of government; and

21 Whereas, the Constitution of the United States has been amended many times in the 22 history of this nation and may be amended many more times without the need to resort to a constitutional convention and has been interpreted for more than 200 years and has been found to 23 be a sound document which protects the lives and liberties of the citizens; and 24

25 Whereas, there is no need for, rather there is great danger in, a new constitution or in opening the Constitution to sweeping changes, the adoption of which would only create legal 26 chaos in this nation and only begin the process of another two centuries of litigation over its 27 28 meaning and interpretation; Now, therefore,

29 Be it resolved by the House of Representatives, the Senate concurring:

30 **SECTION 1.** The General Assembly rescinds all extant applications by the General 31 Assembly to the Congress of the United States to call a convention to propose amendments to the 32 Constitution of the United States, pursuant to the terms of Article V of the Constitution of the United States thereof, regardless of when or by which session of the General Assembly the 33 34 applications were made and regardless of whether the applications were for a limited convention to propose one or more amendments regarding one or more specific subjects and purposes or for a 35

general convention to propose an unlimited number of amendments upon an unlimited number of 1 2 subjects. 3 **SECTION 2.** The General Assembly urges the legislatures of every state that has 4 applied to Congress to call a convention for either a general or a limited constitutional convention 5 to repeal and withdraw the applications. 6 **SECTION 3.** The Secretary of State shall send a certified copy of this resolution to 7 the secretary of state of each state, to the presiding officers of both houses of the legislatures of 8 each state, to the Secretary of the United States Senate, to the Clerk of the United States House of 9 Representatives, to the members of Congress of the United States representing this State, and to 10 the Administrator of the U.S. General Services Administration, Washington, D.C. 11 SECTION 4. This resolution is effective upon ratification.
