REVISION NOTE: Data on the total number of registered vehicles $>6,000 \mathrm{lbs}-17,000 \mathrm{lbs}$ eligible under this bill was not available at the time the initial fiscal note was requested. The Division of Motor Vehicles has since provided this data and the revised fiscal impact is $\$ 64,457$. The previously provided fiscal impact was $\$ 543,806$.

## BILL SUMMARY:

Section 1 amends G.S. 20-79.7(a) to annually provide and issue free of charge a single special registration plate listed in this subsection to a person qualified to receive the plate in accordance with G.S. 20-79.4(a2) for a vehicle weighing up to $17,000 \mathrm{lbs}$.

The special registration plates included in this subsection are:
(1) Legion of Valor registration plate to a recipient of the Legion of Valor award
(2) A $100 \%$ Disabled Veteran registration plate to a $100 \%$ disabled veteran
(3) An Ex-Prisoner of War registration plate to an ex-prisoner of war
(4) A Bronze Star Valor registration plate to a recipient of the Bronze Star Medal for valor in combat award
(5) A Silver Star registration plate to a recipient of the Silver Star award

Section 2 states that this bill becomes effective July 1, 2017 and applies to special registration plates issued on or after that date.

## ASSUMPTIONS AND METHODOLOGY:

A query of the Division of Motor Vehicles State Titling and Registration System (STARS) yielded a total of 588 eligible registered vehicles $>6,000 \mathrm{lbs}-17,000 \mathrm{lbs}$ as of December 31, 2016. See Figure 1 below.

Registration fees for vehicles $>6,000 \mathrm{lbs}-17,000 \mathrm{lbs}$ range from $\$ 77.50-\$ 304.90$. See Figure 2 below for detailed information on registration fees by weight.

Based on the number of eligible registered vehicles on December 31, 2016, the total revenue loss is estimated to be $\$ 64,457$ annually. Figure 3 below provides detailed information on the total number of registered vehicles by weight and associated revenue losses.

Given that the bill as currently written only provides a single special registration plate free of charge, it is possible that a qualified person may have more than one registered vehicle and the actual revenue loss could be less. It is also possible that the fiscal impact could be nominally higher if the number of qualified persons eligible to receive free registration plates under the bill is more than what was reflected in registrations as of December 31, 2016.

Any impact to DMV operations is assumed to be nominal.
SOURCES OF DATA: Division of Motor Vehicles
TECHNICAL CONSIDERATIONS: The bill as currently written is unclear on whether or not special registration plates for Bronze Star (BZS) or Silver Star Disabled Veteran (SSD) are included. Due to the updates required to the State Titling and Registration System (STARS), DMV estimates it will not be able to implement the changes presented in this bill until February 1, 2018.
