A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR CAPITAL IMPROVEMENTS AND EXPANSIONS OF FACILITIES IN THE COLLEGE OF AGRICULTURE AND LIFE SCIENCES, NORTH CAROLINA STATE UNIVERSITY.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of ten million three hundred eight thousand three hundred dollars (\$10,308,300) for the 1989-90 fiscal year to be used for the construction of a building on the Centennial Campus of North Carolina State University to house a Department of Toxicology.

- Sec. 2. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of four million three hundred forty-eight thousand three hundred dollars (\$4,348,300) for the 1989-90 fiscal year to complete the construction of facilities for aquaculture research and extension programs throughout the State.
- Sec. 3. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of three million six hundred thirty-eight thousand six hundred dollars (\$3,638,600) for the 1989-90 fiscal year to be used for construction of a building on the North Carolina State University campus to house the Department of Agricultural Communications.
- Sec. 4. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of three million four hundred one thousand dollars (\$3,401,000) for the 1989-90 fiscal year to be used for the repair

and construction of small animal research facilities that meet federal guidelines for small animal research.

Sec. 5. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of two million three hundred six thousand nine hundred dollars (\$2,306,900) for the 1989-90 fiscal year to be used for renovations and new facilities at University Research Units and Outlying Research Stations of the North Carolina State University College of Agriculture and Life Sciences.

Sec. 6. There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of one hundred eighty-six thousand five hundred dollars (\$186,500) to be used to replace the cooling towers for the Schaub Hall Food Science Building and the Phytotron Controlled Environment Building at North Carolina State University.

Sec. 7. This act shall become effective July 1, 1989.
