When considering the items listed in subdivisions (6) through (9), the Office shall determine the appropriate weight to be given each item.

- Sec. 2. There is appropriated from the General Fund to the Office of State Budget and Management the sum of \$5,000,000 for 1990-91 fiscal year for funding of the Criminal Justice Facility Fund. These funds shall not revert at the end of the fiscal year for which they are appropriated but shall remain available until expended for the Criminal Justice Facility Fund.
- Sec. 3. From the funds appropriated to the Office of State Budget and Management for the 1990-91 fiscal year in Section 2, the Office of State Budget and Management may use no more than one percent (1%) of the funds appropriated for costs of administering the Fund.
 - Sec. 4. This act shall become effective July 1, 1990.
