A BILL TO BE ENTITLED

AN ACT TO ESTABLISH HOUSE OF REPRESENTATIVES DISTRICTS AND TO
APPORTION SEATS IN THE HOUSE OF REPRESENTATIVES AMONG
DISTRICTS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 120-2 reads as rewritten:

"§ 120-2. House apportionment specified.

(a) For the purpose of nominating and electing members of the North Carolina House of Representatives in ~~1984-1992~~ and periodically thereafter, the State of North Carolina shall be divided into the following districts with each District electing one Representative, except that Districts 4, 11, 12, 13, 14, 17, 18, 19, 22, 24, 41, 45, 46, 52, and 89 each elect two Representatives and except that Districts 23, 25, 40, 48, and 51 each elect three Representatives:
