# A BILL TO BE ENTITLED

#### 2 AN ACT TO PROVIDE FOR THE ELECTION OF THE ANSON COUNTY BOARD 3 OF EDUCATION FROM SEVEN SINGLE-MEMBER DISTRICTS. WITH TWO

3 OF EDUCATION FROM SEVEN SINGLE-MEMBER DISTRICTS, WITH TWO4 AT LARGE.

5 The General Assembly of North Carolina enacts:

6 Section 1. For the purpose of nominating and electing members of the 7 county board of education, Anson County is divided into seven districts, each of which 8 shall nominate and elect one member. The districts shall be the same as those for 9 election of the Anson County Board of Commissioners as provided by Section 2 of 10 Chapter 281, Session Laws of 1987. In addition, two members shall be nominated and 11 elected at large.

12 Sec. 2. The qualified voters of each district established by this act shall 13 nominate candidates and elect a member who resides in that district for the seat 14 apportioned to that district. The qualified voters of Anson County shall nominate 15 candidates and elect members who reside in Anson County for the seats apportioned to 16 the county at large.

17 Sec. 3. (a) In 1991 members shall be elected from Districts 1, 3, and 5 for 18 three-year terms, and two members shall be elected at large for three-year terms.

(b) In 1992 and quadrennially thereafter, members shall be elected from Districts2, 4, 6, and 7 for four-year terms.

(c) In 1994 and quadrennially thereafter, members shall be elected from Districts
1, 3, and 5 for four-year terms, and two members shall be elected at large for four-year
terms.

21		n a vacancy occurs on any district seat, the person appointed to fill the

23	Sec. 5. The results of primary elections for at-large seats on the Anson	
24	County Board of Education shall be determined as provided by G.S. 163-111 for the	
25	group method of election.	
26	Sec. 6. The provisions of Chapter 261, Session Laws of 1967, as amended,	
27	which were in effect at the time of ratification of this act, and which do not conflict with	
28	this act, are not affected by this act.	
29	Sec. 7. The election dates, general timetable, and filing period for the 1991	
30	election authorized by this act shall be established by the Executive Secretary-Director	
31	of the State Board of Elections.	
32	Sec. 8. This act is effective upon ratification. Upon its ratification, Chapter	
33	288 of the 1989 Session Laws is repealed.
