2 AN ACT TO ANNEX SPECIFIED PROPERTY IN THE TOWN OF CARTHAGE IN MOORE COUNTY.

4 The General Assembly of North Carolina enacts:

Section 1. Notwithstanding the provisions of G.S. 160A-58.1(b), the corporate limits of the Town of Carthage are extended to include the following area:

DOT site easement, S 61-13 E 115.5 feet, to the north right of 29 way line, of N.C.S.R. 1838, thence as a north line of the road, N 69-00 E about 1,144.2 30 feet to a new iron pipe, thence with the old Green line, 639.3 feet to a concrete marker, 31 thence west 101 feet to an iron pipe which is the southeast corner of a 34.32 acre tract thence N 07-13 E 1,780.6 feet to a concrete marker, ; thence N 82-52 W 1,742 feet to 32 the center of NC Hwy 22, thence as the center of Hwy 22, in a northerly direction 2,025 33 34 feet to an iron rod which is the southeast corner of the Elwin Blue home tract, thence 35 with his line, N 88-27 W 318.70 feet to concrete marker thence S 61-35 W 1693.9 feet to a concrete marker near the south side of Wads Creek (a corner with Allie Blue); 36 37 thence N 55-55 W 767.2 feet; thence N 32-45 W 551.6 feet; thence N 82-45 W 696 feet; 38 thence N 40-05 W 362 feet; thence N 03-14 E 331.49 feet; thence N 21-43 W 355.66 feet to the BEGINNING. 39
