A BILL TO BE ENTITLED

AN ACT TO PROVIDE AN ANNUAL ONE HUNDRED FIFTY DOLLAR ALLOWANCE TO EACH MEMBER OF THE NORTH CAROLINA NATIONAL GUARD AND TO APPROPRIATE FUNDS FOR THE ALLOWANCE.

The General Assembly of North Carolina enacts:

Section 1. G.S. 127A-139 reads as rewritten:

"§ 127A-139. Allowances made to different organizations and personnel.

(a) There may be allowed each year to the following officers, under rules and regulations prescribed by the Secretary of Crime Control and Public Safety, as follows: to general officers, and commanders of divisions, corps, groups, brigades, regiments, separate battalions, squadrons or similar organizations, not to exceed two hundred and twenty-five dollars (\$225.00); to commanding officers of companies, batteries, troops, detachments and similar units not to exceed two hundred dollars (\$200.00); to executive officers, adjutants, plans and training officers, logistical officers and commissioned officers in comparable assignments in divisions, corps, groups, brigades, regiments, battalions, squadrons and similar organizations, not to exceed two hundred dollars (\$200.00). No officer shall be entitled to receive any part of the amounts named herein unless he has performed satisfactorily all duties required of him by law and regulations and has pursued such course of instruction as may from time to time be required.

(b) There may be allowed annually to the supply sergeant of each company, battery, troop, detachment, and similar organizations, a sum of money not to exceed one hundred dollars (\$100.00) for services satisfactorily performed.

1 (b1) In addition to the allowances provided in subsections (a) and (b) of this
2 section, there shall be allowed each year to every member of the North Carolina
3 national guard who has served for nine months or more the sum of one hundred fifty
4 dollars (\$150.00). This allowance shall be paid on July 1 each year from funds
5 appropriated to the Department of Crime Control and Public Safety for that purpose. A
6 member may not receive the allowance provided in this subsection unless he has
7 performed satisfactorily all duties required of him by law and regulations and has
8 pursued such course of instruction as may from time to time be required.

9 (c) There shall be allowed annually sufficient funds to be allocated by the
10 Secretary of Crime Control and Public Safety among the federally recognized units of
11 the national guard and their headquarters, NCNG State Pistol Team, NCNG State Rifle
12 Team, NCARNG Aviation Support Facility, and NCARNG Aviation Flight Activity for
13 administrative and operating expenses, including heat, electricity, telephone, postage,
14 office supplies and equipment, minor repairs and replacement of equipment, and such
15 other expenses and special items of equipment not otherwise provided as may be
16 authorized in accordance with national guard rules and regulations.

18 (e) The commanding officers of all organizations participating in the
19 appropriations herein made shall render an itemized statement of all funds received
20 from any source whatever for the support of their respective organizations in such
21 manner and on such forms as may be prescribed by the Secretary through the Adjutant
22 General. Failure on the part of any officer to submit promptly when due the financial
23 statement of his organization will be sufficient cause to withhold all appropriations for
24 such organizations."

25 Sec. 2. There is appropriated from the General Fund to the Department of
26 Crime Control and Public Safety the sum of two million one hundred one thousand two
27 hundred dollars (\$2,101,200) for fiscal year 1992-93 to fund the special allowance
28 provided in Section 1 of this act.

29 Sec. 3. This act becomes effective July 1, 1992.
