1 A BILL TO BE ENTITLED  
2 AN ACT TO APPROPRIATE FUNDS FOR A NEW FACILITY FOR THE SCHOOL  
3 LEADERSHIP ACADEMY.

4 Whereas, the 1991 General Assembly, upon the recommendation of the Joint  
5 Legislative Education Oversight Committee, established the Educational Leadership  
6 Task Force "to identify how to best select, train, assess, and regulate persons to become  
7 competent, motivated and trusted education leaders"; and

8 Whereas, the Educational Leadership Task Force, composed of members of  
9 the State Board of Education, the Board of Governors of The University of North  
10 Carolina, legislators, educators, and a representative of business and industry presented  
11 to the Joint Legislative Education Oversight Committee its report, "Leaders for Schools:  
12 The Preparation and Advancement of Educational Administrators", which included a  
13 recommendation to establish a School Leadership Academy to provide continuing  
14 professional development for school administrators; and

15 Whereas, as a result of the recommendations of the Educational Leadership  
16 Task Force, the Joint Legislative Education Oversight Committee recommended to the  
17 1993 General Assembly a package of education leadership bills, including a  
18 recommendation to establish a School Leadership Academy which incorporates and  
19 builds upon the Principals' Executive Program; and

20 Whereas, Section 86 of Chapter 321 of the 1993 Session Laws established a  
21 joint committee of the State Board of Education and the Board of Governors to study  
22 how to establish a School Leadership Academy; and

1           Whereas, the joint committee recommended that the Principals' Executive  
2 Program, which currently has no permanent site, should be incorporated into the School  
3 Leadership Academy and that there should be a new School Leadership Academy  
4 facility to house the Principals' Executive Program and expanded programs; Now,  
5 therefore,

6 The General Assembly of North Carolina enacts:

7           Section 1. There is appropriated from the General Fund to the Board of  
8 Governors of The University of North Carolina ten million five hundred sixty thousand  
9 dollars (\$10,560,000) for a new facility for the School Leadership Academy that  
10 includes instructional, office, and residential space, and that provides the latest  
11 instructional and communications technology. The facility shall be located in the  
12 current vicinity of the Principals' Executive Program.

13           Sec. 2. This act becomes effective July 1, 1994.
