4	The General Assembly of North Carolina enacts:
5	Section 1. G.S. 96-9(a)(7) reads as rewritten:
6	"(7) Effective with the quarter ending September 30, 1992, every employer
7	with 250 or more employees, and every person or organization that, as
8	agent, reports wages on a total of 250 or more employees on behalf of
9	one or more subject employers, shall file that portion of the
10	'Employer's Quarterly Tax and Wage Report' that contains the name,
11	social security number, and gross wages of each individual in
12	employment on magnetic tapes or diskettes in a format prescribed by
13	the Commission.
14	For failure of an employer to comply with this subsection, there
15	shall be added to the amount required to be shown as tax in the reports,
16	a penalty of five percent (5%) of the amount of such tax or twenty-five
17	dollars (\$25.00), whichever is greater. The Commission shall have the
18	power to reduce or waive this penalty pursuant to G.S. 96-10(j). For a
19	person or organization that, as agents, fails to comply, that person or
20	organization shall cease to have the right to report wages and file
21	reports for subject employees for a period of one year following the
