A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO PUBLIC OFFICE UPON THE  
2 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF  
3 REPRESENTATIVES; AND TO INCREASE THE NUMBER OF GENERAL  
4 ASSEMBLY APPOINTEES TO THE WESTERN NORTH CAROLINA  
5 REGIONAL ECONOMIC DEVELOPMENT COMMISSION.

Whereas, G.S. 120-121 authorizes the General Assembly to make certain appointments upon the recommendation of the Speaker of the House of Representatives; and

Whereas, the Speaker of the House of Representatives has made recommendations; Now, therefore,

7 The General Assembly of North Carolina enacts:

8 Section 1. Richard Koerber of Henderson County is appointed to the  
9 Acupuncture Licensing Board for a term expiring June 30, 1997.

10 Sec. 2. J. D. Teachey, Jr. of Duplin County, Zeno Radcliffe, III of Beaufort  
11 County, and Gary Hyatt of Mitchell County are appointed to the North Carolina  
12 Agricultural Finance Authority for terms expiring June 30, 1998.

13 Sec. 3. Sylvania Wilkerson of Wayne County is appointed to the Alarm  
14 Systems Licensing Board for a term expiring June 30, 1998.

38           Sec. 48. Unless otherwise provided, appointments made by this act are for  
39 terms beginning upon the ratification of this act.

40           Sec. 49. (a) G.S. 158-8.1(b) reads as rewritten:

41       "(b) The Commission shall consist of ~~15~~19 members appointed as follows:

- 42           (1) Three members shall be appointed by the Governor;  
43           (2) Two members appointed by the Lieutenant Governor;

1           (3) ~~Five-Seven~~ members shall be appointed by the General Assembly upon  
2           the recommendation of the Speaker of the House of Representatives in  
3           accordance with G.S. 120-121.

4           (4) ~~Five-Seven~~ members shall be appointed by the General Assembly upon  
5           the recommendation of the President Pro Tempore of the Senate in  
6           accordance with G.S. 120-121; and".

7           (b) G.S. 158-8.1(c) reads as rewritten:

8           "(c) The appointing authority shall designate two of the initial appointees pursuant  
9           to subsection (b)(1), one of the initial appointees pursuant to subsection (b)(2), two of the  
10          initial appointees pursuant to subsection (b)(3), and two of the initial appointees pursuant  
11          to subsection (b)(4) to serve for terms ending June 30, 1995; the remainder of the initial  
12          appointees shall serve for terms ending June 30, 1997. Their successors shall serve for  
13          four-year terms ending on June 30 quadrennially thereafter. The appointing authority  
14          shall designate the additional appointees under subsections (b3) and (b4) that were added  
15          to the Commission membership pursuant to an act of the 1995 General Assembly to serve  
16          for terms ending June 30, 1999.

17          Any appointment to fill a vacancy on the Commission shall be for the balance of the  
18          unexpired term. Vacancies in appointments made by the General Assembly shall be in  
19          accordance with G.S. 120-122."

20          Sec. 50. Ray Rouge, III of Wayne County and R. Stephen Stroud of Wake  
21          County are appointed to the Centennial Authority for terms expiring July 1, 1999.  
22          Temple Sloan, Jr. of Wake County and Brent Barringer of Wake County are appointed to  
23          the Centennial Authority for terms expiring July 1, 1997.

24          Sec. 51. This act is effective upon ratification.
