5	AGREEMENTS.
6	The General Assembly of North Carolina enacts:
7	Section 1. G.S. 45-81(a)(1) reads as rewritten:
8	"(1) At any time within a specified period not to exceed <u>15–30</u> years the
9	borrower may request and the lender is obligated to provide, by
10	honoring negotiable instruments drawn by the borrower or otherwise,
11	advances up to an agreed aggregate limit;".
12	Sec. 2. Article 9 of Chapter 45 of the General Statutes is amended by adding a
13	new section to read:
14	" <u>§ 45-82.1. Extension of period for advances.</u>
15	(a) The period for advances agreed to pursuant to G.S. 45-81(a)(1) may be
16	extended by written agreement of the lender and borrower executed prior to termination
17	of the equity line of credit or the borrower's obligation to repay any outstanding
18	indebtedness. Any extended period shall not exceed 30 years from the end of the
19	preceding period for advances.

1	(b) A mortgage or deed of trust that secures an equity line of credit to which the
2	(b) <u>A mortgage or deed of trust that secures an equity line of credit to which the</u> lender and borrower have agreed to an extended period for advances shall have priority
2 3	with respect to advances made after the preceding loan period from a date not later than
4	the date of registration of the certificate described in subsection (c) of this section.
5	(c) The priority provided in subsection (b) of this section shall be accorded only if
6	the grantor of the mortgage or the deed of trust securing the obligation, and other record
7	owners of the real property therein conveyed, execute a certificate evidencing the
8	extension and register the certificate in the office of the register of deeds where the
9	mortgage or deed of trust is registered. The failure of any record owner to execute the
10	certificate shall affect only that record owner's interest in the property, and executions by
11	other owners shall have full effect to the extent of their interests in the property. For
12	purposes of this section, the term 'record owner' means any person owning a present or
13	future interest of record in the real property which would be affected by the lien of the
14	mortgage or deed of trust, but does not mean the trustee in a deed of trust or the owner or
15	holder of a mortgage, deed of trust, mechanic's or materialman's lien, or any other lien or
16	security interest in the real property.
17	(d) The certificate described in subsection (c) of this section may be in any form
18	that fulfills the requirements of subsection (c) of this section, including the following:
