Section 1. Section 1(e) of Chapter 422 of the 1989 Session Laws reads as rewritten:

- "(e) Use of tax revenue. Burke County shall use the net proceeds of the occupancy tax only to promote economic development <u>and travel</u> and tourism in Burke County. <u>The county shall allocate the net proceeds one-half for economic development and one-half for travel and tourism.</u> As used in this subsection, 'net proceeds' means gross proceeds less the cost to the county of administering and collecting the tax, as determined by the finance officer."
- Sec. 2. Effective July 1, 1996, Section 1(e) of Chapter 422 of the 1989 Session Laws, as amended by this act, reads as rewritten:
- "(e) Use of tax revenue. Burke County shall use the net proceeds of the occupancy tax only to promote economic development and travel and tourism in Burke County. The county shall-may allocate the net proceeds one-half for economic development and one-half for travel and tourism. tourism or in any other ratio the board of commissioners considers appropriate. As used in this subsection, 'net proceeds' means gross proceeds

- less the cost to the county of administering and collecting the tax, as determined by the finance officer."
- Sec. 3. Section 2 of this act becomes effective July 1, 1996. The remainder of this act becomes effective July 1, 1995.
