- AN ACT RELATING TO THE DEFINITION OF SUBDIVISION IN MONTGOMERY
 COUNTY.
- 4 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 153A-335 reads as rewritten:
- 6 "§ 153A-335. 'Subdivision' defined.

7 For purposes of this Part, 'subdivision' means all divisions of a tract or parcel of land 8 into two or more lots, building sites, or other divisions for the purpose of sale or building development (whether immediate or future) and includes all division of land involving 9 the dedication of a new street or a change in existing streets; however, the following is 10 not included within this definition and is not subject to any regulations enacted pursuant 11 to this Part: Part, provided that the grantor of any land who by deed subdivides the land 12 other than by recorded subdivision plat shall include in the deed a statement as to why the 13 subdivision is exempt from these regulations by reference to one or more of the following 14 15 subsections: The combination or recombination of portions of previously subdivided 16 (1)and recorded lots if-where the total number of lots is not increased and 17 18 the resultant lots are equal to or exceed the standards of the county as

shown in its subdivision regulations;-regulations and the combination or

2		private road as shown on a plat previously recorded in the county

4	(2)	The division of land into parcels greater than 10 acres if no street right-
5	(2)	of-way dedication is involved;
6	(3)	The public acquisition by purchase of strips of and for widening or
7	(5)	opening streets; and
8	(4)	The division of a tract in single ownership the entire area of which is no
9		greater than two acres into not more than three lots, if no street right-of-
10		way dedication is involved and if the resultant lots are equal to or
11		exceed the standards of the county as shown by its subdivision
12		regulations.
13	<u>(2)</u>	The public acquisition by purchase of strips of land for widening or
14		opening of streets;
15	(3)	The conveyance of a lot or tract for the purpose of dividing lands among
16		the tenants in common, all of whom inherited by intestacy or by will,
17		the land from a common ancestor;
18	<u>(4)</u>	The division of land by any method of transfer among members of a
19		lineal family, which shall include direct lineal descendants (children,
20		grandchildren, great-grandchildren) and direct lineal ascendants (father,
21		mother, grandfather, grandmother) and brothers, sisters, nieces, and
22		nephews;
23	<u>(5)</u>	The division of land pursuant to an order of the General Court of
24		Justice;
25	<u>(6)</u>	The division of land for cemetery lots or burial plots;
26	<u>(7)</u>	The conveyance of a tract or parcel of land of at least 20,000 square feet
27		exclusive of State right-of-way for a road with at least 100 feet frontage
28		upon a State-maintained road, as well as a driveway permit previously
29		issued by the Department of Transportation along the 100 foot frontage
30		and a means of sewage disposal by a previously issued permit from the
31		Division of Environmental Management of the county health
32		department:
33	<u>(8)</u>	The division of land into parcels of five acres or more where the grantor
34		records a road right-of-way agreement prior to or simultaneously with
35		the recording of the deed, which said agreement provides for access to
36		the parcel by a right-of-way of at least 45 feet in width and contains an
37	(0)	agreement for construction and maintenance of the road; and
38	<u>(9)</u>	The division of land into parcels where 10 or fewer lots result after the
39 40		subdivision is completed and each lot in the subdivision is at least one
40		acre in size. The intent of the exemption provided by this subsection is
41 42		to provide for special situations in the rural area of the county in
42 43		accordance with standards and procedures as set forth in the county subdivision ordinance."
