8	Section 1. G.S. 135-40.7A(c) reads as rewritten:

10	necessary care and treatment of chemical dependency under this Part shall provide for
11	benefit payments for the following providers of necessary care and treatment of chemical
12	dependency:

15	a. Chemical dependency units in facilities licensed after October 1,

10	professional counselor offering counseling services that include, but are
11	not limited to, the following:
12	a. Counseling. – Assisting individuals, groups, and families through
13	the counseling relationship, using relationship by treating mental
14	disorders and other conditions through the use of a combination
15	of clinical mental health and human development principles,
16	methods, diagnostic procedures, treatment plans, and other
17	psychotherapeutic techniques, to develop an understanding of
18	personal problems, to define goals, and to plan action reflecting
19	the client's interests, abilities, aptitudes, and mental health needs
20	as these are related to personal-social-emotional concerns,
21	educational progress, and occupations and careers.
22	b. Appraisal Activities. – Administering and interpreting tests for
23	assessment of personal characteristics.
24	c. Consulting. – Interpreting scientific data and providing guidance
25	and personnel services to individuals, groups, or organizations.
26	d. Referral Activities. – Identifying problems requiring referral to
27	other specialists.
28	e. Research Activities. – Designing, conducting, and interpreting
29	research with human subjects."
30	Sec. 5. This act becomes effective October 1, 1995, and applies to claims for
31	payment or reimbursement for services rendered on or after that date.
