BILL SUMMARY: S 1114. PROF'L TCH'G STDS. COMM'N. TO IMPLEMENT THE RECOMMENDATION OF THE JOINT LEGISLATIVE EDUCATION OVERSIGHT COMMITTEE TO CHANGE THE COMPOSITION OF THE PROFESSIONAL TEACHING STANDARDS COMMISSION SO THAT TEACHERS HAVE A MAJORITY, TO EXPAND THE AUTHORITY OF THE PROFESSIONAL TEACHING STANDARDS COMMISSION, AND TO ESTABLISH A PROFESSIONAL PRACTICES BOARD. Effective Sept. 1, 1996, reduces membership of NC Professional Teaching Standards Commission from eighteen to fifteen members. Governor to appoint four teachers and Senate President Pro Tempore and House Speaker each to appoint three teachers, as specified in bill. Commission to be located administratively under State Board of Education (now, Department of Public Instruction). Sets out powers and duties of commission, including to develop and recommend to State Board of Education professional standards or revisions to professional standards for NC teachers. The Commission must submit annual report by December1 of each year to Joint Legislative Education Oversight Committee of its activities during preceding year, together with recommendations and findings concerning improvement of teaching profession. Adds new GS 115C-295.3 to require State Board of Education to establish Professional Practices Board composed of teachers, school administrators, and representatives of the general public. Board to: (1) develop code of ethics for teaching profession and develop procedures to investigate code violations; (2) investigate complaints concerning code violations; and (3) make recommendations to State Board of Education concerning revocation and suspension of teacher certificates as result of ethics violation.
